## **Limited Warranty**

The Warranty applies to the Zone V case, POLAR:MAG® USB cable and headset jack adapter ('Hardware'). The Hardware is guaranteed for a period of 12 months from the initial date of purchase to be free from defects in workmanship and materials in normal use. If a fault arising from a defect in workmanship

or materials occurs during this time, please contact the store

where your Hardware was purchased or visit the Zone V website for further information www.zonev.com/warranty and Zone V will, at its option, repair (with new or refurbished parts) or replace the Hardware. This

warranty does not affect your

consumers' statutory rights.

an invoice or sales receipt detailing the retailer name and address, date of purchase and product code will be required to claim any repair or replacement under the terms

and conditions of the warranty. Zone V Limited reserves the right to refuse any claim under the warranty if an invoice or sales receipt is not provided or has been altered in any way.

## The warranty will be invalid if damage is caused by:

- normal wear and tear such as surface damage, chips, scratches to the case
- cracks or scratches to the magnifying lens
- accidents, abuse or misuse
  acts of God
- acts of Godbeing dropped
- exposure to moisture and or liquids

- exposure to low or high temperatures or rapid changes in these conditions
- unauthorised modifications or repairs
- damage resulting from negligence
- theft or loss

If Zone V Limited repairs or replaces the Hardware, the warranty will continue for the

remainder of the warranty period for a repair or replacement or for 3 months depending on which is longer.

This warranty only applies to the Hardware, namely the Zone V case, POLAR:MAG® USB cable and headset jack adapter as supplied and does not apply to any software.

Zone V Limited is not responsible for any damage to or the loss of any data, applications or external storage devices such as a SD card, or to any malware, including viruses and spyware.

Except for this Limited Warranty and to the maximum extent permitted by applicable law, Zone V and its suppliers provide the Hardware "AS IS AND

WITH ALL FAULTS", and hereby disclaim all other warranties and conditions, whether express, implied or statutory, including, but not limited to, any (if any) implied warranties, duties or conditions of satisfactory quality, of fitness for a particular

purpose, of reliability or availability, of accuracy or completeness of responses, of results, of workmanlike effort,

of lack of malware or viruses, and of reasonable care and skill, all with regard to the Hardware, and the provision of or failure to provide support or other services, information, software, and related content through the Hardware or otherwise arising out of the use of the Hardware. Also, there is no warranty or condition of quiet enjoyment, quiet possession, or

non-infringement with regard to the Hardware. This exclusion does not apply to (i) any implied condition as to title and (ii) any implied warranty as to conformity with description.

This Limited Warranty does not affect any legal rights under applicable national legislation governing the sale of consumer goods. This Limited Warranty cannot be transferred to any other person.

Neither Zone V nor its suppliers shall be liable to you or to any third party for any damages either direct, indirect, incidental, consequential or otherwise (including in each case, but not limited to, damages for the inability to use the equipment or access data, loss of data,

loss of business, loss of profits, business interruption or the like) arising out of the use of or inability to use the Hardware even if Zone V has been advised of the possibility of such damages.

Not withstanding any damages that you might incur for any reason whatsoever (including, without limitation, all damages referenced herein and all direct or general damages in contract or anything else), the entire liability of Zone V and any of its suppliers shall be limited to the amount actually paid by you for the Hardware.

Zone V shall not be liable for (i) any fraud on the part of its employees and/or agents; or (ii) any fraudulent misrepresentation on the part

of its employees and/or agents. Notwithstanding the above, neither party's liability for death or personal injury resulting from its own negligence shall be limited.
