**AN ORDINANCE
TO CREATE A THEATRE DISTRICT WITHIN THE
VILLAGE OF CHAGRIN FALLS.**

WHEREAS, the Village of Chagrin Falls takes pride in its theaters and performing arts venues, including the Chagrin Valley Little Theatre and the River Street Playhouse, both of which are located on River Street; and

WHEREAS, in recognition of the ever-thriving theater and performing arts culture in the Village, this Council desires to establish the "Chagrin Falls Theatre District" which shall encompass River Street and West Street and a portion of West Orange Street.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CHAGRIN FALLS, CUYAHOGA COUNTY, STATE OF OHIO:

SECTION 1. That there is hereby established in the Village the "Chagrin Falls Theatre District" which shall include the area depicted on the map attached hereto and incorporated herein by reference as Exhibit A, which area includes River Street and West Street and a portion of West Orange Street.

SECTION 2. The Mayor or the Mayor's designee is hereby authorized to erect signage, as deemed necessary, to properly identify the "Chagrin Falls Theatre District" on eastbound West Orange Street, southbound West Street, and westbound River Street.

SECTION 3. That actions of this Council concerning and relating to the passage of this legislation were adopted in lawful meetings of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in compliance with all legal requirements, including Chapter 114 of the Codified Ordinances of the Village of Chagrin Falls.

SECTION 4. That in accordance with Section 113.01 of the Codified Ordinances of the Village of Chagrin Falls, public notice of this Ordinance shall also be given by posting a copy thereof for not less than fifteen (15) days in the Village Hall.



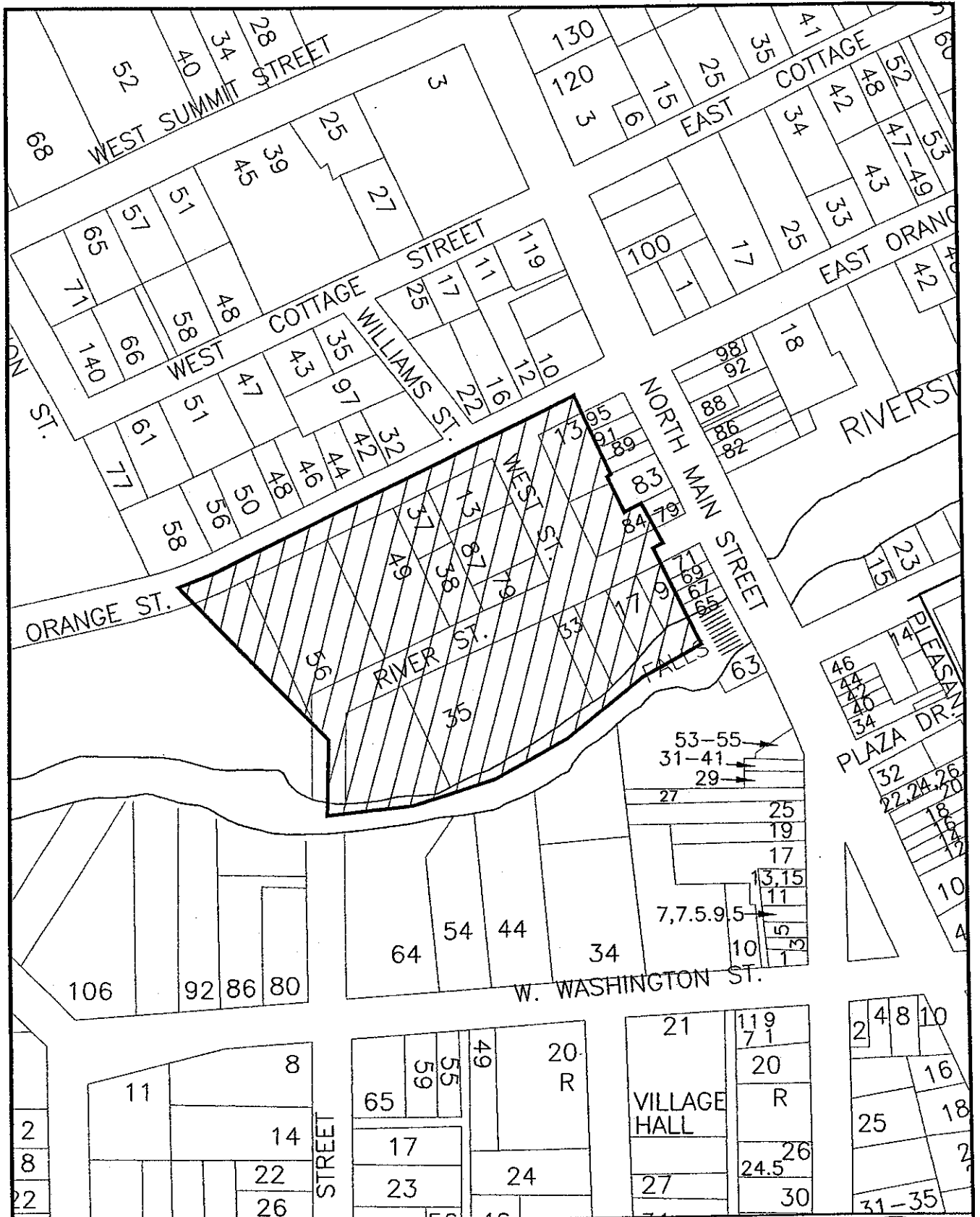
