AN ORDINANCE TO REVISE THE CODIFIED ORDINANCES BY  
ADOPTING CURRENT REPLACEMENT PAGES AND DECLARING AN  
EMERGENCY.

WHEREAS, various ordinances of a general and permanent nature have been passed by Council which should be included in the Codified Ordinances; and

WHEREAS, certain traffic and misdemeanor provisions should be revised to comply with current State law;

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CHAGRIN FALLS, STATE OF OHIO:

Section 1. That the ordinances of the Village of Chagrin Falls, Ohio, of a general and permanent nature, as revised, recodified, rearranged and consolidated into component codes, titles, chapters and sections within the August 2015 Replacement Pages of the Codified Ordinances are hereby approved and adopted.

Section 2. That the following sections and chapters are hereby enacted, amended or repealed as respectively indicated in order to comply with current State law:

Section 3. That the complete text of the sections listed above are set forth in full in the current replacement pages to the Codified Ordinances. Notice of adoption of each new section by reference to its title shall constitute sufficient publication of new matter contained therein.

Section 4. That in accordance with Section 113.01 of the Codified Ordinances, public notice of this Ordinance shall be given by posting a copy thereof, for not less than fifteen days in the Village Hall.

Section 5. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees, on or after December 2, 1975, that resulted in formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 6. That this Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health and safety of the inhabitants of the Village and for the further reason that it is necessary to bring the Traffic and General Offenses Codes into compliance with current State law as required by Article XVIII, Section 3 of the Ohio Constitution and to avoid other practical and legal entanglements, and provided it receives two-thirds of the vote of all members of Council elected thereto, shall take effect and be in full force from and after its passage and approval by the Mayor, or otherwise from and after the earliest period allowed by law.


