The meeting was called to order at 9:00 a.m. by Chairman Larry Trace.

ORGANIZATION

Moved by Mrs. White, seconded by Mrs. Carr that Mr. Trace serve as Chairman of the Board of Cemetery Trustees for the year 2013. The motion carried unanimously.

APPROVAL OF MINUTES

Moved by Mrs. White, seconded by Mr. Trace that the minutes of the meeting held December 12, 2012 be approved. Carried. Ayes: White, Trace. Abstain: Carr. Nays: None.

PRICE INCREASES

Moved by Mrs. White, seconded by Mrs. Carr to increase prices as follows:

6' x 12"	from \$ 375.00 to \$400.00

Columbarium Engraving

One Name	from \$250.00 to \$325.00
Two Names	from \$425.00 to \$500.00

The motion carried unanimously.

MEMORIAL DAY WEEKEND

Mr. Trace reminded Mr. Brockway that 300 chairs need to be rented for the ceremony at the cemetery.

EXPANSION

Mr. Trace asked if they can get a cost estimate on opening a new section. Mr. Arnold said he will contact a cemetery architect to find out how much it would cost to develop per acre.

DECORATIONS - RULES, REGULATIONS, & PROCEDURES

Mr. Trace mentioned that decorations are permissible on graves between December 1st and March 1st and will be removed by village employees if not by the families.


