

A RESOLUTION
ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY
THE COMMISSION, WITH THE EXCEPTION OF THE GENERAL
FUND, OUTSIDE 10 MILL AMOUNT AND RATE, AND
AUTHORIZING THE NECESSARY TAX LEVIES AND
CERTIFYING THEM TO THE COUNTY FISCAL OFFICER

WHEREAS, this Council in accordance with the provisions of law has previously adopted a Tax Budget for the next succeeding fiscal year commencing January 1, 2016 , and

WHEREAS, the Budget Commission of Cuyahoga County, Ohio, has certified its action thereon to this Council together with an estimate by the County Fiscal Officer of the rate of each tax necessary to be levied within the ten mill tax limitation.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF CHAGRIN FALLS, STATE OF OHIO:

Section 1. That the amounts and rates, as determined by the Budget Commission in its certification, be and the same are hereby accepted provided that the General Fund Outside 10 Mill amount and rate shall be amended as set forth in Section 2 of this Resolution.

Section 2. That there be and is hereby levied on the tax duplicate of said Village the rates each tax necessary to be levied within and without the ten mill limitation as follows:

Section 6. That this Resolution shall take effect and be in force from and after the earliest period allowed by law and signature of the Mayor.




