

AN EMERGENCY ORDINANCE  
AUTHORIZING AND DIRECTING THE MAYOR TO ENTER INTO  
A CONTRACT EXTENDING THE DENTAL PLAN PROVIDED TO  
ALL FULL VILLAGE EMPLOYEES WITH DELTA DENTAL FOR A  
TWO YEAR PERIOD BEGINNING JULY 1, 2011 TO JUNE 30,  
2013.

WHEREAS, currently Delta Dental provides a professional service for the Village of Chagrin Falls in that it is the insurance carrier for the dental plan that is provided to all full time employees of the Village; and

WHEREAS, the Village Council deems it necessary and in the best interest to extend this Delta Dental plan for a two year period beginning July 1, 2011 to June 30, 2013 and Council wishes to authorize the Mayor to enter into a contract with Delta Dental for two years beginning July 1, 2011.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CHAGRIN FALLS, STATE OF OHIO:

Section 1. That the Mayor is hereby and herein authorized and directed to enter into a professional service contract with Delta Dental for a two year period beginning July 1, 2011 to June 30, 2013 in order to provide all full time Village employees with a dental plan with certain coverage as set forth in the contract.

Section 2. That the Director of Finance is authorized and directed to pay Delta Dental the appropriate funds according to the 2011/2013 rate structure which has been reviewed and approved by Village Council.

Section 3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this legislation were adopted in lawful meetings of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in compliance with all legal requirements, including Chapter 114 of the Codified Ordinances of the Village of Chagrin Falls.

Section 4. That in accordance with Section 113.01 of the Codified Ordinances of the Village of Chagrin Falls, public notice of this Ordinance shall be given by posting a copy thereof for not less than fifteen (15) days in the Village Hall.

Section 5. That this Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health and safety of the inhabitants of the Village and for the further reason stated in the Preamble hereof, and provided it receives two-thirds (2/3) of the vote of the members of Council elected thereto, shall take effect and be in full force from and after the earliest period allowed by law.

Dear Dave;

Your current Group Dental benefits renew with Delta Dental July 1, 2011.

An original was mailed to your attention May 2, 2011.

The new rates requested are:

**Single - \$33.82/month, an increase of \$1.38/month or 4.2%.  
Family - \$99.74/month, an increase of \$4.07/month or 4.2%.**

These rates were originally guaranteed for *one year*.  
However, we were able to negotiate a *two-year rate guarantee*.

We do not arbitrarily recommend replacement but work for our clients in finding suitable alternatives in the event economic and/or servicing difficulties are encountered with the current provider.

In this case, we are not aware of any servicing difficulties and although there is a modest increase, the rates will be guaranteed for another two years.

We would recommend acceptance.
