

**AN ORDINANCE
AUTHORIZING AND DIRECTING THE MAYOR TO ENTER
INTO A CONTRACT WITH MEDICAL MUTUAL OF OHIO
FOR HEALTH CARE INSURANCE COVERAGE FOR THE
EMPLOYEES OF THE VILLAGE OF CHAGRIN FALLS, AND
DECLARING AN EMERGENCY.**

WHEREAS, the Village of Chagrin Falls has received and reviewed quotes from professional services companies offering to provide health care insurance coverage for the employees of the Village of Chagrin Falls; and

WHEREAS, based upon recommendation, Village Council deems it necessary and in the best interests of the Village to enter into a contract with Medical Mutual of Ohio in order to provide this healthcare insurance coverage beginning on April 1, 2012, and wishes to authorize the Mayor to do so.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CHAGRIN FALLS, CUYAHOGA COUNTY, STATE OF OHIO:

SECTION 1. That the Mayor is authorized and directed to enter into a contract with Medical Mutual of Ohio in order to provide health care insurance coverage for Village employees pursuant to the terms, conditions, and specifications of that company's quote for professional services which is attached and incorporated into this Ordinance as Exhibit "A" which shall be effective on April 1, 2012.

SECTION 2. That the Director of Finance is authorized to make payments to Medical Mutual of Ohio as is set forth in Exhibit "A" from the appropriate fund of the Village.

SECTION 3. That actions of this Council concerning and relating to the passage of this legislation were adopted in lawful meetings of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in compliance with all legal requirements, including Chapter 114 of the Codified Ordinances of the Village of Chagrin Falls.

SECTION 4. That in accordance with Section 113.01 of the Codified Ordinances of the Village of Chagrin Falls, public notice of this Ordinance shall be given by posting a copy thereof for not less than fifteen (15) days in the Village Hall.

SECTION 5. That this Ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health and safety of this Village and for the further reason that this Ordinance must be immediately effective so that the health insurance coverage for Village employees may continue without interruption; wherefore, provided it receives the requisite

number of affirmative votes of all members elected to Council, this Ordinance shall be in full force and effect from and immediately upon its passage by this Council and approval by the Mayor; otherwise, it shall take effect and be in force after the earliest period allowed by law.
