

**AN ORDINANCE
CERTIFYING DELINQUENT WATER BILL AMOUNTS FOR THE
PROPERTY LOCATED AT 291 NORTH MAIN STREET, CHAGRIN FALLS,
OHIO TO THE CUYAHOGA COUNTY FISCAL OFFICER FOR
PLACEMENT ON THE TAX DUPLICATE FOR COLLECTION IN ONE
ANNUAL INSTALLMENT AND DECLARING AN EMERGENCY.**

WHEREAS, pursuant to Ordinance No. 2008-54 passed on December 8, 2008, this Council adopted the current version of the Village's Water Rules and Regulations; and

WHEREAS, Section 8.01 of the Village's Water Rules and Regulations provides: "Any person signing for water service obligates himself or herself for payment whether as an agent for the owner or the owner. The Water Department may proceed against either the tenant or the owner for collections of bills, at the discretion of the Department. This includes certifying past due accounts to the County Auditor for collection with property taxes."; and

WHEREAS, the owner of the property at 291 North Main Street in the Village of Chagrin Falls has a delinquent water bill in the amount of \$253.93; and

WHEREAS, due to the property owner's failure to pay his delinquent water bill, this Council desires to certify the delinquent water bill amount of \$253.93 to the Cuyahoga County Fiscal Officer to be placed on the tax duplicate for collection with property taxes pursuant to Section 8.01 of the Village's Water Rules and Regulations.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE
OF CHAGRIN FALLS, CUYAHOGA COUNTY, STATE OF OHIO:**

SECTION 1. That in accordance with Section 8.01 of the Village's Water Rules and Regulations, the Clerk of Council shall certify the delinquent water bill amount of \$253.93 for the property known as 291 North Main Street in the Village of Chagrin Falls to the Cuyahoga County Fiscal Officer for placement on the tax duplicate for collection in one annual installment, in the form provided in Exhibit A, attached hereto and incorporated herein by reference, along with a copy of this Ordinance.

SECTION 2. That actions of this Council concerning and relating to the passage of this legislation were adopted in lawful meetings of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in compliance with all legal requirements, including Chapter 114 of the Codified Ordinances of the Village of Chagrin Falls.

SECTION 3. That in accordance with Section 113.01 of the Codified Ordinances of the Village of Chagrin Falls, public notice of this Ordinance shall be given by posting a copy thereof for not less than fifteen (15) days in the Village Hall.

SECTION 4. That this Ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health and safety of this Village and for the further reason that this Ordinance must be immediately effective so that the delinquent water bill amount can be certified to the Cuyahoga County Fiscal Officer before the statutory deadline of September 8, 2014; wherefore, provided it receives the requisite number of affirmative votes of all members elected to Council, this Ordinance shall be in full force and effect from and immediately upon its passage by this Council and approval by the Mayor; otherwise, it shall take effect and be in force after the earliest period allowed by law.


