

**AN ORDINANCE
AUTHORIZING A CHANGE ORDER TO THE NORTH
STREET WATER MAIN PROJECT TO INCLUDE THE
SOUTH FRANKLIN WATER MAIN PROJECT, AND
DECLARING AN EMERGENCY.**

WHEREAS, this Council has previously authorized Camino Construction, Inc., to perform the work of the North Street Water Main Project; and

WHEREAS, this Council has been advised that Camino Construction, Inc., has performed the work on the North Street Water Main Project in a very efficient manner, ahead of the project schedule; and

WHEREAS, Camino Construction, Inc., when it performed the work on the North Street Water Main Project, realized two (2) cost saving measures that totaled about five thousand dollars (\$5,000) (i.e. the work was below budget and ahead of schedule); and

WHEREAS, Camino Construction, Inc., being already mobilized in the Village has proposed to do the South Franklin Water Main Project at a cost of one hundred twenty thousand dollars (\$120,000); and

WHEREAS, the Village has received bids for the South Franklin Water Main Project and received a low bid of one hundred twenty four thousand dollars (\$124,000); and

WHEREAS, the Village administration has recommended that Council authorize a change order to the North Street Water Main Project to include the work of the South Franklin Water Main Project, to permit Camino Construction perform that work at a proposed cost that is lower than the lowest bid received for that project; and

WHEREAS, Article IV, Section 8(f) of the Chagrin Falls Charter gives Council the power, by ordinance, to determine the method of advertising and awarding contract and the Village; and

WHEREAS, this Council desires to award the work for the South Franklin Water Main Project to Camino Construction, Inc., at a price that is lower than the lowest bid price that the Village received for the South Franklin Water Main Project, by amending the North Street Water Main Project to include the additional work.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE
OF CHAGRIN FALLS, CUYAHOGA COUNTY, STATE OF OHIO:**

SECTION 1. That the Mayor be and is hereby authorized and directed to execute a change order regarding the North Street Water Main Project to include the work designed for the South Franklin Water Main Project and to increase the price of the North Street Water Main Project by one

hundred twenty thousand dollars (\$120,000) to cover the cost of such work.

SECTION 2. That actions of this Council concerning and relating to the passage of this legislation were adopted in lawful meetings of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in compliance with all legal requirements, including Chapter 114 of the Codified Ordinances of the Village of Chagrin Falls.

SECTION 3. That in accordance with Section 113.01 of the Codified Ordinances of the Village of Chagrin Falls, public notice of this Ordinance shall be given by posting a copy thereof for not less than fifteen (15) days in the Village Hall.

SECTION 4. That this Ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health and safety of this Village and for the further reason that this Ordinance must be immediately effective so that the Village may issue a change order for the North Street Water Main Project while the contractor is still mobilized for such work, so as to take advantage of the cost savings; wherefore, provided it receives the requisite number of affirmative votes of all members elected to Council, this Ordinance shall be in full force and effect from and immediately upon its passage by this Council and approval by the Mayor; otherwise, it shall take effect and be in force after the earliest period allowed by law.


