

**AN ORDINANCE  
AUTHORIZING THE MAYOR TO ENTER INTO AN  
AGREEMENT WITH HEMLOCK LANDSCAPES, INC., FOR  
VILLAGE STREET TREE PLANTING IN YEARS 2012 AND  
2013, AND DECLARING AN EMERGENCY.**

WHEREAS, the Village solicited proposals for Village Street Tree Planting for Years 2012 and 2013; and

WHEREAS, proposals were received on March 21, 2012; and

WHEREAS, the Chief Administrative Officer reviewed and evaluated the proposals that were received; and

WHEREAS, based upon the recommendation of the Chief Administrative Officer, the Village hereby determines that the lowest and best proposal was submitted by Hemlock Landscapes, Inc.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CHAGRIN FALLS, CUYAHOGA COUNTY, STATE OF OHIO:**

SECTION 1. That the Mayor be and is hereby authorized and directed to enter into an agreement with Hemlock Landscapes, Inc., 7209 Chagrin Road, Chagrin Falls, Ohio, for Village Street Tree Planting in Years 2012 and 2013, in accordance with the specifications on file with the Chief Administrative Officer. The agreement shall provide for a per tree cost of one hundred sixty-eight dollars (\$168.00) for Year 2012 and a per tree cost of one hundred seventy-three dollars (\$173.00) for Year 2013. The total funds expended in each year shall not exceed twelve thousand dollars (\$12,000.00).

SECTION 2. That sufficient funds are hereby appropriated to pay for the agreement authorized herein.

SECTION 3. That actions of this Council concerning and relating to the passage of this legislation were adopted in lawful meetings of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in compliance with all legal requirements, including Chapter 114 of the Codified Ordinances of the Village of Chagrin Falls.

SECTION 4. That in accordance with Section 113.01 of the Codified Ordinances of the Village of Chagrin Falls, public notice of this Ordinance shall be given by posting a copy thereof for not less than fifteen (15) days in the Village Hall.

SECTION 5. That this Ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health and safety of this Village and for the further reason that this Ordinance must be immediately effective so that the necessary Village street

tree planting may begin immediately; wherefore, provided it receives the requisite number of affirmative votes of all members elected to Council, this Ordinance shall be in full force and effect from and immediately upon its passage by this Council and approval by the Mayor; otherwise, it shall take effect and be in force after the earliest period allowed by law.


