Florida High School Mock Trial

Teams from across Florida are gearing up for our statewide high school mock trial competition to be held March 5-7, 2015 in Orlando at the Orange County Courthouse! Teams from sixteen judicial circuits will compete in four rounds of competition prior to the final round scheduled for the ceremonial courtroom. "It has been a very competitive year," remarked Erin Watson, state program director for the high school mock trial competition. Circuit competitions were held throughout the state as teams competed for the opportunity to represent their circuits in the state championship. Fletcher High School from Duval County, last year's state champions, won their circuit competition this year and will be returning to compete for the 2015 title, but they will have a lot of competition as new and returning teams line up to take the title as well. "This simulation helps students understand the role of the courts and the procedures in place for a fair and accountable process," stated Watson. The state winners will travel to North Carolina this year for the national finals. Florida placed eleventh last year in the national competition! Good luck to all teams. We the People Program Expanding in Florida

The We the People...the Citizen and the Constitution program is expanding into Florida middle schools. The program, consisting of a textbook and simulated congressional hearing, operates at the elementary, middle, and high school levels. Classroom hearings are held as well as competitive hearings at the high school and now middle school levels. This year a middle school e-book pilot was undertaken in Florida in multiple counties. Martin County teacher Kathleen Cannon was excited to participate and gain the experience for her students. "This was one of the most extraordinary experiences I have ever participated in with my students," Cannon stated. "This will change how we approach civics in our county!" MAST Academy in Miami-Dade won the state finals and will represent Florida in the national finals in Washington, D.C. in April. Marion Technical Institute won the state professionalism award and will attend the national competition as a wild card team. Justice Teaching Awards

Justice Teaching Institute

Twenty-five teachers from throughout Florida will be attending the Supreme Court of Florida Justice Teaching Institute in March to learn about the state courts using a case study method. Teachers will explore the courts and the Constitution in a four and one half day program with all seven justices serving as faculty. The Florida Law Related Education Association, Inc. assists in coordinating the program and providing instructional assistance. This year teachers will examine the structure and function of the state courts, motion to suppress hearings, Miranda warnings and the assistance of legal counsel, among other law related topics. Teachers will participate in a simulated appellate hearing serving as justices and attorneys to reenact a mock oral argument. Judge Karen Cole from the Fourth Judicial Circuit and Judge Kelly McKibben from the Eighteenth Judicial Circuit will serve as mentor judges and assist the teachers in dissecting the material throughout the week. 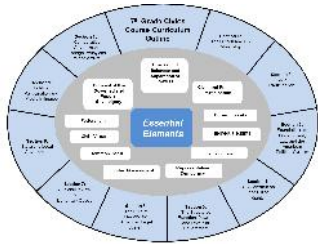
2015 American Bar Association (ABA) National LRE Conference and Summer Institute

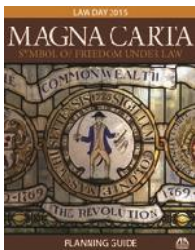
American Civic Education Teacher Awards
