Mayor Brick said I am working on documenting the village's major accomplishments in 2012 and developing major priorities for 2013. Hopefully you all got draft copies. I would really like to hear from you personally or e-mail me so that we can have particularly agreed upon priorities for 2013 so we are all on the same sheet of music.

Mayor Brick said Ben, Tim, and others have prepared a first pass at a proposed capital expenditures, principally for roads, which you should have a copy of. I would suggest that we schedule a meeting to discuss the proposed budget. The overall financial planning strategy I would suggest to develop 2013 budgets with a look at 2014 so that we can have a balanced general fund, meet our required capital needs, and complete the re-paving and reconstruction of South Franklin Street, Solon Road, and North Street in the next couple of years. Secondly I'd suggest we look at developing a 3-5 year budget estimates for a sustainable general fund and required capital needs and an acceptable road program. This would probably include steps to somehow increase revenue.

Mayor Brick said I hope you all know that we have a page on our website to encourage citizens to give us ideas on how to deal with the loss of over a million dollars a year in revenue, principally from the elimination of the State Inheritance Tax. This has been up for several weeks and we haven't gotten any suggestions. I am sure people have ideas, we've just got to make sure we get them so that we can make the best judgements we can. I would encourage you to encourage your friends and neighbors to let us know.

The reason being is that this is the area on Chagrin Road heading out of town towards Bainbridge on the right hand side. At one point in time much of that area was owned by an individual person and there was one master meter that was servicing various buildings. Since those buildings have been built there is individual ownership of some of those units and there is a desire now that each of the units has their own separate meter instead of working off of one master meter for several different buildings. As such, we need to enter into an agreement where by if we do go forward with this the village would have an easement so we can access the water meters, shut off the water if necessary, or take any other actions which relate to the village supplying water to those various buildings. It was the unanimous recommendation of the Utilities Committee that Council adopt this ordinance tonight.
