AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR TO ENTER INTO A CONTRACT WITH MEDICAL MUTUAL OF OHIO FOR HEALTH CARE INSURANCE COVERAGE FOR THE EMPLOYEES OF THE VILLAGE OF CHAGRIN FALLS, AUTHORIZING EMPLOYEE CONTRIBUTIONS FOR PREMIUMS, AND DECLARING AN EMERGENCY.

Moved by Mr. Subel, seconded by Mrs. Lutz that the requirement for reading an ordinance three times be suspended. Carried. Ayes: Evans, Herdman, Lutz, Muscenti, Patton, Subel. Nays: None. Moved by Mr. Subel, seconded by Mrs. Lutz that the ordinance be adopted. Carried. Ayes: Evans, Herdman, Lutz, Patton. Nays: Muscenti, Subel. Mr. Himes said the Mayor's recommendation, in his absence, is the Health Savings Account - Option #3 on the spread sheet. The net savings to the village is a little over \$100,000. The employees remain in the same insurance network. The employee contribution would go from about 8% of the premium to about 11% of the premium, although the employee dollar amount contribution towards the premium remains the same. The cost comparison with the plans, at least the 2011 plan, the survey that we had of valley communities put our premium cost comparable for the family plan. Mr. Herdman said we are saving \$100,000 and if someone would pose the question "could we save more?" the answer is yes but we would do so at the significant detriment to our employees. Given the timing of this and given the transition we made to a new plan I think our employees have enthusiastically embraced this change. I think it is a responsible way to do it and we may be in a position next year where we can save more money without having to do so on the backs of our employees. I think all of us take very seriously the fact that we have families that we are responsible to families of our employees and this is a way to accommodate the needs of those families and also save the village money. For me this is an easy decision because I don't think it is just a question of pure dollars and cents. We are still saving \$100,000 and we are doing it in a way that benefits our employee's families and make sure that they are taken care of. We will revisit this issue at the beginning of the year, I hope. Mr. Patton said I would agree with your comments totally Justin. Based on the fact that it is \$100,000 worth of savings even though the employees are paying the same amount of money their contribution percentage is going up from 8% to 11%. I think this is all positive and I would also agree that at this point in time, due to the timing issue, that I don't think it is fair to our employees if we did not adopt this particular ordinance. I would also agree with you from the stand point that this is something that we definitely have to take a further look into and better earlier than later to raise the various concerns that have been proposed tonight during the Committee of the Whole Council Meeting where we talked about this extensively. Mrs. Lutz said I think six months ago or nine months ago we were looking at a possible fear of a large increase in the premium. This has been talked about throughout the year and because of the timing we were able to garner a really favorable plan. Our employees get to keep pretty much the same benefits and instead of paying more the village is saving \$100,000. If we had more time could we continue to hone it and varnish it and make it better? Probably, but there is something about the timing that this only became available to us fairly recently. Instead of paying a bundle more we are paying far less and we just don't have more time to monkey around with it.
