1. The Mayor called the meeting to order at 7:05 p.m.
2. Planning Department Report 17/23 re: Zoning By-law Amendment 03/17 – Township of Guelph/Eramosa Housekeeping Amendment

3. The Mayor announced that this is a Public Meeting to hear comments from the public and agencies and to give consideration to the Zoning By-law Amendment Application 03/17.
4. The Clerk requested that all persons in attendance for the public meeting to please clearly print their full name, address and postal code on the attendance located at the entrance to Council Chambers. She noted that all names listed on the attendance sheet and the names of those who speak on this item will appear within the meeting minutes. She indicated that addresses listed on this sheet will be used to circulate future notices about this matter to attendees.

5. The Mayor called upon Mr. Mitchell Avis, MHBC Planning, Township Planner, to review the planning report.

Mr. Mitchell Avis, MHBC Planning, Township Planner, provided a PowerPoint presentation on the Zoning By-law Amendment Application. Mr. Avis provided an overview of the location of the subject lands and discussed the proposed

changes. Mr. Avis provided an overview of the agency comments and public comments. He presented the recommendation to Council.

6. The Mayor requested to hear from those in support of the amendment.

Councillor Bouwmeester inquired about the tracking of technical amendments.


