- Attend all SAM training sessions and at least one continuing education session per year for returning SAM volunteers (returning SAM volunteers attend final day of annual training)
- Pay a \$100.00 training fee (includes \$35 for "Weeds of the West")
- Complete SAM Client Contact Forms and Volunteer Timesheet and return these to the Boulder County Extension Office on a monthly basis.
- Interact cooperatively with other trainees and trainers, so as to contribute to a healthy work environment.
- Represent Boulder County and Colorado State University Extension in a professional manner.
- Return 24 hours of volunteer service to the SAM program (3 weeks of voice mailbox staffing @ 4 hrs/week **AND** 12 hrs of other SAM programming: Weed ID = 2 hrs/sample, Articles = 4 hrs/article, other events and projects on a regular hourly basis). If I do not provide 24 hours of service by March 1, 2017, I agree to reimburse Boulder County Extension at the rate of **\$10 per hour** for the hours owed (24 hrs minus hours volunteered) unless other arrangements are made in writing with the Small Acreage Coordinator.

If selected as a volunteer, I understand that I serve at the request of Boulder County and Colorado State University Extension, and that the request can be withdrawn for any reason or no reason at any time.
