Premium MicroPlus is a versatile liquified kelp extract for commercial agriculture.

DIRECTIONS FOR USE

Mixing Directions - Use a minimum of 1 U.S. gallon of water carrier per 1,000 sq. ft. (3.8 liters per 93 m²). Fill mix tank with half of required spray water and turn on agitation. Measure product into tank, add remaining water and other soluble materials. Add a defoaming agent if desired, and adjust pH of tank-mix to neutral if necessary.

Compatibility - This product is compatible with most fertilizers and other spray materials. Conduct a jar test as needed.

SUGGESTED APPLICATIONS

Can be applied as a foliar spray or to the soil. Shake or agitate before use. Apply in the early morning or late afternoon for best results. Allow foliar product to dry on plant prior to irrigation. Use spray adjuvant for superior coverage.

STORAGE AND USE PRECAUTIONS

Store in original containers at temperatures above freezing. Mix with other materials only at time of application and in exact amounts required. Do not return previously mixed product to its original container.
