

### Practical examinations:

- Journeyperson examinations in the following trades consist of written **and** practical examinations: **Electronics Assembler, Esthetician – Nail Care Technician, Esthetician – Skin Care Technician, Hairstylist, Machinist, Motor Vehicle Body Repairer (Metal and Paint), Semiautomatic Welding Production Operator and Welder Trades.**
- Candidates require a pass mark of 70% in the written examination before being eligible to apply for the practical examination.
- A final notice detailing time and place will be mailed approximately one month prior to the scheduled examination date. Only those that receive a final notice detailing time and place are eligible to attend the practical examination.
- There are a minimum and maximum number of applicants that can attend a practical examination. When we reach maximum capacity, any applicant applying after that point will be placed in the next available examination date.
- The SATCC will **not** run a practical examination if there are too few applicants. If there is low enrollment for an examination, the examination will be cancelled and all candidates will be moved to the next available examination date.
- Several trades are not listed on the schedule below. Those applicants will be placed on a wait list and once the minimum number of applications is received a date and location will be scheduled. Candidates will be notified one month in advance to allow them time to prepare.
