# **Bocaps deputized to implement** anti-obstructions order

BAGUIO CITY - Mayor Mauricio Domogan last week deputized barangay officials here to implement the anti- obstructions order along roads within their areas of jurisdiction.

In Administrative Order No. 133 series of 2016, the mayor authorized punong barangays, kagawads and tanods in the 128 barangays in the city to carry out road clearing operations in their areas of responsibility as spelled out in the mayor's earlier directive in Administrative Order No. 116 s. 2016 creating the anti-road obstructions task force to implement transportation and traffic regulations within the city.

AO 116-2016 directs the newly-created task force to "cause the removal of illegally parked vehicles, equipment, including junked items that are parked, occupying or protruding to the Cont. on page 9

# Miss Universe contestants to visit Baguio P300K reward for Korean trader's killer

BAGUIO CITY - Some the initial activities for the Miss Universe contants of the prestigious Miss Universe pageant in Manila will visit the country's undisputed Summer Capital as part of their tight schedule before their coronation night at the SM Mall of Asia late January next year.

Anthony de Leon, general manager of the Baguio Country Club and president of the Hotel and Restaurant Association of Baguio (HRAB), said the visit by the beauties selected by the Miss Universe organizers for the less than 24 hour-visit will add international exposure for the city that will help boost the local tourism industry.

"The city's private sector will shell out at least P15 million to the Miss Universe organizers aside from the expenses for the food, transportation and accommodation just to bring the contestants to the city for various activities lined up by the local organizers led by executives of the Baguio Country Club," de Leon stressed.

testants and reigning Miss Universe titlist Pia Wurtzbach include a golf tournament, tree planting and fashion show to maximize their stay in the city.

Since the time that the Duterte administration announced that the Philippines will host the Miss Universe beauty pageant next year, officials of the city's only exclusive club lobbied with the Miss Universe pageant organizers and the tourism department for Baguio's inclusion in the itinerary of the beauty contestants.

De Leon admitted they had a series of negotiations and lobbying before they convinced the pageant organizers to include Baguio in the list of places to be by the beauty pageant contes-

The BCC official said the date of their expected visit in the city is still being arranged with the international and national Miss Universe organizers to fall within the three days they will be in the country prior to their coronation night.

De Leon explained many lawmakers and local governments submitted proposals to the Miss Universe organizers even offering certain amounts just to have the beauty contestants in their place for added international exposure. Baguio is one of the luckiest to be shortlisted through the diligent negotiating and lobbying efforts of the private sector that will perk up the international exposure of Baguio as a prime tourist destination.

Donaal's letter was furnished the local government of Baguio to help monitor the blades compliance of the

hazardous waste generators to pertinent laws, rules and regulations relative to the proper disposal of their hazardous waste coming from their respective establishments as part of the combined efforts of both the national and local governments to protect the people from being exposed to hazardous waste.

He warned hazardous waste generators that once they are issued the appropriate notices of violation and the agency does not find merit to their explanations to the said notices, their personnel will be invited to a technical conference with the agency's technical people for them to justify their actions.

He explained once the agency personnel will not be satisfied with the justifications of the violations committed by the erring hazardous waste generators, the agency will imposethe appropriate fines against the owners of the establishments with a stern warning that repeated violations relative to the disposal of their hazardous waste will be meted stiffer penalties./ By Dexter See

# City cops another seal of good local governance

copped the 2016 Seal of Good Local Governance (SGLG), an incentives program of the Dept. of Interior and Local Government (DILG), for turning in good performance in various areas of governance.

This is the city's third Assessment Areas for the

BAGUIO CITY - The SGLG in as many years city government since the program was launched in 2014 as a scaled up version of the Seal of Good Housekeep-

year 2016" particularly in financial administration, disaster preparedness, social protection, business friendliness and competitiveness and environmental management."

The city fell short in the aspect of peace and order which it passed in 2014 and 2015.

Mayor Mauricio Domogan received the award from DILG Secretary Ismael Sueno during the SGLG and LTIA awarding ceremonies held last Oct. 27 in Pasay City. DILG city director Evelyn Trinidad accompanied the mayor during the awarding rites.

The city was among the 306 qualifiers out of a total of 1,672 local government units in the

country of which 81 are provinces, 145 are cities and 1,446 are municipalities.

The mayor expressed pride that many LGUs in the Cordillera region also received the award including Benguet, Mt. Province and Kalinga provinces and six towns in Abra (Bucay, Dolores, La Paz, Penarrubia, San Juan and Tayum) and

three municipalities each in Apayao (Buclod, Sta. Marcela and Luna) and Benguet (La Trinidad, Itogon and Kapangan) and Paracelis in Mt. Province and Balbalan in Kalinga. Tabuk City also shared the award in the city category.

The SGLG is an upgraded SGH incentive which aimed to promote

## BLISTT air quality still good to fair

 ${f B}$  AGUIO CITY – The Cordillera office of the Environmental Management Bureau (EMB-CAR) revealed the air quality in the Baguio-La Trinidad-Itogon-Sablan-Tuba-Tublay (BLISTT) area remains good to fair during the third quarter of this year amidst the increasing volume of vehicles and rapid urbanization in the said places.

In a report submitted to Mayor Mauricio G. Domogan, EMB-CAR OIC Chief for Clearance and Permitting Division Engr. Nestor M. Donaal said there were 10 particulate matter (PM) monitoring stations that were monitored during the third quarter using the manual sampling method at the established stations within BLISTT airshed.

He pointed out all results obtained from the BLISTT sampling stations were within the national ambient air quality guidelines value which is 150 micrograms per cubic meter for suspended particulate matter.

Results from 8 sampling stations were within the good air quality index range which is from 0-54 micrograms per cubic meter while results from 2 the sampling stations at Lower Session Road Plaza Garden in Baguio City and Km. 6 in La Trinidad, Benguet were within the fair air quality index range which is from 55-154micrograms per cubic meter.

The EMB-CAR official underscored weather conditions during the reckoning period were generally rainy or there was intermittent rain shower, fair and cloudy during the 24-hour sampling periods in the said areas.

Donaal claimed 9 sampling stations showed a decrease of suspended PM levels as compared to the last results obtained from similar stations during the second quarter of this year.

On the other hand, he noted that the sampling station at the ground of the Itogon, Benguet municipal hall showed a 79 percent increase in suspended PM level as compared with the obtained results from the second quarter of this year. However, the results are still within the national ambient air quality value of 150 micrograms per cubic meter suspended PM levels which are described as good level as compared to the second quarter of this year which is 23 micrograms per cubic meter within **Cont. on page 8**

# Anti-Marcos groups urge SC: 'Side with the truth'

'If Marcos, a dictator and plunderer, gets buried at the Heroes' Cemetery, what shall we call the real heroes who fought against the dictatorship?' says UP historian Alvin Campomanes at a rally in front of the High Court

m ANILA}$  – Groups opposed to a hero's burial for former president Ferdinand Marcos urged the Supreme Court (SC) on Friday, November 4, to "side with the truth" when it rules on the case in a few days.

Martial Law victims and their families, activists, a youth civic group, and some educators braved the rains in front of the SC as they called on the High Court "for the last time" to vote against the interment of the strongman at the Libingan ng mga Bavani.

The High Court is expected to release a decision by Tuesday, November 8, when the status quo ante order (SQAO) it had issued on a hero's burial for Marcos lapses. Susan Quimpo of Bantayog ng mga Bayani Foundation, the sister of two Martial Law victims, said the Court should "side with the truth" when it decides on the

petitions lodged against the burial.

Quimpo, also a member of the coalition of the burial protesters, said her group remained hopeful that the SC would rule in favor of the petitioners. They have yet to consider the possibility of filing a motion for reconsideration despite reports that

it would be a close vote. "We are not talking about it yet. And I don't think there is a set discussion to do

that. We are still hopeful to get the 8 votes by

Petitioners need 8 votes to win the case. A tie would favor the respondents - the Marcos family and the Duterte administration which is implementing the state interment.

On October 18, the SC extended for the second time the SQAO it first issued in August, extending it to November 8.

#### Historical revisionism

Historian Alvin Campomanes of the University of the Philippines stressed how a hero's interment for Marcos would contradict history.

"If Marcos, a dictator and plunderer, gets buried at the Heroes' Cemetery, what shall we call the real heroes who fought against the dictatorship? What will we call the long fight [against the authoritarian regime]? What shall we call the EDSA People Power Revolution and the many young people who offered their intelligence and lives to fight against the dictatorship?" he told his fellow protesters in Filipino.

Campomanes also urged the youth, who did not experience Martial Law, to continue fighting against historical revisionism.

"Just because you weren't born during Marcos' time, you can already keep quiet because you did not directly experience it," he said". As a history professor born in 1987, I am a proof that young people should not be ignorant of the past," Campomanes added.

Millennial Carlo Abadines echoed Campomanes' call, stressing that giving Marcos a hero's burial would hinder efforts to educate the youth on the Martial Law years.

You can just imagine – every year, the Marcoses would have a celebration of the achievements [during Martial Law] at the Libingan ng mga Bayani. The real events of the Martial Law will be covered up," he said.

"To bury him there is a very powerful symbolic act that what happened [during the Martial Law] is just alright?

Petitioners against the hero's burial argued that Marcos is no hero due to state-sanctioned atrocities and the human rights violations committed by government forces under his term. They also cited the fact that human rights victims of the Marcos regime had been awarded compensation by a US court as well as Philippine law.

The National Historical Commission of the Philippines had also opposed the move, citing Marcos' fraudulent war

WHAT IS THE "GREAT TRIBULA-TION"? Do you know what the "great tribulation" is all about? In Matthew 24:15-28 of the Bible, the "great tribulation" is a time of great suffering foretold to occur everywhere in the world, never before seen and never to happen again, where many will die, and only God's chosen people, or those who remained firm in their faith in Him, will live.

Here is an account of the "great tribulation", made by Jesus, our God and Savior, in Matthew 24:15-22: "So when you see standing in the holy place 'the abomination that causes desolation, spoken of through the prophet Daniel---let the reader understand---then let those who are in Judea flee to the mountains...

"For then there will be great distress, unequaled from the beginning of the world until now---and never to be equaled again. If those days had not been cut short, no one would survive, but for the sake of the elect those days will be shortened."

ARE YOU PREPARED FOR THE 'GREAT TRIBULATION'? What kind of great suffering could this be? Could this be the "fire" spoken of in Malachi 4:1-2 and in 2 Peter 3:10 which will engulf the whole world, burning everything in its path, making the sinners and evildoers stubble, leaving not even branch or root among them?

If this happens---and it is surely going to happen because Jesus, as God, is a God of truth---are we prepared for it? Inevitably, if an individual believes in God and in His Word, the Bible, he or she must believe that this day is truly coming, that one day it is going to happen.



WHAT TO DO TO AVOID THE "GREAT TRIBULATION": On the other hand, here is what 2 Peter 3:10 is saying: "But the day of the Lord will come like a thief. The heavens will disappear with a roar; the elements will be destroyed by fire, and the earth and everything done in it will be laid bare... That day will bring about the destruction of the heavens by fire, and the elements will melt in the heat..."

What kind of preparation must be undertaken then if one desires to escape the wrath of the "great tribulation"? In 2 Peter 3:11, it is there written: "... Since everything will be destroyed in this way, what kind of people ought you to be? You ought to live holy and godly lives..."

In Malachi 4, we are told that those who revere God's Name will be saved. Thus: "... 'But for you who revere my name, the sun of righteousness will rise with healing in its rays. And you will go out and frolic like Cont. on page 9

Donaal pointed out construction activities were noted as significant sources of particulates on the established sampling stations which were previously put in place to monitor the air quality in the BLISTT airshed pursuant to the provisions of the Philippine Clean Air Act.

The report noted on-going excavation activities within the Itogon municipal hall compound contributed to the air quality conditions during the time of sampling but fair weather conditions, especially intermittent rains helped wash down suspended particulates in the atmosphere, thus, effective control measures to lessen dust suspension should be always be implemented by the construction firms.

Donaal claimed the continuous ambient air quality monitoring station installed along Plaza Garden in Lower Session Road could not be repaired since its spare parts are outdated and hard to find. It was recommended to be removed and replaced, and the restoration of the PM station installed at Burnham Lake is highly recommended./By Dexter A. See


