The examining attorney acknowledges receipt of applicant's communication filed January 31, 2001. The applicant's descriptive of the mark is acceptable and has been entered into the record. However, the proposed amendment to the identification of goods is unacceptable because it still refers to goods in additional classes. Thus, the requirement for an acceptable amendment to the identification and classification of goods is continued and made **FINAL**.

### Identification and Classification of Goods

The terms “mufflers for motor cars” in the identification are unacceptable because, as engine parts, they are properly classified in Class 7. Please see the attached printout from the Identification and Classification Manual. The applicant must amend the identification to either delete these goods or add an additional class. TMEP section 804.

Furthermore, the terms “lugs and lug nuts” in the identification are unacceptable as indefinite and because they may refer to goods in an additional class. TMEP section 804. The applicant must amend the identification to specify the material composition of the goods. If the goods are metal, they are properly classified in Class 6; if non-metal, they must be moved to Class 20.


Please note that, while an application may be amended to clarify or limit the identification, additions to the identification are not permitted. 37 C.F.R. Section 2.71(a); TMEP section 804.09. 

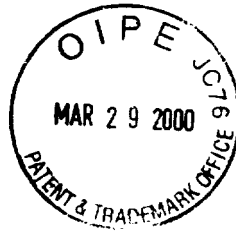
