BAGUIO CITY AND BENGUET

More than four hectares of marijuana plantation were wiped out recently in a three-day eradication operation in the hinterlands of Benguet province.

**Plantation** 

The 51 marijuana cultivation sites, having an aggregate land area of 40,735 square meters, were located in two barangays of Kibungan, Benguet; and in one barangay each in Bakun and Kapangan towns of Benguet. 76.14 percent of these marijuana plantations were found in Kibungan, 21.23 percent in Bakun, while the remaining 2.63 percent were situated in Kapangan.

Uprooted or seized during the marijuana eradication operation last December 12 to 15 were 203,650 full-grown marijuana plants; 106 kilos of dried marijuana stalk; 21,500 marijuana seedlings; 17 kilos of dried marijuana leaf; and five kilos of marijuana seed, which have an overall estimated market value of PhP55,390,000.00.

Additionally, two marijuana cultivators were caught in the act harvesting marijuana at their plantation in Sitio Payakpak, Badeo, Kibungan, Benguet. Cont. on page 8

# 2 Coding Suspended Anew

BAGUIO CITY - Mayor Mauricio Domogan this week suspended the implementation of the number coding scheme in this mountain resort.

Administrative order No. 233 series of 2013 specifically states the suspension is for private vehicles only from December 23, 2013 up to January 10, 2014.

Domogan said, 'the suspension of the number coding is intended for local residents and tourists and their families the convenience and stress-free journey in visiting different tourists spots around the city."

The AO also states chartered public utility vehicles of visitors, tourists, vacationers or participants of sanctioned activities such as conventions, conferences and assemblies are also exempt provided they show proof that they are participants in such activities./paul rillorta

## Mayor Signs Accord with Dost for Road Train System

BAGUIO CITY – this mountain resort will soon be a recipient to the first locally developed train system in the country.

This after the city government here represented by Mayor Domogan and the Department of Science and Technology (DOST) thru the Metals Industry Research and Development Center (MIRDC) represented by MIRDC OIC and DOST Assistant Secretary Robert Dizon signed this week a Memorandum of Understanding (MOU) to study the possibility of commissioning an Automated Guideway Transit (AGT) System.

Accordingly, the MIRDC-DOST will study the viability of deploying the AGT system in Baguio City most especially in the Central Business District (CBD) area to help in traffic

decongestion.

A technical team will be formed by the city to identify the possible routes of the AGT. The MOU was signed December 16 in the presence of DOST Secretary Mario Montejo, City Engineer Leo Bernandez, Jr., DOST-CAR Regional Director Julius Caesar Sicat and OIC-City Planning and Development Officer Evelyn Cayat.

The AGT or 'Road Train' according to Sec. Montejo is being developed by the center and is now undergoing functional tests at the University of the Philippines-Diliman.

"The road train will be an effective means of mass transport that will surely help ease traffic congestion and reduce air pollution," he said.

The mayor is positive of the technology which he said will be a big help in addressing traffic woes. "We welcome this new innovation which is a greener mode of transport, this will contribute in our efforts of protecting the environment by eliminating pollution," Domogan said.

The AGT is considered the first Filipino rapid mass transport system developed by the DOST powered by electricity which runs on an elevated platform at top speeds of 60 kph.

The target area for the road train will include the Baguio-Trinidad route along the Balili river and the entire CBD. **Cont. on page 8**

weekly Ugnayan Presser Wednesday (December 18) shared his administrations thrusts for 2014 here.

The mayor said priority projects for next year include upgrading of the Sanitary Treatment Plant (STP) for the city's liquid waste and the Solid Waste Disposal System.

Domogan said, "the site for the Engineered Sanitary Landfill (ESL) is near the city which can save on fuel expenses on hauling and can also service adjoining nearby municipalities."

The planned Engineered Sanitary Landfill (ESL) will consolidate the Environmental Recycling System (ERS) which the city purchased from Japan and bio-digesters being offered by Ireland.

"I am very optimistic that by next year, the project will be realized," he said.

The city will also push through with infrastructure projects not realized during the current year.

Meantime, Domogan also wished everyone good health for the coming year.

Domogan said he is also praying that no natural disaster will occur and seeks continued cooperation to the programs and projects of the city government.

"I pray that the spirit of love, forgiveness, sharing and humility be in your hearts this yuletide season, and I wish you all a Merry Christmas and a prosperous New Year and may God continue to shower us with his blessings," he said./paul rillorta

## **Outstanding Cooperatives**

**Feted** BAGUIO CITY – the city government here cited the most outstanding cooperatives from among the different thriving cooperatives of the city in simple rites at Abada Hall, Teachers Camp last December 17.

The Special Services Division of the Mayor's Office awarded for the first time, the Baguio Benguet Community Credit Cooperative (BBCCC) as top performer for this year's search for the The Baguio Vegetable Retailers Savings and Credit Cooperative (BAVESCO) placed in second while SLU-SVP Housing Cooperative placed in third.

Also awarded for the Medium Scale Category are 1st placerBaguio Market Vendors Multipurpose Cooperative (BAMARVEMPCO) and BAMAPCOM Entrepreneurs Multipurpose Cooperative (BEMC) as second place.

For the Small Scale Category, the Timber and Lime Multipurpose Cooperative emerged sole winner. Cash rewards were given to each of the winners ranging from P8,000.00 for first place, P7,000.00 for second place and P5,000.00 for thirst place.

The participating cooperatives were judged according to sound leadership, management and organization, financial management and business operation, social relevance and previous awards and recognitions received.

They should also be duly registered with the Cooperative Development Authority (CDA), must be in good standing for the past three years and must have a networth of below 10 million for Micro Scale Category, 10 million to 50 million for Small Scale Category, 50 million to 100 million for Medium Scale Category and 100 million and above for Large Scale Category.

They should also be existing for at least 5 years for large and medium cooperatives, 3 years for micro and small cooperatives and operational for at least 3 years and two years respectively and must be compliant with legal and administrative requirements of CDA and other government agencies.

Meantime, the City of Baguio has been cited by the Central Bank of the Philippines for its support and contribution in the realization of the Credit Surety Fund Program of the city which is also an offshoot of cooperativism in the city. /paul rillorta

## **Unified Stand on 'Paputok'** BAGUIO CITY - City officials

Sought

on Monday agreed to adopt a unified stand on firecracker sale and use in the city amid warring views on whether or not to allow the sale of regulated pyrotechnic

devices this year. "Let's discuss and come up with uniform stand to once and for all settle the issue," Mayor Mauricio Domogan told department heads and members of the city council on Mon-

day. He raised the possibility of issuing an executive order imposing guidelines even as he urged the city council to adopt an ordinance to totally ban the sale and use of the firecrackers in the city.

Considering the views presented by some city councilors, the mayor said the city may exempt fireworks displays being conducted for official activities of the city since these are regulated or done safety nets.

"I hope we can come up with clear guidelines the soonest possible time and I hope the city council will eventually pass an ordinance to ban the sale and including the use of these firecrackers or if they prefer, regulate the use by making it centralized," the mayor said.

The mayor also last Monday asked the members of the city council to support his stand and not consider the appeal of the Baguio-PAILAW group represented Cont. on page 8

## Mayor Defends Budget Allocation for Solid

BAGUIO CITY - Mayor Mauricio Waste Domogan on Monday said solid waste management programs were given the bulk of the development fund in the city's proposed 2014 budget because of these projects merit prioritization to enable the city to advance in its bid for a permanent solution to its waste

"We gave our solid waste program priority because it is the immediate need of our city. It is high time to finish the programs for a permanent solution to our solid waste problem in the coming year so we can stop hauling and save on costs," the mayor said.

Solid waste management programs comprise 73.58 percent of the 20 percent development fund amounting to P107,914,000 allocated for this year's Annual Investment Plan (AIP). The development fund represents 7.73 percent of the city's proposed budget amounting to P1,395,822,000.

The programs listed as major development projects under the AIP are the purchase and development of an Integrated Solid Waste Disposal site amounting to P40 million, construction of two materials recovery facility buildings costing P10 million and the post-closure rehabilitation of Irisan dumpsite (first phase) with a total cost of P8,804,000.

During the budget deliberation last Monday, Councilor Faustino Olowan questioned the allocation of a big amount for the ISWD site and suggested that the city start with just the purchase of the lot so the city can allocate more fund for its other projects.

But general services officer Romeo Concio said it will be useless if the city will not develop and utilize the lot for its intended purpose of developing an engineered sanitary landfill which would enable the city to stop hauling its wastes.

The city at present is working on the acquisition of a 22-hectare lot in one of its neighboring towns in Benguet as site of its ISWD system.

Domogan said several assessments and studies have to be undertaken to qualify the site for the city's ISWMS including a geological assessment by the Mines and Geo-Sciences Bureau of the Dept. of Environment and Natural Resources Cordillera (MGB-DENR-CAR) DENR and the National Solid Waste Management Council (NSWMC) to determine its safety and suitability for the purpose.

The mayor said they have a valid reason for not disclosing the exact location of the place so as not to preempt the outcome of the negotiations./A Refuerzo

## city to Implement SPMS

BAGUIO CITY - The city government here will start its implementation of the Strategic Performance Management System (SPMS) this coming year 2014. This is part of the additional requirement of the Civil Service Commission (CSC) for the city government to hold the Level II Accreditation to take final action on its appointments.

The SPMS of the city of Baguio as contained in CSC Memorandum Circular No. 06, series of 2012 (Guidelines in the establishment and implementation of agency SPMS has been approved by the CSC last November 25 for the agency's initial implementation.

It is remembered that last May of this year, the city government passed the revalidation of Level II Accreditation to take final action on its appointments. This is pursuant to the Civil Service Commission Reso-

## **Electronic Business Permit Processing** System Ready

BAGUIO CITY - The city government will implement the electronic Business Process and Licensing System (e-BPLS) in the processing of both new and old permit applications beginning January 2.

City treasurer Alicia Onoza and acting assistant treasurer Alex Cobarrubias said the system will be employed even if they still await additional equipment to hasten the processing time and reduce the problem of fixing in the licensing system.

Onoza said that under the e-BPLS, applicants for renewal of permits will submit their names to city employees in charge who will check the applicant's records in the computer database for clearances on real property and garbage.

Once cleared, an automatic assessment of the tax dues will be done and the applicant can pay the tax obligations outright.

After the payment, the applicants will be required to submit clearances from the barangay and health office and these will be submitted to the permits and licensing division. Upon satisfaction of all the requirements, the PLD will then print the permit form for signing by the city mayor.

For new applications, the applicants will go straight to the PLD and will be required to submit clearances from the city planning and development office, the city health office, the city building and architecture office and the Baguio Fire Department before their permits can be processed.

The dry run for the system was conducted last Nov. 6 and it proved successful, according to Cobarrubias.

Meanwhile, Mayor Mauricio Domogan issued Administrative Order No. 222 enforcing simpler method of processing for the renewal of Cont. on page 7 permits.

## Wasteland operators

Inquirer's headline summed up the festering issue: "Some journalists had it coming, the probers say." They were referring to the recent killings that victimized three Mindanao-no, not journalists—"block-timers.

"(He) berated targets like they were the worst animals on earth, cocked his gun on the air, challenging (them) to a gunfight." Who did? The probers wouldn't say. But that style fits Joas Dignos, ambushed in Valencia, Bukidnon.

The other two are Michael Milo in Tandag, Surigao del Sur, and Rogelio Butalid in Tagum, Davao del Norte. A faction of the squabbling Davao del Norte Electric Cooperative paid the tab for Butalid's radio program. He slammed their opponents within the same co-op.

The victims "had donors that were rivals of those they attacked," the probers noted. Isn't that prohibited by the Journalist's Code of Ethics?

Of course, said Msgr. Elmer Abacahin who heads Cagayan de Oro's media group. He confirmed the investigators' findings, but added: This was "not sufficient reason to kill the victims."

The dictionary included the word "journalist" in 1693. The word was then defined thus: "a writer or editor for a news medium... who aims at a mass audience." Since then, radio and TV came on stream and the Internet burst into the scene in the mid-1980s. The advent of the new and social media resulted in an explosion of so-called citizen journalists.

Radio/TV stations in Europe and the United States don't have block-timers. Neither do radio/TV stations in other Asean countries. Here, "walk-in customers" can plunk cash for airtime on the over 952 radio stations, which the National Telecommunications Commission oversees-with a shaky hand. That excludes "pirate stations" like the one in South Triangle, Quezon City.

With no questions asked, many block-timers broadcast-what? News and comment, they claim. Character assassination or praise, for a price, critics counter. They "give us the

community," Oscar Wilde wrote.

Print media indicate what is "paid ad." This is published distinct from editorial matter. Block-timers don't own up who pays the tab for their programs. But those praised-or shellacked—give a fair idea of who pays. Stations wash their hands, muttering: "The program does not reflect the management's view."

"Pinabili lang ng suka sa kanto, pagbalik, journalist na (Told to buy vinegar at the corner store, he trotted back a journalist)!" That putdown reflects a key concern of "Crimes and Unpunishment: The Killing of Filipino Journalists." Unesco and the Asian Institute of Journalism launched the book last December.

There were 408 "journalists" covering the Bureau of Customs during the Arroyo administration. That equaled 408 provincial newspapers (32 are dailies). The mob was about seven times the number of foreign and local reporters accredited by Malacañang.

"Most people claiming to represent media are anything but," columnist Boo Chanco snapped. "Many are from tabloids that have no circulation and moonlight as 'fixers.' Past officials tolerated the outsized numbers because they hid dirt." Publishers of major papers and network managers should help sift out those shams.

Today, the Customs press corps is less 97. And Finance Undersecretary John "Sunny" Sevilla, named by President Aquino as officer in charge of that agency, can tighten this loophole further.

"At the new Customs port in Sasa, Davao, 'Friday boys' are known as warik-warik. They list media men for funding," Jun Ledesma of Sun.Star Davao wrote. "I was also told some can even facilitate the release of shipments.

Most "block-timers" operate in a moral wasteland, where facts are few and comments bear a price tag, Viewpoint noted in 2009. "Where the carcass is, there the vultures gather." Electronic gunslinging is abuse. "Power without responsibility has been the prerogative of the harlot through the ages," Irish statesman Stanley Baldwin wrote.

"Block-timing is a primary fund-generator for provincial radio stations," Melinda de Jesus of Center for Media Freedom and Responsibility (CMFR) noted earlier. This proved to be the emerging problem for the Kapisanan ng mga Brodkaster ng Pilipinas (KBP). Programs with little accountability proliferate in a country that works by the revised "Golden Rule": "He who has the gold rules."

A CMFR study found lack of training and, even more significant, ethical sense. A quarter finished high school while 13 percent "had no record of educational attainment." There's little, by way of training on objectivity, balance, fairness—and avoidance of conflict of interest, as journalism's code of ethics provide.

The KBP found fault with the no-holds-barred coverage in the Luneta hostage crisis. Eight Hong Kong tourists died. And the Philippines today still has to cope with the diplomatic spillover, as China presses for reparations. Fines were imposed on major networks.

Still, this was a 180-degree turn for the KBP from the Chavez vs National Telecommunications Commission case of February 2008. In that en banc decision, the Supreme Court, lashed the KBP for playing footsie with the Arroyo regime's gags on the "Hello Garci" tapes.

KBP's Radio Code now prohibits open-ended contracts for block-timers. Identifying sponsors of block-time programs will increase transparency. But the implementation of existing measures—from certification that the "block-timer" adheres to the KBP's code to monthly reports-has been spotty.

Indeed "our membership lists remain porous," observed a Cebu Press Freedom Week editorial. "We've still to flush out the hao-shiaos who flaunt press cards or blocktime microphones."/Juan L. Mercado/E-mail: juan\_mercado77@yahoo.com

SEN. PING LACSON FOR PRESIDENT, IF...

Sen. Ping Lacson is putting his neck on the chopping block by accepting the task of being "Yolanda" rehab czar.If you ask me, the work is herculean in that by the end of the Aquino administration the rehab efforts will not be completed by then. RPIN CRISIS: WE ARE ALL AT FAULT: Lest the critics of President Aquino and his government once again will gang up on him and say it is because of his ineptness and inexperience that are the cause of the breakdown of law and order in the Philippines, where assassinations are becoming a daily occurrence, corruption continuing to be a scourge, and poverty, immorality, and evil behavior among our people is getting more and more serious by the minute, I say hold your fire.

**ANTIDOTES FOR** FIXERS AND FIX-**ING ACTIVITIES**

Sometime before 2007, one DOTC-CAR regional director confessed to me that he could not possibly stop fixing activities in his agency because there is no law that punishes the fixers and fixing activities. What he did not say, however, is that fixing activities has always been prohibited by government policy in all its offices and agencies. Nevertheless, if he were still a director today, he won't be invoking the same excuse because there is now such a law- Republic Act No. 9485 entitled: The Anti Red Tape Act of 2007.

In the same vein, the present Regional Director, Ms. Celina Claver, certainly can not offer the same excuse for, there is now such law and under said law, the criminal liability for fixers is penalty of imprisonment not exceeding six (6) years or a fine not less than P20,000.00 but not more than P200,000.00, or both fine and imprisonment. On the other hand, personnel in collusion with fixers is now punishable by dismissal and perpetual disqualification from public office.

Ironically, it appears that under a Memorandum issued on 4 September 2013 by Director Claver to all DOTC-CAR personnel entitled: FIXERS ERADICATION CAMPAIGN, supposedly issued to complement R.A. 9485, she is actually legalizing fixing activities and legitimizing transactions made by fixers-- by merely requiring presentation of special power of attorney (SPA) from any person representing or transacting in behalf of the actual owners of motor vehicles and applicants. Since SPA can be secured easily from a hospitable notary public for a fee of P50.00, the Memorandum, instead of eradicating the fixers, is causing them to multiply.

If DOTC-CAR is truly serious in its campaign to eradicate the fixers, I would say that it should try to discover more antidotes to control if not entirely eradicate fixing activities which has become a culture in the LTO and the LTFRB. She could try the following:

a) adoption and resolute implementation of the policy that all persons, whether or not authorized by SPA, should not be allowed to transact business in her offices with unrestricted regularity (like more than once a day or several times a week), otherwise, the persons transacting in behalf of the principal would already be engaged in fixing;

b) for the regional director to adopt a methodical monitoring and rotation of personnel to forestall excessive familiarity which graduates to collusions with fixers (fixing activities will not exist even for a day without complicity between personnel and fixers).

If Director Claver can eliminate fixing activities in her turf, a gargantuan job indeed, she could still be the best regional director DOTC-CAR will ever have.

rice Shoshin paid a miller in Cogon, Panitan town, some 40 kilometers away. Youth volunteers waiting in Dumalag repacked 200 of the sacks which Beneco dispatched the following morning to over 300 recipients in barangay Concepcion, a community in the foothills of the town.

"Tamang-tama ang misyon n'yo dahil ngayon ang pyesta ng barangay (Your mission is timely as today is the fiesta of this barangay)," Fr. Olano said before the team climbed up the Imaculada Concepcion chapel which stood on a hilltop.

The villagers heard mass, each now and then murmuring personal intentions and gratitude for having survived the howler that turned the barangay covered court below into a mass of twisted steel.

Limwel Limjuco, area manager of Capelco, said there were about 60 typhoon fatalities in the whole of Capiz province (composed of Roxas City and 16 towns), comparatively low in relation to other areas as evacuation was forcefully done.

Along the highway from the Roxas Airport (which departure area roof was blown off) to Dumalag, were still-to-be-cleared signs of the nightmare: crumpled huts of the poor, mangled steel trusses stripped of roof sheets, thousands upon thousands of tropical trees and coconuts left where they had fallen or sawn for rebuilding, or standing naked, their leaves, branches or their upper halves blown off.

After mass and before the relief distribution, the community drew joy and hope as Fr. Niel christened their three newest members: three-month old John Eman Berino, onemonth old Remy Remaze Queen and two-month old Alyza Faeldin.

Aside from rice, Shoshin provided each relief beneficiary P500 cash support. Fr. Olano, who was accompanied by the church's lay leaders, explained that the recipients were those not served during the first and second distribution of relief goods coursed through the parish.

Back in the parish, the team, guided by a crew from Capelco, and town councilor Ruby Ann Bello set out and delivered the remaining rice sacks to Tapaz, 25 for St. Andre Mission in barangay Taft under Fr. Romel Talabucon, and San Nicolas de Myra Parish under Fr. Wilson Navarrosa.

News of the relief mission soon reached Suhot in barangay Dolores where Fr. Olano had the visiting Baguio team billeted, in a spring resort developed by the municipal government.

"May 45 na pamila ya rin dito at lahat sila ay biktima nga bagyo," social worker Edralin Gico told the team upon its arrival for the night last Monday.

"Magkita tayo pag-gising namin bukas ( Let's see each other when we wake up tomorrow," Julian advised.

As there was no time to purchase more rice for the community, Julian whipped out P1,000 for each household.

The evening before, he met the Beneco crew who were leaving before dawn Tuesday. They had a month-long work repairing the lines in Roxas city, barangay Baybay Culasi, and the towns of Dau, Dumalag and Tapaz.

"Here's a token of our admiration for what you have done for Capiz," he said as he handed out a grand to each.

In an annual homecoming, Chees arrived here at the end of November to help defray the hospital expenses of financially strapped hospital patients here and in his native Bontoc, Mt. Province.

While he was here, his students, friends and supporters in southern Germany were pooling 15,650 euros (P908,158 for victims of Typhoon Yolanda (Haiyan) aside from raising an earlier fund of 5,352 euros (P310,416) for Shoshin's support to patients here.

Any amount remaining from the two funds will be left here for other patients who not sustain their treatments, he said./ Ramon Dacawi.

As per the order, only sanitary permit, barangay clearance, clearance from the treasurer's office and certification of payment of taxes will again be required for the issuance of the renewed permit.

The remaining requirements like the clearances from the Bureau of Internal Revenue (BIR), Social Security System (SSS), Philhealth and the Bureau of Fire Protection (BFP) can be secured after the issuance of the permit.

The said clearances will have to be obtained to complete the validity of the business permits. Those who will not complete the requirements will face closure, the mayor said.

The mayor said many taxpayers have requested "to accelerate the pace of processing business permits by allowing them to secure the required clearances from other government agencies after the issuance of the business permit."

The mayor also reiterated his order prohibiting city employees from facilitating the processing of both old and new business permits.

The mayor said observations in the past show that taxpayers engage the services of several city government employees in the processing or renewal of business permits and these workers spend hours if not days working out these permits thereby affecting their performance in their own offices

"Further, the acquaintance and familiarity as well as influence of these city employees with offices concerned create undue advantage over those taxpayers who do not have connections (so) in order to avoid favoritism and ensure fairness in the application for new or the renewal of business permits, this practice of employees has to be corrected," the mayor said.

Employees who will violate the order will be meted a reprimand, suspension and dismissal./A Refuerzo

Consequently, the juvenile was turned over to the Social Welfare & Development Officer of Kibungan, Benguet; whereas, a criminal case for Violation of Section 16 (Cultivation of Dangerous Drugs) of Republic Act 9165 (Comprehensive Dangerous Drugs Act of 2002) was already filed yesterday, December 18, 2013, against the uncle cohort, before the Office of the Provincial Prosecutor of Benguet, under NPS Docket Number I-05-INV-13L-1828.

The fugitive, whom the nephew earlier named as "Lucas Tacnang", was later, truly identified as Denver Agpad, a resident of Sitio Pul-ag, Badeo, Kibungan, Benguet.

The anti-narcotic operating units were composed of six teams from the Police Regional Office (PRO) – Cordillera (COR), Philippine Drug Enforcement Agency (PDEA) – Cordillera Administrative Region (CAR), and Criminal Investigation and Detection Group – CAR. It was a realization of Operation Plan (OPLAN) "Daydreamer 2" of the Benguet Police Provincial Office (PPO) Provincial Public Safety Company headed by Police Superintendent Lambert Suerte.

This will need creative handling because, one, the MILF will never give up their firearms at the signing of the agreement and two, the general public is now wary about allowing rebels to keep their firearms with a final agreement sealed, taking a cue from what is happening with MNLF and other violent incidents due to the presence of heavy weaponry in the hands of non-government forces.

I didn't realize disagreeing with or criticising some Zamboanguenos would result to one being barred from entering Zamboanga City territory. Good that the other city councilors thought it was a rash judgment call and wanted to hear me expound some more on my written thoughts. I committed to appear before the august body in January after the holidays.

I was glad this happened because it's about time that some wakeup call be made on some Zamboanguenos. No one is talking about the distrust and the hatred arising amongst groups due to the 3-week Zamboanga siege. The terrorism inflicted by MNLF's Ustadz Malik had polarized the locals. There is now seething anger and distrust against Muslims, specifically Tausugs, even if many of the unfortunate innocent victims were Muslims themselves. When I was there recently, even the earnest plan of the city in not allowing the return of Muslims to where their houses were burned was being viewed as discriminatory against the tribes. I talked with ordinary folks in the streets, mostly christians and they were angry and distrustful at Muslims. They knew only Christians were taken and held as hostages by Malik during the siege while Muslims were freed and allowed to go. Let's face it. We must rebuild these broken relationships amongst groups because Zamboanga is the focal center of diverse peoples coming from the neighboring island provinces of Sulu, Basilan and Tawitawi. Unless we heal those "social wounds", incidents such as this one could recur

What the good lady councilor did may be reflective of that gap that we must all help to bridge. I had funny thoughts. To her Zamboanga City is good only for those who agree with her. To her those who do not share her views ought to be forever barred from entering Zamboanga City. She wanted to keep Zamboanga an exclusive enclave . She'd rather that those who "do not belong" to keep off Zamboanga. I do not blame her for being traumatized by the MNLF incident, just like many Zamboanguenos I have talked to. But as I said, her formula would not work. It is a prescription for more trouble. Because just like the Muslims and Tausugs, I would keep coming back to Zamboanga Hermosa, whether I am wanted there or not. It's better to rebuild broken relationships and restore trust for sustainable peace. I learned this in my long work in other conflict-affected areas in Mindanao.

"Let's start to implement a total ban on the sale for if not now, when are we going to start. The ball is in our hands as even if it is Camp Crame that is issuing the guidelines, it is us, the local government units that are issuing permit," the mayor said.

On Wednesday, the mayor assured there will be no change of heart on the issue despite some councilors' intercession for the vendors.

"I made a commitment that last year would be the last time that we will allow them. I have indicated that intention since 2010 and the vendors very well know it. We will never forget that. We've been fair to them and this time we will stand by our position because we will not move forward if we will keep on changing our mind. For if we will not do it now, when do we start honoring our words, when do we start changing our way of celebrating without injuring someone or our environment," the mayor lamented.

Councilor Roberto Ortega interceded for the vendors and talked to the mayor but the mayor clarified that the meeting did not mean that he changed his decision in favor of the vendors.

Councilors Edison Bilog and Richard Carino during Monday's meeting pitched in for the vendors saying the city may be discriminating against the PAILAW group as it has allowed big companies to bid for the city's fireworks display.

"If we will not stop these big companies, why stop the PAILAW group when they're selling only the allowed items. If we will stop PAILAW, the prohibition should apply to all," Carino said.

Councilor Fred Bagbagen however said the ban should not be made total as there are events in the city where the city is also called upon to offer these fireworks treats being a tourist city for visitors.

The mayor clarified that the ban on the sale of firecrackers which he is advocating also covers big companies and what was bidded out are the fireworks activities of the city government where the PAILAW group was even invited to bid.

He also warned PAILAW vendors against carrying out their threat to operate guerilla-style if their appeal will not be given due course.

"On that issue, I conferred with the police and it's up to them to arrest those who will dare to violate. It's a violation of national law and pasensyahan na lang tayo kung sino ang mahuhuli," the mayor said.

He however appealed to the vendors for understanding that he is not doing it not for personal reasons nor to harm the group but for the safety and the health of the people and the environment.

He said he even offered the group an alternative way to sell toys and other Christmas items so the city can look for a proper venue for them but so far the group has made no offer to the city./A Refuerzo

proving the identified projects for the poverty programs of the city for fiscal year 2015 in line with the implementation of the grassroots

participatory budgetary process. The total cost of the projects identified is P21 million wherein P15 million will come from the national fund and six million will come from the fund of the city.

The priority projects includes sustainable livelihood program for youth empowerment through skills enhancement and parent enhancement for family health and development amounting to one million with the city's counterpart amounting to P175,000.

Five million budget will go to the rehabilitation/expansion/upgrading of an existing infrastructure for evacuation center for the city of Baguio. The city allotted P1.5 million for the said project.

2.2 million will come from the national while P800,000 from the city for the oyster-mushroom production and marketing.

On the health and sanitation program among public elementary school students for the installation of water tanks and hand washing facilities, the city allotted Png600,000 while the national allotted two million.

Out of the one million budget provided for the community health team, the city provided P425,000.

Also a priority project is the finalization, packaging and reproduction of the Baguio City Poverty Reduction Action Plan 2015-2025 through the City Employment Program for the Youth (Community-Based Monitoring System) for the 128 barangays in the city. This will cost P1.5 million where P450,000 will come from the city

## **NEWS** Expat Igorot karateka reaches out to capiz typhoon victims

Samaritans in Southern Germany were able to reach out to typhoon victims in two towns of Capiz, thanks to the team work of a small foundation, a parish priest and a crew of linemen from Baguio-Benguet dispatched a month earlier to help restore electric power in the storm-devastated Visayan province.

Expatriate Igorot karate teacher Julian Chees personally delivered over P700,000 in rice and cash to villagers in Dumalag and Tapaz towns in a joint effort with linemen of the Benguet Electric Cooperative (Beneco) and Fr. Niel Olano, parish priest of the St. Martin of Tours Church in Dumalag.

A month of repairing the typhoon-damaged lines of the Capiz Electric Cooperative (CAPELCO) gave the Beneco linemen led

by engineers Rocky Pallogan, Zac Torres and Carlo Bentayen enough background information needed for the relief operation

They firmed up the mission with Fr. Olano who had provided shelter for the Beneco crew and who had turned his parish into a base for such efforts in the wake of the typhoon devastation.

"You are the third group to reach out to the victims here through our parish," he told Chees, a former world shotokan karate champion from Bontoc, Mt. Province who founded and heads Shoshin Kinderhilfe, a humanitarian arm he and his martial arts in Germany founded in 2004 for the needy and sick here in his native Cordillera region. The Beneco crew used their boom truck to deliver 250 sacks of

#### Desperate wife appeals for support week dialysis ses-

At her wits' end P2,200 to pay for her husband's hemodialysis treatment, Ofelia Nalos pleaded Friday for another publication of kidney patient Leonard Nalos' dire need for support, six months after his lifetime plight was turned into a news article

It's a bleak Christmas for most patients suffering from renal failure who must undergo two- to three-timesa-week hemodialysis treatment that has to be sustained for life.

It had been made bleaker by the cancellation of next year's Priority Development Assistance Fund (PDAF) for congressional representatives and senators as a backlash of the discovery that about P10 billion of it were channeled to sham nongovernment organizations.

The PDAF scrapping spells nightmare for thousands of hemodialysis patients, includ-

ing some 200 of over how to get them at the Baguio General Hospital and Medical Center (BGHMC) who had survived on its medical component deposited by individual senators and representatives.

"My husband had used up his dialysis fund from Philhealth last October," Ofelia explained."I also just came from the Baguio office of the Philippine Charity Sweepstakes office

and was told they could not issue yet guarantee letters to patients until they have settled their accounts with the BGHMC."

"My husband must have his dialysis session this Saturday (Dec. 21) and the pressure to raise P2,200 as payment mounts every hour," she admitted. "He made it to the dialysis room last Wednesday as our barangay captain (Henry Figuerras of Dontogan here) allowed us to solicit

After Dec. 21, the family's next worry will be for Leonard's treatment session this Monday, and then next Wednesday, and so on.

"He skipped his session last Saturday as we were financially strapped," Ira admitted.

Missing even a single session can result in pulmonary congestion or fatal consequence.

Leonard, 31 and father to threeyear old Ira, has been suffering from hypertension since 2007, wrote social worker Florecita Tiul-an in a social case study report to support the family's request for

help. Last February, he was hospitalized for body numbness and weakness. Two weeks later, he underwent his first four-hour hemodialysis session to expel body waste that is supposed to be the function of normal kidneys. His thrice-a-
