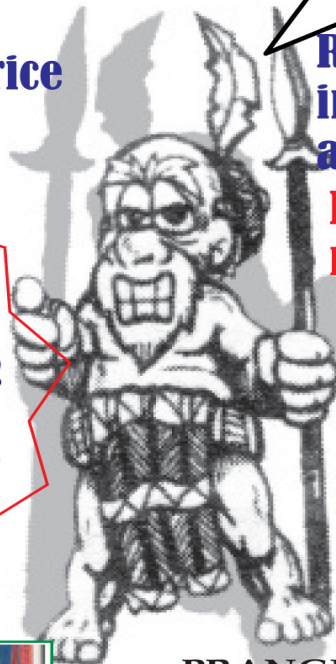
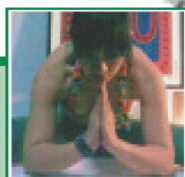

## Lawmaker: 'our efforts are not merely to Correct History, but most Importantly to Correct the wrongs of the past'

Senate minority leader Alan Peter Cayetano pushed for the speedy resolution of the issue of electoral fraud saying that doing so will provide a deterrent to those planning to cheat in the future.

The senator reiterated his view that election fraud is the 'mother of all corruption'. He emphasized that putting an end to the allegations of poll rigging and electoral return switching in the 2004 and 2007 elections by fully uncovering the truth will act as a deterrent for future 'would be cheaters'.

"Resolving these will send a strong message to all election operators that crime does not pay," said Cayetano adding

that if elections were fair, campaign expenses wouldn't be as high and the propensity to recover the amount spent once a politician is elected will not be the case in our political system.

Cayetano pointed out that putting closure to this issue will not only be our country's chance to correct its history marred by the shadow of electoral fraud, but will also help resolve all the other anomalies connected to the Arroyo administration.

"Those who are involved in all the issues we are investigating now, the PNP helicopters, the Fertilizer Scam, the Hello Garci scandal, are still in the government. So if we are truly serious in re-

solving these cases, we need to make those involved accountable, no matter how small or big the part they played in the scam is," he said.

Cayetano added that resolving this issue will allow the present administration to put an end to the epidemic of electoral fraud that was passed from one administration to another in the past.

"When we talk about electoral fraud, we are not only talking about the Arroyo administration. So in the interest of ending this, the government has to show that it is serious and see that this investigation results in the truth coming out and those responsible held accountable," he said. / Office Of Senator Alan Peter Cayetano

## DPWH Asked to Improve info Dissemination, Coordination on Projects

BAGUIOCITY

The city council last Monday urged the Dept. of Public Works and Highways (DPWH) to improve its public consultation and information strategies on their public works projects to allow people more opportunities to be informed, ventilate their opinions and to prepare for the inconvenience that may result from the implementation of the projects.

The body also asked the depart-

ment to install bigger billboards on both ends of the project sites for better visibility and serve the people's information needs.

The body felt that the department's strategy was lacking after the DPWH successfully implemented road works in various parts of the city resulting to traffic snarls, confusion and public outcry.

The city council invited DPWH Cordillera regional director Edilberto Carabbacan and Assistant Regional Director Neri Bueno to

its session to shed light on the on-going projects particularly on their compliance with the provisions of the Local Government Code (LGC) dealing on the need to conduct consultations with the affected parties before the implementation of the projects.

The officials assured that they are complying with said requirements but the body still adopted a resolution asking the DPWH to comply with the consultation re- **Cont. on page 10**

## City Gov't, Media Mourn Death of Pioneer

His colleagues in both the media and the city government best remember him as a principled, virtuous man dedicated to his craft and cause.

Thus indeed is a fitting salute to media and city human resource management pioneer Jose "Joedax" Dacawi, 66, who succumbed to a lingering illness last July 30, almost two years after he retired from the city government as city human management officer. He was laid to rest last Saturday (August 6) at the Baguio Cemetery.

"Joedax... manifested enthusiasm and dynamic energy towards performing

his daily tasks that helped in the attainment of the city's goals and objectives," the city council wrote in a resolution passed last Monday to pay tribute to the late public servant.

"His passing away is mourned not only by his family, but by the City of Baguio as well, for his being an inspiration in its quest for continued excellence and competence," the resolution added.

"His presence may not be physically felt but his memories would always remain in our hearts and the thought that in a part of our history is engraved a person by the name of 'Joedax' who was once with us in shaping Baguio

City." A stickler for Civil Service rules, Joedax is known for his stern leadership style in his department but subordinates swear his strictness was never beyond reason.

He championed discipline, hard work and ambition among his employees and goaded them to continually develop themselves. He led by example and was never unfair or abusive.

"It was he who motivated me to go back to school so that I was able to finish my masteral studies even when I was still serving a utility worker (a position equivalent to that of a janitor). Now, I am into my fourth promotion in a supervi- **Cont. on page 10**

Councilor Isabelo Cosalan Jr., head of the committee, announced the dates of the public hearing for each of the sectors:

\*August 10, 1-5p.m. for the trade and industry and tourism sectors;

\*August 26, 1-

5p.m. for the education, public safety and protection and social welfare services;

\*September 14, 1-5p.m. for the health and communication; and

\*October 5, 1-5p.m. for the housing sector.

## Mayor taps NGO's to help in Drives vs. Illegal Gambling, Smoking

BAGUIO CITY – Two non-government organizations have been authorized by Mayor Mauricio Domogan to assist in the campaigns against illegal gambling and smoking in the city.

The mayor last July 18 issued Administrative Order No. 85 authorizing the duly accredited members of the Bantay Baguio (Citizens Watch), Inc. to assist the city government in monitoring the proliferation of illegal activities such as illegal gambling, businesses operating without business permits and others.

On July 21, the mayor issued Administrative Order No. 86 authorizing the members of the Church of God Baguio to assist the city government in the implementation of the Comprehensive Anti-Smoking Ordinance specifically related to the apprehension of smokers in public places and vehicles and the posting of 'No Smoking' signs in conspicuous places in the city.

The mayor said both groups voluntarily offered their services to the city and the city acknowledges the need to involve the community in its programs in line with its thrust for participatory governance.

"The willingness of the officials and members (of said groups) to help in the implementation of applicable laws and ordinances to prevent and reduce crimes and to reduce pollutants in the city's air is very much welcome for there is a need to tap the services of volunteers who are willing to help the City Government effectively and efficiently enforce existing laws in order to make Baguio City an ideal Character City and clean its air and instill discipline among its residents and visitors not to smoke in public places," the mayor noted in the orders.

Bantay Baguio is a duly registered NGO aiming to serve as guardians of the citizens' welfare by working for the prevention of all kinds of crimes and help enforce anti-vice and local tax ordinances and national laws on environment and sanitation; and promote good character and family unity.

The members of the Church of Baguio meanwhile signified their intention to help the city government in the strict enforcement of the anti-smoking law as well as in the advocacy against smoking.

Both groups were required to submit a weekly report on their designated tasks to serve as basis of executive and legislative actions.

The mayor said the authority will be effective only for one year and subject to renewal depending on their performance./A Refuerzo

## Bakery Owners assure steady supply of Flour, no price hike of Pandesal

BAGUIO CITY- Pandesal, which is a Filipino favorite breakfast, as well as other bakery products such as cakes and pastries, will have a steady supply and no price increase, according to bakery owners in Baguio and Benguet.

Michael Del Rosario of French Line and Sunshine Supermart said that there is a stable supply of flour which is the basic ingredient in making bread and pandesal. "Our dealer transports our supply regularly so far we do not have any problem," he said.

"This rainy season there is a strong competition that's why we make our breads and cakes tastier. We see to it that the customers get their money's worth and the quality of our products is our number one concern," said Del Rosario.

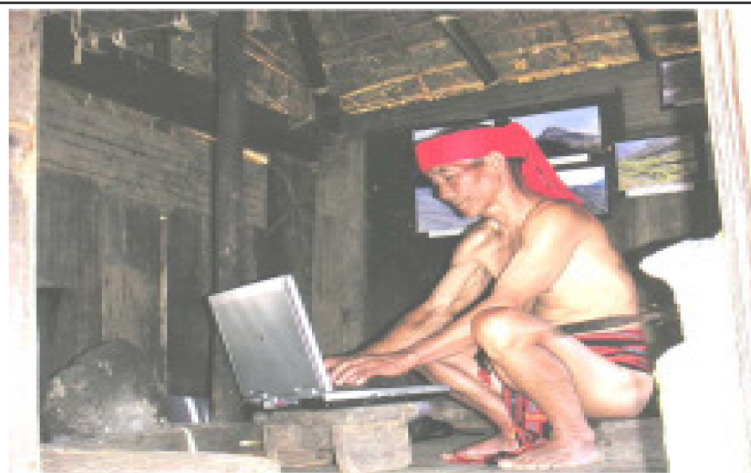
He explained that they have variety of products for customers to choose from and they come up with new products from time to time. He assured that they adhere to excellence in the service of their valued customers while ensuring that their prices are affordable. With the recent typhoons that visited the city, the tourism industry is greatly affected. We did not cutback our staff, as long as we can and that's the policy of our company, Del Rosario added.

Tet Ibasan, assistant manager of Master Hopia, seconded that that with the high demand this season, they have sufficient supply of flour and their supplier has not increased the price.

"Balikbayans find our hopia irresistible, they bring it home for pasalubong. Our "siopao" is much loved by the students and the masses. These are our specialties. We will be baking more cakes depending on the demand and readily we can meet with the steady supply of flour," Ibasan said.

For his part, Eric Espadero of Valley Bread, the biggest supplier of quality loaf bread in Baguio and Benguet, said that the demand for bread and other bakery products is increasing.

## DOTC sets Aug. 12 as deadline for Taxi Calibration

BAGUIO CITY-- The Department of Transportation and Communication (DOTC) in the Cordillera set the deadline of calibration and re-sealing of taxi meters with issuing receipts on August 12, 2011.

According to DOTC Regional Director Celina Claver, taxi operators and drivers who have not complied within the said date will be penalized.

The calibration and resealing process is required in order for the taxi driver to be able to charge the new flag down rate of P35 for the first 400 meters and additional P2 for the next 200 meters and one minute thirty seconds waiting time.

She said that aside from protecting the riding public from unscrupulous taxi

drivers, this will also help in identify legally operating franchises from colorum (illegal) vehicles".

She explained that the receipt issuing meter will contain specific details such as the vehicle plate number, trade name, name of operator, tax identification number (TIN), address, operators contact number, time of pick up, distance travelled the drop-off time and the corresponding rate charge.

"To ensure that the meter is legally calibrated and sealed, a yellow sticker will be placed on the inner right part of the vehicles windshield", she said.

"If the taxi driver fails to present said identifications, chances are the vehicle is a colorum meaning with an irregular or illegal fran-

chise", she said.

Claver is reminding the riding public that in order to identify legally calibrated issuing meters, it must have seals made from silver cable and brass locks with the DOTC hologram.

"We are asking the riding public to be vigilant and report complaints of erring drivers and operators to the Land Transportation Franchising and Regulatory Board, Land Transportation Office or to the DOTC", Claver urged.

After the deadline, this will now be an opportunity for the DOTC to formally identify legal franchises from colorum vehicles plying the streets, and we will subsequently get rid of these colorum units, Claver said./JDP/ JBZ-PIA CAR

# Rehashed Reporting

Did we, in media, adequately report the extent of plunder in Regional Governor Zaldy Ampatuan's office (ORG) for the Autonomous Region of Muslim Mindanao? The Commission on Audit amply documented that looting in its 125- page special audit report on the ORG.

**The key word is "adequately".**

We have hard-nosed reporters who probe beneath the superficial. Recent examples include is Philippine Center for Investigative Journalism reports on secret wealth of candidates to Kapisanan Ng Mga Brodkasters fines, slapped on members for flawed coverage of the Luneta hostage-taking.

But did many papers and stations merely rehash a Department of Local Government press release on ORG? They reported it's misallocation of P2.5 billion to lack of public bidding for

P650.9M worth of projects.

That's accurate —as far as press releases go "We are not merely megaphones nor stamp pads,"the late publisher Joaquin "Chino" Roces said. "Our reports must provide context and significance. These are essential, if citizens are to make informed decisions in a free society."

Below are unpublished excerpts from this COA report. Read them. And tell us if press release rewrites proved "adequate" to our task:

Over 21 months, ORG funneled P14.6 billion in national government cash allocations to 25 line agencies. It spent P2.5 billion for operations.

"ORG transactions of P1.003 billion, were "spurious". Instead of checks, as required by rules, cash totaling P866.5 million were advanced. "These were granted without specific purpose." Doles varied from P15.1M to P5.5M"

"Highly improbable daily cash payments, ranging from P7.0M to as high as P13.4M, were made to purported payees from Cotabato City, Zamboanga City and Metro Manila".

No public bids were called. Stapled to purchase orders were three price quotations by suppliers without any indicated addresses. "Existence of the supposed participating suppliers could not be verified".

Worse, they were "paid in cash out of advances of Mr. Patadon, Special Disbursing Officer". Few had documents "to establish their necessity and legitimacy."

About 95 percent of Special Purpose Fund projects were scrapped. Instead, P153.4M were diverted to relief goods, medicines, catering services, etc. These transactions were not fully documented and paid out of cash advances."

Over the first eight months of 2009, ORG doled P29.2M to maintain a plush Manila Liaison Office, in an exclusive village. "Extraordinary high expenses" were bloated by a payroll of 45 employees. Liason staff got "unauthorized, uncontrolled and questionable traveling and meal expenses."

Travel bills by a footloose l staff shoved claims beyond "allowable expenses" cap by P5.9M. Trip laims were of overlapping duration and bore patchy documentation.

Of P9M advanced for travel, P1.3M remain unliquidated. Receipts and invoices submitted were bogus and P740 thousand plus of current claims fictitious...

Thirteen supposed suppliers denied transacting business with ARRM. Yet, ORG paid them P393.8M in 853 transactions .The whole process — from purchase to distribution and receipt of procured items — had no documentation.

Forty seven supposed suppliers didn't answer COA's request for confirmation. Ten suppliers, it turned out, were not licensed. Their capitalization and gross receipts were, in any case, "way below their reported transactions with ORG. COA's ocular inspection revealed five had the same address, namely: "a mere residential house."

ORG receipts, "bearing the same numbers were issued on different dates for varying amounts." "Serial numbers of receipts, issued by purported ORG suppliers, were consecutive." Obviously, ORG was their only client for long stretches.

Receipts "bearing higher numbers were issued earlier than those bearing lower numbers. Some transactions carried unnumbered invoices. Some receipts, were printed twice or thrice. "(These) further cast doubts on the validity of such transactions.

ORG paid, in 72 disbursements,P261.6M for "debts", despite lack of COA certification that such obligations were valid. In just one day, 117 checks, was disbursed by ORG.

Of 16 creditors who cashed in, 14 did **Cont. on page 10**



## THE PEACE COMBATANT

**New White-Collar Crime: Steal money from the people and then whistle-blow**

There are only 22 white-collar crimes that have been identified by the country that coined the word "white-collar crimes". That country is the leading capital of white collar crimes simply because it is the only country in the world with the biggest number of white collar criminals—the United States. The 22 white collar crimes are tax evasion, securities fraud, money laundering, larceny, investment schemes, insurance fraud, insider trading, health care fraud, forgery, extortion, environmental scheme, embezzlement, currency scheme, credit card fraud, counterfeiting, cellphone fraud, bribery, blackmail, and bank fraud.

One investment fraud that is well-known even in the Philippines is the pyramid or the ponzi scheme. The ponzi scheme originated from the United States. It started with Charles Ponzi of Boston, Massachusetts, who invented the fraud sometime in the early 1900s. Charles Ponzi was able to deprive several thousand people of New England (in the United States) of their hard-earned money. Charles Ponzi simply promised a guaranteed return of 50% to investors on their capital within 90 days. In truth, Charles Ponzi simply financed the dividends of earlier investors through the payments of new investors.

Several years after, Bernard Madoff would copy the modus operandi of Charles Ponzi with more sophisticated innovations. Unlike Charles Ponzi's incredible returns of 50%, Bernard Madoff simply offered small but positive rates on capital. The business looked very credible because there were no extraordinary claims. In fact, Madoff's business existed for several years. However, Bernard Madoff has simply been paying older investors from the investments of newer investors. He was not actually making investments at all. It was only lately or around 2008 when the United States started to prosecute Bernard Madoff and slapped him with a 150--year imprisonment sentence.

America invented the ponzi and the pyramid scheme (the more modern version of the ponzi). We credit America for the ponzi. However, it is now time to credit the Philippines for a new white-collar crime: that of stealing so much money from the people or at least collaborating with the principal thieves in stealing so much money from the people and then turning whistle-blowers later.

One version of this, however, involves agreeing to a plea-bargain in which a general charged for corruption involving several millions if not billions of pesos offered to admit a less serious crime in return for the dropping of charges. Neat. The general is able to steal money and is prosecuted. Nevertheless, he is able to keep much of the money he stole by simply confessing to a less serious crime. Result: millions of profit for the criminal and then the criminal is absolved for the more major crime.

Fast forward. The same pattern is repeated. However, this time, the criminal is only of those involved in the corruption. The criminal is a willing participant to the corruption. He is one of those who earned from the corruption. He got a share from the corruption. He may or may not be one of the princi- **Cont. on page 11**

*I WUZ HACKED -AGAIN!*

**"MONEY BADLY NEEDED"**—Early dawn 3 days ago, I heard a message alert from my cellphone. I saw it was from my daughter Ning, who lived next door, alerting me that she got in her email inbox a mail purportedly coming from me saying that I was stuck in UK (England) because I lost my wallet and I needed money badly. "Either you left for UK without us knowing it or you're here next door, in which case you're hacked again!", she texted. I spent the rest of the wee hours of the morning sending messages to friends (and foes alike) informing them of my predicament that my email address [jessdureza@gmail.com](mailto:jessdureza@gmail.com) was taken over by some unidentified persons. I asked them to ignore messages using that account.

"Sh\_t!" I knew this feeling because when I was Press Secretary some three years ago, my email account was also hacked and compromised. At that time, I was sending by email some sensitive memos to PGMA and other members of the cabinet and other officials. I was worried for a while that the "hackers" were after confidential memos. Happily, they appeared to be doing a scam for quick money.

**SAME TACTIC**—Very much like what happened 3 years ago, this recent hacking has a similar modus operandi. Somehow they are able to "hijack" your email account, perhaps by being able to steal your password and email all whose names are saved in your list of contacts making it appear that it was coming from me. I could not even enter my own account to countermand the scam. They must have quickly changed the password for that account hence I could not use it anymore. It was total capture

There's a song that was made famous by pop group "Timbaland" and it had right through the heart: "Too late to apologize."

Indeed, amid the mish-mash of comments on Sen. Migz Zubiri's sudden resignation at the Upper House, came a little bit too late – after four years after he was declared winner for the hotly contested 12<sup>th</sup> and last seat for senator in the 2007 mid-term elections.

Well, in the process, Sen. Migz heaped praises and a lot too in anathema to it.

For effects purposes, here's a choice cut from Timbaland's "Too late to..."

"I'm holding on your rope,  
Got me ten feet off the ground  
I'm hearin' what you say but I just can't make a sound  
You tell me that you need me  
Then you go and cut me down, but wait  
You tell me that you're sorry  
Didn't think I'd turn around, and say...  
It's too late to apologize, it's too late  
I said it's too late to apologize, it's too late..."

That's only half-way through it but we have to cut it right there anyway it have had been filling up the airwaves for some time now.

Anyways, a member of an election watchdog who blew the whistle on the alleged fraud in the 2007 senatorial polls said Sen. Migz's action was "an indirect admission that he had a questionable mandate."

It was Abdullah Dalidig, chair of the Lanao del Sur chapter of the National Citizens Movement for Free Elections speaking even as he stressed that Zubiri's resignation should not stop from there instead, it should fan out further investigations or inquiry into the role of the previous ruling party that may have allegedly paved the way for his "victory."

For his part, Koko Pimentel, whom some people believe rightly earned the last and 12<sup>th</sup> senate seat sans the alleged "dayaan," praised in part Sen. Migz's sudden resignation saying "it was a rare gentleman's act," but "that should have been done four years ago."

His father and namesake in former senator Aquilino "Nene" Pimentel Jr., who is also acknowledged as the father of the local government code, described the resignation along the same lines.

Truly Zubiri's resignation is seldom seen in Philippine politics, and, notwithstanding a remote "pressure" from Malacanang, is not so very far behind his own admission that "It was the criticism he heard from the yayas or nannies of the schoolmates of his three-year-old daughter that hurt him the most and prompted his decision to resign even before the Senate Electoral Tribunal (SET) decided on his case.

"He cannot take that his daughter is being told that her father is a cheater, and yayas' of other schoolchildren were saying that he cheated in the elections," a source quoted Zubiri as saying.

But whatever effort that Sen. Zubiri, who also hails from Mindanao like the Pimentels, wishes for the public to change its perception on him, the people may not be that easy to forget and tag him as "as a cheat."

Because the thing is, it's really a little bit too late.

The Malaya reported that an "Opposition congressmen said yesterday an assistant secretary was forced to resign after he refused to follow his boss' order to sign a purchase order for computer sets which did not go through the proper bidding process. House minority leader Edcel Lagman and Zambales Rep. Milagros Magsaysay refused to identify the "boss," a Cabinet secretary, but said his initials are "RC," obviously referring to Secretary Ricky Carandang of the Presidential Communications Development and Strategic Planning Office."

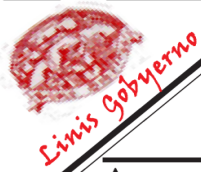

At an eatery near a jitney terminal located at Lake Drive, Baguio City, the operatives, while conducting surveillance, saw a male person writing on a piece of paper and when approached was caught in the act of writing jueteng combination numbers on the evening of July 30, 2011. The suspect identified as Gerald Palomique y Capistrano, 32 years old, married, jueteng bet collector or "kubrador" and a resident of Quezon Hill, Baguio City, was immediately placed under arrest and brought to the police station. Confiscated from the suspect were pieces of paper with written jueteng combination numbers and cash bet amounting Php 110.00. Subject was subsequently detained at Baguio City Jail as per Inquest Prosecutor Paulene Aquino dela Cruz while a

case for violation of RA 9287 was filed against the suspect.

On another earlier incident last July 29, 2011 at about 11:35 am, the operatives effected the arrest of one Ariel Aguila y Atienza, 37 years old, single, native of San Pablo City, Laguna and were then billeted at a hotel in Kisad, Baguio City. Suspect was caught while engaged in an illegal numbers game of "Jueteng" and confiscated from him were jueteng papelitos, cash bets amounting Php 180.75 and other items used in his jueteng activities. Suspect was detained at the Baguio City Jail as per written order of City Prosecutor Ana Valerie Cacho and a case for violation of RA 9287 was transmitted at the City Prosecutors Office.

To cut illegal gambling activities is one of the priority thrust not only of BCPO City Director PSSUPT DAVID LACDAN, but also of the City Mayor, Hon. Mauricio Domogan to attain a gambling free city. But in order to completely eradicate this illegal activity, the authorities need the help of the public. # Amnesty says PNOY's first year showed little progress in human right protection in the Country and in Northern Luzon.....rom page 1

City.

Amnesty International released on June 30, 2011 Progress, Stagnation, Regression? The State of Human Rights in the Philippines under Aquino. The 28-page briefing examines the Aquino administration's progress on 26-key human rights recommendations, which the organization put forward to the newly-elected president Aquino in June 2010. Amnesty International assessed the Aquino administration's performance on curbing political killings, enforced disappearances and torture. It found that Aquino has failed to establish accountability over the state security forces including paramilitary groups and has not made enough progress in disbanding and disarming private armies and in ensuring justice for victims of human rights violations.

Based on Amnesty International's assessment, out of the 26 human rights action points, this is how the Aquino Administration has fared:

- Significant Improvement – 0
- Some Progress – 2
- Little Change – 8
- Stagnant – 8
- Failed – 7
- Regressed – 1

The international human rights organization expressed concern over continued human rights violations in and delayed justice in Northern Luzon. The human rights watchdog particularly mentioned Nelson Asucena, who was shot dead in 2006 by men in camouflaged uniforms in Cagayan Valley and the case of James Balao, who disappeared in 2009 in La Trinidad, Benguet.

"We call on President Aquino to create a Presidential Accountability Commission to ensure the investigation and expedient prosecution of cases of political killings, enforced disappearances and torture. This will ensure that adequate attention is given to investigation and prosecution of alleged perpetrators of those who disappeared, tortured and killed in the first year of the Aquino government and those killed in the last decade under the Arroyo government.

Many people of Northern Luzon face insecurity every day and they await the delivery of justice as promised by President Aquino," added Dr. Parong.

Amnesty International in its Global Human Rights Report 2011 mentioned cases of extrajudicial killings, torture, and ill-treatment, violations of indigenous peoples rights and sexual reproductive rights.

Amnesty International Philippines also noted several applications for mining exploration in Benguet, Mt. Province and Abra and reiterates accountabilities of both mining activities have caught the attention of the local government and NGO's as well.

"President Aquino must not forget the protection of the rights of indigenous Peoples groups in mining affected areas. Poverty and insecurity continue to plague indigenous communities even at the promise of development. The provisions of the Indigenous Peoples Rights Act (IPRA) for free, prior and informed consent of peoples must be implemented with due diligence." Said Dr. Parong.

In Baguio City, the June Pride Month

also put the city in the limelight when LGBT activists marched against discrimination and held same sex union rites. Amnesty International celebrates diversity and believes in human rights for all.

"The Universal Declaration of Human Rights applies to all. Sexual orientation should not be a reason why individuals will not be able to enjoy the same equal rights as everyone else. Discrimination on the basis of sexual identity is a form of human rights violation. Thus we support the immediate enactment of an anti-discrimination law," explained Dr. Parong.

She concluded that, "An entire year has passed with small progress. The Aquino government and local government official s in Northern Luzon need to take programmatic actions against human rights violations." (Press Release)

In the incident 3 years ago, I even went to the extent of contacting the Philippine embassy in London and asking some personnel to visit the "Western Union" addressee that was mentioned in the email where the money should be sent. I wanted to prevent the "contributions" from our unsuspecting "benefactors" from reaching the hands of the scammers. I also asked that if there were money remittances, that they should be forwarded to me in Davao so this could be returned to those who fell for the scam. There was no pouch forwarded to me in Davao up to now.

sory position and in my fourth year of law studies,” said Jerry Guevarra, an employee of the city human resource department.

Along the hallways of City Hall, Joedax may have appeared severe ready to pounce on every employee transgressing a Civil Service memorandum circular and scold even fellow department heads for lack of “vision and planning,” but outside the government confines, he was all human – compassionate, sweet and doting even.

Jerry said he always personally saw to the needs of his employees during department outings and gatherings ensuring they were all properly fed and entertained.

Dan Ricky Ong, a former subordinate, said the man was kind-hearted recalling how his former boss stood by him during a difficult time in his life.

“When my father suddenly died a few years ago, Sir Joedax was at my side, kept me company even at the morgue of the hospital waiting for the remains of my father to be claimed by the funeral parlor until the wee hours of the morning,” Ong related. He said he was sure Joedax did similar if not more mundane favors to his other employees and other people in need.

Joedax entered government service in 1973 as emergency laborer at the city council. He rose from the ranks and became the city human resource management officer, a position held for 36 years until his retirement in 2009.

Before his stint in the government, Joedax was a pioneering media practitioner during the golden age of broadcast and print media in the city. He served as staff member and field reporter of radio DZHB or RMN IBC in the company of fellow media icons Manny Salenga, Willy Caddac and George Jularbal.

He was staff member of The Mountaineer Weekly Paper, Focus Weekly Magazine, Baguio Midland Courier, correspondent of the Philippine Daily Express and president of the Baguio Correspondents and Broadcasters Club (BCBC) in 1987.

Media contemporaries and younger colleagues also have their own stories to tell of the media and government service royalty that was Joedax.

Art Tibaldo, Dacawi's fellow civil servant and journalist, said, “Manong Joe is an exemplary man worthy of emulation. He joined his creator leaving behind a legacy of exemplary service and unquestioned integrity.”

“He was a no-nonsense worker who does not want to be credited or recognized for his contributions. He discourages city activities to go beyond office hours that deprive workers from spending quality time with their families... Civil Service or not, Manong Joe is my “Dangal ng Bayan” awardee,” Tibaldo commented in his Facebook account.

Catherine Miras-Agustin, a former employee of the city mayor's office now based overseas also wrote over Facebook: “Tito Joe was one of the best mentors I ever had in Journalism. He was at his best as CHROMO Head at City Hall as he meant well not only during Values Orientation Workshops but as every government employee performed their respective functions without allowing themselves to be politicized. His wealth was

not yet exist at the time of alleged transactions. Not one replied to COA request for documentation. “ORG officials signatures appeared to be computer scanned. There were no documents to prove that the goods and services were received...”

ARRM officials, from Director Khem Inok, to Financial and Budget Management Services director Batolacangan Abdullah, dawdled on commenting on COA's findings. They repeatedly asked for postponement.

Thus, COA moved a February 24 deadline to March 12. Three days after that lapsed, ARRM wheedled for another two months. No, COA replied. ARRM had “already given ample time.” Just appeal audit findings to the Commission Proper.”

How does one debunk documented findings of p-l-u-n-d-e-r. Amounts stolen make the sweepstakes looting seem like peanuts. Grand scale theft occurred in a region where life expectancy falls below 57 years. Compare that to 74 years in La Union. Forty five persons in ARRM drink from polluted wells. The comparative figure for Ilocos Sur is four.

All these occurred under Gloria Macapagal Arroyo's watch. When did she know about this plunder? What did she do?

The task of the press is also to hold accountable those responsible for misgovernance. But we can discharge this duty only if we also hold ourselves accountable too. That covers reporting which flounders at the level of rehashed press releases./Juan L. Mercado

quirements of the LGC particularly sections 2c and 27.

Vice Mayor Daniel Farinas said the body also wants the DPWH to improve coordination with the local government units to properly guide the locality and avoid confusion.

He said they support the move in Congress to speed up bidding procedures of projects funded under the General Appropriations Act to avoid delay that causes disturbance to the public.

The body also inquired on the department's basis in deciding on road repairs in view of the observations here that the current restoration works are not needed as some roads including Bokawkan road are still in good condition.

The officials clarified that they are following a reliable system of evaluating road condition that classifies the status of roads into three: bad, poor and fair. Bad status would mean that the road requires rehabilitation as in the case of Loakan Road. Poor status means reblocking works as in the case of Bokawkan Road while fair condition requires overlay job.

The body further asked the department to consider adopting new technologies to

speed up the curing period of road works to ease the burden of the public affected by traffic disruptions.

As this developed, the body urged the DPWH to postpone the closure of Ferguson Road until the repair work along Bokawkan Road is finished to avoid further traffic snarls in the area.. Bokawkan Road is slated for opening on Sept. 3.

Moreover, the department was asked to submit a list of their projects in line for inclusion in the Annual Investment Plan of the city./A Refuerzo

nalization of the draft.

A briefing-cum-consultation will also be held among city officials on November 16 at 9 a.m. at the Multi-purpose Hall.

The CLUP defines the utilization and uses of the city's various zones and serves as the basis in the implementation of the city's zoning ordinance.

Mayor Mauricio Domogan, chair of the City Development Council (CDC) which drafted the updated CLUP, said the CLUP serves as "our City's road map to 2020" and "our blueprint for our City's physical and economic development toward a safer and healthier environment."

Domogan said the updated CLUP which took time to complete is a result of a collective effort of the different sectors but the consultations to be conducted by the city council would ensure that the plan would truly mirror the desires and aspirations of all the sectors.

Engr. Evelyn Cayat, officer-in-charge of the city planning and development office (CPDO) and head of the CDC secretariat said four "major spatial strategies" highlight the CLUP, which are the decongestion of the Central Business District through the provision of growth nodes along strategic locations in the City, the designation of additional areas for institutional purposes that support the city's role as an education center north of Manila, the preservation of existing watersheds, forest reservations, parks and other areas supported by Presidential Proclamations and other laws and setting of Environment Development Controls.

The new CLUP's updates center on the allowed uses within the different zones, building heights and the provision of a land use map which specifies the land use allocation of the various zones namely residential, commercial, industrial, institutional and utilities zones./A Refuerzo

prejudice to the outcome of their pending cases.

Requirements include duly accomplished application form (CS Form No. 100, Revised 2007); four latest and identical (1.78" x 1.38" passport size) I.D. pictures bearing the surname, first name and middle initial, taken within three months before the date of filing of the application. Pictures that are scanned, photocopied or computer-enhanced are not accepted. Name tag should not be computer-generated; any valid ID such as Driver's License, SSS ID, current Office ID, Postal ID, BIR ID, or valid passport which contain the applicant's picture, signature, birthdate, and the signature of the authorized head of the issuing agency. Photocopy of the same should be attached to the approved application form to serve as reference for Room Examiners on the day of the examination; and Examination fee of P 500.00.

Passing the CSE-PPT means being conferred an eligibility based on the level of examination taken. taxes to the BIR Central office in Manila, under the new guidelines.

"For this year, we have met most of our monthly targets, except in May and this July, which somehow can be attributed with a high target goal and the loss of our withholding tax collection from Moog and TI", Bilog said.

For this July alone, BIR-Baguio missed its goal or target of P130,472,000 with collection of P120,216,875 only. Bilog though reiterates that, aside from intensifying their tax info campaign, they are also implementing new programs to fill the gap and to further enhance their revenue collections.

In line with this, Bilog bared that last July 23, through a Memorandum of Agreement with the Bangko Sentral ng Pilipinas (BSP), the BIR has started collecting two percent withholding tax from small scale in-

## Rookie cop in Tinoc incident faces criminal and admin cases

LATRINIDAD, Benguet, Aug. 1 - The Police Regional Office of Cordillera (PROCOR), in line with the Philippine National Police Integrated Transformation program and in its own efforts to discipline and rid its ranks with misbehaving members, has filed both criminal and administrative charges against a rookie cop who killed four persons including two police officers in a shooting incident in Tinoc, Ifugao last month.

The suspect, PO1 Mark Davis Dulnuan, a member of 2<sup>nd</sup> Regional Public Safety Battalion (RPSB) Company has been charged with four counts of homicide filed before Regional Trial Court Branch 14, Lagawe, Ifugao docketed under Criminal Case Numbers 1987, 1988,

1989 and 1990 respectively and one count of frustrated homicide before Municipal Circuit Trial Court, Lamut, Ifugao.

Five counts of administrative cases for grave misconduct are being instituted by the Regional Investigation Division and the Regional Personnel and Human Resource Development Division (RPHRDD) will designate a summary Hearing Officer to try, hear and resolve the administrative cases.

It will be recalled that Dulnuan on the evening of July 2, 2011 at Poblacion, Tinoc, Ifugao shoot and killed four persons identified as PO1 Leobinep Binhawan and PO1 Tom Udan, both PNP members of 2<sup>nd</sup> RPSB Company based at Tinoc, Ifugao, and

Benjamin Madino Jr. and Mr. Marcial Calyaen, both civilians and residents of Tinoc, Ifugao. Also wounded was PO1 Dexter D. Catiling, also a member of 2<sup>nd</sup> RPSB Company.

PROCOR Regional Director PCSupt. Villamor Bumanglag stressed that any personnel charged with misconduct shall be meted with the severest penalty under existing laws and other PNP and National Police Commission circulars.

He has time and again reminded all the men and women of the PRO Cordillera to focus on their mandate, act professionally and observe proper decorum at all times to avoid repetition of similar incidents which had tarnished the image of the PNP as a whole. PROCOR

## NFA assures enough stockpile of rice for the rainy days

BAGUIO CITY - With weather disturbances coming in succession, the National Food Authority (NFA) assures the public that there are enough stockpile of rice for the rest of the rainy season.

NFA Baguio-Benguet Manager Rolando Rufo, in an interview, stressed that they have already programmed the purchasing of rice supply for the whole year, and at present they maintain a stockpile that could last for nine months based on the average regular consumption of the people here in the

Baguio-Benguet area.

To date, NFA has a total stockpile of 48,579 (50 kilos) sacks of both local and imported rice including 7,614 sacks of I-rice or Iron-fortified rice in its Loakan and Kadiwa warehouses.

Rufo also pointed out that in the past years, NFA disposes about 2,000 to 4,000 sacks a month during the rainy season or what is called the lean months, but last month they only disposed about 500 sacks, which means that there is also a surplus in inventory of rice in commercial

stalls and in the households. For the increase in commercial rice supply, Rufo credits it to the open-importation of rice to private importers or dealers.

On the I-rice supply of NFA, Rufo affirmed that the NFA has launched this aggressively early this year, in line with the government's effort to address iron-deficiency among Filipino people.

"We have been advocating iron fortified rice before, though back then it is only on areas where there are high prevalence of iron deficiency or for Food for School program, but now we are mandated to promote it to the general public" Rufo said. \*/JDP/LD-PIA CAR

## BIR Conducts Tax Compliance Info Campaign to City Barangay Treasurers

BAGUIO CITY - The Bureau of Internal Revenue Regional District Office 8 (BIR-RDO8) here conducted last Tuesday a tax compliance information, education and communication (IEC) campaign for the 128 barangay treasurers in the city.

## La Trinidad municipal dad wants alcohol regulated

LATRINIDAD, Benguet - Alcoholic drinks and other beverages may soon be regulated in this capital town.

Municipal councilor Roderick Awingan has proposed an ordinance regulating the sale, serving and drinking of alcoholic beverages in all business establishments in the municipality of La Trinidad for a better place to live in.

Awingan noted that several problems in the municipality in the past months are caused by excessive drinking particularly resulting to traffic ac-

cidents and mauling incidents ending in physical injuries especially during the night to the wee hours of the morning.

In the proposed ordinance, it states that "no person or persons, bars, restaurants, accommodations and other establishments, retail dealer, and sari-sari stores and other similar establishments will sell, offer and serve to any person or customers, any kind of alcoholic beverage, foreign or locally manufactured, after 9:00 p.m. until 6:00 a.m. the following morning from

Monday to Sunday."

It further states that "No person shall sell, dispense, serve and drink any alcoholic beverages of any kind in public carinderias and public stalls, parks, streets, alleys and other public places without appropriate special permit."

Angiwan added that no person will also be drunk or intoxicated and behave in a drunken, boisterous, rude or indecent manner in any place or premise to the annoyance of another person. Owners and or managers of the said establishment with the assistance of the local police may force unruly customer out. /JDP/RC-PIA CAR

## Application for Oct. 16 Civil Service Exams now open
