"There is a need to warn and discourage would-be real estate buyers from transacting with these violators to avoid future housing or subdivision-related problems legal or otherwise (apart from) the possibility of putting the lives and properties of clients in danger," the city council said in an approved resolution authored by Councilor Isabelo Cosalan Jr.

"The proliferation of subdivision developers (and the like) circumventing or outrightly ignoring the law had caused a myriad of urban problems due to unsound urban planning, such as housing subdivisions with substandard roads and alleys, inadequate public facilities, non-delivery of title to buyers and other problems as a result of poor planning," the resolution read.

"These erring individuals/ corporations are depriving the

Opposition Senator Francis "Chiz" Escudero on Wednesday said the days of Merceditas Gutierrez as Ombudsman are numbered as she is only serving the unexpired term of her predecessor, Simeon Marcelo.

"By my calculation, Ombudsman Gutierrez's term as head of the anti-graft body ends this October. She has only seven months left as she only serves the unexpired term of her predecessor, Escudero said in a tor, a member of the Judicial Bar Council, pointed out Marcelo was appointed Ombudsman in October 2002 and resigned in November 2005, when Gutierrez was then named as his replace-

"Marcelo served as Ombudsman for over three years and Gutierrez's tenure is now nearing four. Under the Constitution, the Ombudsman and his or her deputies shall only serve for seven years without the benefit of reappointment in the same position," Escudero said. He explained that Gutierrez is not entitled to a full term of seven years, citing a Supreme Court ruling in 1955. Escudero said that in the case of Republic v. Imperial, the Court ruled that: "When the Constitution fixes the duration of a term of office, and at the same time provides for its being filled at a fixed time occurring periodically, it necessarily follows that, a casual vacancy occurring during such term of office, necessity must arise for filling it for the unexpired term; and al-

Senator Chiz Escudero o n Thursday said torturers must be put away for life as hе pushed anew for the passage of an antitorture bill pending in Congress in the light of the brutal killing of the daughter of a communist rebel leader in southern Mindanao.

"Torture and other cruel and inhuman acts have no place in a civilized society. I call on my colleagues in both houses of Congress to once and for a11 criminalize and

penalize these acts," Escudero said in a statement.

"The immediate passage of this bill becomes more urgent with the brutal killing of Rebelvn Pitao. We have to act now for torturers have, for so long, acted with impunity," he said.

Escudero, chair of the Senate Committee on Justice and Human Rights, said the consolidated antitorture bill he authored along with Senators Jinggoy Estrada, Miriam Defensorthe Senate floor.

# Strange Virus

Are we, Filipinos, afflicted by a strange virus? Do we have "amnesia and déjà vu at the same time"? Look at how today's scandals blot out yesterday's scams.

Current headlines zero in on Celso de los Angeles and plunder of Legacy funds. The theft,in Legacy banks and companies, is staggering, even by this jaded town's standards. Victims are mostly low-income folk: retired school teachers, self-employed workers, etc. They deserve expose of this sleaze.

But intense Legcay coverage had unintended results: It smudges equally-shocking holdups, like the World Bank's documented reports on rigged bids for road construction. "Al que no le miran, le olvidan," my grandmother used to say. "Out of sight, out of mind."

A spineless Ombudsman and white-washing congressmen saw to it that World Bank bid crooks were not nailed. As in Jose Pidal's bank

accounts, the First Gentleman was insulated from answering tough

questions. Presidential immunity, in this country, has a reach beyond letter of the law.

Thus, all the road thieves, plus their official "godfathers", cheekily remain in business. "The past is never dead," William Faulkner once said. "It is not even past."

Tell that to former Agriculture Undersecretary Jocelyn Bolante. The Senate Blue Ribbon Committee reported "Joc-Joc" and coterie of runners plundered P728 million worth of fertilizer funds.

Did Bolante and runners blush? Why should they? Joseph Estradsa didn't blink when he signed as "Jose Velarde" Example remains the best teacher. And if anything, "Joc Joc is a quick learner. Now he may run for Capiz governor, come 2010. "One is never so dangerous than one who has grown too old to blush," warned Marquis de Sade.

Some 193 officials dipped into fertilizer loot. Gleefully, they've back-peddaled as this scam slipped into the inside pages. But they leave a worrisome question: Is stealing citizens blind now a qualification for public office?

These are the more recent examples of felony. They're fading rapidly into collective forgetfulness. This lack of recall vests criminals with impunity. Many keep the loot, prosper, only to rob again tomorrow. Indeed, "we live in a world where amnesia is the most wished for state."

You doubt that? Run down an even abbreviated check list of past scams. Whatever happened, for example, to the P532 million overprice for the Diosdado Macapagal Boulevard? No one went to jail. That turned into a dry-run for raids on World Bank road construction projects.

The original price tag for the ZTE broadband project was \$132 million. After the President and First Gentlemen completed a golf game, with ZTE officials, the cost ballooned into \$329 million. Kidnapping of witness Rodolfo "Jun" Lozada capped the press uproar and Senate probe. Malacanang scuppered the deal. But was any one penalized for this attempted hijack?

The President denounces "disappearances" and "salvaging". But no victims turn up. Not activist Jonas Burgos. Nor UP students Karen Empeno, Sherlyn Capada and others. Davao teacher Reblyn Pitao's "crime" was her father is an NPA commander. She was raped and salvaged.


OK. So, military rouges did it. But why do they disdain the Commander-in-Chief's diktats? Is it because her words don't square with her deeds? She coddles, for example, former Gen. Jovito Palaparan. The man ran this country's "dirty war" ala Pinochet.

In October 2007, the President met with congressmen, then with Union of Local Authorities officials. Envelopes were handed out.

"I thought it was a Christmas gift," explained Rep, Antonio Cuenco of Cebu. "What's this P500,000 for?", Pampanga Governor Ed Panlilio asked aloud: "Everybody else zippered up." Cebu Daily News noted. "Even more telling, no one returned an envelope."

Remember the P1.6 billion Mega-Pacific election computers? Senate Report 44 skewered Election Commissioner Benjamin Abalos for tailored specifications and premature approval. "Credible, orderly and

Looking for President Right

This year is jockeying for presidency year.

News says that the leading contenders for the Philippine presidency include Noli De Castro, Francis Escudero, and Manuel Villar. Of course, dark horses led by Mar Roxas, Panfilo Lacson, Bayani Fernando, and Lloren Legarda can easily come into the political picture.

This will be a battle of network, legwork, machinery, funds, and platform.

Hopefully, the winner of the election will not have a dubious background. Further, the president-elect of 2010 must not have a record or image of involvement in graft, drugs, extrajudicial murder, and gambling syndicates.

For national unity, it is important that the president-elect enjoys a fairly large political following. However, as in the nation's experience under former President Fidel Ramos, the new president-elect can use political and managerial experience to compensate his or her lack of a political base.

Largely, except if Joseph Estrada or Gloria Macapagal-Arroyo re-run for president, the top contenders for president do have a relatively pleasant image. All of them are roughly Mr or Mrs clean. All, except for one or two, do not have an extremely contentious background.

Admittedly, networks and popularity will determine the outcome of the elections. Big business and foreign stakeholders will probably be largely indifferent on who will win because the candidates who are likely to win are basically pro-business and also pro-foreign business anyway.

Most likely, even the Philippine left will probably not keen on who will win the presidency because the political and economic platforms of the candidates are not really different. Of course, the Philippine Left MAY still choose to support one presidential candidate but they will probably focus on reaching the grassroots.

Further, the Philippine Left has the option of not supporting any presidential candidate but only local ones. They have nothing much to win or lose anyway by supporting any of the presidential candidates.

Instead, the Philippine Left may concentrate on the local by establishing alliances focused on the local elections. Of course, they will also strongly support their party list parties.

I say we follow the probable indifference of the big business groups and the Philippine Left and focus instead on voter education. We clarify the issues involved both at the national and local levels. We give voters the freedom to choose their presidential candidates and suggest a set of criteria they can use in choosing both their president and officials at the local levels.

Of course, as citizens, we have to make a decision, especially at the local level. I say we do this after a discussion of platforms and issues involved at the national and local levels. We make a stand after a period of discussion.

After the elections, we convert ourselves to become critics of all government officials, including those that we have supported. In some cases, critical collaboration can be appropriate.

However, the proper function of the press really is to serve both as critic and mirror of society. It is not the proper role of the press to be a collaborator of any politician. Leaders come and go and cease to be relevant. Both a mirror and a critic are needed for society to see when leaders cease to be relevant.

Responding to the Alyansa's calls for Bible donors to be distributed to members who will be at the Mabini Hall of the Quezon Memorial Circle in Diliman, Quezon City on March 15, Sonny and Johnson promised to donate 100 Bibles each. That's a total of 200 Bibles, of course.

THE SCRIPTURES A SAFEGUARD (Fourth of 5 Parts)

The truths most plainly revealed in the Bible have been involved in doubt and darkness by learned men, who, with a pretense of great wisdom, teach that the Scriptures have a mystical, a secret, spiritual meaning not apparent in the language employed. These men are false teachers. It was to such a class that Jesus declared: "Ye know not the Scriptures, neither the power of God." Mark 12:24. The language of the Bible should be explained according to its obvious meaning, unless a symbol or figure is employed. Christ has given the promise: "If any man will do His win, he shall know of the doctrine." John 7:17. If men would but take the Bible as it reads, if there were no false teachers to mislead and confuse their minds, a work would be accomplished that would make angels glad and that would bring into the fold of Christ thousands upon thousands who are now wandering in error.

We should exert all the powers of the mind in the study of the Scriptures and should task the understanding to comprehend, as far as mortals can, the deep things of God; yet we must not forget that the docility and submission of a child is the true spirit of the learner. Scriptural difficulties can never be mastered by the same methods that are employed in grappling with philosophical problems. We should not engage in the study of the Bible with that self-reliance with which so many enter the domains of science, but with a prayerful dependence upon God and a sincere desire to learn His will. We must come with a humble and teachable spirit to obtain knowledge from the great I AM. Otherwise, evil angels will so blind our minds and harden our hearts that we shall not be impressed by the truth.

Many a portion of Scripture which learned men pronounce a mystery, or pass over as unimportant, is full of comfort and instruction to him who has been taught in the school of Christ. One reason why many theologians have no clearer understanding of God's word is, they close their eyes to truths which they do not wish to practice. As understanding of Bible truth depends not so much on the power of intellect brought to the search as on the singleness of purpose, the earnest longing after righteousness.

The Bible should never be studied without prayer. The Holy Spirit alone can cause us to feel the importance of those things easy to be understood, or prevent us from wresting truths difficult of comprehension. It is the office of heavenly angels to prepare the heart so to comprehend God's word that we shall be charmed with its beauty, admonished by its warnings, or animated and strengthened by its promises. We should make the psalmist's petition our own: "Open Thou mine eyes, that I may behold wondrous things out of Thy law." Psalm 119:18. Temptations often appear irresistible because, through neglect of prayer and the study of the Bible, the tempted one cannot readily remember God's promises and meet Satan with the Scripture weapons. But angels are round about those who are willing to be taught in divine things; and in the time of great necessity they will bring to their remembrance the very truths which are needed. Thus "when the enemy shall come in like a flood, the Spirit of the Lord shall lift up a standard against him." Isaiah 59:19.

Jesus promised His disciples: "The Comforter, which is the Holy Ghost, whom the Father will send in My name, He shall teach you all things, and bring all things to your remembrance, whatsoever I have said unto you." John 14:26. But the teachings of Christ must previously have been stored in the mind in order for the Spirit of God to bring them to our remembrance in the time of peril. "Thy word have I hid in mine heart," said David, "that I might not sin against Thee." Psalnrl 19:11.

from their 2008 goal. Vitug said they will have their usual campaign for registration of businesses, tax-mapping and bench marking. Accdg to Vitug, their registration campaign is doing well this first quarter of 2009 as they already had an increase in revenue of almost P1 million, from their La Trinidad/Benguet Revenue District Office (RDO9) alone.

For the BIR's "Oplan Kandado", a program against taxpayers who are evading or omitting payment of correct taxes, Vitug said they are now conducting covert operations, which is the initial phase of the program, and that they have already submitted some names of establishment to BIR commissioner Sixto Esquivas.

Vitug reiterated that their thrust, for the first semester of this year, is to achieve their collection goal, as this semester is a challenging period and an increase in their collection would be better for the country, especially, in helping those who are in need or the displaced workers.

"We will continue to strictly impose our tax codes, regulations and issuances and probably at the same time look on the businesses, on how to help them", Vitug added. The BIR will also meet with the Filipino-Chinese Chamber of Commerce and other business organizations to tackle the status of businesses in the region./Lito Dar/PIA

Ombudsman Mercedes Gutierrez prosecuted no one. She didn't get back the money paid. There was a majorcrime, Ms Guiterrez admitted. But no one was liable. "Where in the world does a major crime occur without a criminal?," asked Viewpoint (Inquirer, 7/29/08) "Onli inda Pilipins."

Many scams disappear in amensia's pits: from 1,353 overpriced but lightless street lamps installed, during Asean's Summit, funneling of Girl Scout funds into a congresswoman's personal account to; kickbacks in text-

books, etc...

The press does a yeoman's job of exposing these finagling. But does our job end there? "We're always moving on to the next thing," a broadcast executive noted. "Hence, we really never develop a vocabulary for sustained coverage."

Officials must be held accountable. In ancient Rome, the engineer would stand under an arch when the last capstone is put into place. Accountability in today's government is possible only if the press dispels annesia. Follow-up ensures. "permanent ghosts, stamped, inked, imprinted, (are) eternally seen."

Newspapers are now developing checklists. They track how a scam develops or fizzles. That shapes the tough follow up questions. AsSaul Bellows stressed: "Memories keep the wolf of insignificance from the door"

City Government of the needed revenues for public services and facilities, aside from unduly altering the existing plans and uses of certain communities and zones prescribed by the law, issuances, local ordinances and resolutions," the resolution added.

At the same time, the resolution enjoined the said developers to comply with the requirements by applying for development permit, final approval of subdivision, certificate of registration and license to sell with the city government.

Cosalan said the HLURB had recently furnished the city government a list of subdivisions monitoring without certificate of registration and license to sell.

As a requirement, the developers need to apply for a development permit and final approval of the subdivision from the city government which will be the basis of the HLURB in issuing the required certificate of registration and license to sell.

In the resolution, the city directs the city planning and development office and the city buildings and architecture office to issue the necessary notice of violation to the subdivision developers which were listed as delinquent by the HLURB.

The said offices were also urged not to issue locational clearances, building, excavation and other permits to said erring developers./aileen p. refuerzo

though the mode of filling such vacancy is prescribed by the Constitution, yet the incumbent only holds until the time arrives for filling the office in the regular mode and at the regular time prescribed by the Constitution." He explained that Section 9 of Article XI of the Constitution provides for the appointment of the Ombudsman and his or her deputies, which includes the President choosing from a list of at least six nominees prepared by the Judicial and Bar Council, and from a list of three nominees for every vacancy thereafter. Section 11 of the same article provides for their terms of office, which is seven years, Escudero said.

"So the Office of the Ombudsman fits the rule enunciated by the Supreme Court in its 1955 decision. It has not been overturned so it is still binding and absolutely enforceable," the senator said.

Put simply, Escudero said that it is the Office of the Ombudsman that has a fixed term of seven years and not the person occupying it.

"Therefore, to say that Gutierrez has only until October 2009 to serve as Ombudsman rests on firm and solid legal basis. This is a Supreme Court decision and all of us must follow the rule of law," he said. Gutierrez is now facing possible removal from office as an impeachment complaint had been lodged against her at the House of Representatives.

"I hope she makes the most out of her remaining days in office by sending the biggest crooks in government to jail," said Escudero./ Office Of Senator Chiz Escudero

ment is in contrast to the global reality of women hardly making it to the top of their organizations.

"New research from Grant Thornton International reveals that women still hold less than a quarter of senior management positions in privately held businesses globally," according to the IBR's press release about its 2009 report.

The IBR added that only 24 percent of senior management positions are

currently held by women – "a figure identical to 2007 and only a marginal improvement from 2004 when only 19% of senior level positions were held by women."

The Thornton IBR 2009 also lamented that "34% of privately held businesses globally have no women in senior management."

The Grant Thornton International Business Report is an annual survey of the views of senior executives in privately held businesses (PHB) all over the world. Launched 17 years ago in 1992 in nine European countries, the report now surveys over 7,200 private businesses in 36 economies providing territory, regional and global trend data on the economic and commercial issues affecting a sector often described as the 'engine' of the world's economy."/PIA

mum of 12 years depending on the gravity of the offense.

The bill defines torture, involuntary disappearances and other cruel and degrading treatment or punishments, and penalizes the perpetrators of such acts. It also provides for the protection of complainants and witnesses and persons involved in the prosecution and the establishment of a rehabilitation program for victims.

The 20-year old Pitao is the daughter of Kumander Parago, head of the New People's Army's Pulang Bagani Command. She was abducted by unidentified armed men while on her way home from St. Peter's College in Toril District in Davao. She was later found dead in a ditch, her body showing signs of torture, strangulation, rape and stabbing.

Escudero reiterated his call for the capture of Rebelyn's killers, saying those responsible should be made to answer for their atrocious acts.

Under the bill, no justification can be offered to justify torture and other inhuman punishments, which will be declared as criminal acts. Persons who participate in acts of torture will be penalized as principals, as well as their superiors in the military, police or law enforcement establishments who ordered the infliction of physical harm to any victim./Office Of Senator Chiz Escudero

center amid the Panagbenga celebration last March 2. Last year, another portion was razed in another blaze.

"The recurring fires at said area are unavoidable due to the rapidly deteriorating state of the market exposing market frequenters, mechants and tourists to the risk of being caught in another mishap. Aside from being a fire hazard, it poses danger to health and life as it also has become a health and peace and order risk," the mayor noted in Administrative Order No. 50 which created the said team.

He said the Regional Trial Court has upheld the validity of the contract between the city and the Uniwide, a decision that dissolved the temporary restraining order that prevented the city from pursuing the deal with Uniwide.

He said the Local Government Code also authorizes local government to do actions that are "essential to promotion of general welfare,"... "promote health and safety,"... and "preserve the comfort and convenience of their inhabitants."

"These alarming condition of our iconic Baguio City Public Market needs to be addressed immediately, hence the need to create a team to take necessary steps to avoid these destructive and injurious occurrences from taking place yet again," he said.

Rabanes said that three possible actions can be expected from Uniwide which are either to push through with the development, form a consortium to undertake the project or sell rights over the project.

The city's talking points will be open to all possible measures that would lead to the development of the market which is long overdue.

The mayor had earlier expressed preference for Uniwide to cede the development project to the city government so the city can have the freedom to chart the development on its own./ aileen p. refuerzo

able to take advantage of the coffee boom in the country in the mid 80s.

There was scarcity of public utility vehicles then (the Refaldas reside in Gawidan, Bagumbayan which is about 35 kilometers from town), in 1986, she was challenged to buy a second hand Ford Fiera, the first ever indication that her family was beginning to progress. For fear of being held up when she goes home late, Antusa decided to buy a house and lot in Dagupan Weste, their present residence in the city proper. She said that it was a product of their earnings from coffee and savings from the salary of her husband.

Over the years, they acquired an additional five hectares of land and planted 2,500 Arabica coffee, now fruit-bearing. In 2005, she was awarded the ARB Female Entrepreneur during the Agraryo Trade Fair.

In the 1990s, she joined an educational trip organized by KALINGA Coffee growers and the DTI to places where coffee mills were being fabricated. In one farm owned and managed by a coffee processor in Batangas, she was surprised to see a sack with her name among those being classified and later labeled as Batangas coffee. This prompted her to come up with the idea of establishing her own processed coffee. She was also challenged with the thought, "If the Batangas farmers can, why can't we?

She actively participated in trainings, trade fairs provided by DAR, Nestle, DTI, DOST and LGU. She was able to purchase a roasting machine and other equipments for her processing plant from the P300,000 loan she availed from the Small Business Guarantee Fund of DTI.

In 2003, she started producing Kalinga Brew packed in cacha bags designed by Design Center of the Philippines (DCP). Antusa said her first paper packaging received a lot of criticisms from customers, thus she approached DAR and DOST for the redesigning of Kalinga Brew packaging. Antusa also admitted that for the first three years of coffee processing, she did not have a good return of investment (ROI). She reasoned out that probably, it was because she was still perfecting the product.

But she remained undaunted. She has complete faith in her technology, which she says is her own. "My blend is my own, no preservatives. My product is unlike the instant coffee, which has a lot of aroma but has a bland taste. The coffee roasting process which is done five hours is also my edge." With a glow in her eyes, she gladly says, "it really take a lifetime to reach our dream and it's not always the financial benefits that keep you craving for more but the lessons that you learn along the way."

Kalinga brew is one of the selected local products of Kalinga exhibited in regional and national trade fairs like the Impakabsat, OTOP exhibit, Philippine export, international food fair at the World Trade Center and last week at the national trade fair held at the Mall of Asia. Antusa also brought her product to Macau, Hongkong and China. Aside from walk-in sell-

ers and her own outlets in the province, the product has gained entrance in known city supermarkets and hotels around the country.

"Modesty aside, my coffee business reached a phenomenal profit and is well earning, Antusa said./PIA-Kalinga w/ Jocelyn Bengwayan of *DAR-Kalinga*

in public places designated for the said celebrations.:"

As proposed, the city mayor's office through the public order and safety division in coordination with the city police, city treasurer's office and the city council committee on market trade and commerce will be tasked to monitor compliance by the organizers.

Printed advertisements of liquor and cigarette or gambling companies sponsoring any of the activities will be posted only in designated areas as approved by the city engineer's office and no such materials will be posted within the premises of the festival site.

Proposed penalties are immediate stoppage of the activities or removal of illegal advertisement materials upon discovery of the violation; fine of P5,000 if activities continue after four hours of due notice to stop or remove the materials; and cancellation of permit if activities continue after 24 hours of issuance of stoppage and removal notice.
