Bill Hurdles Committee Freedom of 1

(FOI) is seeing some light after it hurdled committee approval last week, March 3, 2015.

Baguio Representative Aliping announced the approval of the FOI Bill by the Committee on Appropriations where he is a member for the majority.

The FOI was co-authored by Aliping. Principal author is another Cordilleran Ifugao Representative Teodoro Brawner Baguilat, Jr.

Aliping said he is "hoping this approval by the Committee on Appropriations will finally escalate the deliberation of the bill leading to its passage".

Aliping is also appealing that the bill be certified as urgent by the President that it may see passage the soonest.

"The Freedom of Information bill has already gone through a very long legislative history," he said. "Malacanang has also provided its inputs and presented its own version. There is no more reason to delay the passage of this Bill. It is high time that we afford our people the Freedom of Information Law.

Aliping said that the Constitution provides the people with the right to information, however, government agencies have been left to devise their own, often stringent, restrictions, making it diffi-

NBI Intensifies Drive Against Bilog Bares Most Active, Peddlers of Spurious Land Least Active City

Under the leadership of ATTY. ROMULO Titles Under the leadership of International Director, NBI-CAR, operatives of the Bureau conducted successive entrapment operations that led to the arrest of several persons while receiving the proceeds of loans they secured using spurious titles as collateral.

The first entrapment operation on February 11, 2015 led to the arrest of BUDDY WONG MILANES, a resident of Baguio City. Initially, MILANES lured complainant STEPHEN DV GALERA to accept a Transfer Certificate of Title (TCT) over a parcel of land in La Trinidad, Benguet as collateral for a loan. MILANES received a total of Php290, 500.00 from GALERA. However, when GALERA verified at the Office of the Registry of Deeds, he found out that the TCT is fake. Ironically, MILANES was not satisfied with the amount he initially took from Complainant and he contacted the latter to seek an additional loan using the same title as collateral. This time, GALERA sought assistance from NBI-CAR, whose operatives wasted no time in setting up the entrapment of MILANES. He was later arrested after he received the entrapment money during the sting operation at Malcolm Square, Baguio City.

On March 10, 2015, the group of EVELYN B. ALBERTO, KRISTA A. MALIONES, HASHLY A. BALAG-EY (who used the alias MAGDALINA CAYETANO, KAREL JANE ABAYA and RUBEN A. SALMING, respectively) and JOSEPHINE T. DANGPA were arrested at the office of a Notary Public along Session Road, Baguio City. Earlier, ALBERTO was able to defraud Php725,000.00 from Complainant JOSIE P. PUDDONG by obtaining a loan and using several TCTs of various properties in the Province of Benguet as collateral. When presented at the Office of the Registry of Deeds of Benguet, it turned out that the TCTs were fake. Despite having a large loot, ALBERTO was not contented and she introduced BALAG-EY to Complainant on the premise that the latter wanted to seek a loan of Php250,000.00 using TCT No. 016-2012001732, which allegedly pertains to a property in La Trinidad, Benguet. This prompted PUDDONG to go to NBI-CAR to report the matter. An entrapment operation was carefully planned wherein ALBERTO, BALAG-EY, MALIONES and DANGPA were arrested after the parties executed a Real Estate Mortgage Agreement and their group received the entrapment money.

In a related operation by NBI-CAR on March 4, 2015, one ADRIAN B. PADILLA was arrested for selling a lot in Baguio City using falsified public documents. Complainant GLENNYLENE F. ROMERO saw an advertisement at the website of WWW.OLX.Ph regarding a 300 square meter lot in Guisad, Baguio City that is for sale. When she contacted the advertisers, the group of JOSE B. TEJADA, ADRIAN B. PADILLA and MARILOU PADILLA appeared and claimed that they were brokers who were authorized by the registered owner, RAFAEL O. JAPA, to sell the lot. To convince complainant, they presented an Irrevocable Special Power Cont. on page 8

Lawmakers BAGUIO CITY - Vice Mayor Edison Bilog Monday revealed the list of City Councilors who have registered a perfect attendance in all council sessions and those who fell short of it.

From among the 11 lawmakers, only two registered a perfect attendance from the 40 regular sessions and 4 special sessions conducted from January to December of 2014.

Registering a perfect attendance are Councilor Peter Fianza who chairs the Committee on Education, Culture and Sports and Councilor Leandro Yangot, Jr. who chairs the Committee on Lands, Housing

The Vice Mayor said he should have also registered a perfect attendance if he was not legally prevented from attending two council sessions.

It can be recalled that Mayor Mauricio Domogan issued Administrative Order No. 83 series of 2014 designating Vice mayor Edison Bilog as 'Acting City Mayor' from July 28 to August 8, 2014 during the latter's official travel to San Jose California for the 58th Annual Conference of the Sister Cities International Conference and trade mission to Los Angeles, California to visit the existing waste to energy facility. Mayor Prioritizes Collapsible Parking, Not Carnival in

Jadewell Area BAGUIO CITY – a garden in the Ganza area will have to wait it out.

This was revealed by Mayor Mauricio Domogan during the Weekly Ugnayan Presser Wednesday after a proponent submitted a proposal to the city government to transform the area into the Baguio City Amusement

The proposal is conceptualized as a mini-carnival which would incorporate the provision for non-permanent steel structures for fun rides and the installation of stalls that will run from March to June, 2015.

The proposal for the amusement garden was received February this year and was forwarded to the Committee on Market, Trade and Commerce chaired by Councilor Elaine Sembrano for recommendation and appropriate

The mayor said there is still a problem regarding the use of the former Jadewell parking area which has a pending writ of execution.

"There is an unresolved issue on this, if we let them operate they might say that we are pre-empting the decision of the court in the motion for execution filed by Jadewell," Domogan said.

Domogan added, "if the city government will get the consent of Jadewell, it might be interpreted that I am agreeing that Jadewell has the right to operate, "he said.

"I told them that the safest thing to do is to wait for

the ruling on the motion for writ of execution," he said.

Domogan also said, "in the meantime, he has already ordered the technical team to bid the area to interested investors for a collapsible temporary parking which he said is allowed under the contract between jadewell and the city."

Meanwhile, the action of the Committee on market, Trade and Commerce on said proposal is still being awaited and will have to be deliberated in the council. /Paul Rillorta

Dads Cautious on Fund Drive for Brgy Tanods

BAGUIO CITY - the Committee on market, Trade and Commerce chaired by Councilor Elaine Sembrano has put forward its recommendation on the request for a two-month long trade fair in the city's premier park here.

The Liga ng mga Barangay-Baguio City Chapter is requesting the City Council to allow them to put up a trade fair at the Juan Luna Drive which is targeted to be part of the Summer Activities.

The Liga as per Board Resolution No. 9 series of 2015, strongly urges the city government to allow them to conduct a trade fair starting March 15 to May 15 for the purpose of raising funds for the benefit and provisional grant of honorarium for barangay tanods and street sweepers of the 128 barangays of the city.

This stemmed from a directive and memorandum from the Commission on Audit (COA) directing that honorarium granted to barangay appointees specifically tanods and street sweepers should now be charged against Personnel Services (PS) account and no longer under the Maintenance and Other Operating Expenses (MOOE).

The Liga said majority of the 128 barangays could no longer apportion an allocation for the honorarium of their respective appointees due to limited and meager budget which has initiated some barangays to request Councilor Roberto Ortega, Chair on the Committee on Peace and Order and Liga President Councilor Michael Lawana to author an ordinance which would subsidize the honorarium of barangay tanods with limited funding.

The resolution also states it is expected that identical propositions and actions from other districts of various barangays will be flooding the city government urging the latter to act on the

The Liga said the conduct of a trade fair is deemed most convenient, reasonable and practicable means by which the latter may aid the 128 barangays purposely for the benefit of tanods and street sweepers.

The said board resolution is supported by the Federation of Barangay Tanods-Baguio Chapter where tanods dwindled from 960 strong to only 200 this year due to lack of funds.

The move is also supported by Burnham-Legarda Barangay which crafted a resolution supporting the same.

However, The Committee on Market, Trade and Commerce has the following observations with respect to the proposed trade fair.

The two-month timeframe patently violates the 15-day timeline restriction provided under section 2 of Ordinance No. 13 series of 2012 or the Trade Fair Ordinance and is also violative of the venuerestriction which states; 'to totally disallow the conduct of trade fairs and other similar activities in all city-owned or city managed public parks."

The committee also states the goal which is to raise funds for the benefit and provisional grant of honorarium for barangay tanods and street sweepers is noble but it cannot justify the patent violation of an existing city ordinance.

The committee also notes there is no provision for a trade fair for the summer activities (SUMVAC) and in fact has never had any trade fair as part of the activities.

The committee suggests other law-abiding means of fund-raising activity should instead be fostered.

Meantime, Mayor Mauricio Domogan said, "it is still awaiting the deliberation of the city council regarding the issue and maintains the existing city ordinance should prevail." /Paul Rillorta

Mass Consultation on Tax **Increase to Push Through**

BAGUIO CITY - The city council will proceed with the planned mass consultation on the proposed tax increase soon to explain the proposal and get the sentiment of the various sectors on the proposed adjustments in the business and real property taxes.

This after Councilors Betty Lourdes Tabanda and Richard Carino reiterated the body's action in October last year tasking the council committee on ways and means cluster B under Vice Mayor Edison Bilog to schedule a general public hearing on the issue instead of pocket consultations to save on time and resources.

The consultation will be held either in the last part of March or early part of April depending on the availability of the venue at the Convention Baguio Center.

The aldermen earlier opted for a common hearing to also ensure that complete facts will be presented to the public to avoid confusion and misconceptions.

Mauricio Mayor Domogan last year sought a speedy consultation for the city and the people to "strike an agreement on what is reasonable to both the city and the taxpayers.'

He said the city is now obliged to implement the increase after years of stalling to make the antiquated rates attuned with the times and with the requirements of the law.

The city is eyeing a 10 percent increase in business taxes under Tax Ordinance No. 2000-01 including city market rental and fees and garbage charges which were last adjusted in 2001 or 13 years ago.

The mayor said the rates are now outdated and must be revised to keep up with the prevailing charges now being levied by nearby cities like Urdaneta and Dagupan in Pangasinan and San Fernando City in La Union which impose business taxes higher by as much as 500 percent than the

The Moro Islamic Liberation Front should lay down arms, sever ties with terror groups and abide by their commitments during the peace process.

These are the conditions given by Senator Alan Cayetano, in a privilege speech Wednesday. Given these, he called for a continuation of peace talks following a one year probationary period for the MILF to comply to these conditions.

"Yes, we need and want peace. But PEACE on paper will remain just a piece of paper if we do not DISARM," said Cayetano.

Cayetano cautioned that while government continues to push for peace in Mindanao, he has received reports the MILF is building up arms and recruiting new members. He also showed documents supporting claims the MILF knowingly harboured international terrorist Zulkifli bin Hir

"To the MILF....Put down your arms and prove to us that you have truly turned your back on terrorism," Cayetano said. "Dismantle your weapons factories, stop building new camps and allow for a comprehensive inspection by a neutral international team. Finally, surrender or join government forces in hunting down Usman and Umbra Kato and all terrorists in your areas.

At the same time, Cayetano reminded government that even though the BBL is important, the attainment of justice for the police Special Action Force commandos killed in Mamasapano and the preservation of the nation's integrity are para-

"We must focus not on the BBL, but on building a Just, Inclusive and Lasting Peace," Cayetano

Cayetano earlier withdrew his support of the BBL, following the Mamasapano massacre, and offered the first alternative to a rushed passage of the flawed BBL./Office of Senator Alan Peter Cavetano

City assessor Nilda Navarro, in an endorsement dated Feb. 13, re-Mayor ported to Mauricio Domogan that the proposed updated schedule of fair and current market values for land, buildings and machinery in the city for the period 2015-2017 was reviewed by the BLGF and was issued a certification that it complied with the Local Assessment 1-04.

Cayetano to MILF: Lay Down Stop Political Vilification of Activists. Uphold People's Democratic Rights members and

Alliance (CPA) and the Ifugao Peasant Movement (IPM) raise our strong concern over the heightened political vilification against community organizers, members and leaders of people's organizations by suspected State security forces in Ifugao province. Pictures of active members of people's organizations and community organizers are being circulated in certain social media groups in Ifugao that are labeled with malicious, baseless and libelous statements that these people are members and sympathizers of the New People's Army. This is clearly an act of political vilification which violates basic rights to life, liberty, security and due process of individuals and organizations.

This is not the first time that IPM, its members and officers are targeted for political vilification. In October 2012, a Target List released by the 86th Infantry Battalion surfaced in Tinoc, Ifugao. The Target List bore names of 28 individuals that are members of people's organizations and residents of Ifugao. William Bugatti was on this list before he was extra judicially killed on March 25, 2014. In February 2014, posters with the heading "Rupa Ken Nagan ti NPA nga Agsusuweldo" (Faces and Names of the New People's Army Receiving Salaries) were posted in the market and waiting sheds of different municipalities in Ifugao by suspected State security forces and their agents. The posters unjustly tagged leaders of people's organizations, including the CPA, IPM and the Cordillera Human Rights Alliance, and party lists as enemies of the people.

The IPM firmly believes that the continuing political vilification against its organizations,

The Cordillera People's leaders is a desperate move by suspected state security forces and proponents of big energy projects to silence the people in their defense and assertion of their basic rights over their ancestral lands and natural resources.

> Those behind this political vilification are deliberately hiding their true identities under fake names. In all the internet posts, fictitious names are used to malign IPM. its members, leaders and advocates of environment, human rights and indigenous peoples. The perpetrators are afraid of their own shadows and cannot even stand by their accusations. Who would have the interest and capacity to spend time creating fake names on social media, tailing people on their daily activities, secretive taking of photos of innocent individuals and posting in social media, and making graphics to forward its narrow and dim-witted ideas? The Ifugaos are hard-working people and would spend their time trying to make ends meet rather than involving themselves into these dirty tricks. The answer is clear. Only state security forces and their agents have the motive, and spending time and people's money to support these forms of political vilification. History and past experiences reinforce this trend of political vilification.

The accusations against IPM and advocates of environment and human rights as members, supporters and even calling them as enemies of the peoples are a product of concocted lies and unfounded facts by suspected intelligence operatives of state security forces in their attempts to discredit progressive organizations and individuals. As a matter of fact, IPM as a

BOI: Mamasapano Report Presents 'true' Picture

One step closer to the truth, or at least a semblance of it.

A month and a half after a police operation ended in the death of 65 people, including 44 elite cops, an independent body composed of police officers has finally submitted its report to Philippine National Police (PNP) Officer-in-Charge PNP OIC Deputy Director General Leonardo Espina.

In an interview with reporters prior to the submission of the report on Thursday, March 12, PNP Board of Inquiry (BOI) and Criminal Investigation and Detection Group (CIDG) chief Police Director Benjamin Magalong said an initial 5 copies will be ready by Thursday afternoon.

The copies were turned over to Espina, followed by a presentation by the BOI. Espina will then submit the report to Interior Secretary Manuel Roxas II, who ordered the creation of the BOI.

The first 5 copies will be submitted to the PNP OIC, Roxas, the House of Representatives, the Senate, and the Office of the Ombudsman.

It remains unclear if the report, or at least its summary, will be released to the public by Thursday, but Magalong said they were "ready" to present it to the public should they get clearance from Roxas.

"[Secretary Roxas] would also like the result of the investigation to be released. Kung kami lang tanungin ninyo, gusto na naming ilabas (If it were up to the BOI, we want it to be released right away)," said Magalong.

Roxas is expected to present the report to President Benigno Aquino III.

Magalong declined to give any details of the report pending clearance from higher uthorities.

Among the chapters of the report seen by reporters as the BOI members signed the document are the following:

Up to 100 copies of the exhaustive report will be created, said Magalong. The BOI would have to sign each copy one by one.

Magalong and a team of 6 other police generals, colonels, and a major, prepared which would be, thus far, the most comprehensive investigation of the incident. The Armed Forces of the Philippines (AFP) head earlier come out with its own probe that only covered the involvement of their troops.

'Transparent, truthful' report

Magalong expressed confidence that the body was able to ferret out the truth regarding the operation, as he brushed aside speculations of a whitewash.

Responding to questions, he said: "Makakatulog kami nang maayos at haharap

Responding to questions, he said: "Makakatulog kami nang maayos at haharap kami sa mga tao na hindi kami nahihiya. Haharap kami sa family ng SAF at mga namatayan, na at least masabi namin sa kanila na katotohanan ang aming hinangad sa aming imbestigasyon."

(We can sleep soundly at night and we can face the people without any shame. We will face the families of the SAF, of those who were killed, and at least we can tell them that we aimed for the truth in our investigation.)

He added, "We are confident that it (the report) will enlighten everybody as to what happened."

Asked whether the President's statement before evangelical leaders had any impact on the BOI, Magalong said that they did not pay any attention to it. He said they did not feel "any pressure" from anyone while conducting the investigation.

On January 25, 392 troopers from the PNP Special Action Force (SAF) entered barangay Tukanalipao in Mamasapano town, Maguindanao, to neutralize bomb makers and terrorists Zulkifli bin Hir or "Marwan," and Abdul Basit Usman. Marwan was killed while Usman fled.

In what was apparently a botched exit plan, members of the 84th and 55th Special Action Companies (SAC) – the striking and main blocking forces – encountered fighters from the Moro Islamic Liberation Front (MILF), its splinter group the Bangsamoro Islamic Freedom Fighters (BIFF), and Private Armed Groups (PAGs).

"Oplan Exodus" is the bloodiest one-day operation in PNP history and is the biggest crisis in the Aquino administration. Its effects go far beyond the fields of Mamasapano.

The operation – kept a secret from the Armed Forces of the Philippines (AFP) – pitted the two forces against each other. Police officials and SAF troopers themselves have questioned why the AFP was unable to send artillery support to the beleaguered SAF, while the AFP argues it did not have enough information the morning of the clash on January 25.

It has also imperilled the passage of the proposed Bangsamoro Basic Law, the culmination of years of negotiations between the government and the

MILF. The passage of the law would lead to the creation of new Cont. on page 8





the defendants should be adjudged to pay the plaintiffs exemplary damages in such sum as the Honorable Court may determine.

4.06. The plaintiffs, repeatedly, and for years, exerted earnest efforts to arrive at a compromise with the defendants, but the latter refused to cooperate. Because of this plaintiffs were constrained to litigate on the matter to protect their right and interests. Accordingly, the defendants should be made to pay attorneys fees in the amount of Three Hundred Thousand Pesos (P300,000.00) and Ten Thousand pesos (10,000) per lawyer for every appearance, plus the cost of litigation.

PRAYER WHEREFORE, it is respectfully prayed of the Honorable Court that Judgment be

implementation of the 'Salaknib ti Waig' program."

The 'Salaknib ti Waig' program is a continuing environmental management program of the city government patterned with the DENR 'Adopt an Estero' program which aims to sustain waterways protection initiatives by tapping the assistance and support of partners from the public, private and community sectors being implemented by the City Environment and Parks Management Office (CEPMO).

Bilog said, "in connection with the Salaknib ti Waig program, the city council adopted a resolution recommending to the DENR Secretary thru the Environmental Management Bureau-Cordillera, to designate the Bued River as Water Quality Management Area in accordance with Republic Act no. 9275 otherwise known as the Philippine Clean Water Act of 2004.'

"Your legislators have also been mindful of the need to maintain a pollution free environment and this was manifested with the adoption of a city resolution confirming the Memorandum of Agreement for the installation of an Air Quality Monitoring System at the Burnham Park," he said.

A MOA was entered into by Mayor Mauricio Domogan representing the city government and EMB-CAR for the installation of the PM 10/1.2 air monitoring station to continuously record the ambient air quality of the city in compliance with the Philippine Clean Air Act of 1999 sometime last year.

Other notable resolutions passed are the adoption of the Baguio City Disaster Risk Reduction and Management Plan for 2014 to 2016 which is seen as more responsive to the needs of the city in terms of disaster preparedness and the confirmation of the MOA between the city government and the United Nations World Food Programme for the implementation of the WFP-funded disaster preparedness and response/climate change adaptation programme approved as part of the third phase of the technical support to the government for disaster preparedness and response activi-

The council also passed city resolution 216 appealing to President Benigno Simeon Aquino III to take cognizance of Department Circular No. 1 series of 1990 of the DENR whereby applications covering areas within city land needs for public purpose shall be rejected, and the city land needs shall take precedence with the applicants notified accordingly.

The council hopes the measure will protect the remaining public lands identified belonging to the city

On health, the council adopted resolution 160 confirming the MOA between the city government and the DSWD, field office for the continuing feeding program of the city and enacting city ordinance 32 which tends to regulate the participation of children during parades.

The council also passed resolution 53 requesting the 128 barangays to supervise and monitor various convenient stores and ambulant vendors within their jurisdictions in selling tobacco products within 100 meters from schools and see to it that signages are placed informing the public that selling tobacco products to persons under 18 years of age is prohibited.

Bilog said, "other resolutions passed include urging the city government to intensify thru appropriate agencies, the conduct of handicraft skills training for livelihood purposes and Ordinance 68 creating the Baguio City Sports Promotion and Development Council supplementing efforts towards the realization of the city's sports code, a technical committee was previously created by virtue of Administrative order 95 series of 2011 by the mayor."

He already underwent three chemotherapy sessions costing P17,150 each and has three more to go against the disease. If it's any blessing, his condition was diagnosed to be at stage II, an indication that his chances at survival is good, provided he would undergo the six-chemotherapy protocol prepared by oncologists at the Baguio General Hospital and Medical

Like any debilitating disease, however, cancer and the chemotherapy sessions one has to undergo suck out one's ability to work.

"His wife could not work for they have a baby to take care of," noted Cont. on page 9



SP Reports Prioritizing Environmental Laws in

2014 BAGUIO CITY - lawmakers in this mountain resort has prioritized the passage of appropriate legislation which has greatly contributed to the benefit and welfare of the people

This was revealed by Vice Mayor Edison Bilog during Mondays regular flag raising ceremony where he publicized the Sangunian Panlungsod's accomplishment report for the year 2014.

Bilog said, "the city council was able to pass 73 ordinances and adopt 351 resolutions among which are laws which sustains the campaign to preserve, maintain and protect the fragile environment of the

"One particular alarming environmental concern which your Sangunian has paid particular attention to is the continuing depletion of our ever dwindling and scarce water supply," he said.

Bilog said in order to address the problem, the Sangunian adopted several resolutions to protect the remaining water sources one of which was a legislative measure that would allow the city government to be an intervenor in all water rights permit application in the City of Baguio.

This originally stemmed from an earlier complaint from concerned barangays regarding a water rights permit application filed by the BCDA over water sources within the Camp John Hay reservation, "Bilog said. "It is our hope that by interceding in these water rights permit applications filed with the National Water Resources Board (NWRB), the city government can formally express its opposition and perhaps even convince and persuade the NWRB to deny these applications, "he stressed.

The city government sees the need to urgently protect the remaining water sources especially underground sources from depletion as it the biggest source of drinking water for residents.

Bilog added,"another important accomplishment is the confirmation of Memorandums of Agreement established between the city government and various agencies, educational institutions, non-government organizations, other private groups and barangays for the promotion and Cont. on page 9
