

### Reappointment to the Judicial and Bar Council to be banned

Representatives has approved on second reading a measure banning the re-appointment of a regular member of the Judicial and Bar Council (JBC) who has already served the full term.

Baguio Representative Nicasio M. Aliping, Jr, co-author of the measure said "House Bill 6040 disqualifies a regular member of the JBC from being reappointed to the same position in any capacity once said member has served the full term of office."

"The disqualification shall also apply to any person who has been appointed and has served the unexpired portion of at least two years of the term of office of a regular member who has ceased to become one by reason of death, incapacity or resignation," he said.

The Judicial and Bar Council of the Philippines is a constitutionally-created body that recommends appointees for vacancies that may sion on Appointments.

> Aliping said the bill seeks to ban the re-appointments to the JBC to avoid the possibility of instances where its members, in their desire to be reappointed to the Council, may succumb to pressure from the executive to nominate individuals based on political considerations instead of their actual merits and qualifications, seriously undermining the quality of judicial appointments and the independence of the judiciary as a whole.

He said the measure shall enhance the independence of the Judiciary by insulating it from political pressure.

One of the key provisions of the bill enumerates the regular members of the JBC as provided under Art. VIII, Section 8 (2) of the 1987 Constitution, who shall be appointed by the President for a term of four (4) years with the consent of the CommisSupreme Court, and rep-

# Aquino should be impeached, then jailed with Roxas over Mamasapano

President Aquino 3rd's sudden reference to an "alternative truth" to the massacre of 44 Special Action Force troops in Mamasapano convinces me – again – that there is something deeply wrong in this person's psyche.

Was the Mamasapano massacre such a trauma for him, over which he has been probably having psychotic nightmares, that he wants to create an entirely different narrative of that day of infamy for our Republic?

Or is he so afraid that he won't escape accountability in the next administration that he wants to change while he is in power the accepted, proven accounts of what happened in Mamasapano, Maguindanao, on Jan. 25, 2015?

# EDITORIAL Trial hearings of defendants accused of the massacre of 58 people in

The President's favorite newspaper Philippine Daily Inquirer, as usual, jumped to Aquino's aid by running "alternative" narratives of the massacre in its front pages the next two days.

One was woven by the Moro Islamic Liberation Front which claims that the terrorist Marwan wasn't killed by the SAF, but by his own aides, who were after \$5 million bounty on his head put up by the US. That certainly robs the SAF of their victory, and makes the massacre of the 44 useless. That fits with Aquino's implicit narrative that the SAF were massacred because their leaders didn't coordinate with the army, and even were foolhardy to risk talks.

Yesterday the other "alternative" narrative reported by the newspaper implies that the SAF weren't really as good a force as they were depicted. Either US operatives or their mercenaries directed and undertook the operation, with two even killed in it.

The article according to the newspaper, was based on a video clip by an identified "TV journalist". This is rather strange since any journalist whether local or foreign, print or broadcast would claim such a scoop for his own, and not give it to another news outfit.

This is disgusting.

The massacre of our best fighting men the SAF 44 is one of the worst failings, if not the very worst failing, of Aquino.

Pretending nothing was happening? Aquino, Roxas, and Gazmin midday in Zamboanga City January 25, 2015, while SAF troops were pinned down in Mamasapano, Maguindanao, begging for help.

Aquino should be impeached, and after stepping down from office in 2016, he should be jailed for his complicity in the operations that resulted in 44 SAF troops massacred.

His right-hand man, Manuel Roxas 2nd, could have intervened to save the police's SAF, since the PNP was after all under his responsibility, as chairman of the National Police Commission. According to his sworn statements in the Senate hearings he was told of the operation early morning, and by mid-morning of the SAF's difficulties. He didn't lift a finger to give the SAF troops aid, even as he was with Aquino the whole day.

#### Roxas should be barred

And he wants us to elect him as commander-in-chief of all the Republic's armed forces? Forget every blunder he's done, forget his mismanagement of the MRT-3 and the Yolanda disaster management. His complicity in the Mamasapano massacre alone should bar him from having any public office, appointive or elective.

Aquino, Roxas, and the AFP chief Voltaire Gazmin were together in Zamboanga the whole day, yet they pretended that nothing was happening.

The details of Aquino's complicity have been incontrovertibly established as facts. They leave no room for any "alternative truths": Aquino was on top of planning ever since it was conceived



in mid-2014, and even had three meetings in Malacañang with suspended police chief Alan Purisima and then SAF head police chief superintendent Getulio Napeñas, and even intelligence officer Fernando Mendez. However it was illegal for Aquino have had as operations man his bosom friend, Purisima, who had already been suspended by the Ombudsman at that time.

For that, Purisima was charged by the Ombudsman for usurpation of authority. But it was Aquino who ordered him to usurp authority. Why isn't he made accountable? Could Purisima refuse an order of the President, his close friend?

He was on top of the entire operation as the tragedy was unraveling on January 25. He even boasted in an impromptu speech before the SAF two days later that "Maaga pa lang, tuloy tuloy na ang mga ulat na natatanggap namin." (Early in the morning, I was already receiving reports on the operation.)

He was with his top security officials in Zamboanga City that day, starting early in the morning up to dusk, on the pretext of checking on a bombing incident two days before.

His planned scenario though was for him to immediately to go to Cotabato City, an hour by helicopter, to congratulate the SAF troopers for their capture of the global terrorists in Mamasapano, and to boast how he himself was on top of he operation.

Yet even when he had received reports that the SAF troopers were pinned down and begging for artillery and air support, Aquino did nothing.

#### Stand down

It wasn't that he was stupid or was paralyzed to rescue the troopers. The chairman emeritus of this newspaper, Dante Ang, had reported based on his reliable sources that Aquino actually ordered the army to stand down, as their efforts to rescue the SAF troopers allegedly would risk his peace talks with the MILF. This claim has not been refuted.

Aquino and Purisima have covered up for the President's complicity. The transcript of Purisima's cellphone conversations with him that was submitted to the Senate hearing had a yawning eight-hour gap, which is impossible. No one in the Senate he controls, not even Senator Poe, had the guts to subpoena Globe or PLDT if in that eight hours, Aquino sent text messages or talked to Purisima.

Of course Globe and PLDT would not, as they have claimed, kept the actual text messages in their data bank. All that's needed are the logs whether Aquino and Purisima's cellphones were sending messages to each other during those eight hours, which the telcos explained they have (how would they charge you if they didn't?).

US President Nixon fell from power to a great extent because he could not explain an 18-minute gap in tapes of his conversations with his officials involved in the Watergate scandal. Here, Aquino and Purisima can't explain an eight-hour gap that could have established without a shadow of a doubt whether or not the commander-in-chief allowed his troops to be massacred.

Media Literacy Integration in the Philippines' Educational System (Part 2) BY: MARVIN WACNAG LIDAWA

Moreover, the United States had its early evolutionary ways of fostering media literacy to its populace whichfocused onthe ability to access, evaluate, produce, and critically analyze, media forms and media messages. Due to the outpouring advent of media technologies like "use of digital tools for constructing and communicating ideas online databases, blogs, Twitters, wikis, texting, podcasts, image repositories, and digital videos has evolved a completely new set of digital literacies that not all students necessarily possesses.' In 1989, Ernest Boyer the former president ofthe Carnegie Foundationfor the Advancement of Education (CFAE) and a former US Commissioner of Education stated: "it is no longer enough simply to read and write. Students must also be literate in the understanding of visual images. Our children must learn how to spot a stereotype, isolate a social clichéand distinguish facts from propaganda, analysis from banter, and important news from coverage." In 1996, the National Council of English Teachers (NCET) endorsed a resolution that "viewing and visually representing are a part of our growing consciousness of how people gather and share information. Teachers should guide students in constructing meaning through creating and viewing non-print texts." In 2008, NCTE recognized the importance of new digital /media literacies because to them, the 21stcentury demands literate persons to possess a wide range of abilities and competencies dictated by technology that has formulated the onset of new media.

Similarly, according to Pungente, J. (2011), 1987 was when media literacy started for the government of Ontario, Canada pioneered by groups of teachers from theOntario Association of Media Literacy(OAML) which formed a great part for Ontario's integration of media literacy in the curriculum under the Ministry of Education (ME) in the country.It was this time when media literacy has been mandated as a part of the English curriculum for grades eight (8 to) thirteen (13). In relation to it,eight(8)key concepts was adapted from Great Britain and Australia that provide theoretical bases for all media literacy on Ontario's provincial standards of integrating media to the educational curriculum. Thesekey concepts emerged from all media activities which offer teachers common language and frameworks for discussion of its acceptance to the curriculum; all media are made, media construct reality, audience negotiate meaning to the media, media messages have commercial implications, media messages contain ideological and value messages, media messages contain social and politicalimplications, formand content are closely-related with media messages, and its medium has a unique aesthetic form. The purposes of these key concepts are to be utilized as the main tools to be used to think critically about the media. Whatever ways these countries including the Philippines expressmedia literacy's objectives, all of them head towards one common purpose: the utilization of media's content and forms to achieve valuable effects.

Finally, itis high time for the Philippine Academe to take part of media literacy's nationwide campaigns. The attempt to integrate media education in the Philippines is a little too late but as media

of 1984 or an Ordinance adopting a Comprehensive Transportation and Traffic Regulations in the city particularly section 11, vehicles parked in undesignated areas will be towed.

Section 12 also states in order to prevent drivers and owners of vehicles from further violating the land traffic laws, both plate numbers of vehicles parked and unattended in 'No Parking' areas shall be detached and a traffic citation ticket shall be attached to the windshield informing the driver or owner of his violation.

There are also existing City Ordinances prohibiting 'on-street parking' and signages are in fact installed

However, due to the absence of parking spaces in these areas, motorists are forced to park on the streets.

The SP Research division also observed the traffic personnel cannot ensure the full enforcement of the ordinance at all times due to lack of manpower.

In order to cope with this, the Traffic Management Branch of the BCPO patrol said areas during rush hour.

The team also observed business establishments along these areas have limited or no parking spaces for their customers.

Establishments, schools including residential houses are mandated to have their own parking areas and not on the city's roads.

How could they become catalysts of instructions when their students have advanced knowledge than they are? utilization, the fund shall be used for "actual expenses, including the payment of premiums for the posting of bail bonds and cash advance for expenses by indicted public employees and officials.'

The fund will be used for the "defense of administrative, civil or criminal cases filed against them in courts for acts committed in the performance of their actual functions," the provisions further stated.

Escudero, however, wants the provisions clarified because the proposal is vague and the scope too broad.

"Even the ambit of the cases covered is unclear. If you go by the language of the special provisions, even those charged with graft and corruption can apply for bail money and charge the lawyer's fees to the fund," he pointed out.

"If this fund will be used to help employees or officials who are sued in connection with the performance of their official functions, I'm all for it, but never for rape, never for graft and never for murder." the senator added.

According to Escudero, there is an existing legal fund available to government employees and officials who are hauled into courts for acts committed while performing their jobs.

# WACS completion to jumpstart waste management system

BAGUIO CITY - The city will fast-track the completion of the terms of reference (TOR) for the Integrated Solid Waste Management System (ISWMS) with the completion of the waste analysis and characterization system (WACS), the main requirement to jumpstart the city's garbage program.

Mayor Mauricio Domogan on Wednesday said the WACS was presented last Tuesday with the finding that the city's daily waste production has reached 402 tons.

The mayor said as per the WACS, 100-130 tons of wastes are being disposed at the engineered sanitary landfill in Capas, Tarlac while 30 tons are being processed by the Environmental Recycling System (ERS) machines.

'More or less 55 percent of the wastes are being recycled and the remaining percentage is being disposed in the various barangay disposal systems, he said.

With the completion of the WACS, the city can now finish the TOR for the ISWMS, a multi-strategy program for the long-term solution of the city's garbage problem.

"We hope that we can finish the TOR for submission to the city council so that if approved, we have it published for bidding," the mayor said.

City general services officer Romeo Concio of the City Solid Waste Management Board said the WACS serves as basis of all solid waste projects in the city and even the ten-year solid waste management plan as it contains primary data needed to determine the viability of solid waste projects and thus is essential to the implementation of the ISWMS.

The ISWMS is a multi-strategy program for the long-term solution of the city's garbage woes

More than reforestation, the National Greening Program (NGP) of the Department of Natural Environment and Resources, it poses threats of displacement of communities and land grabbing from the peasant farmers. This is the situation in all the affected communities of Isabela because of the NGP.

Particularly in the mountain communities of San Pablo, Isabela, small peasant farmers are in a state of dilemma since DENR introduced NGP in their area in 2011. Most of the peasant farmers are also indigenous people's settlers coming from the Cordillera region. In an interview with Manong Delfin who is an Ayangan from Ifugao, he said that they migrated in Lingbanan, San Pablo in 1990. Since then, they developed the area with agriculture. Along with his neighbors, they planted bananas, rice, root crops and fruit-bearing trees to support their families

Since 2011 when the NGP was implemented, Manong Delfin and his village were informed by the DENR-Isabela that their community is located in a forest zone. Because of this, the farmers cannot get titles for their lands. But even with this, Manong Delfin and his village registered strong opposition to the NGP plan. According them, once trees are planted in their corn, rice and banana fields, DENR can claim ownership to the planted areas. During the interview, they also accused DENR in hiring armed men and people from other communities to plant seedlings in their area.

But what is alarming is their statement that when Manong Delfin along with their community brought their issue to local government units and concerned agencies, they claimed that no single assistance was given to them. Manong Delfin also

admitted that they cannot hire lawyers to help them in their case because they have no resources.

It was their big relief when they attended the Punganay Cagayan Valley, a gathering of indigenous peoples and advocates in Ilagan, Isabela on the second week of September 2015. During the gathering, they also heard similar NGP problem in other municipalities of Isabela. With the same problem, Manong Delfin and other affected communities vowed to strengthen their unity to advance their campaign against NGP and related peasant issues.

Sulong Katribu Party list is one with peasant farmers in San Pablo in their campaign to defend the land they till. Sulong Katribu values more the lives of the people rather than a program like NGP that displaces people from their source of existence. Sulong Katribu strongly believes that programs such as reforestation should be based on people's participation and not just dictated for the sake of spending people's money. /Sulong Katribu

# Proposed P200-M Bail Bond Fund to Aid Officials in Law Suits

Sen. Francis "Chiz" Escudero wants budget officials to explain the details of the proposed P200-million bail money neatly tucked in the 2016 national budget which can be tapped by people in government to help them deal with legal cases, including malversation of public funds.

Called the "Legal Defense Fund" or LDF, Escudero said this lump sum in the proposed spending package is buried in the fine print of the Miscellaneous Personnel Benefits Fund (MPBF).

Under the proposed provisions governing its

ture funds for the city has reached its all-time high this year as the allocation for Baguio nearly doubled from last year's allotment.

In the 2014 General Appropriations Act (GAA) enacted by Congress, the city received an allocation of P392.3 million. This year the GAA rose to P679.6 million or an increase of 73.2 percent allowing for more development projects for the city.

All these were made possible by the active participation of Baguio Rep. Nicasio M. Aliping

tives' committee on appropriations of which he is a member for the majority bloc.

Rep. Aliping said the Athletic Bowl upgrade and rehabilitation was allocated P50 million which will allow for a rubberized track and field oval to conform to international standards. "This will make it possible for us to host national games like the 2016 Palarong Pambansa," he stressed.

Aside from the Athletic Bowl upgrade, Rep. Aliping was also able to work out the funding for various barangay infrastructure projects.

Already completed are the following: construction of multipurpose building for Gibraltar barangay; construction of day care center requested by the Dizon-Manzanillo barangay; construction of covered courts at Atok Trail barangay, Andres Bonifacio/ Cresencia Village barangay, Pinget barangay, and Asin Road barangay; installation of drainage at Alfonso Tabora barangay: construction of flood control system at Lower Ouirino Hill barangay: and concreting of the Mercury Street Extension at Upper Quezon

Also funded by the increased allocation are ongoing projects at Holy Ghost Proper, Green Water Village, San Vicente, Gabriela Silang, and Fort del Pilar barangays. Projects lined up for implementation under the 2015 GAA are: the completion of the IBP Building, completion of the multipurpose barangay hall of Middle Rock Quarry barangay, and covered courts for barangays Country Club Village and Sto. Rosario.

Aside from barangay projects, the increased allocation will also allow for the completion of the second phase of the three story, nine classroom building at the Pines City National High School which was allotted P11 million.

Other P99.5 million was set aside for the construction of school buildings under the senior high school program of the government for the following: Baguio City National High School - Main, Guisad Valley National High School, Irisan National High School, Joaquin Smith National High School, Mil-an National High School, San Vicente National High School and Sto. Tomas
