

BAGUIO CITY August 05 – Members of the City Council took turns in criticizing officials of the regional and district offices of the Department of Public Works and Highways (DPWH) for the delayed implementation and poor quality infrastructure projects in the different parts of the city that is now causing tremendous traffic congestions and inconvenience to the motoring and commuting public.

The council expressed disappointment over the repeated failure of the regional and district offices of the DPWH to closely coordinate with the local government, public utility companies and other sectors will be affected by programmed infrastructure projects in the city to avoid perennial traffic jams and inconvenience to the public.

Worst, the council stated the DPWH offices seem to take for granted the local government and the public in the implementation of projects by refusing to work round-the-clock that would have shortened the inconvenience suffered by the public, thus, the need for concerned agencies and offices to now strictly impose adherence to the timeline and the programs of work by contractors. Engr. Edgardo Enriquez, assistant chief of the DPWH-CAR's planning and design division, apologized to the members of the council and the public for the current tremendous traffic congestions around the central business district and other barangays and the inconvenience to the public caused by the simultaneous implementation of their various programmed public works projects due to the late inception in consideration of the agency's adherence to the request of the local government not to implement their works during the peak tourism months of February up to May.

Indonesia's Constitutional Court is considering making gay sex a crime, with Islamic activists pushing for the change insisting Thursday the homosexual community was causing "moral degradation" in the Muslim-majority nation.

The move comes after the gay community in Indonesia began coming under sustained attack earlier this year, with ministers and religious leaders denouncing homosexuality and LGBT websites blocked.

BAGUIO CITY - The former Special 6th Division of the Court of Appeals (CA) commended the City Government for the continuous rehabilitation of the closed 5.2-hectare Irisan open dumpsite which was the earlier subject of a consent decree after being subjected to a writ of kalikasan by concerned environmentalists in Baguio and Benguet.

In a two-page resolution dated June 27, 2016 signed by Associate Justices Ricardo R. Rosario Rosemarie D. Carandang and Japar B. Dimaampao, the CA cited the local government for the sustained activities leading to the permanent closure of the dumpsite and the adoption

of appropriate solutions to address the city's garbage disposal problems.

On March 21, 2016, the CA directed the Department of Environment and Natural Resources (DENR) through the Office of the Solicitor-General (OSG) and the City Government and its officials to submit their respective periodic reports on the implementation of the covenant's content in the consent decree issued in the environmental case.

In its monitoring report on the closed Irisan dumpsite, the DENR informed the CA the facility remained closed for dumping and was secured with perimeter fence; upon entering the facility, mounds of compost were noted inside the facility; as previously observed, the dumpsite has not been used for dumping and the area has slowly been covered with natural vegetation: the two Environment Recycling (ERS) machines continue to process the city's biodegradable waste with each machines capable of processing 24 tons of biodegradable waste into compost fertilizer and that the retaining walls, its buttresses, perimeter canals, storm or surface run-off canals. fence and other engineering structures are still intact and functioning.

Campaign against dengue

BAGUIO CITY – The Oplan Alis Kiti-kiti, Goodbye Dengue campaign to destroy mosquito breeding places, is ongoing in schools, churches, business establishments and households in the 128 barangays in full coordination with the Health Services Office (HSO), Mayor Mauricio Domogan assured last week.

As the number of dengue cases increased with fatalities in the city, the 4PM clean-up habit should now be done earlier, or at 9AM, the mayor said. A house-tohouse campaign to eliminate

breeding sites is also being was known. implemented.

Last Monday, City Health Services Officer Rowena Galpo said despite the fourfold increase of dengue cases, the cordillera region ranks 12 among the 17 regions. The pronouncement of an outbreak or a state of calamity is still far off, she added.

Galpo said that as of July 23, there are 1332 hospital-reported Dengue cases as compared to 270 cases in January to July 2015. A clustering of cases were reported in the barangays, it

Misting, with water-based larvicidals are being done in the barangays and some schools with just-hired job order fumigators. Personnel and volunteers from the **Emergency Medical Services** (EMS) and City Disaster and Risk Reduction Management Office (CDRRMO) are helping out, Galpo said.

TWG formed to study feasibility of Antamok open pit

BAGUIO CITY – Mayor Mauricio G. Domogan ordered the creation of a Technical Working Group (TWG) to conduct the necessary assessment and evaluation on the Antamok open pit site of the Benguet Corporation (BC) as a possible site for the city's long overdue integrated solid waste disposal facility.

The local chief executive created the 7-man TWG to pursue the assessment and evaluation of the site after he personally met with BC officials who offered the use of their open pit area for planned integrated solid waste disposal facility.

The local government will pursue the establishment of the integrated solid waste facility within the feasible area of the open pit site so that we will be able to put up our lasting solution to the city's solid waste disposal facility. We have to be firm on our commitment to pursue lasting solutions to our garbage problem for the benefit of local residents and visitors alike," Domogan stressed.

The TWG will be chaired by City General Services

Officer Romeo D. Concio with City Engineer Elpidio Garabiles, City Planning and Development Officer Evelyn Cayat, Environmental Management Bureau Cordillera Regional Director Reynaldo Digamo, Mines and Geosciences Bureau Regional Director Fay W. Apil, and representatives from the National Solid Waste Commission (NSWMC) and Benguet Corporation. as members. Earlier, BC offered to the

city government the use of its open pit site in Antamok as a potential area for the integrated solid waste disposal facility.

Under the planned facility, the city will be putting up a centralized materials recovery facility, an anaerobic digester, a waste to energy plant, the operation of the city's Environmental Recycling System (ERS) machines, engineered sanitary landfill, health care and medical waste treatment plant and special waste treatment plant.

Domogan said the put-up of the integrated solid waste disposal facility will not only be beneficial to the city but By Dexter A. See

also for the garbage disposal problems of La Trinidad, Itogon, Tuba, Sablan and Tublay pursuant to the spirit of the BLISTT growth development corridor.

However, Domogan explained the city is not abandoning its earlier plan of putting up the integrated solid waste disposal facility in the city-owned 139-hectare property in barangay Sto. Tomas School area so that it will have an alternative in case the TWG will find out that the Antamok open pit site is not feasible.

Domogan gave the TWG at least 45 days to submit its findings and recommendations so that the local government will be guided on finding lasting solutions to the city's garbage woes.

It was learned that the BC management, the City Government of Baguio and the Municipal government of Itogon signed a memorandum of understanding that defined the duties and responsibilities of the parties related to addressing the solid waste concerns of the BLISTT local governments./

No deduction on retirement pay of workers asserted

there should be no deductions shall be made from the retirement pay of local government employees pursuant to existing laws, rules, regulations and jurisprudence.

City Legal Officer Melchor Carlos Rabanes cited that the matter has been upheld in the case of the Government Service Insurance System (GSIS) versus the Commission on Audit (COA) wherein the issue raised before the Supreme Court is whether COA disallowances could be legally deducted from retirement benefits on the ground that these were monetary liabilities of the retirees to the GSIS.

Rabanes qhoted the SC ruling which stated "It is clear from the above provision that COA disallowances cannot be deducted from benefits from Republic Act 8291, as the same are explicitely made exempt by law from such deductions. Retirement benefits cannot be diminished by COA disallowances in view of the clear mandate of the foregoing provision. It is a basic rule in statutory construction that if a statute is clear, clean and free from ambiguity, it must be given its literal meaning and applied without any interpretation. This is what the GSIS cannot directly

BAGUIO CITY – The City is known as plain-meaning rule or verbal egis. Accordrule or verbal egis. Accordingly, the GSIS interpretation of Section 39 that COA disallowances have become monetary liabilities of respondents to the GSIS and therefore fall under the exemption stated in the law is wrong. No interpretation of the said provision is necessary given the clear language of the statue. A meaning that does not appear nor is intended or reflected in the very language of the statute cannot be placed therein by construction."

Moreover, the SC ruled if we are to accept the GSIS interpretation, then it would be unnecessary to single out COA disallowances as among those from which benefits under RA 8291 are exempt. In such a case, the inclusion of the COA disallowances in the enumeration of exemptions would be a mere surplasage since the GSIS could simply consider COA disallowances as monetary liabilities in its favour. Such a construction would empower the GSIS to withdraw, at its option, an exemption expressly granted by law. This could not have been the intention of the statute."

Rabanes added the SC in the similar case stated "while proceed against respondents' benefits, it can nonetheless seek restoration of the amounts by means of proper court action for its recovery. Respondents themselves submit that this should be the case, although any judgement rendered therein cannot be enforced against retirement benefits due to the exemption provided in Section 31 of RA 8291. However, there is no prohibition against enforcing a final monetary judgement against respondents other assets and properties. This is only fair and consistent with basic principles of due process."

Rabanes asserted the law mandates that the terminal leave benefits of retirees shall be immediately released despite the pendency of an administrative case against the retiring employee and with more reason that the terminal leave benefits of the employee cannot be withheld for COA disallowances that have not yet become final and executor.

The legal officer declined from making a categorical statement as to what course of action should the City Accountant take under the premises and instead allow him the freedom to make up his mind as they respect his discretionary power./By Dexter A. See

Extrajudicial killings in the Philippines: *Open letter from civil society calling on UN drug* control agencies to take urgent action

To: Mr. Yury Fedotov, Executive Director, United Nations Office on Drugs and Crime (UNODC)

Dear Mr. Fedotov.

We are writing to request that the International Narcotics Control Board (INCB) and United Nations Office on Drugs and Crime (UNODC), as global authorities with responsibility for international drug control, urgently take action to condemn the extrajudicial killing of people suspected of using or dealing drugs in the Philippines, and to call for an immediate halt to these killings.

704 people have been killed between the 10th of May 2016 to the 29th of July 2016, as reported by a media outlet monitoring the number of drug-related deaths, ABS CBN News. These killings have reportedly taken place in several parts of the country, including Manila, Bulacan, Cebu, Rizal, Abra, Bataan, Pangasinan and Cavite, and carried out by police or "unidentified hitmen". The rapidly rising number of deaths occurring on a daily basis is the direct result of President Duterte's campaign to eliminate drug-related problems in the country.

Mr. Rodrigo Duterte won the presidential election held in the Philippines on 9th May 2016, and was inaugurated as president on 30th June 2016. Since his election campaign, Mr. Duterte has repeatedly urged law enforcement agencies, the public at large and even the Communist-led New People's Army (NPA) to kill people suspected of dealing or trafficking drugs as well as people who use drugs, as part of his pledge to end criminal activity within three to six months in the Philippines. Although Mr. Duterte said in his inauguration speech that "[my] adherence to due process and the rule of law is uncompromising" and "the Republic of the Philippines will honour treaties and international obligations," he has made public statements which incite extrajudicial killings and contradict his stated intentions to comply with the Philippines' human rights obligations.

Instead of ensuring the protection and rights of people who use drugs, including the right to health and provision of voluntary, evidence-based drug treatment and harm reduction services, President Duterte has called for them to be killed. Instead of ensuring the rights of people suspected



of committing drug-related crimes to due process and to a **EDITORIAL** fair trial, the President has called for them to be executed on the spot. Despite reports of killings that involve no violent resistance, the President, Solicitor-General and

Chief of Police have assured law enforcement officers that they will be protected against conviction of criminal offenses in the discharge of their anti-drug related duties, thereby implying impunity for extrajudicial killings.

The outcome document of the UNGASS on the world drug problem that took place in April 2016, states the following:

4. (b) bis. Promote effective supervision of drug treatment and rehabilitation facilities by competent domestic authorities to ensure adequate quality of drug treatment and rehabilitation services and to prevent any possible acts of cruel, inhuman or degrading treatment or punishment, in accordance with domestic legislation and applicable international law;

4. (o) Promote and implement effective criminal justice responses to drug-related crimes to bring perpetrators to justice that ensure legal guarantees and due process safeguards pertaining to criminal justice proceedings, including practical measures to uphold the prohibition of arbitrary arrest and detention and of torture and other cruel, inhuman or degrading treatment or punishment and to eliminate impunity, in accordance with relevant and applicable international law and taking into account United Nations standards and norms on crime prevention and criminal justice, and ensure timely access to legal aid and the right to a fair trial;

UNODC and the INCB are committed to a human rights-based approach to drug control. The 2016 World Drug Report explicitly states that "Guaranteeing the rule of law needs to be viewed as a concept wider than mere coercion; it also encompasses inclusive access to justice delivered fairly, in full respect of human rights, through a robust system that places authority in the hands of relevant institutions, with appropriate safeguards." The report adds that, "State authorities [should] act in compliance with the rule of law and international norms and standards concerning, inter alia, the use of force, the protection of victims and the treatment of offenders." Similarly, Mr. Sipp's foreword to the 2016 INCB Annual Report states that the drug control system should be based on the "principles of proportionality, collective responsibility and compliance with international human rights standards".

The approach taken by President Duterte clearly deviates from these important global norms for the implementation of drug control policies.

With many more lives at stake, it is of critical importance for the UNODC and INCB as global authorities on international drug control to demand an end to the atrocities currently taking place in the Philippines, and to state unequivocally that such actions do not constitute acceptable drug control measures. We call on the UNODC and INCB to communicate strongly with the Philippines government the following messages:

a. President Duterte's actions to incite these extrajudicial killings cannot be justified as being in line with global drug control. All measures taken to control drugs in the Philippines must be grounded in international law

b. Request that President Duterte put an immediate end to incitements to kill people suspected of committing drug-related offences

c. Encourage President Duterte to uphold the rule of law and ensure that the right to due process and a fair trial is guaranteed to all people suspected of committing drug-related crimes, in line with the conclusions of the 2016 UNODC World Drug Report



e. In line with the international human rights obligations of the Philippines – and with the official position of both the UNODC and the INCB - call on the Philippines not to re-impose the death penalty for drug offences.





Dr. Celia Flor Brillantes, assured the respondents' identify as confidential as with HIV AIDS conducted. There has to be informed consent, and the need for a confirming test before the patient is conferred a positive result. All assistance options is then offered to the patient.

She pointed out that family and community support counts most, with some support groups that are willing to help out.
