Thus, said mayor Mauricio Domogan last week, apparently lamenting failure of two Cordillera congressmen to set their hands on the proposed organic act now known as House Bill (HB) 5595.

During the 'Ugnayan' presser hosted by DZEQ 'Radio ng Bayan' Wednesday, Domogan can only surmise, "Maybe those who did not sign have concerns."

He added, "I hope we could sit down with them to explain whatever it is that [prevented them from affixing their signatures on the proposed autonomy bill]."

The Cordillera congressmen filed HB 5595 in the House of Representatives, December 6, with hope the administration of Pres. Benigno 'PNoy' Aquino would endorse the same as priority piece of legislation.

Only Benguet congressman Ronald Cosalan and Abra rep Maria Jocelyn Bernos declined affix-Cont. on page 10

### **Mayor Eyes Specific Guidelines** on Firecracker Sale, use

BAGUIO CITY – The city government will come up with more specific guidelines on the sale and use of firecrackers here to ensure strict compliance by the populace and achieve the city's ultimate aim of preventing firecracker-related injuries.

Mayor Mauricio Domogan told the weekly Ugnayang Panlungsod media briefing last Wednesday that he will meet with concerned parties to flesh out the specific rules taking off from the guidelines adopted by the city council through a reso-

The mayor was shooting for the amendment of the ordinance regulating the sale of firecrackers but said the resolution which expanded the list of prohibited firecrackers to virtually allow only the aerial ones will do for now.

"I understand that the city council had no more time to amend the ordinance so we will just work on the resolution they passed," he said.

He said they will consider the recommendation of the Dept. of Health to set up a common fireworks display in the communities to discourage the indiscriminate use of firecrackers in the drafting of the guidelines.

'I just hope that all concerned will comply with the guidelines and the regulations so that we can succeed in our aim of preventing firecracker-related injuries," the mayor said.

As per the guidelines adopted by the city council, the city will prohibit the sale of all firecrackers and pyrotechnics with explosive content that may endanger life and limb, such as bawang, baby rocket, small triangle, judas belt, pulled firecrackers, luces, jumbo regular and special, whistle bomb, five star, sawa, atomic big triangulo, super lolo, kwiton and watusi and their equivalents, luces, roman candles, fountains and the like, trompillo, kwitis, pailaw, pop pops, aerials like Dragon, Tiger and Platinum Products.

The body urged the creation of a "Task Force Paputok" to inspect the quantities and kinds of firecrackers and pyrotechnic devices sold and held in stock by or in the possession of every licensed distributor, retailer or wholesaler.

The body also set regulations on the sale and affirmed that only those persons/entities duly authorized by Special Business Permits to distribute and/or sell the firecrackers and pyrotechnic devices will be allowed to distribute and sell such

They also set the venue and date for the distribution and sale at the Old City Auditorium, Burnham Park from December 20 to December 31, 2011./A Refuerzo

## Smart-Looking guy turns Santa

LATRINIDAD, Benguet - A Samaritan who declined to identify himself appeared last Monday morning at the Benguet Renal Center here, asked the costs and then deposited P17,600. He said it was for end-stage kidney patient Genevieve Gano, so she could have her twice-a-week hemodialysis treatment until the year's end.

"He's about 30 to 40 years old, sported a black leather jacket, cowboy buckle and pointed boots; 'maporma' looking), 'parang rakista' (like a band musician)," recalled hemodialysis nurse Cherry Palsic. "He introduced himself as Manuel

Manuel, or whoever he is, returned the following morning while Genevieve was attached to the blood-cleansing tubes for her four-hour treatment. He handed the 21-year old girl P10,000, saying it's for her daily needs.

The dialysis session last Tuesday was courtesy of a bank manager who, out of habit, would now and then whip out P3,000 as support "to whoever needs it most", and then quickly advise that he be not identified.

Genevieve, a farmer-couple's daughter from Hungduan, Ifugao, began using Manuel's fund last Friday. At P2,200 per session, it was good for eight treatments, with the fund having run through on Jan. 3 under the twice-a-week (Tuesday and Friday) schedule at the renal center behind the Baguio General Hos-

The regular cost is P2,600 per session, but Palsic explained the center applied the discount for persons with disabilities. "Genevieve's case is chronic and, as such, she's considered a PWD and therefore entitled to the discount.

Until the other week, Genevieve was surviving almost on empty, having reduced her treatment to once-a-week. And to survive, she transferred last December to Bayombong, Nueva Ecija, to be near a renal center in Solano city which allowed 50 percent down payment. The shift in location also brought her closer to her parents' place, but had to bear the burden of daily survival by her lonesome in a hut.

She made her initial pitch for support in June last year, a year after she was diagnosed for total kidney failure, a year after she began twice-a-week dialysis treatment. By then, her parents and relatives had exhausted their resources to keep her alive.

The diagnosis ended her dream of finishing a degree in commerce at the Benguet State University where she was in junior year when the medical findings came.

Among those who responded to her plea then were expatriate Baguio boy Freddie de Guzman in Canada, Jody Pimentel, Mila Espino, lawyer Rodrigo Kito and Shoshin Kinderhilfe, a foundation built by former world traditional karate champion Julian Chees and his students in Germany.

A man who also requested anonymity and she referred to as "Lolo" met her at a pizza shop inside the SM mall in Baguio and handed P3,000.

Last week, Manuel and the bank executive were joined by a police team led by officer Magantino who delivered P1,000 to the renal center. Young journalist Rubyloida Bitog also reported that a woman donor also coursed P1,000 last Wednesday through ABS-CBN Television.

While her treatment fund lasts this Christmas, Genevieve stays with Bitog in the latter's boarding house here.

Those who would like to flesh out the spirit of the season can ring up the girl at 09129632162, or, as Manuel, the Santa in black leather did, deliver their support to the Benguet Renal Center.

As this was being written, Genevieve texted, saying lawyer Amadeo Degay deposited P3,000 at the center./Ramon Dacawi.

### Over P9M Worth of Marijuana **Eradicated in Benguet**

BAGUIO CITY—About P9,285,600.00 worth of marijuana had been uprooted and burned on-site in an eradication operation in four sitios at Tacadang, Kibungan, Benguet recemtly.

The operating units from the Philippine Drug Enforcement Agency - Cordillera Administrative Region (PDEA-CAR), Police Regional Office - Cordillera, Military Intelligence Group – 1, and Criminal Investigation and Detection Group conducted the joint operation from November 30 to December 2.

Overall, 38,000 full-grown cannabis plants and 42,140 cannabis seedlings with Dangerous Drugs Board value of P7.6 million and P1,685,600.00, respectively, had been uprooted and burned on-site during the three-day marijuana eradication operation in 18 plantations, measuring an aggregate land area of 9,665 square meters, all located in barangay Tacadang.

The anti-narcotic operatives also conducted dialogues with barangay residents disseminated information on ill effects of marijuana use, legal implications of marijuana production and trading, participation of the community in the enforcement of the drug law and other related issues.

From January 1, 2011 until this operation, there had been 15 marijuana eradication operations carried out by government troops in the Cordillera Region resulting in the destruction of 1,634,148 full-grown cannabis plants, 858,000 cannabis seedlings, 333,641.50 grams cannabis dried leaf, 48 kilos cannabis stalk, 60 kilos cannabis brick, 400 pieces of cannabis fruiting top and three kilos cannabis seed, and arrest of one marijuana cultivator.

Five of the 15 eradications were effected in Kibungan, Benguet; three each in Bakun, Benguet; Tabuk City, Kalinga; and Kapangan, Benguet and one in Tinoc, Ifugao./PIA CAR/

### Leading Anti-Corruption Agencies Meet to Review Gaps on Major

BAGUIO CITY - In observance of the International Anti-Corruption Day as declared by the United Nations, Transparency International-Philippines is conducting a one-day forum entitled Bridging the Gaps in Integrity initiatives on December 12, 2011 at the Baguio Country

The forum will be undertaken in collaboration with the Office of the Ombudsman and the Integrity Project of the US Agency for International Development (USAID).

Ombudsman Conchita Carpio Morales will give the keynote address. She will share her office' corruption prevention measures, its thrust in pursuance of corruption cases and the needed support for more effective resolution of such cases.

Representatives from various agencies and sectors including Philippine National Police, Philippine Drug Enforcement Agency, Department of Justice, Office of the Ombudsman, Integrated Bar of the Philippines, Supreme Court, Bureau of Jail Management and Penology, media groups, and civil society organizations will come together to discuss success factors and challenges in implementing integrity related initiatives and pursuing resolution of corruption cases - from reporting, investigation to prosecution and define ways of closing the gaps in implementing integrity initiatives and pursuing resolution of corruption cases.

Based on the Corruption Perceptions Index (CPI) 2011 released last week by the anti-corruption global watchdog Transparency International, the Philippines currently ranks 129th least corrupt out of 183 countries surveyed. With a score of 2.6 (with 0 most corrupt/10 least corrupt), there is a slight movement up for the first time since 2004, given the country's score and rank.

Consolidating the efforts of the various anti-corruption agencies is one concrete step in further strengthening integrity initiatives. To maximize resources and optimize results, agencies need to more closely collaborate to complement each other's plans and projects. The current political environment in the country provides a great opportunity to achieve major stride in battling corruption.

We are optimistic that the Philippines will improve its standing in the CPI in the coming years. With the aggressive efforts of the government and the concerted initiatives of the civil society organizations, business community, private sectors and the whole public, we can really have substantial accomplishment in fighting corruption, "said Dr. Georgina Encanto, President, Transparency International-Philippines./PIA CAR/Office of the Ombudsman

## CSC enjoins Govt Offices to join 18day Campaign to End Violence Against

### Women

**BAGUIO CITY** - The Civil Service Commission (CSC), through an nouncement signed by its Chair Francisco Duque III, enjoins all national government lineagencies, local government units (LGUs), Government-owned and Controlled Corporations (GOCCs) and state universities and colleges (SUCs) to join the country's observance of the 18-day Campaign to End Violence Agains Women(VAW).

The said campaign spearheaded by the Philippine Commission on Women (PCW) in coordination with the Inter-Agency Council on VAW and Children (IACVAWC), runs

from November 25 up to the December 12.

CSC-CAR Legal Officer Atty. Emily Lagan, in an interview over PIA Hour radio program, encouraged government agencies and institutions to conduct activities in relation to 18-day Campaign to End VAW that will contribute to intensified public awareness on VAW, anti-VAW laws, and services to survivor of VAWs.

He also enjoined government offices and institutions to join the simultaneous blowing of whistles on VAW at 4:00 pm on December 12 which marks the culminating event of the cam-

"Blow whistle on VAW' is a part of this year's campaign which advocates the use of whistle, as a symbolic and practical device in preventing and speaking against VAW, as well as in supporting VAW survivors,' he

In the same interview, Lagan reminded government offices and institutions to maintain a female/gender friendly and professional working environment, which is in accordance with the Magna Carta for Women – a comprehensive women's human rights law that seeks to eliminate discrimination against women by recognizing, protecting, fulfilling and promoting the rights of Filipino women, especially those in the marginalized sectors.

# Partial Redemption Former Rep. Mark Cojuangco went "ballistic" on a TV-talk

show this week. The ex-Pangasinan legislator flared at persistent criticism over a Supreme Court award of 16.2 million San Miguel Corporation shares, to his father: tycoon Eduardo "Danding" Cojuangco.

My father "had a right" to those shares", Mark asserted. Instead of being panned, Danding should be credited, among other things, for setting up a replanting program and "petrochemical plants to add value to the coconut:" Dear Ol' Dad" was then Ferdinand Marcos' coconut czar.

Close association between Marcos and Cojuangco had not been proved, the High Court claimed last April. This was essential to establish a case for ill-gotten wealth.

'The biggest joke to hit the century", Justice Conchita

Carpio snapped in a scathing dissent

Cojunagco's SMC bonanaza were bought from levies the Marcos' dictatorship wrung from indigent coconut farmers.

People Power I also banished the Cojuangcos to Hawaii "The only time I was able to see President Marcos a lot was during our exile in Hawaii after EDSA 1986," recalls Mark, whose admiring parents named him after Marcos.

The dictionary definition of crony is buddy or pal of similar age. My father is much much younger than Marcos... He respected Marcos as a leader", Mark said. "But to say he was a crony, dictated on by the President, malayo po yon."

Not so, wrote Justice Maria Lourdes Sereno in her dissent on the SMC fracas. Sapped by the martial law levy, coconut farmers "in effect financed expansion of the business empire of Eduardo Cojuangco....Illicit acts were obscured by a corporate

Four sets of evidence, prove "Cojuangco's close association with Marcos, plus the "behest" nature of loans used to purchase SMC stocks.

(1) Marcos appointed Cojuangco to head both Philippine Coconut Authority and United Coconut Planters Bank,. Through these positions, buttressed by a series of "tailored" executive issuances by Marcos, Cojunagco "employed a scheme of corporate layering and multi-level loan transactions to divert public funds"

How? Cojunagco brokered terms of UCPB in his favor. Coco levy funds were deposited interest-free at UCPB, "which administered them as it pleased.". As UCPB president, Cojunagcio wrung "substantial loans used to purchase the SMC shares, directly in his name or "indirectly through his dummy corporations....He used prima facie public funds (derived from the coco levy) in CIIF Oil Mills to snap up substantial amounts of SMC" stocks.

Shell firms were whistled up "for the sole reason of purchasing SMC shares." These "fronts" parceled "favorably obtained credit from UCPB to different entities." There'd be no paper trail, leading to "a single natural person who had control and management of the bank.

"These anomalous transactions were built on the sweat of coconut farmers. (They), left an indelible mark in the country's history of recovering ill-gotten wealth" Sereno wrote. "The Court majority effectively impeded gains... to retrieve public funds misappropriated by Marcos cronies.

(2 Previous characterization of Cojuangco, by the Supreme Court no less, "affirms what has long been within the realm of public knowledge - that Cojuangco is a "close associate" of Marcos.

The tribunal upheld a Court of Appeals decision that Philippine Charity Sweepstakes' Fernando Carrascoso, Jr. rightly withheld Danding's winnings in several horse races.

"There is no denying that plaintiff is a very close political and business associate of the former President," the Supreme Court said. "(Thus) Carrascoso could not be faulted in asking further instructions from PCGG...on what to do with the prizes.

After approving a lower court's judicial notice of what is accepted public knowledge, the Court... can no longer backpedal, a decade later, to deny close association between (Marcos and Cojuangco) for alleged lack of "competent evidence" Sereno wrote.

(3) Two blocks of Bulletin Publishing Corporation shares – 46,626 and 90,877 — in the name of Eduardo Cojuangco, were in fact "ill-gotten wealth" of the Marcoses, the Court ruled in Republic vs. Estate of Hans Menzi.

Cojuangco acted as "dummy, nominee or agent" of

Pope Benedict XVI was reported in the news report to have lighted a huge Christmas tree in Umbria using a table computer from his official residence in the Vatican. 
Mistletoes were also sacred plant during paganism and the practice of kissing under the mistletoe was a pagan fertil-

### ADVOCACY MINDANOW

Maguindanao Massacre two years ago (day three)





(Note: This is the 3<sup>rd</sup> installment of a 4-day series authored by Dureza, former presidential adviser on Mindanao who is now Publisher of the Mindanao TIMES, a daily newspaper and manages in the private sector Advocacy MindaNow Foundation.)

DAY THREE, Nov 25 830 AM, I visited a funeral parlor in Marbel. Some bodies were not identified yet. I talked with the relatives, many parlor-hopping, visiting every funeral parlor and looking at mangled bodies hop-

ing to identify missing loved ones.

I motored back to the 601st army brigade headquarters. We were frantic for some sworn statements so the legal process could start. It was the third day and there were no arrests yet and the public was getting angry - although I had no first hand information on this as I was not reading any of the newspapers and not even watching the TV during the whole period. I was just getting text messages. I knew from experience that a crisis manager could be affected one way or the other by external public pressure coming from those who were not on the ground, far from the venue of action and usually unaware of the many facts and nuances of certain developing events. I preferred to stay focused on my game plan.

I reconvened the crisis committee and tasked the PNP team to go and visit the Mangudadatus in Buluan and take the affidavits of the witnesses they could immediately present. The PNP team returned empty handed. They were told to come back the following day as everyone was engrossed with the search and retrieval operations. Also, the Mangudadatu lawyers would handle the documentation. We understood. I knew parallel investigation and documentation work was also ongoing in several areas. But again, no single document was at hand. Anxious and desperate in having some "paper" in my hands to get Unsay in the event he would not surrender as earlier agreed, I suggested to the NBI team which came from Manila to issue a summons of sorts. Even the NBI team at that moment said they had no basis yet to issue summons. As a lawyer, I understood perfectly. But how about the public that was already crying for blood? The PNP said it could issue an invitation but I bucked. Knowing the public sentiment already building up, people would surely mock and say: you "invite" those criminals ÔNLY?, etc).

12 NOON –Over lunch at the brigade, I consulted with the crisis committee on my plan, which also coincided with the suggestion of Col Geslani that it was time to contact the Ampatuans and call in Datu Unsay to voluntarily surrender. As they committed to me the previous day. Without any document in my hands, I thought diplomacy or negotiations would fill in the gap for the moment. I was also confident that Bapa Andal would be true to his commitment to give Unsay to me.

While this was on my mind, I was already getting a briefing on the operational plans that would be launched to forcibly take Unsay in custody. There was need for time for the augmentation forces to arrive from other parts of Mindanao and even as far as Samar. Disarming the well-armed Ampatuan forces was necessary before any operations was to be launched to minimize resistance and casualties.

2:00PM - I motored back to Marbel to dialogue with all the families of the victims and brief the media on latest updates. My handling of previous crisis situations taught me that as equally important in dealing with criminal elements was properly dealing with families or those affected by the incident. Dealing also with the media and providing transparent information flow was also very important. Although there were operational matters that could not be made public in the meantime, explaining this to media and the public would be received favorably through frequent brief-

I made several calls while enroute to the family dialogue. I first called ARMM Gov. Zaldy Ampatuan. I told him it was time to bring in Datu Unsay. He told me he would consult the father, Gov. Andal. I said I had only until 5 pm that day to work on this plan. After 5pm, the scenario would no longer be the same, I told him. I sent a soft and veiled warning that if Datu Unsay would not surrender, things would be out of my hands. The military formula would be applied and it would unnessarily result to lose of lives. I knew Gov Zaldy (Datu Puti to others) was a mild-mannered man and would understand my plan.

### 126 Avail of DFA-city Gov't Passport TABUK CITY, Kalinga - One hundred

program twenty six individuals have recently received

their passports after the city government here helped facilitate their application at the Department of Foreign Affairs (DFA).

City Public Employment Service Officer (PESO) Loyda Saboy said DFA Tuguegarao office delivered the passports last November 25, just 20 days the applicants filed their application on November 5. Passport processing she said usually takes months before it is released.

According to Saboy, the original plan was to invite the DFA National Office for a mobile passport activity last November, but was re-scheduled because the required 500 applicants were not met. She said that since their announcement last August, more than 400 individuals manifested their interest to avail of the pro-

However, since the mobile passport machines were already booked until January, the city government through the full support of City Mayor Ferdinand Tubban opted to ferry the applicants to DFA Tuguegarao to avail said passport application and renewal service, with the city government hiring at least three buses for the activity. Meals and snacks she said were also provided for.

According to Saboy, out of 221 who availed, only 126 were able to submit all the required documents for their application. Priority she said were also given to those needing passports immediately like newly hired Overseas Filipino Workers.

Said program of the city government was conceptualized a few years ago to facilitate the speedy and easier passport application processes to help especially OFWs from Tabuk as well as those coming from the other municipalities of Kalinga and nearby provinces.

She said that by bringing said DFA service in the province, applicants would be spared from spending much time and money for the trips they have to take just to process their passports.

The city government is planning to hold another mobile passport service by February or May next year. Applicants she said are invited to come to the City PESO to inquire for the requirements. In certain cases such as applicants for minor and others, there are some documents that are being required by the DFA which the applicants should know to facilitate their applica-

"It is required that before they avail of the mobile passport services, all documents should be in placed to avoid delaying the process," she said./JDP/GGD-PIA CAR, Kalinga

## K + 12 Basic Education Graduates will have Tech-Voc Employable Skills -

BAGUIO CITY - Through the national government's K + 12 basic education reform program, high school graduates will soon have the necessary technical-vocational (tech-voc) education and skills development that would give them a very good opportunity to be employed or to be entrepreneurs at young age.

Thus affirmed Undersecretary Milagros Dawa-Hernandez, Technical Education and Skills Development Authority (TESDA) Deputy Director General, in an interview during her meeting with

the TESDA family in the Cordillera.

According to Hernandez, part of the priority agenda of President Benigno Aquino III is to bring in reforms in the country's basic education as the Philippines is one of only two remaining countries that still have a 10 year basic education. Our high school graduates today even if they graduate as valedictorian lack the tech-voc skills education and training that could immediately provide them a better opportunity for employment or to start a livelihood, she noted.

The K+12 requires all incoming students to enroll into two more years of basic education. The K+12 system will include Universal kindergarten, six years of elementary, four years of junior high school with an additional two years for senior high school. The 6 year high school is set to be implemented next school

"Through the K +12 basic education program, tech-voc education and skills development will be embedded in the curriculum of basic education, particularly on the higher years or from grade nine to 12 and through TESDA regular high school graduates could also get a National Certification (NC I or II) if they pass the required assessment", she said.

According to Hernandez, the core objective here is to provide pre-employment education and skills to young people since not all high school graduates are capable or fortunate enough to pursue higher education and that not all needs to take one just to get a good employment or entrepreneurship opportunity.

Through the K + 12 basic education program, we are looking at a yearly average of about 1.2 million high school students that already have tech-voc education and skills training wherein upon graduation can even be nationally certified by TESDA (up to NC II level), upon passing the needed certification assessment requirements, according to Hernandez.

She also bared that it is a priority of the Aquino administration to intensify the country's tech-voc education and skills development training, so that we can respond to the manpower need of the leading industries in the country such as the Business Process Outsourcing (BPOs) and electronics/semi-conductor indus-

### Benguet Officials Push for Exemption BeGH may soon increase Hospita of Penalties, Surcharges on Electric Charges and fees - The Benguet General Hos-Bills of Barangay LGUs LATRINIDAD, Benguet - Provincial LA TRINIDAD,

officials are pushing for the exemption of barangay local government units from penalties and surcharges imposed on the delay of payment of electric bills.

The provincial board passed a measure requesting the Benguet Electric Cooperative (BENECO) to exempt the barangays in the province from the penalties or surcharges being imposed on the delays in the payment of electric bills.

BENECO was granted by the National Electrification Commission the sole franchise to operate an electric light and power service in the City of Baguio and Benguet province.

As premised, the necessary expenses of these barangay units are often delayed mostly because of the time required in accomplishing documents to support their financial and other obliga-

LA TRINIDAD, Benguet pital may soon increase its hospital charges and fees due the

increasing prices on all commodities including medicines.

The provincial board in its regular session held recently recommended the proposed increase and adjustments in hospital charges and fees as supported by the findings of the Provincial Finance Committee.

The BeGH operated as an economic enterprise way back in 2006. Since its conversion, it receives a yearly subsidy of P40 million from the provincial government while the remaining budget for the year is generated from the income derived from hospital fees and charges.

Based on the reports of Board Member Juan Nazarro Jr, chairman of the Board of Directors of BeGH, the proposed adjustments were computed based on current charges from the different hospitals in Baguio City as per recommendation of the hospital committee.

To cite example, proposed room rate increase ranges from P100 to P150.00 per day.

For x-ray fees for various body parts, increase ranges from P20 to P160.00 for chest, head, and abdomen but for skeletal survey and special procedures the increase is P1,000 or more. For ultrasound fees the increase is from P100 to P250.00. The increase in cost of laboratory fees depend on the type of procedure.

Another reason stated in imposing increase in charges is due to the new hospital services being performed and the new equipment being used which were not covered under the 2005 Benguet Revenue Code. The new charges are those which have no current fees.

Referred to the Provincial Legal Officer, the findings is that the increase and adjustments are just and reasonable and are within the powers of the provincial board to adopt the necessary amendments of the 2005 Benguet Revenue Code.

While on my way to downtown Marbel, I got a call from the father, Gov Andal telling me that he would turnover to me Datu Unsay but requested that the deadline be moved from 5pm that day to 10 AM, the following day. I immediately told him I could not guarantee things if the deadline were moved. He said the Ampatuan clan would meet that evening and discuss things and bid goodbye to Datu Unsay. I told him I would get back to him by phone.

Up to this time, the Palace was periodically informed of actual developments on the ground. I then made a call to palace officials with whom I had been consulting and informed them of Bapa Andal's proposal that he would give to us Unsay the following day instead of that afternoon.

There were objections. And understandable reservations. What if the extension was a ruse to give opportunity to Unsay to escape that evening? What were the guarantees that he would voluntarily surrender during the new deadline? People were becoming outraged not only on the crime but on the perceived slowness of government, so why waste more time? The forces were ready to strike, so why delay? One palace official said he would agree to move the deadline to surrender the following day but Unsay must be in my personal custody and spending the night with me in the same room. Their concern was understandable. They were getting the public pressure to act swiftly. But I stayed the course.

I also reasoned back: How sure are we that we would get Datu Unsay in the operations? From yesterday's visit to the Ampatuans, I was certain that he was not there in the immediate vicinity but came from somewhere far and surely physically secured considering that it took him almost 1 hour to arrive after he was called by the father. I wanted as much as possible a bloodless event. There was too much blood spilled already. An assault would surely cost lives knowing the armaments and the culture. And there was no guarantee we could take Datu Unsay that way. I also said I believed Gov Andal was sincere when he told me he would bring out his son when needed. To wrap up my point, I said: I would take full responsibility for whatever outcome.

My new timeline was adopted. I called Bapa Andal. Everything was set: 10 a.m. Nov 26 at the Maguindanao capital grounds in Shariff Aguak, the handover would take place.

That night, we reviewed the "pickup" scenario several times and mapped out contingencies just in case things would not go as planned. In the meantime, government troops moved according to operation plans. That evening, I got a call from Atty. Cynthia getting an assurance from me that nothing would be launched that evening until the 10 AM pickup time the following day. I told her that I had full control of the scenario for as long as the Ampatuans would be true to the agreement. Any troop movement they must have noticed was to ensure that the handover the following day would proceed without incident. I knew the troops were prepositioned and in place to ensure our safety if things went wrong, ready to hit if the pickup failed. That same evening, as

planned, the troops were moving to neutralize early any resistance. The Ampatuans must have noticed. Or were tipped off.

Later in the night, another complication suddenly arose. Gen Serapio and Col Geslani informed me that they got information that Toto Mangudadatu, as a show of defiance and determination to continue his fight, would motor with his followers to file his certificate of candidacy the following morning in Shariff Aguak. That would endanger the smooth flow of our"pickup" operations in the same venue: Shariff Aguak. immediately called Gov. Mangudadatu. I told him that there was something afoot the following morning and that, without disclosing what it was all about, I requested if he could convince Toto to move his filing to another day. It was close to midnight and the ground operations were underway. A defiant caravan would mess things up. A few minutes later, Gov Teng called and said the clan agreed. There would be no movements on the Mangudadatu side the following day, except Gov Teng's going to Buluan to join the rest of the clan there.

.....from page 2 way and loops to La Trinidad with easier access to Tuba, Sablan and Itogon. The town of Tublay may also be included in the loop, it was learned. A common area for transportation; jeepneys and buses, shall be proposed.

A middle ring for transportation shall pass through Bonifacio st.-North Drive-Gov. Pack road-Kisad road-Legarda st.-Yandoc st.-Abanao st.-Bonifacio st. while an inner ring passes through Bokawkan-Yandoc-Kisad-Military Cut Off-South Drive Circle-Leonard Wood rd.

Housing areas, schools, tourism and industrial areas shall be considered in the transport loop, for the whole BLISTT area, the planners were informed. A centennial village with a thousand housing units is proposed in a neighboring town, with utilities being considered and prepared.

Among the spatial strategies studied and planned for the city, a multi-nodal urban form is considered. This strategy "redirects development away from the urban core or city center toward identified urban growth areas or nodes," which would have a "cluster of development with each cluster having its own specialization.'

There were also considerations made for reforestation and reservation areas, water sources, hazard lines, sinking areas and special zones. All the representatives agreed to have a detailed report on the said zones in their respective areas. La Trinidad, for one, shares the Busol Watershed with Baguio, while other areas are being used as watersheds for neighboring ar-

For the special industrial zones, the planning officers have scouted around for appropriate areas, Sablan and Tuba being the nearest possible places. The move is seen to provide jobs for college graduates from neighboring towns.

In his welcome remarks, Mayor Mauricio Domogan emphasized the importance of neighbors in the planning and visioning for the BLISTT areas. "We are happy to listen to you, our important partners, (your) concerns, suggestions, proposals, and comments, are valuable, as long as it is for the collective good of our people and environs," he said. These shall be included in the City Land Use Plan which is pending in the city council, he added.

As the forum is the fifth in the series, progress has been made, but would still need more inputs, the mayor said. Visioning have been done earlier with the barangays, the youth, the Baguio Centennial Committee and the community as a whole, it was learned.

Councilor Isabelo Cosalan, Jr., who handles the committee concerned with the forum, expressed concern for a neighboring area for the city's garbage. He however said, he understands the need for continuing consultations, as to ancestral domain issues, and Environmental Compliance Certificate (ECC) required for a sanitary landfill, or materials recovery facility (MRF). Liquid waste in the waterways going though the sewerage plant are also being studied, in consideration for neighboring areas where the rivers proceed.

### New Curriculum Under K to 12 for **Implementation next School Year**

BAGUIO CITY - The national government, through the Department of Education (DEPED) has already started implementing the Universal Kindergarten Law for all five year old children this school year and starting June 2012 the new curriculum for grades 1 and grade 7 will be implemented in line with the country's K to 12 Basic Education Program.

This was disclosed by DEPED Secretary Bro. Armin Luistro during the K to 12 Pre-summit Conference for education sector stakeholders of Northern Luzon, held at the Teachers Camp here earlier this week.

The K to 12 system includes universal kindergarten, six years elementary, four years junior high school and additional two years of senior high school.

By next school year, all incoming grade I should have attended kindergarten while incoming first year or grade 7 students will be covered by the six year high school curriculum. With this, the K to 12 will have its first graduates by 2018.

According to Luistro, the K to 12 program seeks to enhance the quality of basic education in the country as it aims to produce holistically developed learners who have 21st century skills and are prepared for higher education, middle level skills development, employment and entrepreneurship.

Luistro also assured that alongside with the implementation of the K to 12, they also aim to address the other perennial problems that hound the country's education including concerns on classrooms, teachers, textbooks, chairs and toilets within the next two years starting in 2012.

In terms on the issue of lack of teachers, Luistro disclosed that if we include the about 50,000 teachers being supported by the different Local Government Units (LGUs) all over the country, to the government hired teachers, the problem is not on congestion but on the mal-distribution of teachers.

According to Luistro, out of the 45,000 public schools and 20 million students nationwide, there are only about five to six percent schools mostly in urban areas that experiences conges-

"The problem is not congestion; if we plan it very well and if we have elbow to move students and teachers in different areas, we will have no problem with classrooms and teachers,'

Luistro also disclosed that before the next school year (SY 2012-13) starts, all government teachers will report first ton their respective division offices before they are deployed to their respective assignments to identify the excess teachers in each division and to see what area or division needs additional teach-

Luistro reiterated that r with or without the K to 12, government is keen on addressing the perennial problems that have been hounding the country's education sector./JDP/LD-PIA CAR
