Smoke Violators Increasing in City

BAGUIO CITY the conduct of another operation by the Roadside Inspection, Testing and Monitoring Team (RITMT) for 5 days yielded an increase in violators.

This was revealed by the City Environment and Parks Management Office (CEPMO) during the regular meeting of the Alay sa Kalinisan, Inc. (ASKI) held last Tuesday.

In the report, the team conducted roadside testing on both diesel and gas fed vehicles at Governor Pack Road, Session Road and Magsaysay Avenue from October 4 to 8.

A total of 172 vehicles were flagged, 99 for diesel and 73 for gas.

After the test, 64 vehicles (diesel fed) failed while 44 ve-

Market Supt warns of scams in market

BAGUIO CITTY -Market Superintendent Policarpio Tamayo this week warned interested individuals wanting to obtain "stall rights" in the market not to transact business with persons who represents themselves as agents.

Tamayo said reports reaching his office of unscrupulous persons collecting money from vendors promising them with "spaces" for Block 3 should not be entertained.

He said this persons who take advantage do not have authority and are not connected in any way with the city government and their transactions are illegal. force is still formulating guidelines for the use of Block 3 and we are still reconciling our records, he said.

Interested persons are advised to visit his office for clarification and information on certain rights in the market.

The rehabilitation of Block 3 will take a period of 220 days./paul rillorta

Nursing graduate airs plea to mend
hole in hear heartfee and room charges.

Unable to take the nursing board examinations just so her brother could finish his own nursing course, Jheremy Camacho, turned to on-line tutoring Korean students in English.

Last June, the 26year old underwent medical examination for a call center job in Manila that would enable her to earn for her own nursing board review. The companycommissioned clinic came up with a finding, but advised her to 2Dhave а echocardiogram to confirm the diagnosis.

She had the test as a charity case, and was told the clinic diagnosis was right. Not fit for call center duty, she came back to Baguio where another 2D Echo validated her condition.

Doctors advised her to give up her online tutoring and to prepare for corrective surgery - as soon as possible to prevent life-threatening complications.

"Miss Camacho is suffering from a congenital heart disease. Atrial Septal Defect (ASD) which was confirmed and reconfirmed by repeated 2D echocardiograms," her attending physician,. Dr. Renato Manalo, wrote.

"Presently, she is asymptomatic but already presents with mild pulmonary hypertention that is developing secondary to the ASD," the doctor explained last July.

The doctor recommended open heart surgery, stressing it as urgent, "to avoid the development of Eisenmenger Complex which may render her inoperable and would have a shortened life span once this complication has set in".

The surgery would cost, at a minimum, P350,000 if done on a package deal at the Philippine Heart Center in Quezon City.

If it's any relief, the operation can be done in Baguio, with a local hospital estimating the expense at P270,000, with the waiving of surgeon's The operation was originally set last September 27 but was reset first week of October due to fund lack. It's being reset again, to when her family is able.

Jose, Jheremy's 56-year old father, has been driving a taxi since 1984, enabling him and wife Leticia to raise four children. Adeline, the eldest child at 32, is now married and living in Manila. John Michael, 23, also took up nursing and is now a volunteer nurse at the Philippine Military Academy. Dustin is 8 and a thirdgrader at the SLU Laboratory School.

City To Pounce On Parents Allowing Kids To Engage In Child Labor cially during rush hours unmindful of

BAGUIOCITY – Parents who will continue to allow their minor children to engage in child labor practices like selling plastic bags or hauling baggage at the city market and hailing taxicabs for a fee along city streets can be charged of child abuse.

Mayor Mauricio Domogan Tuesday said this can be an option for the city government if parents will not heed the city's appeal to keep their children out of the markets and the streets and instead enroll them in schools.

The mayor said that with the current campaign to stop these activities, the city resolved to round up the children and confer with their parents through the city social welfare and development office. City market superintendent Paul Tamayo reported that since the campaign, the number of children selling plastic bags has visibly decreased and this is expected to continue as the city secured the commitment of the Muslim community to which most of the children belong, through the Office of Muslim Affairs (OMA), to stop the practice.

The mayor earlier called for the meeting with the OMA to discuss possible solution to the problem.

The mayor also tasked Tamayo to investigate reports on the proliferation of streetchildren hailing taxicabs for passengers for a fee of P5 which was suspected to be part of the activities of a syndicate.

The children were observed milling along Abanao St. jostling for positions to stop taxicabs especially during rush hours unmindful of the danger of being bumped or sideswiped by the vehicles.

In last Tuesday's meeting, Tamayo reported that the children were observed to be remitting their collections to a certain man. He said they tried to accost the children and the man but they evaded them when they ran towards a damaged fence which Tamayo said was suspected to be intentionally destroyed to allow the said children to elude an arrest.

Domogan said the city will continue to investigate the matter and will sustain rounding up these erring children and conferring with their parents.

"I hope they will cooperate with us as what we are doing are also for the good of their children," the mayor said./A Refuerzo

Kindergarten 101 On Hunger

"The lola sat down and ate the rice I gave. Then, she cried," our 4-year grand-daughter Kathie explained: "There were two children with her," 7-year old sister Kristin added. "They ate the sardines I put on their rice".

Welcome to Kindergarten 101 on hunger.

Kristin is a first grader and Kathie is in kindergarten. Both study at Cebu International School. Sundays, their parents drive them to where grimy out-of-school kids cluster. The two share food packs they've prepared.

"Happiness never decreases by being shared," the Buddha taught. For now, that's enough for Kristin and Kathie.

Later, they'll learn that 17 out of every 100 youngsters can't even enrol in primary school. Then, they may see that kids they shared food had little chances for full human lives. But that'll be

long after the wife and I will have passed on. "Large numbers start dying after they

are born", says the new report Winning the Numbers, Losing the War. Scrawny stunted kids here are "comparable to the prevalence of underweight children, under 5 year of age, in Sub-Saharan Africa.

In Burundi, Madagascar, and Malawi, poor nutrition stunts about half of the children, says 2010 Global Hunger Index Ineffective government, conflict, and political instability interlock. These spiral into hunger and high infant mortality.

That's a stark snapshot for "World Food Day". Over 150 nations mark, on October 16, their commitment to fill granaries —and failure to do so.

Remember the 1974 World Food Conference? Then U.S. Secertary of State Henry Kissinger proposed a gung-ho ideal: Food and Agriculture Organization member-nations should ensure that "within a decade, no child should go to bed hungry".

It didn't work out that way.

Bolting food prices, the financial crisis and ecological corrosion saw the number of hungry people breach the one billion threshold last year. "Don't trust a hungry man to watch your rice," a Tibetan proverb cautions.

More Filipinos are hungry now than in 2000. That was when the Philippines and 188 other countries, pledged to meet Millennium Development Goals (MDGs). The eight Goals set minimum targets that'd tamp down hunger, keep kids in school, cut down maternal deaths and enlarge freedoms.

MDG Goal 1 committed us to "halve the proportion of people who suffer hunger" by 2015. How far have we lagged?

About four million families today are food-short. Only four out of every 10 Filipino households get "the recommended energy intake per person," the last national nutrition survey reports. Scrub the technical jargon and that reads: Almost half of Filipinos don't get enough to eat.

Social Weather Stations tracked quarterly, since 1998, penury and empty bellies. Leery of "window dressing", SWS uses "selfrated hunger" as it's main gauge. Food lack sweeps away fuzz that blurred traditional peso-and-centavo yardsticks.

Hunger levels see-sawed, SWS found. But starting June 2004, these climbed to double digit levels. They've never returned to single digit levels. And malnutrition cuts a deadly swath in the boondocks.

"The poor and excluded, in 2010, live in rural communities far from Manila," the report notes. They are the landless, homeless, jobless, underemployed, uneducated, sick, malnourished and discriminated against. Many are women, Muslims and indigenous peoples.

Chipping away at chronic hunger isn't enough. Three out of 10 kids are undernourished. Over 26 percent kids, under 5, are underweight. Those stunted crest at 28 percent. The highest incidence of ill-fed kids cluster in places like Bicol, the Zamboanga Peninsula and Autonomous Region of Muslim Mindanao.

The MDG target on hunger alleviation "is way off track" If we're to catch up, business-as-usual approaches will no longer do. Studies of 122 developing and transition countries "show the

That I am filing a complaint for violation of the Anti Graft and Corrupt Practices Act [RA 3019], Code of Conduct and Ethical Standards for Public Officials and Employees [RA 6713] and Dereliction of Duty- Art, 209 of the Revised Penal Code [RPC] against Asst. Bagnio City Prosecutor ROLANDO VERGARA with contact address at the Baguio City Prosecutor's Office, Hall of Justice Abanao St., Baguio City;

That based on the foregoing I have strong reason to believe that the respondent had violated Sec 3 [a] of RA 3019 stated as follows :

Sec. 3. Corrupt practices of public officers. - In addition to acts or omissions of public officers already penalized by existing law, the following shall constitute corrupt practices of any public officer and are hereby declared to be unlawful:

(a) Persuading, inducing or influencing another public officer to perform an act constituting a violation of rules and regulations duly promulgated by competent authority or an offense in connection with the official duties of the latter, or allowing himself to be persuaded, induced, or influenced to commit such violation or offense.

Likewise RA 6713 Section 4 - a, b, c and e clearly state the following for which the respondent should observe and be reminded of :

Section 4. Norms of Conduct of Public Officials and Employees. - (A) Every public official and employee shall observe the following as standards of personal conduct in the discharge and execution of official duties:

(a) Commitment to public interest. - Public officials and employees shall always uphold the public interest over and above personal interest. All government resources and powers of their respective offices must be employed and used efficiently, effectively, honestly and economically, particularly to avoid wastage in public funds and revenues.

(b) Professionalism. - Public officials and employees shall perform and discharge their duties with the highest degree of excellence, professionalism, intelligence and skill. They shall enter public service with utmost devotion and dedication to duty. They shall endeavor to discourage wrong perceptions of their roles as dispensers or peddlers of undue patronage.

(c) Justness and sincerity. - Public officials and employees shall remain true to the people at all times. They must act with justness and sincerity and shall not discriminate against anyone, especially the poor and the underprivileged. They shall at all times respect the rights of others, and shall refrain from doing acts contrary to law, good morals, good customs, public policy, public order, public safety and public interest. They shall not dispense or extend undue favors on account of their affice to their relatives whether by consanguinity or affinity except with respect to appointments of such relatives to positions considered strictly confidential or as members of their personal staff whose terms are coterminous with theirs.

(c) Responsiveness to the public. - Public officials and employees shall extend prompt, courteous, and adequate service to the public. Unless otherwise provided by law or

ensure openness of information, public consultations and hearings whenever appropriate, encourage suggestions, simplify and systematize policy, rules and procedures, avoid red tape and develop an understanding and appreciation of the socio-economic conditions prevailing in the country, especially in the depressed rural and urban areas.

Malfeasance and Misfeasance in Office [Dereliction of Duty], Art. 209 [RPC] – "Betrayal of trust by an attorney or solicitor-Revelation of secrets. – I n addition to the proper administrative action, any attorney at law or solicitor [procurador judicial] who, by any malicious breach of professional duty or of inexcusable negligence or ignorance shall prejudice his client,..."

That after our meeting at the Linis Gobyerno, Mr. Farres informed me that he will accompany us before the next trial date to discuss and clarify matters with the respondent;

10. That on the morning of September 2, 2010, I together with Mr. Freddie Farres and Mr. Odell Aquino went to the office of the respondent to clarify the disheartening statements of the respondent while in a discussion with the respondent Mr. Farres stated

Is it true that you stated to our members, the herein complainants, that they would have to produce the witness [security guard] otherwise they will loase their case?

Yes we need the security guard as our witness, was the reply of Asst. Prosecutor Vergara;

So how is this, as prosecutor it is your job to handle prosecution since your office had found probable cause and filed the complaint, are you still comfortable to handle prosecution ?

No 1 are not comfortable in prosecuting this case, you better just get a lawyer was the reply of And . Prosecutor Vergans:

I also asked Asst. Prosecutor Vergara, if it is true that he told the complainants our members that if in case there will be an offer for a settlement from the accused they should consider it and what was his basis for saying so has there been any offer ?

According to Assi, Prosecutor Vergara there was no offer mode by the occured and his only busis is the motion for re-consideration filed by the accused, this was the reals of Asst. Prosecutor Vergara;

Furthermore, Asst. Prosecutor Vergara: elaborated that if in case there is an offer they should acriously consider it even if the amount is not based on their actual elaboral damages as most often than not the actual amount_does not get realized and that they should consider themselves locky to get whatever amount they can get, this was the further comment of Asst. Prosecutor Vergara;

 That the aforecited clarifications are just some of the questions in our dialogue with the respondent that will clearly show his attitude and refusal to handle prosecution;

Disaster Preparedness for Baguio City

It is disheartening to discover the official website of the Baguio City government is NOT working. I intended to see whether it has a disaster preparedness plan ready for the coming typhoon (code named Juan locally but code named Megi internationally). The dominant forecast is that the typhoon will hit land northeast of the country then hit Apayao and exit to the sea through the Ilocos Region. It is good that once the typhoon is in the Philippine area of responsibility, the weather Bureau will be making forecasts every hour, according to P-noy!

However, what everyone of us should now is that the typhoon path has actually five possibilities. One of the five possibilities is that being followed by PAG-ASA. However, one of the five possibilities is that the typhoon can pass through Baguio City and Benguet and exit through Pangasinan. Another one of five possibilities is that the typhoon will go northward and not hit the Philippines. The latter is probably no longer probable as we are informed by the latest weather report that the typhoon is really to hit land Sunday, 17 October.

We must monitor PAG-ASA's forecast but we must also be aware that PAG-ASA is not the only weather bureau in the world that is monitoring the typhoon. I used to track typhoon back in my elementary days out of a hobby. Recently, in the light of PAG-ASA's failure to forecast typhoon reliably, I began to monitor the weather forecasts of weather stations abroad on our own weather and typhoon. I found out that their forecasts are more reliable than our own and I concluded that the culprit probably lies in the equipment of our weather bureau.

However, a private organization in the Philippines has been better than our PAG-ASA in making weather forecasts. This private organization is that one represented by www.typhoon2000.com. How is that possible? I think the reason lies in the organization's bold use of the weather forecasts of weather bureau's abroad. In addition, the www.typhoon2000.com use not only one but several forecasting models.

What is a forecasting model? Basically, a forecasting model uses formulas on how the typhoon tract can be anticipated. The formulas themselves are based on reasonable assumptions. So if there are several forecasting models, this means that each typhoon forecasting model uses a set of assumptions.

Thus, in making forecasts, a person who is conscious that other forecasting models are available would be very careful in making his or her statement forecasts. More than this, the forecaster may even more informative if the other forecasting models are also reported. The other forecasting models would basically show the other movement possibilities for the typhoon. It would most likely inspire preparedness rather than a false sense of security for many people that their locations would not be within the path of the typhoon.

What is the point therefore? The point is that a weather forecast is only one of the several possible tracks of the typhoon. Preparedness requires that other forecasting models be reviewed as well concrete steps taken towards greater preparedness. For instance, have the city defined on the map the areas vulnerable to flooding? Suppose there is a typhoon, to what offices should the affected residents flock to when it becomes necessary? Will there be blankets? Will there be soups or noodles? What are the concrete plans? In case of strong earthquakes, where are the evacuation areas? What are the guidelines? Are they appropriate? For instance, one poster says that we can hide under the table? Is this advise appropriate given that most tables in the classrooms are frail?

A Baguio City government website is important. However, more important than this, the Baguio City government must be instructive on how we can cope with disasters. For example, it must contain all the emergency numbers as well as concrete advise on what we must do during landslide, fire, earthquake, gas attack, and various other types of disasters.

I am sharing the post here, for whatever it is worth. -000-

"BE PROUD YOUAREA CATHOLIC": Excerpts of an article written by non-Catholic Sam Miller - a prominent Cleveland Jewish businessman: "Why would newspapers carry on a vendetta on one of the most important institutions that we have today in the United States, namely the Catholic Church?

"Do you know, the Catholic Church educates 2.6 million students everyday at the cost to that Church of 10 billion dollars, and a savings on the other hand to the American taxpayer of 18 billion dollars. The graduates go on to graduate studies at the rate of 92%. The Church has 230 colleges and universities in the U.S. with an enrollment of 700,000 students.

"The Catholic Church has a non-profit hospital system of 637 hospitals, which account for hospital treatment of 1 out of every 5 people - not just Catholics - in the United States today.

"But the press is vindictive and trying to totally denigrate in every way the Catholic Church in this country. They have blamed the disease of pedophilia on the Catholic Church, which is as irresponsible as blaming adultery on the institution of marriage.

Dig this. Only recently while I was browsing the Internet, I chanced upon an article that should be cause for alarm for us media practitioners, especially those based in Mindanao.

An article from the website of an AM radio station said that a "death squad for media" is threatening media practitioners in Cotabato City.

Hey....! President Noy...! Are you there...there...ther...the...thrrr...!

The report said some media members in Cotabato City are receiving death threats through text messages and phone calls from members of the alleged death squad.

Among those who received threats were Director Ali Macabalang of BPI-ARMM, Noel Punzalan of the Philippines News Agency, Nash Maulana of the Philippine Daily Inquirer and other reporters from Bombo Radyo and Manila Bulletin.

The threats came after some Mindanao-based journalists began tackling some sensitive issues, including the controversial Maguindanao massacre where 57 people, including 30 media members, were brutally killed allegedly by members of the Ampatuan family.

Our group now calls on the Philippine National Police (PNP) to seriously look into the matter as putting it in the backburner would be another Maguindanao massacre in the making.

We believe that this threat is designed to silence the media on the issues regarding the massacre, especially now that the trial of the multiple murder cases against the Ampatuan has begun.

and 1 day to a maximum of 13 years. This stemmed from a case of violation of Sec. 3(e) of R.A. 3019 otherwise known as the Anti-Graft and Corrupt Practices Act.

In Pamintuan's decision dated October 8, 2010, it is noted that Caburao dilly-dallied in his investigation on a case of tax fraud case that was assigned to him way back 1999. Accordingly, Caburao took 3 years to make a final report on a very easy case wherein "all he has to do was to consult the B.I.R. Official Table of Capital Gains Taxes," the Decision reads. This delay has caused the delay also of the resolution of tax fraud case against spouses Benito and Lydia Areola. The complainant in this tax fraud case is Freddie J. Farres (Executive Director of an anti-graft group, Linis Gobyerno), who is also the same complainant for the case against Caburao for dereliction of duty.

The decision states that Farres and his wife bought a piece of land from spouses Areola amounting to P1.8 million. The Areolas, however declared a selling price of merely PHP500K, which was the basis of the capital gains tax paid by them. Farres maintained the cost of sale is 1.8 M evidenced by a notarized Deed of Sale, which he submitted to the BIR. This mis declaration by the Areolas prejudiced the BIR of its tax collection, much needed by the government.

Caburao, in his testimony said that he did his job in 33 days. The court said otherwise, based on documentary evidence. "The record shows that the investigation and final submission of investigation report by the accused Caburao did not take place within 33 days. What the accused was referring to finishing in 33 days was his preliminary report that he was still investigating and asking agencies and a court on the Areolas. The record further reveals that it took accused Caburao as BIR Investigator almost 3 years before he concluded this investigation and submitted a Formal Report from April 22, 1999 to January 29, 2002, despite numerous follow-ups of private complainant for the said Final Report. It even took 2 sitting B.I.R. Commissioners in the persons of Commissioners Beethoven Rualo and Guillermo Parayno to order the submission of the said Final Report, to no avail, as the same was only submitted by the accused after almost 3 years.'

Simply put, it took 3 year to finish a job that can be done with dispatch on same investigation day of April 22, 1999, "before sunset of said day, literally and figuratively." What was the accused waiting for given that much delay? Or was not the accused deliberately delaying the final report for whatever reason or gain?" the Decision added.

"Clearly, the Government was damaged and prejudiced for almost 3 years in being unable to collect the said Capital Gains Tax due to the Dereliction of Duty of the accused. Taxes are the lifeblood of the Government, and any failure to its collections affects the basic social services that the Government has to provide for the people. Worse, if failure of the collection to taxes is brought about by some officers and employees of the B.I.R., who are mandated by law to effect an efficient and honest collection of taxes but did not, like the herein accused.... Clearly, the guilt of the accused for the Dereliction of Duty under the Anti-Graft and Corrupt Practices Act was proven beyond reasonable doubt."

Aside from imprisonment, Caburao was also perpetually disqualified from holding a public office and is also ordered to pay actual damages in the amount of PHP 80,161.07 with legal interests from 1999 until the amount is fully paid, plus costs of suit. This reporter was trying to get in touch with Caburao but due to the City Jail schedule of visitor he was adviser to come back on the allowed schedule. Meanwhile, Farres, the Executive Director Of Linis Gobyerno stated that, the group will not be deterred from pursuing the fight against graft and corrupt practices in government./GP.Binwagan

window of opportunity for improving nutrition spans from conception to age two. After age two, the negative effects of undernutrition are largely irreversible," cautions the International Food Policy Research Institute in a World Food Day report.

Child undernutrition could be cut by 25-36 percent, IFPRI adds. But countries must "make nutrition, especially for young children, a political priority." Funnel where scarce taxes will do the most good – among pregnant and breastfeeding women and children in their first two years of life."

President Benigno Aquino worked in larger allocations for education, health and poverty reduction in the proposed 2011 budget. That is a modest start. "One swallow does not make a summer."

Philippine Institute of Development Studies' Rosario Manasan estimates P100.4 billion should beef up allocations for education, health, water and poverty reduction. That didn't happen when a President feasted at \$20,000 Le Cirque dinners and Tesda spent P66 million for GMA T-shirts.

NGO coalitions offer the "Alternative Budget Initiative. These focus on where the poor are, explains Leonor Magtolis Briones, convenor of Social Watch Philippines which organized the ABI. Priorty should go to agriculture and fisheries women, indigenous peoples and Mindanao.
