To date, your generosity has generated an impressive return. You've helped permanently protect more than 60,000 acres.

In 2022, we continued to enhance our nature preserves with access improvements and habitat restoration, making notable progress toward the future opening of Black River Sanctuary, our 14th and newest nature preserve, offering 187 acres right within the Lehigh Valley.

The whole health of our 10-county Lehigh River watershed happens one willing landowner at a time, and every tree, shrub, and wildflower taking root improves our water quality. Last year, you helped **restore 1.5 stream miles across more than a dozen sites in Lehigh and Northampton counties.**


