# Warring Bible, Law Insights Follow Media-Covered Gay 'Union'

BAGUIO CITY – Various religious leaders and local officials last week vocally expressed antagonism over rites purporting to be a 'joining together' of members of the same sex.

In the heels of a media-covered 'gay declaration of monogamy' administered by the local Metropolitan Community Church (MCC), religious leaders, June 28, mustered faithful and came up with a manifesto against alleged 'misrepresentation of truth.'

In feelers sent to members of the City Council, members of the Evangelical Christian Community Baguio-Benguet (ECCBB) questioned the legality of 'same-sex marriage' saying it has no basis in law.

They claimed the Family Code of the Philippines itself defines marriage as a union "between a man and a woman," adding the ceremony conducted by MCC is sham.

# Civilians can report erring cops thru Delinquency Reporting System

BAGUIO CITY - Civilians and even fellow officers can report infractions committed by policemen with the Delinquency Reporting (DR) system of the Philippine National Police (PNP).

Police Regional Office-Cordillera (PRO-COR) Information Officer Police Senior Inspector Pelita Tacio, bared this new system during a radio interview.

Tacio explained that in the DR system, complainants need only to go to the nearest police station. They can just fill out the DR form stating the time, place and date that the offense was committed. The policeman accused of committing the offense then has 24 hours to give his side before he is given a demerit for

She stressed that this is a preventive measure designed to lessen the incidence of misdemeanors of PNP personnel by instituting on the spot corrections thereby eliminating or at least mitigating the cause of such wrongdoing, and to remind and instill in all PNP members the observance of proper decorum at all

Considered as minor infractions are sloppy wearing of the police uniform, tardiness, smoking in places not designated as smoking areas", violation of traffic rules, use of vulgar or insulting languages or exhibit similar rudeness to the public, spitting, littering, urinating in places other than the designated areas, sleeping on the post, absence during flag raising ceremony and other activities, and leaving the post for more than two minutes.

# Benguet To Conduct Resources **Inventory Training to Fastrack Turn-**Over of Communal Forests to LGUs

Benguet - The province is working out for the conduct of a training on assessment and inventory of resources in communal forests in efforts to fastrack the turn-over of the management of communal forests from the Department of Environment and Natural Resource(DENR) to the local government

According to Provincial Environment and Natural Resources Officer Guillermo Fianza, the towns of Atok, Sablan and this town have already submitted all the necessary

LATRINIDAD, requirements for some portions of their communal forests with the DENR-Central Office but are pending awaiting the submission of assessment and inventory of resources.

> Fianza said resources inventory is an additional requirement prior to the issuance of an administrative order of the DENR relative to the management of communal forests by the LGUs.

> He also bared that concerned staff of the PENRO, Community Environment and Natural Resources Office

(CENRO) and the Environment and Natural Resources Office(ENRO) will undergo a refresher course in the inventory of resources such as techniques in accounting timber among others.

According to Fianza, documents submitted to DENR-CO will still undergo deliberations before the DENR Secretary finally approves and issues an administrative order(AO).

After 12 months upon issuance of the AO, a management plan governing the development of the communal forest will be formulated and

# **DPWH Enforces Truck, Bus Ban** Along Fragile Kennon Road

BAGUIO CITY - All types of buses and big trucks weighing 11 tons and above are not allowed to pass in the historic Kennon Road, as per advisory issued by the Department of Public Works and Highways.

Covered in the ban are trucks with the following description; 6 wheeler weighing 11 tons (loaded), 10 wheeler with 12 tons (no load) and 18 wheeler 17 tons (no load).

According the Engr. Edilberto Carabbacan, regional director of DPWH Cordillera, the truck and buses ban is to prevent accident and further destruction to the three bridges along Kennon road which were declared by the Bureau of Design of the DPWH as 'weak'.

The DPWH is strictly enforcing a one-way traffic with no shifting gears along the Kennon Bridge, Demonstration Bridge and Camp 6 Bridge for safety purposes.

'Our concern is safety for everyone, the motorist and the riding public. We have already recommended for the immediate repair and restoration of the bridges,' he said.

Carabbacan admitted that Kennon Road is fragile considering that there are many areas aside from the bridges, which need repair.

"If we continue allowing heavy trucks using Kennon Road it would aggravate the damaged sections,' he explained.

The scenic Kennon Road is still the shortest route going to Baguio and it is where one can see the panoramic Zigzag Road and the Lion's head /Joseph B Zambrano/JDP/JBZ-PIA

# 8 Couples Marry in Same-Sex Holy Union

BAGUIO CITY - "I do..." Eight couples including a foreigner exchanged vows in the first holy union of same-sex in the country held here in this mountain resort over the weekend.

The Metropolitan Community Church (MCC) of Metro Baguio spearheaded the solemn wedding ceremony of samesex couples at the Ayuyang Restaurant attended by at least 100 witnesses, family and other supporters of the couples.

American Richard Macleland and Filipino partner Jonjon Punzal came up to Baguio City from Caloocan City on Saturday to be blessed and united as one in the church ceremony. The couples for two years were joined by three other male couples and four female couples from Baguio and other parts of the country.

MCC pastor Myke Sotero said that although same-sex wedding is not allowed under existing Philippine laws, their church organization only aims to assert the right to love and relationship of same-sex couples by conducting the holy union.

Sotero explained that the mass wedding is not same-sex marriage but same-sex Holy Union as there is no law yet recognizing same-sex marriage in the country. He said that the Holy Union is a celebration of the love of the same-sex couples and it is not immoral.

He adds that the MCC offer a safe haven for the Lesbian, Gay, Bisexual and Transgender where they can build a relations hip with God and live the way they are without fear of discrimination.

MCC Makati Pastor Edgar Constantino cleared that holy union rites are given to LGBT couples who wish to profess their love and fidelity to one another before God and the community. He stressed that the constitution provides a clear provision on religious freedom and separation of church and state.

The Holy Union event was the highlight of the annual Baguio Pride Network celebration. It also coincided with the legalization of Same-sex Marriage in New York City in the United States of America.

Meanwhile, the same-sex wedding gathered negative reactions particularly from the different religious sect here in the city. The Catholic Church together with the other Christian Churches here in Baguio criticized and condemned the act of same-sex wedding which they point out is immoral and unacceptable./Redjie Cawis/JDP/RC-PIA CAR

# Low Bail Bond Contributory to Recurring Incidents of Pickpockets,

Snatching

TRINIDAD, Benguet July 1 (PIA) - - The Sub-Committee on Intelligence Coordination (SCIC) of the Regional Law Enforcement Coordinating Committee (RLECC) is exploring possible solutions on the low bail imposed on perpetrators of street crimes, which is one of the reasons of the recurring incidents of pickpockets and snatching particularly in Baguio City.

SCIC reported based on that records, there are suspects of pickpocket and snatching who have been in and out of jail, attributing the same to the affordable bail bond of only

P1,000.00 to P2,000.00 for such offense.

This is further aggravated by the victims' decision not to file case against the suspects due to the long case proceedings. Notably, victims are usually tourists.

During second quarter RLECC meeting Thursday, the SCIC requested RLECC to possibly consider reviewing existing laws relative to the amount of bail imposed on perpetrators street crimes such as pickpockets and snatching, and make necessary recommendations for amendments to increase the same to discourage the perpetration of said crimes.

According to Atty. Elmer Sagsago of the Department of Justice (DOJ), when the Prosecutors Office file cases of theft, it also recommends the amount of bail.

"The amount of bail is based on the value of the property that was taken because the value of the property determines the possible

penalty", he added. He also affirmed that the DOJ is merely recommendatory and that it is the court that has the final say on what would be the final amount to be posted by the accused.

He recommended that perhaps a dialogue with

### Casino says he Will not **File Same-**BAGUIO CITY - Bayan Sex Marriage Bill Muna representative Teddy

Casino made it clear that he will not file a bill that would involve same-sex marriage.

Casino made the clarification amid concerns over the first same-sex wedding in the country that was held in the city last weekend and creating a stir over the past days.

The mass same-sex wedding done last Saturday, June 25 at the Ayuyang Restaurant here in Baguio joined in "Holy Union" eight same-sex couples to highlight the celebration of the Baguio Pride Network.

The ceremony officiated by the Metropolitan Community Church also coincided the passage of the legalization of same-sex marriage in New York in the United States.

Casino, who led the Pride parade at the city's thoroughfares last Sunday said that he is not filing a same-sex marriage bill but he is promoting of the House Bill 1483 or the Anti Discrimination Bill.

He stressed that same-sex marriage is not included on his Anti Discrimination Bill that he is pushing for its passage in the Congress. There is no bill on same-sex marriage filed in Congress and Senate at this time, he added.

The lawmaker explained that the HB 1483 aims to guarantee equal rights among the lesbians, gays, bisexuals and transgender and prohibit the discrimination they are experiencing.

Casino said that the LGBT are being widely discriminated today in schools, work place and the communities. They are always subject to ridicule, discrimination and even violence he adds.

He said that reports on hate crimes to LGBT recorded from January to June this year is 104 cases and this has been increas-

Casino said sexual orientation and gender identity should not be a hindrance to the enjoyment of the constitutional rights as Filipinos so he is really working for the Anti Discrimination Bill's passage./ Redjie Cawis/JDP/RC-PIA CAR

# Feathered Desaparecidos

The grey-haired visitor from Brussels was perplexed, 'Where," he asked." did your birds disappear to?"

In his native Belgium, storks tiptoe unhindered between tractors. Robins and pigeons fill the parks. "Feed the birds / Two pence a bag" is the haunting "Mary Poppins" refrain.

In contrast, birds here run a gaunlet of slingshots, traps and pollution —and disdain."If it flies, it dies", a Negros gun club bragged. We've razed forests, paved over mangroves ("Asphalt is the last crop') and poisoned rivers that are habitats for birds.

The Mindoro imperial pigeon, Sulu hornbill and Mindanao parrotfinch have vanished, we wrote in 2004. Since then, the number of native species, threatened with extinction, have risen

to 89. Among these are the Blue-Winged Racquet-Tail, the

Isabela oriole, the Dark-Eared Brown Dove, Mindanao Bleeding-Heart and the Chinese Crested Tern.

"Your children will no longer thrill, as we once did, to the heart-stopping dive of a hawk," National Scientist Dioscoro Umali, told UP graduating students, just before his death. "We've stripped the land of its beauty," he said "And the

"We've stripped the land of its beauty," he said "And the bitter tragedy is the victims are our grandchildren — flesh of our flesh, bone of our bone."

Yet, the Philippines is a "mega-diversity nation," notes the UN's "State of Environment in Asia and the Pacific". It's wedged among the top seven countries that "collectively claim more than two-thirds of the earth's biological resources." The Philippines and Australia top Indonesia in number of "endemic" or native birds.

The UN sponsored World Migratory Bird Day on May 8 last year. It's theme was: "Save migratory birds in crisis – Every species counts!". No less than 77 species of egrets , plovers and sandpipers rest at Olango Island, off Cebu, as they traverse the East Asian Migratory Flyway, to flee winter.

Worldwide, a staggering 1,227 or 12.4% of the total 9,865 extant bird species in the world are currently classified as globally threatened. Of these, 192 are tagged "Critically Endangered.."

An estimated 19% of all known birds are considered migratory. BirdLife International classifies 11% as "Globally Threatened."

Today, the Philippines has deteriorated into a "bio-diversity hot spot" —one of the region's 12. This strip expends from Indian Ocean islands, Eastern Himalayas to Sri Lanka. Many endemic species face extinction within this belt.

Deforestation saw "a number of bird species disappear from Cebu, Negros, Panay and Mindoro," the UN study notes. "Of highest priority for conservation are Indonesia's Lower Sundas, Eastern Himalayas, Luzon (especially Mindoro)" it adds.

On an Ulaan Bator hilltop, I watched hawks, swoop from clear Mongolian skies. Childhood memories of hawks swooping to snatch chicks in outlaying barrios resurfaced. "My grandchildren never saw this," I mumbled. "And they're poorer for the loss."

The Master from Galilee used the image of a hen, sheltering chicks from marauding hawks, to underscore "the time of visitation."

Birds perform multiple tasks from curbing insect infestations to scattering seeds.

In the shrinking North Negros Forest Reserve, 20 percent of trees will fail to regenerate, if the present rate of hunting continues, a University of British Columbia study notes.

Like rivers, birds make up a unique and sensitive early warning system. When rives dry up, or birds disappear, they signal that "the environment is under such stress that species which lived in them for thousand of years, can no longer survive," the Philippines Red Data Book notes.

The graybird and flower pecker (dicaeum quadricolor) were unique to Cebu. They've been wiped out and are now numbered among "feathered desaparecidos".

Add to these "disappeared" the Black-Hooded Coucal, Negros Striped-Babbler, Philippine Cockatoo, White-Throated Jungle-Flycatcher and Flame-Templed Babbler.

Cebu Daily News' mascot is the endangered black shama or siloy. But 'I haven't seen a siloy," columnists Roy Lu wrote. 'Worse, I have seen other birds that will never sing again: the tukmo, the kukuk."

"Concentration of endangered birds is larger in islands like Hawaii, the Philippines, Indonesia or **Cont. on page 11**

The news of Friday evening, 1 July 2011, is disturbing for all of us.

On TV was the scene of Davao City Mayor Sara Duterte, hitting with the sharp edges of her clenched fist the face area near the eyes of the City Sheriff. The punches were executed not one, two, or three times but five times!

I suspected (I may be wrong, of course) that the Mayor had done a similar thing in the past because the punches were "professionally" executed: the Mayor knows how her punches can bring maximum visible damage to her "victim": using the sharp edges of the hand, attacking that part of the body where the bone is relatively sharp to damage the skin and flesh of the victim.

It appeared that hitting the Sheriff was premeditated by the Mayor (the incident that led to the punches was not likely planned). The Mayor looked for the Sheriff, demanded for the Sheriff, and had asked the Sheriff to come closer. The Mayor used her had to gesture to the Sheriff to come closer so she could deliver the punches with "professional" precision. These are figures of speech, of course.

Will the Mayor be the contrabida in this case? Most likely not. If we are to use Facebook as the indicator of public opinion, it is easy to conclude that our citizens are divided on the incident: some people are criticizing the Mayor but quite a number and probably a larger number is supporting the Mayor. Will a legal case arise from the case? Most likely not because the Sheriff who received the Mayor's punches has indicated that he will not file a case. To her credit, Mayor Duterte indicated that she would apologize to the Sheriff but not to the public. Neat.

The Duterte clan has a reputation for promoting extrajudicial killings in Davao City. However, the people of Davao has continued to vote for a Duterte for their Mayor. The national association of Sheriffs has poised to protest the punching but public opinion may likely side with Sarah Duterte even as Malacanang called for an investigation of the incident.

The context under which the Mayor punched the Sheriff: A court order was issued for the demolition of 200 "squatters" homes. The Sheriff was poised to implement the court order and violence between the demolition team and the squatters are brewing. The Mayor requested an extension of only two hours before implementing the decision. The Sheriff refused the request and pushed for the implementation of the court order. This led to a scuffle between the demolition team and the "squatters", prompting the Mayor to attack the Sheriff.

The two hours extension of the deadline requested by Duterte could have been useful for negotiations between the demolition team and the squatters to work. It could have been used to make cooler heads prevail and prevent a violence to ensue between the demolition team and the "squatters". It was a reasonable request. THE TRUTH IN THE POC-GTK ROW? Go Teng Kok was declared a "persona non grata" by the Philippine Olympic Committee (POC) not only because he sued the sports body on two occasions in violation of the POC Constitution, but more because of a series of "grave excesses" which the POC considered as sufficient bases to render him unfit to remain as a member or official of the POC.

This was made clear during the POC executive board meeting where Go, or popularly known as GTK, was "disowned" by the POC, and is in fact shown by the minutes of that board meeting (which meeting was considered a first at the POC because all its executive board members were present all at the same time—a phenomenon that rarely happened at the sports body).

Based on records coming from the POC, particularly the minutes of that fateful meeting of the POC executive board, it appears that Go Teng Kok was declared a "persona non grata" by the POC upon the vote of all its board members, including his known allies, after they tackled and were confronted with his alleged past excesses as a POC official.

"COMPELLING REASONS TO DECLARE GTK PERSONA NON GRATA": What were the supposed past excesses of GTK, entered into the minutes of the POC meeting, which prodded all its board members to disown Go Teng Kok and declare him a "persona non grata"? The minutes and the report of POC officials show the following:

First: The POC considered Go to have undermined efforts by the POC to unify the different sports sectors comprising the POC. This was allegedly due to his influencing the selection of leaders for wushu, billiards, basketball, table tennis, badminton, bowling, swimming, and volleyball.

Second: The POC considered Go to have influenced athletes to defy rules and policies promulgated by past POC officials. A case in point cited by the minutes and by my POC friends was Go's alleged leading of a boycott of the Philippine National Games in Bacolod City, which resulted in the banning of the athletes that supported the boycott from the National Pool.

-000-

"GTK VIOLATED POC CHARTER" AND MORE: Third: The POC found Go to have violated its Constitution by his having sued it twice, since it is the POC—not the courts—which is the final arbiter of disputes among national sports associations (NSAs) like the PKF. Because of this, the directive of the International Olympic Committee for POC to resist political, legal, religious, or economic pressures against the Olympic Charter was even disregarded.

Fourth: The POC found Go to have reneged on his own handwritten pledge to withdraw the first case he filed against the POC, and that while he had asked for arbitration to find an end to this first case, he nevertheless filed another case against the POC, this time to block the elections for PKF in Bacolod City.

Fifth: The POC found Go to have financially supported the election of convicted individuals as officials of NSAs; admitted that he operated a gambling den while he was president of the Philippine Amateur Track and Field Association; and maintained close ties with someone awaiting deportation, as well as with illicit organizations abroad. Any reactions, Mr. Go Teng Kok?

# Feature: Farmer finds fulfillment in Arabica coffee Organic Farming for Consuming Public Cordillera

An organic practitioner finds fulfillment in producing organic vegetables and fruits to feed the consuming public.
"We produce because we love people," said Mario Canuto

who is into organic farming for seven years now.

Mario Canuto used to practice the conventional way of farming employing chemically prepared inputs such as pesticides and fertilizers which he learned from his parents way back at a young age.

But he recounted that prior to the introduction of Masagana 99 sometime in 1972, farmers were engaged in natural farming or organic farming. With the advent of inorganic farm inputs, his father also tried and adopted like any other farmer, which eventually became a trend.

Although the ill effects were not pronounced at the start, through the years it manifested adverse effects in the environment such as human health and the soil condition.

What happened to his farmer-friend an eye opener. He suffered from lung cancer attributed to his exposure to inorganic farm

Another turning point for Canuto was the high cost of agrochemical inputs. True enough he may have gained lots of income if he was lucky but the high cost of inputs compensated.

He gave up the conventional way and tried to shift to organic farming. But it was not that easy, he quipped.

He started in 2004. He did composting his own way without the appropriate technology. There were several failures he encountered but persevered.

If he learned of any training on organic farming, he joined. It was a trial and error for him applying every technology he learns.

In the course of the trainings and learnings he acquired, it was a painstaking experience for him, yet he never gave up. He now learned to prepare appropriate pesticides to control insects and fertilizers to enhance and supplement the soil.

One of the learnings he also shared was that it takes around two years to condition the soil before producing a good quality of vegetable or fruit.

Organic farming is like taking care of a person that needs nurturing from time to time, Canuto said. It also inculcates discipline, he added.

At the time his produce was picking up in 2007, his only market was his neighbors and friends.

Canuto has a farm in Balili, in this town and in Camp 7, Baguio City.

But when he joined the Benguet State University Internal Guarantee System (BIGS) in 2007, his market expanded in Baguio City and La Union. BIGS was developed to monitor and guarantee cropping system for organic farm practitioners

In organic farming you can do intercropping unlike the conventional farming, Canuto said.

He harvests twice a week with the diversified crops he now produces such as vegetables and fruits.

With organic farming I always have a penny in my pocket even if they say I don't have wheels,' he said in the dialect.

The price is high but safety is assured, he said. The demand of organically produced vegetables is high. 'Isu nga haan nga maawanan ti market' (because there is always market for it), he added

Canuto also encouraged other farmers to produce and consumers to patronize. He also sought the help of the government to advocate organic farming. / Susan Aro/SCA, PIA-CAR/Benguet

# AFP Strengthens Alliance Stakeholders to Counter Insurgency Threatened

'If only our coffee farmers would produce Arabica coffee through agroforestry system technology, the problem on the degradation of pine forests and Cordillera watersheds which resulted from the cutting of pine trees would be addressed'. Macanes explained.

## Disposal of Pesticide Containers to be Regulated Soon

Benguet, June 30(PIA) - - Disposal of empty pesticide containers will no longer be a problem when the ordinance regulating the collection and retrieval will take effect.

The indiscriminate disposal of pesticide containers believed to be potential sources of environmental contamination and pollution led to the crafting of the measure which was approved for third reading.

One of the notable provisions of the Ordinance No. 148 series of 2011 mandates farmers the triple rinsing of the empty pesticide containers prior to its disposal.

It also mandates distributors, dealers, and agrochemical companies in cooperation with

the highest with 35 barangays, followed by Mountain Province with 34; Benguet with eight; Ifugao with six and Apayao with four.

He also bared that they have monitored 10 barangays in Mountain Province affected by the CNN.

Viteno explained

LATRINIDAD, the provincial government and its constituent local government (LGUs) the collection and disposal of the triple rinsed containers.

> The ordinance defines triple rinsing as an on-farm practice involving proper rinsing of pesticide containers for three times with uncontaminated water.

The rinsate resulting from the cleaning of containers with water will be set aside as spray solution for the farmers to utilize in their farms.

On the collection provision, LGUs at the barangay and municipal level will have to provide collection centers to ensure availability of storage sites for empty pesticide containers prior to disposal.

barangays are those communities that have been established as a territory of the CNN where infrastructures and organizations of the rebel groups are in

Threatened barangays, on the other hand, are those communities being estabaffected lished by rebel groups

Another significant provision is that it does not allow the selling of the containers to junk shops.

The pesticide industry in close coordination with the Fertilizer and Pesticide Authority and the Provincial Task Force on empty pesticide containers to be organized as mandated will handle the arrangement for the disposal.

Barangay officials will supervise the collection of such containers in their respective area of jurisdiction.

As can be recalled, Committee on Agriculture Board Member Apolinario Camsol who proposed the measure was able to get the nod of some agrochemical companies on the collection and retrieval scheme./ Susan Aro/JDP/ SCA- PIA CAR, Benguet

Rightly or wrongly, what is projected in the media is a Robin Hood Mayor and, like it or not, many will be siding with a Robin Hood. we believe in and uphold as the absolute authority for moral conduct, any marriage between people of the same sex is abhorrent in the eyes of God.'

They warned "Any attempt to violate God's holy will" is a cause for his wrath making same sex 'marriage' a danger.

MCC is led by Myke Sotero, Ceegay Agbayani, Regan Luna and Egay Constantino.

They 'formalized declaration of monogamy' amongst eight of members of the MCC last week in a ceremony which simulated a church wedding.

While Sotero declared what transpired was a mere declaration of love between one person to another, other denominations expressed shock on how the ceremony was conducted.

'[MCC's] action weakens our already struggling family and community structures by encouraging a mindset that goes against healthy propagation of the human race."

'[It] confuses the natural parentchild relationship with the unnatural, causing socio-cultural, moral and spiritual breakdown," they added.

ECCBB is composed of the Association of Metro-Baguio Christian Ministers, Benguet Evangelical Association of Ministers, Trinidad Evangelical Association of Ministers, Good News Community Church, United Church of Christ in the Philippines, Bethesda Ministries, Cordillera Prayer Network, and God's Great Mercy Ministries.

Reacting to the statement of ECCBB alderman Philian Weygan-Allan meantime proposed a resolution denouncing and prohibiting ceremonies purporting to be same sex marriages or unions in the City of Baguio.

# Warring Bible, Law Asin Hydro Privatization on as Terms Approved

Insights Follow Media - BAGUIO CITY - The city government is now preparing to bid out the operation of the city-owned Asin mini-hydroelectric plants in Tuba, Benguet to qualified private in-BAGUIO CITY – The city government is now preparing to bid out the operation of vestors after the city council last Monday approved the terms of reference (TOR) for the contract to rehabilitate and manage the power generating facility.

Mayor Mauricio Domogan hailed the development as a milestone in the city's thrust to maximize the power generating potential of the plants and restore their viability which slackened under the city government's reins due to lack of funds and expertise.

"I hope we can speed up the paper works to facilitate the bidding and realize the long overdue privatization of this vital facility," he said

The city council last Monday approved the TOR upon the recommendation of its committee on laws which posed a condition that the "contract for the privatization be submitted to the City Council for confirmation.'

The TOR, which took time in the drawing board, provides the requirement for the "rehabilitation, upgrading, expansion, operation, maintenance and lease" of the minihydros for 20 years.

The bid components will be for rehabilitation and rental under the conditions that the operator "shall invest at least P500 million for the rehabilitation, upgrading and expansion of the plants to produce 41,406,178 kilowatthours, install independent substation and power line to the national grid."

The operator will be given four years to implement the rehabilitation.

The city's remuneration will be minimum of P16 million per annum or the peso equivalent of a minimum 30 percent of gross production valued at the prevailing selling prices, whichever is higher for the first two years. The amount will be increased to minimum of P35 million on the third year; minimum of P45 million on the fourth year and minimum of P50 million on the fifth year until the end of the contract.

The operator will also be bound by the following terms:

\*Remit one percent of the gross receipts to the province of Benguet, municipality of Tuba, barangays Tadiangan and Nangalisan, the gross receipts based on the distribution scheme provided for in the Local Government Code;

\*Remit three percent of the net surplus to the affected landowners including those provided under the Compromise Agreement approved in Resolution No. 247 series of 2010 which was made part of the TOR;

Absorb existing qualified personnel; and

\*Return the facility to the City Government in good running condition at the termination of the contract.

The TOR also provides the guidelines on the bidding process and requirements, evaluation of bids, award of contract, construction period and other terms dealing on penalty, liquidated damages, protection of the forest reserve, requirement of regulatory, right of way, clearances and permits, improvements, meter reading, visitation, arbitration and venue of actions. / A Refuerzo

# Rainwater harvesting endorsed

BAGUIO CITY - The city council last week has approved the resolution endorsing rainwater harvesting in public schools and barangays in the city of Baguio.

The approved resolution requested the Baguio Water District (BWD), City Environment Parks and Management Office (CEPMO) and City Building and Architecture Office (CBAO) to encourage other institutions and barangay households to "devise ways to do simple rainwater harvesting to minimize dependence on commercial water supply and to maximize the use of rainwater made available by nature.

The resolution came on the heels of the felt effect climate change where there is heavy precipitation during wet season, but with water shortage as a big volume of water flows underground and to the big bodies of water. Water harvesting thus, is considered as a mitigating measure being adopted to meet the demands of consumers.

Authored by Councilor Betty Lourdes Tabanda, the technique for collecting rainwater water may be termed as "household rainfall catchment system" with water to be used for laundry, gardening, flushing toilets and others.

The simple technique requires the construction of three principal components: the catchment area,

collection device and the conveyance system. The catchment should be from the rooftop, where the rainwater would drop into the conveyance system down to a collection device. Impurities would be allowed to settle before the rainwater is directed to a storing device.

The resolution was also anchored on RA 6716 which provided "for the construction of water wells, rainwater collectors, development of springs and rehabilitation of existing water wells in all barangay in the Philippines to be able to provide adequate water supply as a provision of the social services program of the government."/juliegfianza

The AFP also monitored 350 non-violent activities conducted by these rebel groups in the provinces of Ifugao, Kalinga and Mountain Province. These activities include the operations being done by the rebels in the threatened barangays to gain more forces in the different communities.

Viteno said that to counter these insurgency operations, the AFP is shifting from the militaristic or use of arms and violence to people- centered security strategy such as building and strengthening alliance with stakeholders especially the local government units and the communities.

Meanwhile, newly installed RPOC Chairman, Ifugao Governor Eugene Balitang, said the increase of the number of CNN and insurgency activities in the region particularly in their province, is an off shoot of the different antiinsurgency drives being conducted by the AFP in the provinces in North Luzon.

Balitang added that most rebels being driven away from nearby provinces such as Nueva Vizcaya, Isabela and even Ilocos are getting into the Cordillera provinces./ Redjie Cawis//JDP/RC-PIA CAR

Drug Administration (FDA) Director Suzette

The communication received earlier, warned the general public about DEHP-contaminated food products as being harmful to human beings; with high doses and repeated exposure (and ingestion) causing fertility problems and damages to the kidney.

Accordingly, DEHP is "widely used as a plasticizer in manufacturing articles including medical devices such as intravenous bags and tubings, blood bags and infusing tubings and nasogastric tubes" and has been "illegally added to a food product raw material." It however, emulsifies and improves the taste, texture and appearance of food, and is cheap, thus is used as a preservative.

Secretary Domingo's letter revealed that DEHP, as to Taiwan FDA, has been sold to food manufacturers who in turn are exporting their products to different countries including the Philippines. "FDA is seeking assistance in monitoring the said Taiwan products," the communication states.

FDA Director Lazo also stated in the communication that supermarkets and retail stores are being instructed to temporarily remove from store shelves high-risk products including sports drinks, soft drinks, fruit juices, and jellies "until such time when these have been proven to be free of the contaminant, DEHP.

A list of seemingly DEPH-contaminated food and food products has been provided to local store owners here in Baguio, through their association presidents who attended the meeting.

The mayor earlier instructed the LPMCC with Councilor Pinky Chan-Rondez, City Treasurer Thelma Manaois, Baguio City Police Office P/Supt David Lacdan, City Mayor's Office, Baguio-Benguet Groceries, Supermarkets, Traders and Entrepreneurs association, the local DTI, FDA to work as a team, "so that none would ingest the contaminated food and food products."

The public is also requested to refrain from buying imported products without food registration number and English translation.

The Baguio-Benguet businessmen representative during the meeting assured the mayor that they are willing to remove questionable products from their grocery shelves. It was learned however that only products confirmed tainted with DEPH after thorough laboratory tests would be completely removed from their establishments. - juliegfianza

Step 5 is for drivers and operators following requirements such as Official Receipts, Certificate of Registration, franchise decision, DTI trade name, accreditation, calibration booklet, and receipt issuing meter.

He stressed that the LTFRB will be strict with the said requirements before calibrating and resealing the meters for the new flag down rate.

In addition, operators and drivers are required to provide coin box, seatbelts, clean seat covers, no smoking sign, trash bin, driver's identification card, inside markings of trade names, plate number and contact number and receipt issuing meter.

Itliong reiterated that the above conditions must have to be met by the franchise holders before they could implement the new rates./ Mari Cruz/JDP/MC-PIA CAR

# Palace lacks commitment to investigate HELLO Garci

Cayetano: a thorough investigation will put closure to Hello Garci

Senate minority leader Alan Peter Cayetano chided the government for its lack of commitment in investigating the Hello Garci scandal of 2004 – stressing the case's importance in eradicating graft and corruption.

Remember, Hello Garci is not only about cheating and operation on a provincial level. It is also about the use of government resources to prop up former President Arroyo's reelection bid through the use of Overseas Workers Welfare Administration (OWWA) funds, PhilHealth funds, Philippine Charity Sweepstakes Office (PCSO) funds, etc," he said.

Cayetano also challenged the Palace to define what kind of Comelec it wants due to its lack of a proactive or firm stand regarding the investigations.

"I throw back the question to the Palace: What kind of Comelec do you want? What kind of Chairman do you want? What kind of elections in 2013 and 2016 do you want?" he

"Right now, it seems that a Hello Garci type of Comelec is okay with you since everything is passed onto Brillantes who is taking it one press release at a time. Even if we pull all the front pages of our major broadsheets, there is still no commitment from the government to investigate," he added

The minority leader pointed out that conducting the investigation in its entirety, whether or not it be about electoral cheating, is within the jurisdiction of the Comelec.

"Why don't we start with the 2004 elections, with Hello Garci?" he asked.

He pointed out, however, that if the Palace will not investigate, then different branches of the government would have to step in.

"If the Palace will not investigate, the Senate should investigate. If the Senate does not investigate, Comelec should investigate. If the Comelec still does not want to investigate, then we will have no choice but to do it through Commission on Appointments (CA). We will use the confirmation hearing to investigate," he said.

### PNP Establishes Innovations to Speedto determine if the fin-Up Crime Investigations

June 28 (PIA) - - The Philippine National Police (PNP) is currently establishing new innovations in order to effectively speed-up ballistic examinations and crime investigations.

Police Regional Office Cordillera (PRO-COR) Crime Laboratory Chief Senior Superintendent Dalmacio Magantino announced in a radio interview that the PNP is in the process of introducing new forensic trends to further improve the speedy resolution of crimes.

These include among others the newest Integrated Ballistic Identification System project or "IBIS" of the PNP. This is an effort of the PNP Project management Office the

BAGUIO CITY, prove the capability enhancement particularly under the national firearms control program, he explained.

According to Magantino, this instrument will be used to create a registration database that can rapidly trace the owner of the gun even if the serial number is obliterated.

Aside from the IBIS, Magantino likewise informed that the Automated Fingerprint Identification System (AFIS) is also being introduced by PNP. This is the first electronic and scientific method of capturing fingerprint images and textual information.

The AFIS system will speed up fingerprint of the PNP to im- matching process

gerprints lifted off a crime scene match the fingerprints of known criminals kept on file by the PNP, he added.

He expressed hope that the new technology will help investigators in establishing the identities of suspects involved in crimes.
