Mayor creates "anti-obstructions"

task force

BAGUIO CITY – Citing the city's traffic related problems due to illegal parking and other obstructions along the Summer Capital's public roads and highways, Mayor Mauricio Domogan has issued administrative order no. 116, series of 2016, creating the "anti-road obstructions task force" to implement transportation and traffic regulations within the city.

It designates city engineer Elpidio Garabiles as chairman with councilor Michael Lawana and Ret. Gen. Villamor Bumanglag as vice-chairpersons representing the government and private sectors, respectively.

Members include councilor Benny Bomogao; DOTC-CAR Dir. Jose Eduardo Natividad or representative; DPWH-CAR Dir. Danilo Dequito or representative; DPWH-BCDEO **Cont. on page 9**

**Duterte: "I believe in God"

Inter-municipality jeeps barred from picking up passengers in city

BAGIO CITY - The Regional Trial Court (RTC) Branch 6 upheld the constitutionality of a local resolution prohibiting all inter-municipality utility vehicles passing through or going in the city to pick up passengers along existing Baguio jeepney routes and dismissed the petition for declaratory relief against the measure for lack of cause of action.

In a 13-page decision, Judge Cecilia Corazon S. Dulay-Archog pointed out the City Council, through Resolution No. 115, series of 2014, merely adopted Resolution No. 1, series of 2014 of the city's Traffic Transportation Management Committee (TTMC) which was the product of research, various deliberations and public hearings.

The court added by adopting Resolution No. 115, series of 2014, the City Council was merely expressing its collective sentiment or opinion in the management of traffic incidents in the city, explaining that a resolution is different from an ordinance considering that the former is merely a declaration of sentiment or opinion of a law-making body on a specific matter while an ordinance

claimed a resolution is also of a temporary nature while an ordinance is more permanent.

When the City Council adopted the assailed resolution, the court stated it was for the noble purpose of maintaining peace and order among jeepney franchise holders.

"Who knows when circumstances change, the resolution by its temporary nature will be revised, amended or abandoned. The court will even accede that indeed during morning rush hours, commuters with the bulk comprising of students and employees line up in long queues with no jeepneys in sight. In such an extraordinary situation when there are no available jeepneys with intra-city routes available, it may be highly impractical to have an absolute prohibition on all jeepneys with inter-city routes not to pick up passengers," the decision stressed.

The court recommended a modification of the resolution to accommodate instances as cited would also be helpful to all parties concerned, especially the commuting public.

Further, Archog tioned resolution is valid and that the concerns of petitioners regarding the imposition of penalties is baseless, thus, the provision in the resolution stating 'that penalties, if any, shall be imposed' is a mere surplusage and that no penalties have been mentioned or cited to have been imposed by the local legislative body.

The court stood firm on its stand that the arguments of the petitioners against the assailed resolution lack merit.

The City Council pointed out that the assailed resolution was enacted to administer or manage the common routes in the city and that it merely adopted Resolution No. 1, series of 2014 of the Traffic and Transportation Management Committee.

The local legislative body further argued that it is within the authority of the city to promote the welfare of the public and to issue regulations related to transportation.

City to bid out operation of Asin resort

BAGUIO CITY - Mayor Mauricio G. Domogan ordered concerned offices of the local government to prepare the simple terms of reference for the public bidding of the operation of the city-owned Asin hotspring resort located in Tadiangan, Tuba, Benguet.

The local chief executive said the local government won the case it filed against the previous resort operator, thus now inviting qualified operators to bid in the operation of the Asin hot spring resort.

"It is high time that qualified resort operators manage the Asin hot spring resort so that the income will start accruing to the coffers of the local government. We have to assign responsible people to manage the resort so that we will not be short changed like what had been happening in the past," Domogan stressed.

Eugene Buyocan, assistant City General Services Officer, revealed personnel of the local

government already served the notice of eviction to Roger Sinot but the latter continued operating the facility after the city staff left. Buyocan recommends the assignment of permanent personnel to guard the government property from illegal occupation by unscrupulous individuals.

Domogan claimed the best remedy to the current predicament of the city is to formulate the terms of reference to justify the conduct of public bidding for the operation of the resort so that the former operator will eventually vacate the

According to him, the city must already possess this property to maximize the use of the resort as venue for seminars and outdoor activities not only for city officials and employees but also for the paying

Earlier, a local court ordered the eviction of Sinot as operator of the Asin hot spring resort and ordered him to pay the local government the amount of more than 800,000 in alleged accumulated rentals and surcharges for having operated the city-owned property over several decades now.

While the local government is awaiting the conduct of the bidding process, the City General Services Office was advised to hire job order personnel who will be assigned in the area to guard the swimming pool and other facilities within the Asin resort from being wilfully used by the former operator and other people living in the area for their personal benefit.

The Asin hot spring resort is one of the most frequented places in the nearby town of Tuba because of its therapeutic properties and it serves as a rest and recreation area for local residents considering its proximity from the city, being 16 kilometers away from the city proper or a good 45 minutes drive along paved roads./By Dexter A. See

City sets regulations in use of government ambulance

AGUIO CITY – The city government set Bregulations on the use of the three government-operated ambulance units serving the city's constituents.

In Administrative Order No. 112, Mayor Mauricio Domogan authorized the city treasurer's office to collect fees from patients using city-owned ambulances for transport within and outside the city.

The fees will be minimal or "socialized" and will go to the maintenance of the vehicles, gasoline, meals for volunteers and toll fees.

The three ambulances are assigned in three separate offices - the health services office, the Bureau of Fire Protection and the City Disaster Risk Reduction Management Committee (CDRRMC) under the city administrator's office.

The HSO maintains the Baguio City Emergency Medical Services (BCEMS) as the pre-hospital emergency management arm of the CDRRMC which includes ambulance services under the Health Emergency Management System.

The mayor emphasized that while the BCEMS uses the HSO ambulance to transport patients for medical treatment at hospital facilities or referral for higher management within and outside the city, the transport of patients is not the priority function of BCEMS.

"As the pre-hospital emergency arm of CDRRMC, its main function is primarily emergency medical responders," he said.

As to the payment of the regulatory fees, the process will be as follows: applicants will secure payment slips from the office where the ambulance is assigned indicating the appropriate amount to be paid at the city treasury office. The offices will record all official receipts before transporting the patient and will prepare necessary official travel order for the personnel in the ambulance team to be signed by the department or assistant department head and approved by the city mayor.

The city treasury office will collect the amount based on the payment slip issued by the concerned offices based on the following charges: For every trip within Baguio City, the client will pay P500 one way and for trips outside the city, the client will pay P75 per kilometer. /Aileen P. Duterte 'endorsing what amounts to mass murder' - US senator

The US senator also says President Rodrigo Duterte's plan to revive the Philippine Constabulary 'is a deeply troubling development'

m ANILA,\ Philippines}$ – US Senator Benjamin Cardin, ranking member of the US Senate's foreign relations committee, criticized Philippine President Rodrigo Duterte over recent killings in line with his administration's war on drugs.

"President Duterte, in advocating and endorsing what amounts to mass murder, has chosen the wrong way," Cardin, representing the state of Maryland, said in a colloquy - a dialogue between senators on the Senate floor - with US Senator Patrick Leahy of Vermont on Monday, September 26.

Cardin explained that he, along with most of his colleagues, understands Duterte's aim "to stop the devastation" caused by illegal drugs.

"We also have a long history of both successful and unsuccessful efforts to combat narcotics, but we have learned that there is a right way to approach this issue - with law enforcement, due process and rule of law, with treatment - and a wrong way,"

He added, "Senator Leahy is absolutely right when he said that a lack of respect for rule of law and democratic governance breeds instability, distrust, and sometimes

Of these, 2,217 people have been slain in extrajudicial killings, while 1,257 have been killed in police operations.

Cardin issued this statement as Leahy warned the Philippines of "further conditions" on US aid if extrajudicial killings continue in the Philippines.

Leahy is the ranking member of the US Senate subcommittee that funds American foreign assistance programs.

$\hbox{`Troubling' plan to revive PC}$

In his conversation with Leahy, Cardin also cited Duterte's plan to revive the Philippine Constabulary (PC).

Started by the American colonial government in the early 1900s, the PC was the militarized police force that implemented Martial Law in the 1970s.

During the Martial Law years in the Philippines, the PC arrested activists and took over key private establishments and functions such as traffic control and garbage collection.

Several years after dictator Ferdinand Marcos was ousted, the PC was dissolved in favor of the civilian Philippine National Police.

Cardin described the PC as "the most abusive para-police under the Marcos regime." The US senator said that "for any historian of human rights abuses in the Philippines," Duterte's plan to revive the PC "is a deeply troubling development."

Leahy, for his part, said he fears more than 6,000 extrajudicial killings in the Philippines by the end of 2016.

"This is not a situation in which there is occasional error or the over-zealous application of force. This is systematic, widespread, brutal, and beyond the bounds for a constitutional democracy," he said.

Leahy said "state-sanctioned violence" will require "an appropriate response by the US government."

The senator pointed out that the relationship between the Philippines and the US "is more than an alliance," but is "a genuine friendship... built on shared values."

"It is because these extrajudicial killings shake the very foundation of that shared vision of shared values that I find these developments so deeply troubling," Leahy said./ Paterno Esmaquel II / Rappler.com



P3.5 million earmarked to fence Gibraltar property

Baguio City – The City Government recently earmarked some P3.5 million to bankroll the fencing of the city-owned property within Gibratar barangay to prevent further encroachments in the said government property.

City General Services Officer Romeo D. Concio said the survey of the metes and bounds of the property was already completed and will be submitted to the City Buildings and Architecture Office (CBAO) for the preparation of the detailed plans and specifications for the fencing project.

At the same time, concerned city hall offices will conduct the required joint investigation relative to the existence of informal settlers that built their structures within the government property in order to guide authorities on future actions to take to spare the property from being squatted upon.

Part of the activities that will be undertaken by the City General Services Office, in coordination with the CBAO, will be the putting up of monuments within the government property which will serve as the guide for those who will prepare the plans and specifications of the fencing project in ascertaining the proper boundaries of the property.

It can be recalled that City Legal Officer Melchor Carlos Rabanes urged concerned offices of the local government to take the appropriate steps in preventing the encroachments being made by informal settlers into the government property which is considered within the prime area considering that it is adjacent the Wright Park, one of the major tourist destinations in the city.

Concio admitted the need for the local government to be aggressive in protecting the government properties, especially the lands, to prevent the assets from being squatted upon by informal settlers who want to gain at the expense of the city.

According to him, one of the problems encountered by the office in the completion of the survey is the absence of a permanent surveyor assigned to perform the said task which should have been completed earlier but he is still optimistic that the local government will be able to immediately fence the property the soonest.

The detailed plans and specifications for the fencing project will be forwarded to the Bids and Awards Committee (BAC) that shall subject the project to public bidding in order to determine the complying and responsive bidder that will be in charge to implement the fencing project.

Concio appealed to the supposed informal settlers to cooperate with the local government in the implementation of the fencing project so that the government property will be spared from the proliferation of informal settlers that might result to further complications in the future once they opt

 ${f B}$ AGUIO CITY – The City Environment and Parks Management Office (CEPMO) underscored the city's air is still breathable amidst a report from the World Health Organization (WHO) that the city is one of the most polluted cities in the country.

City Environment and Parks Management Officer Cordelia Lacsamana pointed out the WHO report was based on consolidated reports way back in 2013, thus, the data gathered then are considered to be out dated and were already overtaken by the implementation of numerous mitigating measures that helped sustain the city's air quality to be good to fair based on the ambient air quality monitoring of the Cordillera office of the Environmental Management Bureau (EMB-CAR).

"WE remain to be aggressive in the implementation of various programs and projects geared towards improving the city's air quality and we were able to go so far in sustaining and innovating our interventions that helped improve the air quality around the city. Our city's air remain to be breathable and appropriate advises have also been issued to individuals with conditions aggravated by pollutants in the air to stay away from the few identified areas that have been considered to be with fair air quality," Lacsamana stressed.

Domogan issued a stern warning to machine shop owners who had been using portions of the sidewalks and even national and city roads as their parking areas and repair sites to start looking for their parking slots to avoid the vehicles of their clients from being taken by the local government.

local chief The executive also warned vehicle owners from using widened roadlines in the city as their parking areas because they are part of the target of the anti-obstruction task force once it will be in full operation next week.

'We are saddened by the refusal of our vehicle owners to comply with our repeated appeal for them to avoid using the roads as their parking areas to help decongest traffic; we have to resort to the use of existing laws, rules and regulations to compel them to abide by the rules. We do not want to penalize our constituents for their simple violations but it seems that they have put to the test the limits of the powers of of their belligerent attitude,"Domogan stressed.

He said it has been pinpointed by studies that one of the major causes of traffic congestions around the city is the wayward parking of motor vehicles on the sides of the various roads and the use of the widened roads as parking areas of machine shops and vehicle owners instead of serving its purpose for the benefit of all motorists.

According to him, much have been already been said to convince local residents, machine shopowners, among others, not to use the sides of roads and widened portions of roads as parking areas because of worsening traffic congestions but it seems the appeal of the local officials have fallen on deaf ears.

Domogan explained notices will be issued to owners of junk vehicles parked along roads to remove their vehicles obstructing the smooth flow of traffic within a reasonable period of time; if the owners refuse to do so, members of the anti-obstructin task force Dexter A. See

Domogan reiterated motor vehicle owners were given sufficient time to look for parking areas for vehicles so as not to obstruct the smooth flow of traffic in the different parts of the city, thus, it is now the time for the city to take back the portions of the roads being used by individuals and businesses for their own use in order to help improve the traffic situation around the city.

He appealed to local residents, machine shop owners, and vehicle owners to cooperate with the city's anti-obstruction campaign to bring back order and improved traffic in the different parts of the city as part of gaining people's trust in government efforts to improve community welfare./By

Time is up for erring business establishments in city

BAGUIO CITY -Mayor Mauricio G. Domogan said the grace period given by the local government to owners of business establishments that converted their allocated parking spaces to commercial spaces already expired; concerned offices must already monitor the compliance of businesses to existing regulations to avoid being closed.

The local chief executive pointed out the existence of parking spaces in buildings is part of the conditions imposed by the local government for the issuance of their building and occupancy permits; the absence of such parking allocations will be a ground for the city to initially cancel the occupancy permits issued to owners of businesses and the subsequent withdrawal of their building

'We have given the establishment owners sufficient time to remedy the their lessees who rented

situation and bring back the parking slots and the parking spaces that were converted to commercial spaces. We need the parking spaces in the buildings to decongest our major roads from being used as their parking spaces since the parking allocations were converted to commercial spaces by building owners," Domogan stressed.

The City Mayor directed concerned city hall offices to conduct inspections on identified business establishments that contravened the conditionalities of their to allow the cancellation of their building and occupancy permits the soonest.

The Mayor said that the matter of these contravensions had already been discussed with the concerned building owners three times and it was the business owners who requested for sufficient time for them to comply because they have existing contracts with converted them to commercial spaces.

Under the National Building Code of the Philippines and other related local ordinances, owners of buildings are mandated to provide parking spaces for their lessees to avoid vehicle owners from parking on the sides of roads and in open public places.

He asserted that time is already up for the building owners to start complying with what was previously agreed upon between the local government and their group to avoid the outright cancellation of their respective building and occupancy permits that will result to the closure of their establishments.

He appealed to building owners to start rectifying the anomalous situation by reconverting the commercial spaces into parking areas and not wait for the inspection by the
