 $B^{\rm AGUIO\,CITY\,-\,The\,City\,Government\,paid\,tribute}$ to the late Councilor Roberto Ortega who died last July 30 due to a lingering illness. He was 78.

Mayor Mauricio Domogan and Vice Mayor Edison Bilog led city officials and employees in paying their last respects to the deceased alderman during a necrological service last Wednesday at City Hall where his remains were brought last Tuesday from La Union for a two-night vigil.

Last Thursday, his remains were transported back to San Fernando City for the continuation of the wake but not after a funeral procession around key places in the city. Interment is scheduled today, August 6.

In City Council Resolution 282 series of 2017, Ortega's political career and achievements were recalled thus:

City government bent on BGH to put up 2 parking buildings pursuing e-governance

BAGUIO CITY -The City Government is bent on pursuing programs to transform into an e-government through the use of Information and Communication Technologies (ICTs) and other web-based telecommunication technologies to improve the delivery of public service.

Mayor Mauricio Domogan bared this in his state-of-the-city address (SOCA) last Monday (July

"We have joined the bandwagon of voluntarily transforming into an e-government consistent with the national thrust to revolutionize local governance by making LGUs (local government units) electronically enabled with the overall intention of improving the delivery of public services, promote transparency in government transactions and increase public access to government information services," the mayor said.

Spearheaded by the Management Information Technical Division under the City Budget Office, the city's ICT program started with the citywide computerization program in the mid-90s.

To date, the city has spent more or less P50 million to install the basic ICT infrastructure with the MITD at the helm of mainstreaming ICT and developing the appropriate tools and applications for various critical and lifeline government services.

All of the programs are in accordance with the ICT strategic action

2013-2025 developed as the city's e-government transformation roadmap.

The mayor said that at present, the city has automated six basic operations in the city government: the e-Business Permit and Licensing System (eBPLS), the automated processing of business permits which has a tracking system that can show the status of a business permit or license application and can easily generate reportorial requirements of the local chief executive and other city officials. It currently stores a database of 25,000 permitted businesses in the city:

Real Property Tax Collection System (RPTACS) which automated the real property tax assessment and collection and provides an integrated information system for the offices of the city treasurer and city assessor avoiding irregularities in transactions. It has a database of 91,845 registered real property owners and 130,930 real property

Civil Registry Information System (CRIS), an automated registration and printing of various civil registry documents based on a database of birth, death and marriage which enables an annual average transaction of 16,000 documents:

Health Patient Information System (HPIS), a partnership project provided by the Wireless for Health (WAH) to manage patients' health processing system that has

> Online Building Permit Application (OBPA) has a pre-evaluation process where digital copies of plans, designs and cost estimates are uploaded for review before final copies are submitted for final processing. The digital review facilitates processing and spares applicants from submitting voluminous documents and personally lining up to wait. It is expected to be implemented within the year;

> Integrated Surveillance System with CCTV installation which was initially conceived for the central business district to monitor peace and order, traffic and transport management and disaster risk reduction and manage-

> To promote transparency in government transactions, the mayor said the city deployed working systems to facilitate in-house and administrative operations covering personnel concerns, financial management, procurement, planning and budgeting through the following ICT programs: the city government website which was developed to provide online information about frontline services, and how these can be accessed from our city offices; leave administration system, an electronic employee leave

Dr. Ricardo Ruñez, BGHMC medical center chief, said the short term plan of the hospital will be the construction of a 3-storey parking structure near the administration building that could accommodate more than 50 parking slots for its patients and visitors aside from relocating the hospital's emergency room nearer to Kennon road so that patients being brought for emergency purposes could be given immediate medical attention.

On the other hand, he informed the members of the local legislative body during Monday's regular session that the hospital's medium term plan is for the construction of a 6-storey parking building near the Flavier building that could accommodate more than 100 slots for its patients and visitors to improve the parking

lessen the impact of the lack of parking spaces around the hospital compound.

"We continue to look for ways on how we can maximize the available spaces in our compound for those who have patients and our regular visitors transacting business with the different departments of the hospital. We want our patients and their family members to have a stressfree stay in our hospital," Ruñez stressed.

The BGHMC head claimed the planned multi-level parking structures in the hospital compound is in preparation for the expected expansion of the hospital's bed capacity to around 1,200 bed capacity with an expected influx of people and vehicles entering and going out of the hospital every hour of the day.

According to him, BGHMC management is still studying the possibility whether or not to offer the parking structures free to patients and visitors for the benefit of ensuring sufficient parking spaces for those who are in need of medical intervention from experts assigned in the hospital.

Ruñez explained management is trying to negotiate a loan with the Development Bank of the Philippines (DBP) to fund the construction of the two multi-level parking structures within the hospital compound and the loan will be repaid through the savings of the hospital or through the collection of reasonable parking fees from user of the facilities.

City Planning and Development Officer Evelyn G. Cayat underscored the city needs more multi-level parking projects like what BGHMC is planning to put up to provide adequate parking spaces for the rapidly increasing number of motorists plying the city's streets, thus, the local government is supportive of the endeavour because it will help a lot for the hospital patients, their wards and their visitors.

The City Council passed a resolution supporting the overall development plan of BGHMC, including the planned construction of 2 multi-level parking structures within the hospital compound that seeks to provide convenience to hospital patients and their visitors. /By Dexter A. See

The city has two interactive systems in place that serve as avenues to access information, make queries and provide feedback to the city government: Online Public Assistance and Complaints Desk, an online communication via webchat that directly accepts requests as well as complaints. It provides a collaborative venue where the support may come from different offices or departments who can help or assist solve problems, issues or address concerns related to public governance. it has a feature of an offline mode to queue the posted public concerns and whenever live chat feature is not available and the e-Directory and Information Support Services (EDISS) which provides online services mainly for directory information services that act as digital yellow pages.

"We have seen the benefits of adapting ICT in our present systems. If we are to promise better and faster public services, we need to step up our current efforts to facilitate our transformation into an e-government to fully realize e-governance. The initiative puts us one step ahead of other cities and lgus and already aligns us with the national vision of a "Digital Philippines" now being aggressively advocated by the national government," the mayor said. /Aileen P. 

20 barangays ordered to liquidate livelihood

BAGUIO CITY - Mayor Mauricio G.
Domogan ordered some twenty punong barangays to liquidate more than P15 million livelihood funds that were downloaded to their barangays to prevent the non-release of future assistance to beneficiaries of the government's livelihood assistance program in the future.

The local chief executive informed the concerned punong barangays to submit to the labor department their complete liquidation reports to avoid being marked in bad standing and to allow more residents to benefit from the livelihood assistance being extended by the agency to concerned barangays.



Tax 'reform' program burdens poor more than the rich-IBON

Research group IBON said that Pres. Rodrigo Duterte's State of the Nation (SONA) statement that "we achieved the first step towards more equitable taxes" is incorrect because the poorest majority of Filipinos will be paying more taxes than the rich. The Department of Finance is covering this up, the group also said.

According to IBON executive director Sonny Africa, under the tax 'reform' package recently passed by the House of Representatives (HOR) and now with the Senate, the poorest 60% of Filipinos will pay more out of their already very low incomes than the highest income 40% of Filipinos.

"The poorest 60% will pay Php32.9 billion in additional taxes next year which is 1.6% of their combined family income of some Php2.0 trillion," he said. "The highest income 40% on the other hand will pay just Php14.7 billion which is only 0.4% of

their total family income of some Php4.1 trillion." Filipinos will be paying less than half as much

in additional taxes. Measured as a share of their total income, the poorest 60% will pay four times as much as the highest income 40% including the richest Filipinos,"

Taking all the components of the tax package into consideration, Africa said, the highest income 40% will gain Php140.1 billion from lower personal income, estate and donor taxes. He said that this off-sets much of the additional Php154.8 billion they will pay in additional VAT, petroleum and automobile taxes.

On the other hand, Africa said that the poorest 60% do not gain anything from lower personal income taxes - being exempted from paying this already. They will however pay an additional Php32.9 billion in additional VAT and petroleum taxes. This does not even include further inflationary effects and the impact of the onerous tax on sweetened beverages.

Africa added that these estimates exclude the Php2,400 cash transfer for the poorest half of families that the DOF is hyping. He said that the DOF is only using the cash transfer to cover up for the gross inequity of the tax reform package. "After 2018, the cash transfer will be discontinued but the tax burden on the poor will remain," he clarified. "The tax burden on the poor will become even worse as even higher petroleum excise taxes start to be applied," Africa warned.

The tax impact is estimated by IBON for 2018 from scant data available from the DOF. Family income estimates are from the government's latest Family Income and Expenditure Survey (FIES) from 2015.

CHILD KIDNAPPING IN RP IS REAL: Parents, guardians, and any other person whose job or concern is to take care and assure the safety of children and other minors, this column today is not meant to scare or frighten you, but on Wednesday, August 02, 2017, the truth and reality of syndicates snatching, kidnapping, and taking away kids for a host of reasons jolted me like I was hit with several bolts of lightning.

One of the lady preachers of the Anak ng Diyos Kadugo Ni Kristo (AND KNK or the Children of God Blood Kin of the Christ) Church told me and the other preachers and deacons of the AND KNK who were gathered for their regular Wednesday Bible immersion and admin-

istrative deliberations while she was profusely crying, that one of her grandsons had become the latest victim of kidnapping.

The lady preacher said the incident happened at Payatas, Quezon City, a squatter colony near the La Mesa Dam complex, just this week, as her grandson walked home from school at about 1 p.m. The mother of the grandson, one of the preacher's daughters, was with the child and two other kids of hers who were also going home when, literally, at the batting of her eyelashes, the grandson was gone.

CHILD KIDNAPPED IN PAYATAS, QC: Frantically, the mother of the child who vanished from her sight tried to look around her, searching for the child, her eldest. But he was nowhere in sight---as if he vanished into thin air. As panic began to engulf her, the mother literally dragged her two other very young children with her as she went hither and thither, and even in circles, searching for him.

When the missing child could not be located even after almost an hour of searching, the mother rushed to the nearest police station and reported the apparent kidnapping of her son. Policemen then were dispatched to join the search. Unfortunately, as the afternoon descended into dusk, their efforts yielded no sign of the child.

As daylight started to give way to the enveloping darkness of the night, the mother found herself retracing her steps back to the school of her missing son. She dreaded going home to their shanty, where the wake of her husband who died last year was held, without their child.


GOV'T INCAPABLE OF STOPPING CHILD KIDNAPPING: But as she sat on the side of the road, she caught sight of her son, stripped of his school uniform---polo and shorts---and was only in his underwear, looking dazed, and gravely afraid. She rushed to the son and tried to hug him. At first, the son coiled away from her, perhaps unable to recognize her with his troubled mind.

But as recognition came back to the child he embraced his mother in a tight grip, crying. The mother tried to talk to him, asking him questions, but the boy kept quiet all the time. Even today, the lady preacher said the kidnapped boy doesn't want to talk at all. He has refused going out, even to go to his school, indicating that he is still suffering from deep psychological turmoil, which may take a long time to heal.

Indeed, this experience of the grandson of the lady preacher confirmed, beyond reasonable doubt, that there are people out there, whether organized or not, who are engaged in snatching away or kidnapping of children, mostly to take their internal organs so they could be sold to rich patrons. Since no one in government appears capable of stopping this, parents and elders can only rely on God to take care of their children.

On the P6.4-billion worth of shabu smuggled from China

The ongoing investigation on the large-scale smuggling of methamphetamine (shabu) from China betrays a glaring inadequacy of the anti-illegal drug program of the government. While our law enforcers focus their attention on going after street peddlers and drug addicts, less efforts have been placed on other, perhaps more important, aspects of the War on Drugs: supply and demand reduction.

The obscene amount of shabu confiscated during a raid in Valenzuela was only identified after being informed by customs officials in China. Without such

piece of intelligence, the contraband could have been distributed all over our country by now. also adopted a resolution asking the Department of Energy to consider the application of BENECO for hydropower development for the Nalatang River.

Firstly, the court noted, "Hedcor did not establish a clear legal right to preliminary injunction". It said that the amendment to the hydropower service contract between Hedcor and the Department of Energy was executed only on June 13, 2016.

"Also the endorsement letter was sent to the NCIP on 22 June 2016 for Hedcor to secure the necessary permits and clearances from all relevant government entities including the certification precondition and the conduct of the FPIC (free and informed prior concent) process," the court said.

"Indubitably," the court said, "the alleged acts were committed prior to the amendment of the Hdropower Service Contract between Hedcor and the DOE on 13 June 2016."

Therefore, the court added, "as of 22 June 2016, Hedcor has yet to file its application before the NCIP for Certification Precondition based on the amended contract. It can not rely on its earlier application filed on 31 July 2015 and the proceedings therein had which were deemed mooted with the execution of the amended contract." /Ramon Dacawi.

Baguio to host, heart, trauma, brain center

Baguio General Hospital and Medical Center (BGHMC) was identified by the health department as one of the expansion areas for the put up of state-of-the-art health facilities to help decongest the overcrowded hospitals in Metro Manila and allow the maximum use of existing tertiary hospitals for medical purposes.

Dr. Ricardo Ruñeez, BGHMC medical center chief, said included in the hospital's master development plan will be the put up of an 8-storey heart center, a 6-storey trauma center and a 6-storey brain center within the next years.

Earlier, President Rodrigo Duterte announced his plan to improve the tertiary hospitals in the different urban centers in the country for them to cater to the complicated medical requirements of patients seeking medical attention so as not to contribute in the clogging of hospitals in Metro Manila.

"We are grateful that BGH was chosen by the health department as one of the beneficiaries of the government's plan to improve the facilities to cater to the medical needs of people not only from the city but also from other parts of Northern Luzon considering that it is a tertiary hospital," Ruñez stressed.

The BGHMC head underscored part of the buildings that will be constructed will be the provision for underground parking to help address the parking needs of patients and visitors seeking medical attention from the facility.

According to him, part of the development of the BGH structures will be the conversion of the buildings into green buildings to make the facilities a treatment haven for patients seeking treatment from specialists in the said hospital.

Suntrust told to restore damaged private properties

AGUIO CITY - Mayor Mauricio G. Domogan $oldsymbol{\mathsf{D}}$ ordered the management of the Suntrust Properties, Inc. to immediately address the complaint of the administration of a nearby condominium developer regarding the collapsed portion of their property that compromises the stability of some portions of their properties.

In his letter to Suntrust president Harrison Paltongan, the local chief claimed he was in receipt of a letter from Anna Manayon, president of Tower Condominium Corp., complaining of the alleged collapsed portion of the perimeter wall damaging the immediate wall, security camera, perimeter lighting and landscaping exposing the water pipe that connects the driveway tank which reportedly compromises the foundation of their driveway and their parking area to their property which is adjacent to the property of Suntrust. Domogan pointed out the matter had been allegedly raised previously and brought to Suntrust's attention even during one of the meetings of the local legislative body but no action has been done by the company to the fix the cut area, thus, the need for Suntrust to undertake the appropriate measures to address the problem the soonest.

The management of Tower Condominium demanded from Suntrust Properties, Inc. the immediate restoration of their perimeter wall as well as the rehabilitation of their compromised foundation

Manayon informed Mayor Domogan the latest incident of erosion in their property happened at around 9 pm of July 27, 2017, thus, the need for immediate action by the concerned company to prevent the situation from worsening considering the expected continuous rains from the enhanced southwest monsoon.

According to her, though there was not enough time to articulate the complete list of their concerns, they left the previous council meeting with the understanding that what has happened to the national road will be avoided.

Further, she revealed their company's administrative officer has been consistent in bringing to the attention of the appropriate officers and officials their concerns.

Manayon claimed one of Suntrust's commitment to the initial environmental examination checklist submitted to the environment department is to avoid long exposure of open cut in the said area, but it was observed that the same has been exposed since April.

Domogan said Suntrust must start working on the problem within an acceptable and reasonable time to prevent further complications to the existing problem in Gibraltar and to prevent the situation from getting worse if the pressing concern remains unattended.

Suntrust committed to the local government that it will restore the collapsed portion of the Gibraltar road triggered by its excavation activities for the construction of its own condominium project in the area but the same was further complicated with the complaint from the management of the similarly situated company developing another condominium project adjacent to its property in the said area. /By

City ready to release payment to Asin landowners

Blocal government has been ready to release the P2.7 million payment to affected landowners of Asin who were affected by the previous operation of the city-owned Asin minihydro power plants.

According to him, the put up of a TRCA does not require the issuance of the environmental compliance certificate (ECC) from the Environmental Management Bureau (EMB) but it has to pass stringent requirements which are much easier to comply compared to the requirements of an ECC.

He admitted the realization of the city's TRCA within a portion of the Antamok open pit area will definitely a big help in significantly reducing the expenses of the local government in the hauling of waste outside the city.

Under the provisions of Republic Act (RA) 9003 or the Ecological Solid Waste Management Act, local governments are obliged to close the operation of their open dumpsites and establish their environmentally acceptable controlled dump facilities for the sustained preservation and protection of the environment and the health of the people.

The city was able to close the operation of its 5.2-hectare Irisan open dumpsite and opted to continue hauling its residual waste to the Capas sanitary landfill while pursuing a long-term solution to the city's garbage problem with the proposed put up of the integrated solid waste disposal facility either in the 139-hectare city-owned property in Sto. Tomas School Area or the Antamok open pit site in Itogon, Benguet. /By Dexter A. See

will be equitably distributed to them.

The supposed payment of the P2.7 million compensation to the landowners who were affected by the operation of the Asin minihydro power plants was stalled because of the failure of the local legislative body to condone the claim of the city over the supposed compensation for the landowners.

"We will have to undertake another survey to pinpoint those landowners who were not included in the original list so that they will be included once the survey results will show that they are part of these that were affected by the previous operation of the city-owned power plants," Domogan stressed.

He asserted that the funds for the payment of the compensation of the landowners had been made available by the local government but it was not released after the city filed a damage suit against the landowners who allegedly diverted the flow of the water in the river that affected the continuous operation of the power plants.

He explained that if the city deducted its damage claims that amounted to P2.09 million from the compensation of the landowners, then the landowners should have only received more than P600,000 which should have been released way back in 2009.

The filing of damage claims against the landowners who diverted the flow of water in the Asin river that affected the operation of the minihydro power plants and the subsequent filing of damage suit against the landowners happened during the previous administration of the local government.

When Domogan came back as the city's local chief executive in 2010, the local government and the affected landowners agreed to a compromise settlement of the case but the landowners must still seek the concurrence of the local legislative body on the compromise agreement which took sometime before being granted.

He underscored that there is no truth to the claims of some landowners that the local government does not want to settle its obligations with them because the funds had always been ready but the affected landowners have to satisfy some requirements before the payment will be released to them. /By Dexter A. See

park and garden in front of the hospital will not be affected by whatever development introduced to convert it as one of the state-of-the-art hospitals in the country in the future considering that it will serve as a buffer zone of the facility.

He explained the operation of the three major facilities that will be located in the hospital will be towards the end of the term of the President as the budgetary requirements for the construction of the buildings and the purchase of the required units of equipment has been programmed for the next three years.

Another salient aspect of the planned development of BGHMC is the proposed expansion of its bed capacity from 500 beds to at least 1,200 beds in the coming years to accommodate the rapidly increasing number of patients seeking medical attention from the tertiary hospital in the city.

He expressed his gratitude to the members of the local legislative body for passing a resolution supporting the planned BGH development that will include the provision for the construction of multi-level parking structures and underground parking facilities for their new buildings that will be equitably spread in the different parts of the compound.

At present, BGH always exceeds its bed capacity by as much as 20 to 30 percent depending on the illnesses whose treatments are being sought from the hospital. /By Dexter A. See

service providers in the city's various parks, city market and other tourist spots availed of the free training on cardiopulmonary resuscitation (CPR) last July 28 to enable them to attend to heart disease-related emergencies in their places of work.

Councilor Elmer Datuin said this is in line with the city's aim of making its tourist spots "CPR-ready" to enhance services to visitors and residents especially in life-threatening emergencies.

The city took advantage of the free CPR training conducted by the Philippine Heart Association (PHA) Baguio-Benguet Chapter at the Notre Dame de Chartres Hospital upon invitation of PHA-BBC president Dr. Justina Calibuso.

Calibuso said the undertaking is part of the PHA's advocacy flagship project dubbed "CPR

"We are bent on clinching the CPR-Ready Philippines status in 2021 to keep pace with our Asian neighbors and Western allies that have been reaping the benefits of being CPR-prepared nations for years. Their citizens (as young as 8 years old and up) are CPR-skilled and their strategic public places are equipped with AEDs," Calibuso said.

lishments to provide basic life support services by employing personnel trained in CPR who can administer CPR and AED in the event a customer would require the same.

He said having CPR and AED ready personnel increase the chances of survivals of patients suffering from cardiac arrest.

The ordinance will also require government and private buildings to supply and maintain an AED device made available in cases of emergencies.

The City Health and Services Office (CHSO) will be mandated to issue policies or guidelines and conduct orientations to establishments for the implementation of the ordinance.

Melvin Jones grandstand perimeter to be designated as night market area

BAGUIO CITY – the city will be earmarked
The City Council for the improvement of the approved on first reading a proposed ordinance formally designating the area around the Melvin Jones grandstand as the permanent site for the night market, providing funds for its operating structure and for other purposes.

The ordinance authored by Councilor Leandro B. Yangot, Jr. stated the amount of P25 million from the annual budget of

night market operating structure to accommodate vendors in the designated night market area.

To help in the implementation of the local legislative measure, Yangot recommended the creation of a night market technical working committee composed of the City Mayor as chair, the chairperson of the City Council Committee on Market, Trade, Commerce

and Agriculture as vice chair and action officer, and the City Planning Development Officer, City Budget Officer, City Engineer, City Building Official, City Treasurer, City Bids and Awards Committee (BAC) chair, City Environment and Parks Management Officer and 2 representatives from the private sector as members.

The technical working committee shall prepare the comprehensive feasibility and profitability study of the night market operation in the proposed area, prepare the architectural plan for the operation of the night market in the said area, conduct the appropriate survey to determine actual meters and bounds of the area to be delineated and identified and designated as site for the night market; prepare the comprehensive guidelines, rules and regulations for

the temporary dump the operation of the night market and submit the feasibility study, architectural, survey plans and guidelines to the City Council for its consideration within 60 days upon

approval of the measure. Yangot pointed out since its inception initially as an experimental activity to completely rid public easements such as roads, streets and sidewalks within the central business district from illegal and itinerant vendors pursuant to administrative Order No. 203, series of 2006, the night market oper-

ations at the Harrison road proved to be the best solution. It remained so pending the identification of a permanent site for its operation.

For quite some time, Yangot claimed while the night market operations at Harrison road inevitably addressed the proliferation of illegal and itinerant vendors in the central business district and is actually generating added revenue to the city with a monthly income of approximately P1.4 million, its present site is within a national road and it clearly violates the established rule that open spaces, roads, alleys and sidewalks are for public use and are, therefore, beyond the commerce of man.

Yangot claimed it is imperative that the local government relocate the site of the night market operation to a more secure and permanent location and the area around the Melvin Jones grandstand has been eyed as the best and suitable site to transfer the night market operation considering its location which is near the existing night market. /By Dexter A. See

Baguio to put up residual con-Antamok tainment area

BAGUIO CITY - Mayor Mauricio G. Domogan disclosed that the local government will be putting up its own temporary residual containment area (TRCA) within a portion of the 60-hectare Antamok open pit area while awaiting the establishment of the much awaited integrated solid waste disposal facility which is -part of the final mine rehabilitation and development plan for the said area.

The local chief executive said the put up of the city's TRCA will be done simultaneous with the put up of Itogon's TRCA within a portion of the Antamok open pit that will purposely serve as

area for the residual waste generated in the city and the municipality.

He added the put up of the city's own TRCA will definitely translate to the eventual stoppage of the hauling of the city's residual waste to the sanitary landfill in Capas, Tarlac within the next several months wherein sufficient savings will be realized by the local government, especially in the funds earmarked for the hauling of garbage to Tarlac.

"Once out TRCA will be established within a portion of the Antamok open pit area, we have to strictly implement the segregation of waste at source so that only the residual waste will be dumped in the facility so that the area could be used for a longer period of time. We urge our constituents to further improve the disposal of their garbage at source so that they will not suffer the consequences of their failure to abide by the garbage disposal rules," Domogan stressed.

The local government is spending some P70 to 85 million in the hauling of the city's residual waste from the staging area of the hauler in Longlong, Puguis, La Trinidad, Benguet to the Capas sanitary landfill in Tarlac based on the hauling cost of P932 per ton and P500 tipping fee per tons of residual waste dumped in the facility.
