File Campaign Expense Reports, Candidates Told

Time to report the millions of pesos spent during the cam-

Commission on Elections Chairman Sixto Brillantes Jr. reminded candidates in the May 13 elections to file their campaign expense reports before the poll body or face sanctions. All candidates, including those who lost, are required to file their statements of election contributions and expenditures (SECE), he said. Deadline for the SECE is June 13 at 5pm, exactly a month after Election Day.

Winning candidates who fail to submit their expense reports will not be allowed to assume office on June 30, said Brillantes who explained that the poll body has reached agreement with the Department of Interior and Local Government (DILG) to bar non-filers from assuming local office.

Brillantes said they will immediately check after the deadline who among national and local candidates failed to submit their SECEs. This is a departure from the old practice where filings were not checked right away because of the volume of filers

"Our initial thrust is to check who submitted already, Then, we will publish their names and also say those who failed to submit will not be allowed to sit so that they will be forced to file their contributions," Brillantes said in Pilipino.

Non-filers or late filers will also face administrative fines of between P10, 000 to P30, 000 for first offense and P20, 000 to P60, 000 for the second offense. The fine depends on the elective position.

Brillantes said the audit will be done later. He said those who underreport their expenses will face perjury and election offense charges./Mikha Flores/(VERA Files is put out by veteran journalists taking a deeper look at current issues. Vera is Latin for "true".)

City Awards Lupong Tagapamaya 2012

The City government awards the Lupong Tagapamayapa 2012 through the Special Services Division last June 2 during Baguio City Hall's Flag Ceremony.

Imelda Village won 2012's Lupong Tagapamayapa Incentive Award (LTIA) among 24 barangays and will represent the city in the National competition. The said barangay defeated 2011's champion Irisan Village who only came 1st runner up in the recent LTIA.

A P30,000 incentive was given to the Imelda Village while Irisan received P25,000 pesos.

Other barangays in the top five were: Upper Rock Quarry (2nd runner up) with P20,000, Pacdal (3rd runner up) with P15,000, Lourdes Subdivision (4th runner up) with P10,000, and Middle Quezon Hill (5th runner up) with P8,000.

P5,000 incentive was likewise given to barangays Fairview, Gibraltar, Middle Quirino Hill, Pinget, and Pinsao Pilot Project.

Among the other finalists were Alfonso Tabora, Andres Bonifacio, Bakakeng Central, Brookspoint, Holy Ghost, Leonila Hill, Loakan Proper, Lower Rock Quarry, Palma-Urbano, Pinsao Proper, Quezon Hill, Sto. Nino, and Upper QM.

LTIA 2012 awards committee is led by Baguio City Mayor Mauricio Domogan and DILG-Baguio Director Evelyn Trinidad.

The search for the best performing barangay in the city for the Lupong Tagapamayapa Incentive Award for 2012 started on Feb 19 and ended Feb 28 this year with the aim to recognize the efficiency of barangays in settling disputes within their community outside the formal courts of justice.

After the awarding, Mayor Domogan commended the barangays who participated in the search, stating he hopes that this awarding will serve as a continuing inspiration and challenge in administering justice in their respective areas. Baguio not Included in APEC Conference's **Shortlist of Potential**

The city of Baguio was removed as one of the considered venues that will hold the 2015 Asia-Pacific Economic Cooperation (APEC) forum and related meetings in the country. Baguio City Mayor Mauricio Domogan confirmed this in the weekly Ugnayan and said that this was the issue they have discussed during a meeting with Hotel and Restaurant Association of Baguio (HRUB) and Loakan Airport representatives last Wednesday.

Domogan stated that one of the probable main reasons behind this is the absence of commercial flight in the city which is the flight from Manila to Baguio and vice versa. According to Domogan, the Loakan Airport did not pass the aviation safety requirement of APEC's shortlist of probable cities. The Mayor further explained that under such requirement, Loakan must be completely closed to pedestrians and animals, using it exclusively for airport services provided that a bypass road will be constructed.

Domogan said in the meeting that he recalls appropriating P12 million to Loakan Airport for the purpose of the bypass road construction. However, according to Domogan, the Loakan Airport representatives in the meeting reasoned that they think the budget was re-aligned to other projects. Domogan ordered Loakan Airpoort to inform the city council as well as HRUB within three days regarding what happened to the said appropriation.

If ever it was found out that the budget was re aligned to other purposes, the Mayor stated that the city government will find funds even just for the construction of foot trail. He said this is just as important for the distance from the other side of the airport to PMA will be made closer via foot trail for pedestrians.

Domogan further added that the city was not informed of a bid that a municipality can pass to the APEC committee for them to include in the shortlist. That is why Domogan ordered Department of Tourism (DOT) CAR Regional Director Purificacion Molintas to get the requirements of the said bid and to identify the committee behind the process. The City will then comply with and meet the requirements of the summit and partner with the private sector particularly HRUB to pass a bid to the APEC committee.

9 cities are contending to host the 2015 APEC summit namely Metro Manila, Cebu, Tagaytay, Clark, Subic, Iloilo, Bacolod, Boracay and Davao. According to the Mayor, Albay submitted a bid to likewise host some of the APEC conferences. And Baguio City is very much qualified to hold one of the conferences as well, points the Mayor.

It will be the second time for our country to host this global forum with 20 expected world leaders to discuss different issues with a main thrust to boost economical and political ties. Philippines hosted its first APEC summit in 1996 in Subic.

The host of the APEC Economic Leaders' meeting must have the capacity to accommodate 63 heads of states, and foreign trade ministers. Over 3,000 to 4,000 delegates will arrive for the APEC Cont. on page 7

Caucus on Dev't Programs First in Mayor's Agenda

AGUIO CITY - Mayor Mauricio Domogan's first order of business for his fresh mandate as chief executive is to gather executive and legislative officials for a caucus to chart the development direction for the city in the next three years.

"The first thing we will do after June 30 (the start of the term of the new officials) is to conduct an executive-legislative planning session where we will take up and agree on development programs to be pursued in the coming three years," the mayor told his Ugnayang Panlungsod media briefing last Wednesday.

The mayor said this is part of participatory leadership which he has been advocating since the start of his term as

Although the mayor had bared his administration's development thrust early on, he expressed reception to new ideas that the incoming set of officials may proffer during the planning session.

"We hope that with our continued teamwork and cooperation, we can achieve all our development goals in partnership with the private sector," the mayor said.

The mayor earlier said he intends to continue his unfinished projects and programs on infrastructure development, educational and social services, peace and order and environmental protection.

An inauguration program is being prepared for incoming city officials to mark the start of their terms of office. Outgoing city officials will also be feted.

The new set of Baguio officials are outgoing Councilor Nicasio Aliping Jr. who will replace incumbent Rep. Bernardo Vergara in Congress, Domogan and Farinas who were reelected to their respective posts as mayor and vice mayor along with council reelectionists Edison Bilog, Betty Lourdes Tabanda, Isabelo Cosalan Jr., Elmer Datuin, Richard Carino, Peter Fianza, Fred Bagbagen and newly elected councilor Joel Alangsab who will have to leave his post as Association of Barangay Councils (ABC) president, comebacking councilors Roberto Ortega, Leandro Yangot Jr., Faustino Olowan and Elaine Sembrano./A Refuerzo

City Officials Urged to Look Into The Improvement of Loakan BAGUIO CITY — Baguio Country Club

Airport (BCC) General Manager Anthony de Leon

urged re-elected as well as newly elected officials of the city to look into the improvement of the Baguio City Loakan Airport to further boost the tourism industry not only of the City but the Cordillera region as a whole.

In his opening message during the launching of BCC's latest marketing campaign featuring Ms. Universe 2012 runner-up Shamcey Supsup and BCC image model, and its updated website last week, De Leon said one of the reasons why Baguio City was not included in the list of 9 possible venues for the Asia Pacific Economic Cooperation (APEC) Summit to be held in the Philippines at the latter part of 2013, was that the Loakan airport does not pass international standards, particularly the situation where vehicles, persons and animals cross the runway at any given time.

He said that along with their continued marketing of the Club is the promotion of the city's various tourism sites and event offerings. From the humble beginnings of the Baguio Country Club to what it is today, de Leon said the Club has always carried with it its commitment to reach out and help in the promotion of the City as a major tourist destination not only in the national but in the international scene as well.

For his part, Mayor Mauricio Domogan, who was also present during the event, acknowledged the issue saying that the city government has been coordinating in the past with the Air Transportation Office (ATO) as they are the ones managing the airport. He said the local government will continue to do so until a solution that will serve the best interest not only of the tourism sector but the concerned community and the entire city as well is reached.

City Calls Attention to Local Code Requirements on Water Applications

BAGUIO CITY - Can the city impose its own requirements on water permit applications vis-à-vis those of the National Water Board Resources (NWRB)?

The city council will thresh this out to firm up future actions on NWRB requests of posting of water permit applications being directed to the body.

Councilor Peter Fianza opined that the body need not tackle such requests as "posting of water permit applications should be ministerial" based on NWRB procedures.

But Councilor Perlita Rondez expressed apprehension that the body's lack of action over the requests might

be regarded as disinterest to matters affecting the state of the city's surface ground water.

"I'd like to know whether not approving the application is equivalent to the city's giving up its right to say something about how the city council cares for the city's surface or ground wa-

City to Send Team **Abroad for Waste Management Plant** Inspection

Baguio City Mayor Mauricio Domogan said in weekly Ugnayan that the city is finalizing the sending of a Technical Working Group to visit the operation of the waste- to-energy plant in Europe.

The Mayor hopes that the Technical Team will go there by the end of June this year. Domogan explained that the waste to management plant complements and supplements the City's Environmental Recycling System (ERS) operation.

He further describes that after the materializing of 48 tons of biodegradable waste, the garbage will continue to be processed by the ERS then the rest of the garbage will be go through the waste-to-energy plant.

However, Domogan clarifies that he will not be going with the Technical Team to examine this plant. What is important is that the members of the city council will check the feasibility of the plant before continuing its implementation in the city.

"To see is to believe. Importante na tignan muna nila 'yan at makakatulong yan sa discussion to pursue the city's direction to have the waste-to-energy plant for disposing our garbage." The Mayor reasoned.

Last year, Domogan had chosen the proposal of waste-to-energy technology from Germany Dominion Clean Energy to solve the city's solid waste management problem. The National Economic Development Authority (NEDA) has also issued clearance for the city to proceed with the

In an interview last year, General Services Officer Romeo Concio said the waste energy facility will be able to process mixed waste. He added that the facility would require a minimum of 200 tons of garbage daily for it to be able to produce electricity. The city produces 160 tons of garbage daily but adding the waste from business establishments, the city is expecting to reach the 200 tons minimum for the said project to be feasible.

The City government required the Dominion Clean Energy to post a P30 million bond that will be forfeited in the event that the project will fail after 90 days of full operation./ G.Esperanza

Shriveled seeds

Did the hunting of fruit-eating birds lead to the shriveling of tree seeds, asks the journal Science in its latest issue. This can damage, beyond previous estimates, already-stressed tropical rainforests.

Deforestation in Brazil resulted in trees that yielded smaller, frailer seeds. "The story we are documenting... is common in other tropical areas around the world," explains Spain's Prof. Pedro Jordano. "(That's) where big mammals and birds are disappearing." As in the Philippines?

Jordano and Sao Paulo State University scientists sifted through more than 9,000 forest seeds. They factored in issues like soil fertility to thinning forest cover. Seeds were significantly smaller, they found. They were less likely to regenerate.

"Kung ano ang binhi, siya ang bunga," a Tagalog proverb says. "What the seed is, so is the fruit." In the parable of "The Sower," many of the seeds also didn't sprout. Some were "trampled underfoot." "Birds of the sky" devoured others. Most fell on rocks or thorns, and withered.

Loss of birds triggered today's shrinking seeds, writes BBC's science reporter Rebecca Morelle. She quotes Jordano: "The main factor was the disappearance of

EDITORIAL the large frugivore (fruit-eating) species... One of

our major surprises was how deforestation influences the evolution of plant traits—all within a few generations."

Brazilian birds, like the "toucan" and "cotinga," have been hunted to near extinction. In the Philippines, 89 birds are endangered. The Philippine eagle is the best known. Also threatened are the Philippine cockatoo, Cebu flowerpecker (dicaeum quadricolor), Visayan wrinkled hornbill and amphibians, including the panther flying frog.

The Ticao Tarictic hornbill and the Sulu bleeding heart are gone for good. "If we don't preserve our endemic feathered treasures, they'll just be remembered in stamps," says ornithologist JC Gonzales. Inexplicably, "songbirds exposed to polluted environments sing more," says a feature on exotic birds in cities. "But they also die early."

Like Philippine rainforests, Brazil's Atlantic timberland "was once home to a vibrant array of plants and animals." But the launch of sugar and coffee plantations, in the early 19th century, altered the forest cover radically. Today, just 12 percent of Brazil's original forest remains.

Less than a quarter of Philippine rainforests are left. In 1595, they blanketed 27.5 million hectares. But a logging mafia wrecked that "heirloom." Log exports topped 11.1 million cubic meters in 1974, then slumped to 841,000 cubic meters a decade later. The forests still have to recover.

Juan Ponce Enrile's logging firm "chain-saws" the last rainforest in Samar. Will tree stumps crown his checkered career? Enrile seesawed from a fake martial law ambush to People Power hero, jack-knifed into coup plots, then emerged as a firm chair of impeachment process.

Forest depletion denudes the mind. A Negros and Panay survey discovered that most schoolchildren have no concept of natural forests. When asked to draw, they depicted neat rows of plantation trees. Some "baby-boomers think molave (Philippine mahogany) is a street sign," a forester explained.

Until the early 1980s, the word "biodiversity" rarely cropped up, even in scientific meetings. It means the complex web of life forms. This coils within a species or system and can unravel. This is richest along the equator: in fishing grounds along Western Pacific coasts and rainforests. Tropical forests cover 6 percent of the earth but contain more than half the world's plant and animal species.

Biodiversity in a large number of tropical forests, however, is still eroding, says a 36-nation study in Asia, Africa and Latin America. At the rate of today's depletion, there is concern "whether tropical forests will continue to function as 'arks' for biodiversity and natural ecosystem processes."

William Laurance of James Cook University (Australia) led the study team. It pinpointed hunting as one of the main threats to biodiversity in protected areas. "About 85 percent of these reserves suffered declines in surrounding forest cover in the [past] 20 to 30 years. In contrast only 2 percent gained surrounding forest."

UP students launched, in 1910, the first formal reforestation program at Los Baños. In 1917, President Sergio Osmeña opened Cebu's Camp 7 reforestation project. It still exists in a province where forest cover is less than 2 percent. The key project of his grandson, outgoing Rep. Tomas Osmeña, is a bare 296-hectare reclaimed plot. South Road Properties is semi-desert.

Only 30 percent of reforestation projects succeed. "People hardly recognize the benefits from protecting the environment." Connivance sabotaged the program. When the forests go, so does the topsoil which produces food. Over half (52 percent) of the country is eroded.

In the Ateneo University publication, "Forest Faces: Hopes and Regrets in Philippine Forestry," Peter Walpole writes: "Regeneration is taking place as secondary forests regain their original stature. Cogon (imperata cylindrica) fields, that blanket logged-over areas, shelter a new generation of pioneering seedlings. (This) is a phoenix forest that could restore and regenerate our landscape. There is hope. But it needs a nurturing hand."

Climate change, however, unleashed three typhoons, within three years, on Mindanao. In the past, a storm slammed the island once every 17 years or so. It may deny us the time needed to reverse shrunken tree seeds./Juan L. Mercado

WHERE ARE THE BATS & FIREFLIES?

BATS — I remember those childhood days when every late afternoon just before sundown, the skies would darken due to thousands of bats flying low overhead heading towards the mountains and the forests to forage for food at night and then fly back early morning towards their roosting places in the trees near the sea. And slept when daybreak came. A tree would look like a laden, black christmas tree populated by bats, hanging upside down. Like clockwork, they winged back to the foraging places at nightfall. And back again to roost by daybreak.

When I visited our barangay last week, I kept looking and waiting till sundown but I didn't see the bats anymore.

FIREFLIES — When I went to the highlands along the **Davao-Bukidnon** road a few days ago, I spotted a solo firefly in the ceiling in the middle of the night. There used to be thousands of them in a big tree nearby some **20 years ago** when I first came to that place. I stared at the ceiling for a long time and watched it with fascination, gracefully and softly blinking. Now, I was so thrilled seeing a single one.

I don't see many of them anymore.

RIVERS — I was reading an email from INTERNATIONAL RIVERS FOUNDATION, an Australia-based environment advocacy group and I was reminded about what I experienced when I was handling Mindanao for Malacanang several years ago. I would always notice the "dying" rivers from the air everytime I crisscrossed the region on board helicopters or small low-flying planes going somewhere.

One interesting common observation (and you can check this out today): populations like towns or cities — or even barangays in most cases — cluster around rivers or lakes or bodies of water. During those early years, our forefathers knew that life was better when they lived where there were available water for food, transpo, and other life-sustaining necessities.

Unfortunately today, our rivers are "dying". I always felt bad seeing from the air cleavages along hillsides or what used to be waterways that no longer had water running down the slopes — or if any, they were in trickles. Many riverbeds today have wide spaces without water. And seldom would I see rivers that have sparkling or clear water, mostly brownish and muddy.

When I was a kid in our barrio (now barangay), going to the river to take a bath or fish was always a delight. Today, our river is so silted and must have chemicals in the water due to banana plantations and a sugar mill around its banks that parents shoo their children away from the water. Even the fishes are no longer there. Or if there are, they must be laden with toxic substances not fit for consumption.

DEVELOPMENT? Some say this is the price of development. Yes, definitely times have radically changed. For the better? I dunno. But I am sure there must be a way to revive those dying waterways and bring back the bats and the fireflies.

Remember the famous line: "WE DID NOT INHERIT THE EARTH. WE MERELY BORROWED IT FROM OUR CHILDREN.".

So, what do we return to them when their own time comes around to get back what we borrowed? How do we return the bats, the fireflies, and the sparkling rivers that are no longer around? Have we lost them forever? IAM SURE THERE MUST BEA WAY!!



With very busy environment of the City Market during mornings, there are a couple of things you should watch out for. You may bump into other market-goers who just like you carry two full plastic bags on each hand or, given the human congestion and how fast some vehicles pass by in the middle of the road in the city market, they may bump into you as well. I'm still surprised I have never heard of anyone being run over in that place.

One thing you should also keep an eye of is the heavy carriages of vegetables and other trade that may hit your head whenever the person carrying the load walked past you. Just like what happened to me some time ago when a couple of guys who were each carrying a medium-sized box walked towards me. Fortunately, I docked my head just in time we were parallel to each other. For reasons unbeknownst to me, though, I looked back immediately to read what was written in those boxes. One of them read 'fragile'. After a fraction of a second, I saw something peeped into a hole on the box. It seemed like a nose trying to sniff the outside air. With the little whiskers and spots close to its nose, that moment I knew it was an animal in there—and a dog no less.

Baguio is known for asocena, the illegal slaughtering of dogs for food trade. In spite of the reports on incidents being a little hush-hush at present, this inhumane practice is still up and running behind closed doors. In fact, in a report of ABS-CBN just last year, the increase of Korean nationals in the city has boosted the local dog meat trade. In the same report, it was mentioned that eating dog meat is nothing but a norm in Korea, and Cordillerans have dogs cooked for offerings during rituals. Under the Animal Welfare Act of 1998, however, the law does not prohibit the slaughtering of animals when it is done for rituals of indigenous communities. Nevertheless, under this Act along with the Anti-Rabies Law and Consumer Act, dog carnage for meat trade is by all means illegal.

For years now, I have always wondered why we don't have any Animal Welfare groups in the city of Baguio that even non-government groups are unheard of. I have only encountered individuals who are passionate in fighting for animal rights. Usually, these individuals report to the Philippine Animal Welfare Society (PAWS) located in Quezon City or the nearest and most accessible animal welfare group which is unlikely located in our city proper. And the last resort is to get the help of any government agency who also has the capability to address issues on animal rights.

But it's still different from having a special group who exclusively deals with the humane and ethical treatment of animals. They know better than anyone who is there in other government agencies who are juggling from one issue to another. An animal welfare group will give their utmost attention to your plea unlike other agencies or officials who will most likely shun these kinds of concern, as they are 'not as important' as other public matters.

I asked my dad recently about this question why we don't have any recognized local animal welfare groups. He looked at me as if I was kidding. He said that eating dog meat lies in the traditions of many Cordillerans, and they will most likely laugh at the existence of such groups in the city. I know he was exaggerating when he said that but it is still clear that many of us ignore this very important matter. It seems that even the law could not get in the way of this illegal practice.

But even so, I still wish to see a formation of a group on animal rights in the future that will be recognized not only by the local government but also the people of Baguio. Residents who truly care for animals will have them as partners in eradicating the illegal dog meat trade in the city and other inhumane treatments to animals while promoting humanity overall. Who's with me?

Dengue Alert on Anew

BAGUIO CITY - The dengue fever alert is on anew in the city as the Baguio Health

Department city epidemiology surveillance unit (CESU) reported a 120.83 percent increase in the number of cases from January to May 31 this year.

Mayor Mauricio Domogan on Friday tasked the barangays here to take the lead in undertaking preventive measures through regular clean-up activities to search and destroy mosquito breeding places and continually educate their constituents on seeking early medical attention in case of affliction.

CESU head Dr. Donnabel Tubera said the city recorded a total of 106 cases from January to May 31 this year as against the 48 cases listed during the same period last year.

Statistics in the past four weeks showed a clustering of cases in Pinsao Pilot Project where three cases were reported. Two cases were reported in Bakakeng Central and one case each in barangays Bakakeng Norte, Camdas, Country Club Village, Dominican Mirador, Engineer's Hill, Fairview Village, Gabriela Silang, Gibraltar, Guisad Surong, Happy Hollow, Irisan, Lucnab, Private Rd Magsaysay, New Lucban, Pacdal, Pinget, Upper Rock Quarry, Sto. Tomas Proper and Slaughterhouse Compound.

Tubera said the highest age group affected was between 10-19 years old with seven cases and 20-29 years old with six cases. Fourteen of the patients were male and eight were female.

Tubera said the city health office conducted entomologic survey in selected barangays and distributed long-lasting insecticide treated nets (LLIN) curtains in 12 elementary schools particularly Crystal Cave, Roxas, San Carlos, San Luis, Pacday Quinio, Magsaysay, Pinsao, Rizal, Dona Aurora, Aguinaldo, Baguio Central School and Dona Josefa.

On June 25, the health office will launch the "Mag 4 o'clock Habit, Araw Araw" campaign in Baguio Central School, as part of the celebration of the Dengue Awareness Month and ASEAN Dengue Day this month.

During the monthly Association of Barangay Councils (ABC) meeting with the mayor last Friday, Tubera apprised the barangay officials on the status of dengue cases and on the measures to be undertaken to prevent the occurrence of more afflictions.

The barangays have been designated as focal points of the "Search and Destroy Campaign" through the "Aksyon Barangay Kontra Dengue" (ABKD) anti-dengue drive of the Dept. of Health in cooperation with the Dept. of Interior and Local Government (DILG).

The said campaign is a part of DOH's Integrated Vector Management (IVM), an evidence-based campaign to reduce mosquito density through community participa-

The city health office is continually advocating the "4S Strategy" in its anti-dengue campaign in the barangays.

The 4S stands for Search and Destroy which involves the clean-up of surroundings and removal of stagnant water that serves as breeding ground for the deadly mosquitoes; Seek Protective Garment which prescribes the use of long garments, mosquito nets along with the use of insect repellants to protect the body from mosquito bites; Secure Immediate Medical Consultation where persons with dengue fever symptoms are advised to seek medical attention; and the Say No to Indiscriminate Fumigation and Say Yes to Fumigation only in times of Outbreak.

Dengue fever is an infection caused by dengue virus which is transmitted by the bite of an infective female

The signs and symptoms of dengue fever are: on-andoff fever lasting for two to seven days; loss of appetite; nausea/vomiting; abdominal pain; body weakness; small reddish spots on chest area, arms and legs; bleeding signs (nose and gum bleeding, vomiting blood, bloody stools and abdominal pain); restlessness; weak, rapid pulse; cold, clammy skin; and difficulty in breathing.

Persons that manifest these symptoms must remember the following: High fever should be treated by sponging and giving paracetamol and not aspirin as it may cause bleeding and/ or gastric irritation and must increase fluid intake or use oral rehydration solution.

Persons with second stage symptoms like flu-like symptoms, bleeding, abdominal pain must be brought to immediately to the nearest health center or hospital for treatment./A Refuerzo

The five member team who evaluated the barangays are Assistant City Prosecutor Ruth Bernabe, DILG City Director Evelyn Trinidad, BCPO representative Atty. Eleonora Tabdi, ABC President Coun. Joel Alangsab and Alberto Tomas of the Special Services Division of the Mayor's Office.

The search was focused mainly on the performance of the participating barangays in handling cases brought before them for settlement and proceedings as mandated by the Katarungan Pambarangay Law and how they have effectively and efficiently handled the same.

The barangays who participated in the search were recognized and awarded last Monday (June 3) in simple rites during City Hall's Flag Raising Ceremony.

Mayor Mauricio Domogan said, "The successful awards should encourage other barangays to participate and showcase their best practices for the next search."

have regular financial support from relatives.

A total of 206 indigent senior citizens, 145 females and 61 males benefited from the grant totaling P309,000.00.

Under Republic Act 9994 or the Expanded Senior Citizen Act of the Philippines, the Social Pension is given to indigent senior citizens whose eligibility is determined by the DSWD.

The senior citizen is then entitled to a monthly stipend amounting to P500.00 to augment the daily subsistence and cover medical needs.

Beneficiaries of the aid are those who are frail, sickly or with disability, not receiving other pension benefits from government and private agencies, and no regular source of income, compensation or financial assistance from any member of the family to support their basic needs.

Domogan said, 'he is happy to see indigent senior citizen's who came personally to get their cash grant and proud that the law which he principally sponsored and have fought for is now benefitting them.'

Senior citizens who were unable to come physically during the distribution of their Social Pension Grant will be visited by the DSWD and their benefits will be handed to them personally at their residences./paul rillorta

Councilor Erdolfo Balajadia said the city may be able to impose its own rules in accordance with Ordinance No. 13 series of 2007 or the Water Code of Baguio City which he said requires water permit applicants to secure clearances and requirements with the city before they can conduct ground drilling activities.

'Our water code states that although the national office can issue permits and can post (applications) even if the matter does not pass through the city council, the applicants have to first get permit from the city before they can break the ground (for their water projects)," Balajadia noted.

The water code provisions require water applicants to secure permits and clearances from the City Water Resources Board and from the Baguio Water District.

It also imposes requirements for accreditation of water well drillers, annual verification of water sources and extractors and water distributors.

The code was passed to address the lack of control over water extraction and other threats to the availability of water resources within the city.

daily clients stands at 1,430, and it went as high as 1,883 clients last May 21, wherein most of the clients were even requesting for multiple documents.

Aside from their walk-in clients, the Baguio Outlet is also processing the daily requests for NSO documents from their BREQS (Batch Request System) partners that SM City Baguio; NSO-Ifugao; NSO-Abra, and the Local Government Units (LGU) of Dolores, Abra; Bontoc, Tadian, Bauko, Barlig, Paracelis of Mountain Province; Alfonso Lista, Ifugao, and Tinglayan, Kalinga.

The BREQS is where the public can also patronize or go to apply for their NSO documents which will allow them to save time, money and effort of travelling to Baguio.

Gulla reiterated their appeal to the public to plan their schedule for getting a birth certificate for school or board examination purposes, and for those going to the NSO, not to bring in companions especially children, as they will add up to the congestion in the service area.

She also called for patience among their clients, as getting impatient or illtemper with the long lines and the overcrowding will not resolve anything and will only make the inconvenient situation in the Baguio Serbilis Center worse.

Aside from Birth, Death and Marriage Certificates and Certificate of No Marriage or Cenomar, the NSO – Baguio outlet also process authentication of Local Civil Registry (LCR) issued documents, endorsement of newly registered documents with coordination of the

city post office. There, he handed P2,500 to the distraught father.

At angelus last Thursday, a forty-something donor called Noli, for him to meet her at the lobby of the Flavier Building of the BGHMC.

"She told me she's also a cancer survivor and, because of the trauma, apologized for not seeing my daughter," Noli said. "She handed P5,000 support. When I asked who we were indebted to, she just identified herself as "Honey"."

Last Friday morning, Noli also received a guarantee letter from Rep. Bernardo Vergara asking the BGHMC to charge P15,000 from the solon's Medical Assistance Fund for Rossana's treatment.

These gestures proved a windfall for Noli, who earns between P150 to P200 daily driving a tricycle owned by a barangay official of Asan Norte in Sison, Pangasinan.

Rossana was diagnosed in September, 2011 for acute lymphocytic leukemia. With support from Senators Allan Peter and Pia Cayetano and Antonio Trillanes and Rep. Kimi Cojuangco of Pangasinan, she began her protracted treatment protocol at the BGHMC.

Last February, the girl suffered a relapse. It meant she had to start her treatment all over again. The new treatment protocol was pegged initially at P34,200 a month for the "remission induction chemotherapy", to be administered weekly for four to six weeks.

She had her first back-to-square-one chemo last Monday. Because of the prohibitive costs, it was three months delayed.

With a long way to go, she still needs all the help she can get. As she has no cellphone, Samaritans can ring up her father's, perhaps until next Sunday, which will be Father's Day. The number is 09204508497

Two other fathers who also declined to be identified also kept alive the hopes of 51-year old cancer patient Emilia Tallongen and 21-year old heart patient Crisly Anayasan

As he usually does when he reads a patient's appeal, one of the two donors had his secretary hand P12,000 to Tallongen and P15,000 to Emilia Anayasan, mother of Crisly.

Tallongen's fight against the big C was also boosted by a P2,500 support from the other Samaritan, also a regular donor who likewise gave P2,000 for Crisly. On top of these, another kind soul deposited P3,000 to Tallongen's bank account.

Tallongen worked for 10 years as street sweeper and is now on her llth year as barangay nutrition worker assigned at the Campo Filipino District here. In June last year, she noticed a swelling on the left side of her neck. It was diagnosed as Hodgkins lymphoma, or cancer of the lymph nodes. After undergoing surgery, she began chemotherapy.

Crisly, son of a seamstress from San Carlos Heights, Irisan here, was born with a heart defect medically known as ventral septal defect, perimembanous type. For years now, his mother has been working on a possible surgery at the Philippine Heart Center, something she hopes would be done before the boy turns 22 in December.

Santos, 60 and afflicted with breast cancer, will have her sixth chemotherapy on June 15 at the Notre Dame Hospital here.

tution provides that persons charged with capital offenses are not entitled to bail when the evidence of guilt is strong.

In a 44-page ruling, the Sandiganbayan division said the prosecution failed to present strong evidence against the three.

The court, however, clarified that the grant of bail to the three accused cannot be taken as a ruling on the strength of the prosecution's entire case against Arroyo and the rest but simply to establish a basis to deny or allow the defendants to post bail.

"The above-stated ruling and pronouncements of this Court must not be construed to mean that We are passing judgment as to the final result or outcome of this case with respect to the bail petitioners or the other accused who did not take part in the bail petitions," it said.

Associate Justice Rafael Lagos penned the resolution, with Associate Justices Efren de la Cruz and Rodolfo Ponferrada concurring.

At present, three other defendants — former PCSO general manager Rosario Uriarte, former PCSO board directors Jose Taruc V and Ma. Fatima A. S. Valdes, and former Commission on Audit chairman Reynaldo Villar — remain at large.

Former COA-Intelligence Fund Unit head Nilda Plaras, also a co-defendant, secured an injunction order from the Supreme Court on the basis of her legal challenge on the validity of the indictment from the Office of the Ombudsman.

The defendants were all accused of conspiracy in the irregular transfers of confidential intelligence funds of the PCSO amounting to P366 million between January 2008 and June 2010.

However, the Sandiganbayan held that documentary evidence and the testimony of government witness Aleta Tolentino presented by the prosecution during the bail hearings do not constitute "evident proof of plunder" against Valencia, Morato and Roquero./KBK, GMA News

Mayor Ok's Push for Local Flights

BAGUIO CITY - Mayor Mauricio Domogan welcomed moves of the Hotel and Restaurant Association of Baguio (HRAB) calling for the re-opening of the city's only airport here.

In a letter petition to his Excellency President Benigno Aquino III, HRAB Officers called on the president to consider re-opening the Loakan Airport to commercial traffic.

The letter also implores the city government to pass measures which will lead to the airports re-opening by creating a special committee to ascertain state of the Airport, conduct assessment of its facilities and services, implement upgrade and rehabilitation plans and conduct consultations to residents which will be affected.

Domogan said, "agreements have already been reached between the Air Transportation Office (ATO) replaced by the Civil Aviation Authority of the Philippines (CAAP) and the city government years back for the re-opening of the airport."

The first is the total closure of the Loakan Airport to pedestrians and animals to ensure aviation safety and the development of a by-pass road towards Kennon Road to service residents across the runway.

Domogan also said, "a P12 million appropriation from the budget of the ATO has been reserved for the development of the alternate route.

'We still have to check if the appropriation is still available so that we can implement it already but if it has been realigned then we have to look for funds," he said.

The bid to re-open the airport is anchored on the country's selection to host the Asia Pacific Economic Cooperation (APEC) summit which will be held in November, 2014.

Delegates from 21 APEC nations are expected to attend the week-long event which can pour in millions of dollars for the country and its host cities.

Nine cities were identified as APEC destinations; Manila, Clark, Subic, Boracay, Cebu, Iloilo, Davao, Bacolod and

However, HRAB said the city was not included in the list of host cities, it also said the city government should consider submitting a competitive bid to be considered one of the host cities like what the City of Albay did.

Domogan admits, he is not aware of the requirements to bid and to what committee should the bid be forwarded to.

"I think that we have to get the requirements first before we can bid," Domogan said.

Domogan said, "if the city can comply then it can submit its interest to bid and host some of the activities of APEC."

Baguio Seniors Receive Cash Aid
