The Filipino People's Revolt of 1986 is Unfinished

Peter Cayetano has urged both the Senate and the House of Representatives to work for the early passage of the Freedom of Information (FOI) bill in spite of reluctance of the Aquino administration to certify the urgency of the bill.

Cayetano said the early passage of the Freedom of Information (FOI) bill will not only ensure transparency and accountability in the government but will establish an institutional mechanism by which the citizenry can be empowered by giving it access to public documents that involve public interests.

"By aggressively working for the passage of the bill, both the Senate and the House of Representatives can also show that we are, indeed, an independent branch of government with its own priority agenda irrespective of the

Last December, the 14 were arrested along with 10 Chinese nationals by Philippine authorities and the Interpol for allegedly operating an international fraud syndicate that has swindled mainlanders from China of some \$20 million.

has lividly raised those three issues surrounding the deportation snafu. I will summon them to an inquiry at the Senate if I find their explanations unsatisfactory, Escudero said.

Betel Nut Users Urged to Spit in BAGUIO CITY - Betel nut afi-

Containers cionados here are now required to spit their litter in containers.

The city council approved on final reading Ordinance No. 6 series of 2011 which enhanced the city's anti-spitting measure by including betel nut users in the regulation by including an additional section mandating betel nut users to use containers for their refuse.

Councilor Perlita Rondez, author of the measure, said this seeks "to address this specific act of unhygienic act of spitting betel nut juice in sidewalks, street ways, drainage canals, waterways and other public places.'

She noted that the city has an existing anti-littering Ordinance No. 54-88 or An Ordinance Penalizing the Illegal Disposal of Refuse, Excrement and Egesta; Removal or Destruction of Receptacles for Refuse; and Illegal Obstruc-

tion of Waterways and Dumping into Bodies of Water; Requiring Certain Persons, Institutions and Establishments to Provide for Receptacles for Refuse to Keep Surrounding Clean and to Pick up Litters; Providing for Amnesty from Prosecution... "

She said that however the said ordinance "remains more honor in breach than in compliance.

"The ever-increasing betel nut aficionados have created a bane in the city's Clean and Green efforts especially that of its health and sanitation initiatives," she stressed.

As approved, section 1 of Ordinance Numbered 54-88, as amended by Ordinance Numbered 047, Series of 1995, and Ordinance Numbered 14, Series of 2006, shall include the following section as Section 1.B, which shall read as follows:

'SECTION 1.B. It shall be mandated for betel nut (nga-nga) aficionados to discreetly spit in receptacles or containers to ensure the sanitation of public places and to safeguard the health of all citizens and persons in the City of Baguio.

Penalties for violation of the ordinance will be based on Section 8 of Ordinance Numbered 54-88, as amended by Ordinance Numbered 047, Series of 1995, and Ordinance Numbered 14, Series of 2006./A Refuerzo

Mayor Assures Weeding out of Illegal as City Pursues Pocket Deals **Developments at the Market**

BAGUIOCITY Mayor Mauricio Domogan Wednesday said unauthorized sub-leases and other shady deals at the city public market will eventually be weeded out as the city continues it pocket developments to put back order at the city trading center.

The mayor said that after the refurbishing of the Block III section which was inaugurated last week, the city will focus its attention on the development of the Block IV

area via a P12 million initial fund which will be supplemented by another P8.5 million currently being worked out for realignment.

The mayor brushed off claims that the city does not own Block IV. He

Cash Benefits for Senior Citizens

Increased

BAGUIO CITY The city government will increase the cash benefits being granted to senior citizens who render community service from P20 to P30 per hour commensurate to the work done.

The city council approved on final reading Ordinance No. 7 series of 2011 amending Ordinance No. 53 series of 1995 for this pur-

Ordinance 53-95 sets it a policy of the city government to extend cash benefits to qualified senior citizens in the form of honorarium in an amount of P20 per hour commensurate to services rendered by senior citizens as determined by the Office for Senior Citizens

Affairs (OSCA). Councilor

Lourdes Betty Tabanda, author of the ordinance, said that the amount should be increased as it is no longer realistic.

"Fifteen years after the passage of this ordinance, there is a need to amend certain prostated visions thereat because they are no longer realistic and do not conform with the intent of the legislative enactment, Tabanda noted.

The grant of the honorarium is pursuant to Republic Act No. 7432

As per Ordinance 53-95, any qualified senior citizen as determined by the OSCA may render service to the community which consists of any of the following: tutoria1 and/or consultancy services; actual teaching and demonstration of hobbies and income generating skills; lectures on specialized fields like agriculture, health, environmental protection and the like; the transfer of new skills acquired by virtue of their training; undertaking other appropriate services as determined by the Office for Senior Citizens Affairs (OSCA) such as school traffic guide, tourist aid, preschool assistant, and others.

The ordinance empowers OSCA to award or grant benefits or privileges mentioned in this Ordinance. It may conduct investigation in order to deter-

a "final decision" that 16 towns masqueraded as cities.

Boos swamped Senator Ferdinand Marcos Jr 's bid to resurrect his family's efforts to move Marcos Senior's body from a refrigerated Batac mausoleum to Libingan ng mga Bayani. Will Marcos' fake World War II medals be interred?, critics sneered.

Journalists are padlocked, by their craft, into this sound chamber, Louis Lyons would drill into editors at Harvard University's Nieman sabbaticals. A babel of voices batters them They range weak whimpers to imperious tones, shrill screams to fading tones.

"Learn to listen," Lyons would say. "Extract what is true and relevant ouf of this chaos. At t the same time, think for yourself. That's the only way you can serve those you write for or broadcast to."

The press needs to spike it's daily overload of trivia. It must focus limited reources on "deep-running currents", as the late European statesman Jean Monet would say. Swirling beneath the obvious, these are survive-or-perish issues for countries.

Often, these lethal threats are silent and thus overlooked. Victims of obscene infant mortality rates, for example, can not even whimper. Few of these concerns make headlines.

The issue range from chronic hunger, spiking food prices to spiraling number of abortions. Below are two issues. Feel free to add to this admittedly incomplete list.

Consider coral reefs. Few bother since they're submerged. Yet, reefs nuture so richly marine life – source of protein for the poor -- they're dubbed "rainforests of the sea." Science Journal, this year, confirmed that "reefs are also centers of evolution.

"(They) give rise to many more new species than other tropical marine habitats," writes Wolfgang Kiessling of Berlin's Humboldt University. "New species originate 50 percent faster in coral reefs than in other habitats....If we lose reefs we lose an opportunity to create new species by evolutionary processes."

In the Philippines, warming of sea water, stemming from El Niño, unleashed coral bleaching. In 1998. That decreased live coral cover by as much as 49 percent. Altered chemistry triggered algal blooms or "red tides". Resulting fish kills.proved devastating since 51.8 percent of fishing households scrounge below poverty lines.

The seas have not cooled since. UP's Perry Aliño and De la Salle's Al Licuanan warned. Today's continued coral bleaching "could surpass the 1998 catastrophe.". Among today's bleaching hot spots are: Batangas (Nasugbu, Lian, Bauan, Mabini, Lobo and Calatagan), Oriental Mindoro (Calapan) and Quezon (Pagbilao).

"Reefs at Risk Revisited", just published by World Resources Institute (WRI) in Washington DC, backstops that warning. Three-quarters of the world's coral reefs are at risk due to overfishing, pollution, climate change and other factors, says this new study.

"Regionally, southeast Asia is the worst affected region, Over 95 percent of reefs are under stress. The Philippines is among the list of threatened countries. This includes: Comoros, Fiji, Haiti, Indonesia, Kiribati, Tanzania and Vanuatu.

The Filipino People's Revolt of 1986 is Unfinished

We commemorated recently the 25^{th} anniversary of people's power revolt.

Although the February 1986 people's power revolt appears to have started with the call of Cardinal to support the beleaguered forces of Juan Ponce Enrile and General Fidel Ramos, the event is actually a culmination of long years of struggle of the Filipino for freedom. As early as day 1 of the declaration of Martial Law by President Ferdinand Marcos in 21 September 1972, Filipinos have expressed their opposition to the regime. The February 1986 event could not have happen if Filipinos of earlier years have not been braved enough to shatter the atmosphere of fear under several years of Martial Law under Marcos.

Like it or not, the February 1986 people's revolution is a joint undertaking of left, middle, and left-of-right forces in Philippine society to establish a government that is generally acceptable to all people. One evidence of this is that the key leaders of the Cory Aquino government in 1986 come from a mix of personalities from left to right of the political spectrum. One of the personalities associated with the birth of the Aquino government is Juan Ponce Enrile who had admitted to have faked his own ambush to provide Marcos with a justification to declare Martial Law. Another personality is Francisco Tatad who acted as Marcos spokesman during the larger part of the Martial Law regime.

Unfortunately, some elements in the military have perceived the Aquino government as a centrist government who have included "leftists" in her government. Probably against the wishes of the commander-in-chief or perhaps a product of her loose hold on the military, the military during the early years of Aquino government has bombed and strafed villages perceived as bases of the left while conducting peace talks with the National Democratic Front.

It is a sad event in Philippine history that some elements in the military have branded as "leftist" the likes of Teddy Boy Locsin and even the current Vice-President Jejomar Binay. In fact, the most bloody revolt of the Reform-the-Armed Forces Movement or RAM of Gringo Honasan in 1989 has targeted the removal of personalities like Jejomar Binay as one of the fundamental demands of their movement. Tragically, Honasan and the RAM has perceived Binay as part of the left prompting Teddy Locsin to comment one time that the RAM and Honasan has been seeing everything and everyone as "red" in the Aquino government.

The key lesson provided by the 1986 people's revolt is that the Filipino people as well as all peoples of the world has the capability to bring down a dictatorship. It is for this reason that we must persist on commemorating EDSA. EDSA has to be remembered so we will continue to know that people have the power to bring down a dictator to his knees. However, there is another important reason why we must remember EDSA 1986. We must continue to remember EDSA 1986 because the people's revolt of 1986 is unfinished. Graft and corruption is so large, deep, and widespread in the military and the police. This is **Cont. on page 11**

said he is certain that the ownership of the area has been returned to the city government by former President Gloria Macapagal-Arroyo.

He lashed back at the city's enemies at the public market whom he said are just resorting to loose talks in their effort to hang on to their shady transactions at the city market which he vowed will soon be uncovered and put to stop.

He said these people are using the market as their "gold mine" enriching themselves by illegally leasing out areas and thereby shortchanging the city government and victimizing the hapless vendors.

"We will definitely push through with the Block IV development to eventually clean and put it back in order," he said.

The city will also target the development of the dilapidated market building along Magsaysay Avenue which has been recommended for declaration as a public nuisance by the city fire marshall Richard Villanueva.

Villanueva in a report to the council said the building which was earlier condemned by the City Building and Architecture Office has been determined to be a fire hazard. Villanueva strongly recommended the dismantling of the said edifice.

The council however decided to first refer the matter to the city health office for proper recommendation.

As for the newly renovated Block III, the mayor said that the Baguio City Market Authority has begun the screening process for applicants for the 473 stall slots at the building.

He said the city received a total of 700 applications and these were being classified according to the criteria set by the city.

There were three classifications of applicants set by the city and among the criteria was that the applicants must not be opposed to the

development undertaken by the city at the market.

The mayor said this is but proper as the city must only patronize those who are supportive of the city's cause and not those who are opposing the city's efforts because of their own vested interests.

He said the city will fasttrack the screening to eventually award the stalls to qualified applicants./A Refuerzo



LCP THREATENS IMPEACHMENT VS. SC JUSTICES: The Supreme Court must answer threats by the League of Cities of the Philippines (LCP) that it will seek the impeachment of court justices who allegedly maneuvered to reverse their decision on the cityhood of 16 towns, which already became final, after allegedly receiving "secret letters" bearing the name of former Solicitor General Estelito P. Mendoza.

The high court must explain its side posthaste because the league's accusations, made through LCP President Oscar Rodriguez, mayor of San Fernando City, Pampanga, and LCP secretary general Hernani Braganza, mayor of Alaminos City, Pangasinan, have the effect of reinforcing charges made by Lauro Vizconde that decisions in the high court could be swayed one way or the other, for huge monetary considerations.

If the Supreme Court will just remain silent on the allegations of the LCP now, Filipinos may not be faulted for thinking that decisions issued by the tribunal for or against them have been the result of horse-trading or negotiated accommodations, for one consideration or another.

PERCEPTIONS OF DOUBLE STANDARD FIRM UP:

This latest tirade against the high court is unfortunate, coming as it does on the heels of widespread perception that there is really no justice anymore that could be expected from the judiciary, especially if one is poor or does not have the money to spread around.

Rather than dispelling this widespread perception, Vizconde's revelations (although being staunchly denied by the concerned justices now) and the LCP's anguished complaint that the Supreme Court could reverse even its final judgments after receiving "secret letters", have the combined effect of confirming, even if mistakenly, that justice has a double standard and a high price tag hereabouts.

Something must be done real fast to correct all of these, but the question is, what, really, can be done? Perhaps, all concerned must take inspiration from the Bible, particularly from the Book of Amos, where it is mandated that we must "...maintain justice in the courts..."

If we do not heed what the Bible is saying, and if we do not follow God's commands written in it, everyone whose hands have been dirtied will surely be punished and completely destroyed, as Deuteronomy 28:15-68 are saying.







Walter William's Journalist's Creed

This creed was written by Walter Williams (1864-1935), the man who founded the world's first school of journalism at the University of Missouri and perhaps contributed more toward the promotion of professional journalism than any other person of his time.

I believe in the profession of Journalism.

I believe that the public journal is a public trust; that all connected with it are, to the full measure of responsibility, trustees for the public; that acceptance of lesser service than the public service is a betrayal of this trust.

I believe that clear thinking, clear statement, accuracy and fairness are fundamental to good journalism.

I believe that a journalist should write only what he holds in his heart to be true. I believe that suppression of the news, for any consideration other than the welfare of society, is indefensible.

I believe that no one should write as a journalist what he would not say as a gentleman; that bribery by one's own pocket book is as much to be avoided as bribery by the pocketbook of another; that individual responsibility may not be escaped by pleading another's instructions or another's dividends.

executive's priorities," Cayetano said.

"While we in the Senate are still hoping the Palace will soon have a change of heart and later certify the FOI bill as urgent, nothing should prevent the House of Representatives and the Senate into making it a priority bill," he added.

The senator, principal author of the FOI bill, earlier expressed disappointment at Malacanang's decision not to include the FOI in the list of 17 priority bills after repeated assurances during the presidential campaign that the passage of the FOI bill will be one of his priorities once elected.

He recalled that then Senator Benigno Aquino III also voted for the passage of the FOI bill during the 14th Congress

The minority leader said both chambers of Congress have been burdened for so long with having to conduct series of hearings and investigations in aid of legislation on reported anomalous transactions by government agencies like the NBN-ZTE, Fertilizer fund scam and now the AFP corruption and the Garcia plea bargaining deal, and those hearings were hampered by refusal of government agencies concerned to release pertinent documents unless these were subpoened.

The holding of such hearings, he said, can be minimized and prosecution of guilty parties can be expedited with the FOI law in place.

Since the Philippine Anti-Graft Commission has been dissolved by the Aquino administration and the establishment of the touted Truth Commission has been derailed, only the early passage of the FOI bill now will redeem President Aquino's campaign promise to lead the fight against unabated corruption in government," Cayetano said./Office of Senator Allan Peter Cayetano

First, Ma said the Philippine government violated international law and time-honored international practices when it deported the Taiwanese nationals to China instead of repatriating them to their home country.

Second, the Taiwanese legally entered the country with valid passports, contrary to the claim of concerned authorities that they were undocumented.

Third reason cited by Ma was the complete disregard of the Philippine government's own law on the writ of habeas corpus obtained by the suspects' lawyer from the Philippine Court of Appeals. Escudero said he wanted to closely look into this matter not to get involved with the decade-long rift between China and Taiwan, but to ensure the employment status and future of the Filipino workers there.

"There are more than 100,00 Filipino workers whose livelihood depends on employment in Taiwan. We must address the issue because I worry for our workers who are already there as well as the lost opportunity to our people who already incurred expenses and were expecting employment already in Taiwan,' Escudero said.

Following the deportation and strong protest by Taipei, Taiwan decided to extend visa processing for Filipino workers to four months from 14 days, a move that could delay the deployment of almost 5,000 Taiwan-bound overseas Filipino workers (OFWs).

"We leave the foreign policy within the realm of the chief executive and the executive branch, but I am hopeful that we can still exhaust all means available to repair our cultural and economic ties with Taiwan as this affect the lives of many Filipino families," Escudero said./Office Of Senator Chiz Escudero

the fact suggested in the cases of Garcia, Ligot, Reyes, and the rest of the crying and perceived to be lying generals.

The non-military component of the government is also deeply corrupt as can be seen in the case of the cancelled ZTE deal. Has this ended with the Aquino government? So far, there is no evidence that it has. Besides, the Aquino government has not been providing strong support to the whistle blowers. The Aquino government has also been failing to provide moral support to those who have dared to expose military, police, and government corruption. So how can we expect that corruption would end or would at least significantly diminish under Aquino?

Sadly, because of the widespread corruption that is unabated and which is likely persist as unstopped, the Filipino has to continue organizing and strengthening themselves so the full ideals of the 1986 revolt can be realized: the establishment of a full democracy that is confirmed with a virtual absence or virtual insignificance of cor-

Next, consider forests. Rapid population growth, destructive logging and the energy crunch are "drivers of change," says FAO's Asia-Pacific Forestry Outlook (to 2020). A major log exporter in the 1960s-1980s, the country imported 0.165 million cubic meters of logs in 2005.'

"By 2020, natural forests will have declined further because of continued illegal logging and poaching for fuelwood, despite watershed rehabilitation efforts.' Wood will increasingly come from plantations, depending on how well they're managed and supported.

A well intentioned President Aquino clamped on a log ban. "Legitimate wood producers (e.g. farmers who plant trees for a living) are already targets for extortion,' writes former FAO forester Pat Dugan DENR field officers to NPAs routinely intercept trucks loaded with plantation-grown timber and demand money. The log ban will create ideal conditions for corruption to flourish.

'The principal cause of tropical forest destruction always has been fire. Clearing for kaingins, plantations, etc invariably includes burning. Fires prevent growth of seedlings dispersed by wind, animals and rain. They sprout naturally in the neverending ecological process of plant succes-

"If we could stop fire for ten years, most of our denuded mountains would be forested again. But I don't see this happening for as long as the wrong solutions are adopted to address the problems of defor-

"Imelda Marcos declared a log ban in Negros Oriental in 1979. It got her a lot of headlines. But that's about it. At that time the province had 19 percent forest cover. That log ban is still in place. And forest cover has dropped to around 3 percent. Need I say more?"/J.L.Mercado

Seven Baguio Jins crack into elite RP Taekwondo Team roster

Mendoza, Solimen, Caslangen, Sembrano, Soria, and Martinez are family names of Baguio residents for now. Soon, according to the best in the sport of Taekwondo, they will become legends.

February 18: The evening sun is sinking over the heart of Baguio City like a great red fist being swallowed by dark clouds of uncertainty.

At a small gym somewhere behind the post office, six youngsters -feet gnarled by years of battle that betray their ages - rush to check their mates at the terminal - their faces painted with mixed worry, excitement, and expectation of what's to come.

Number seven' is already in Manila as he is set to 'thread the needle' ahead of his other highland compatriots. The six on the other hand, are just about to board a bus to dreamland.

As they walk towards the terminal, a veil of mist suddenly enveloped them, as if to kiss them farewell as they brave the lions den known to mortals only as Central Taekwondo Gym (CTG).

Keno Anthony Mendoza (15-years old), Apriel Solimen (16), Suzzane Caslangen (14), Benjamin Keith Sembrano (15), Billy Joe Soria (21), and Harold Martinez (23) did not exactly know what awaited them during the tryouts for the elite Philippine Taekwondo Kyorugi (sparring) Team set February 20.

They've been training tirelessly for years under the tutelage of Baguio coaching phenom Arnold Oglayon of the Baguio Defenders Gym – more than 250-kilometers from CTG in Manila.

All of them with the exception of Sembrano, who is a student at the Baguio City National Science High School (BCNSHS), study as athletic scholars at the University of Baguio (UB).

By sundown in Manila, February 19, 21-year old Jonathan Rilloraza successfully renewed his spot in the Philippine Taekwondo Poomse (forms) Team, providing his fellow Baguio warriors reason to believe they too, are qualified to don the Republic's colors.

Lawmaker Wants Prisoner-Exchange Treaties with other Countries

Senator Chiz ernment to initiate a prisoner exchange treaties with countries hosting overseas Filipino workers (OFWs).

Escudero, chaircommittee on justice and human rights, reiterated this call in the light of the case of Ramon Credo, Sally Villanueva and Elizabeth Batain – Filipinos condemned to die for drug trafficking in China. Their executions were temporarily suspended after China's Supreme Court extended a "special arrangement, regard-

The senator said the government could work out a prisoner-exchange arrangement with other countries similar to the RP-Spain Transfer of Sentenced Persons Agreement, which aims to ensure the effective reformation and rehabilitation of Filipinos serv-Cont. on page 11 ing sentences in Spain since they will be afforded the opportunity to serve their sentences in the Philippines.

"We have OFWs serving long sentences and are awaiting death sentences in countries where no family can visit them. This is already a scourge to both the convicted and their families. The anguish of not being able to talk to or see their families forever is already a that sentence amounts to death,' Escudero said.

Escudero said the prisoner-exchange agreement should be pursued through the Department of Foreign Affairs (DFA) by way of a bilateral treaty.

The senator also said that the agreement should not be on a quidpro-quo-basis, which means that all prisoners should be transferred to their country of origin regardless of the number of foreign nationals in Philippine

"We should pursue this treaty especially since we have more citizens in foreign jails rather than the other way around. We pursue this move not because we condone their deeds but because it is the government's duty to look after the welfare of its citizens no matter if they are guilty or not,' Escudero said. "Let all available remedies and steps be exhausted to afford our fellows the services of their government.'

Records from the DFA show that there are more than 3.000 Filipinos abroad who are either in detention or facing criminal prosecution. Of these, 70 percent are embroiled in immigration-related offenses and will be deported after serving brief sentences. The rest are in custody for crimes such as theft and drug traffick-Cont. on page 11
