

STL operator must get business permit

BAGUIO CITY – Mayor Mauricio G. Domogan said the operator of the State-run Small Town Lottery (STL) in the city should first secure a business permit from the local government prior to the conduct of their collection and drawing activities in the different parts of the city.

The local chief executive pointed out while the operator was able to secure a license to operate from the Philippine Charity Sweepstakes Office (PCSO) even without the expressed consent of the local government, it is necessary for the licensed operator to also secure the mandatory business permit from the city because their activities in the city are classified as business.

"We learned that the STL operator already started the dry run for its operations but it is important for them to secure the mandatory business permit from the city before their full blast operations since their activities are considered business operations," Domogan stressed. DPWH, developer, officials barangay d ummone

BAGUIO CITY – The City Council approved a resolution inviting the management of the SunTrust Properties, Inc., the officials of the Department of Public Works and Highways-Baguio City District Engineering Office (DPWH-BCDEO), barangay officials of Gibraltar and Mines View, the management of Tower Condominiums and the sisters of the Good Shepherd Convent, and the contractor of the on-going construction to appear before the local legislative body on May 22, 2017, to shed light on the complaint of residents regarding the damages and inconveniences allegedly caused by the current development works within the SunTrust property.

The resolution authored by Councilors Leandro Yangot, Jr., Faustino A. Olowan, Arthur Allad-iw, and Edgar M. Avila stated in the observance of due process, the local legislative body needs to listen to the side of the developer and the complainants relative to the alleged collapse of the national road and the erosion of portions of some private property damaging surrounding private and public properties and caused inconvenience to the public, to ferret out the truth and guide the local government in concretely solving and taking action as well as applicable policies in aid of legislation regulating construction works that affect the public.

The resolution added on several occasions, the construction of a high-end condominium at Gibraltar reportedly owned by the Suntrust Properties, Inc. had been the subject of numerous complaints by residents claiming that the development in their place caused the collapse of the national road and the exposure of a sewage pipe posing danger to the lives and health of motorists and residents and the neighbouring properties as well.

Earlier, affected residents in the area alleged that half of the road near the construction site reportedly collapsed, including the sidewalk, forcing pedestrians to walk on the road exposing them to possible accidents.

With the advent of the rainy season, the concerned legislators need to assess the extent of the damage and the inconvenience caused and determine if it is related to the on-going Suntrust Properties project.

It will be recalled that the road pavement near the project site of the controversial company collapsed last Cont. on page 5

How important is the EUto the Philippines?

m ANILA,\ Philippines}$ – The Philippine government explained its decision to refuse new grants from the European Union (EU) by saying that the country must be "independent."

Before making the controversial decision, Philippine President Rodrigo Duterte had already dared the EU to withdraw its aid, saying that the country would survive.

The EU previously warned that the Philippines could lose its trade incentives *if it did not improve the human rights situation in the country.*

Just how important is the EU to the Philippines? Rappler takes a look:

1. The EU is a major donor and source of Official Development Assistance. *The EU was the 8th largest contributor of Official Development Assistance*

(ODA) to the Philippines in 2015, according to latest data from the National Economic and Development Authority (NEDA). The EU provided \$227.31 million in grants, interest-free, and accounted for about 2% of the total ODA funding in 2015.

According to the EU office in Manila, aid to the Philippines was raised to €325 million for 2015 to 2019, from €130 million for 2007 to 2014. Bulk of the current aid has gone to Muslim communities

in Mindanao where the EU has been active in funding peace- and development-re-

lated initiatives.

In a statement last April, EU Ambassador to the Philippines Franz Jessen said the EU is providing 80% of the multi-donor Mindanao Trust Fund for the socioeconomic recovery of conflict-hit communities in Mindanao.

"Over the past 11 years, the program has delivered more than 500 community sub-projects for over 650,000 people in 316 conflict-affected communities all over Mindanao, in an effort to demonstrate the benefits of reaping the dividends of peace," Jessen said.

2. The EU is the Philippines' 2nd top export destination.

The EU has been a major export destination of Philippine products.



In the 1st quarter of 2017, about \$901.24 million worth of products from the Philippines were received by the EU, according to data from the Philippine Statistics Authority (PSA). That's equivalent to about 15.5% of total exports and more than the \$577 million worth of goods shipped in the same period

in 2016.

Exports to the EU grew 48% in the 1st quarter of 2017, making the EU the biggest and fastest-growing export destination of Philippine goods. The EU overtook the longtime top export markets, the United States and Japan, in March.

These were generally the result of the Philippines enjoying the benefits of its EU GSP+ status (Special Incentive Arrangement for Sustainable Development and Good Governance). The GSP+ scheme is a preferential tariff scheme that allows the Philippines to export more than 6,000 products, including fruits, coconut oil, footwear, fish, and textile, to any EU member-country tariff-free.

The Philippines is the only ASEAN country and among 13 beneficiaries with a GSP+ status.

According to the European Commission, the Philippines' main exports to the EU include office and telecommunications equipment, machinery, and food products, as well as optical and photographic instruments.

The conditions for GSP+ include adherence to core international conventions on environmental protection, good governance, and human rights.

3. Europeans are the 3rd largest group of tourists in the Philippines.

Europeans are also the 3rd largest group of foreigners visiting the Philippines, next to the Americas and Asia. Cont. on page 7

MBUDSMAN HAS THE RIGHT TO SAY WHETHER MORALES CAN BE A STATE WITNESS OR NOT: Now, let's get this over with: transforming Janet Lim Napoles as a witness for the government in connection with the theft, stealing, and plunder if you may, of hundreds of billions of pesos as pork barrel of congressmen and senators, and even of President Benigno Aquino III, must be conformed to first by Ombudsman Conchita Carpio Morales because it becomes a reality.

Under the present system where criminal cases for graft and corruption or plunder involve a government official in the discharge of his or her official functions, it is the Ombudsman which has the exclusive right to investigate and prosecute them, and to determine who would be its witnesses to pin down the accused in those cases.

There is no other government agency which possesses this power granted to the Ombudsman---not even the Department of Justice, the Office of the Solicitor General, or any other government lawyer can exercise this right, power, and jurisdiction of the Ombudsman insofar as criminal cases involving government officials are concerned. At this point, however, Morales already said she will not allow Napoles to be a state witness.

OPTIONS FOR DUTERTE GOV'T ON NAPOLES: So, where does this leave the Duterte government which is obviously conducting negotiations with Napoles so she can become a witness who will finger other government officials who may have committed diversion of government funds in the nature of congressional or presidential pork barrel?

There are several options. The first, of course, is impeaching Morales. But this is a dead alternative now, considering the inability of those who want to impeach her, like the Volunteers Against Crime and Corruption (VACC), to convince even just a single congressman to endorse their impeachment complaint last Wednesday, May 17, 2017.

The second is to talk to her, and persuade her to resign now. Unfortunately, however, this is similarly a dead option, since it is highly unlikely that Morales will agree to resign, unless of course, someone, somewhere, makes her an offer she cannot refuse, in the nature of the offers usually made Cont. on page 6 by Mafiosi bosses during their heydays.

operation is the government's approach to curbing the proliferation of the age-old jueteng operations, the poor man's gambling game in the different parts of the country but law enforcers must be vigilant of the possibility that enterprising collection agents might take advantage of the situation to still collect bets not for STL but for jueteng.

While it is true that bet collectors are provided by the Pines State Gaming Corporation with uniforms and identification cards, Domogan underscored there is still a big chance for enterprising collectors to collect bets not for the STL draw but for jueteng that continues to persist in the different barangays.

According to him, he was not provided with the rules and regulations on how the STL operations will be done that is why he is still waiting for the PCSO or the operator to orient local officials on the operations of the enterprise and also answer questions raised by the public.

He admitted jueteng is considered a cat-and-mouse game between law enforcers, the bet collectors and the operator because there are still rampant jueteng bet collections in the city's barangays even with the government's pronouncement to curb the proliferation of illegal gambling around the city.

Under the previous administration, applicants for STL operations in a certain area must first secure the consent of the concerned local government through an approved resolution of the local legislative body but in the revised guidelines for the enhanced STL operations, the consent of local governments is no longer required provided that interested operators must comply with the provision of the multi-million bond, among others.

Domogan said that the local government will insist that the STL operator in the city must first secure the

Here Come the Uber, the Grab and the Uhop...

A fter the Mega Taxi, Vehicle-for-Hire (VFH), the P2P, the GT Service and the UV Express Service, now come the Uber, Grab and Uhop services, all inventions of the LTFRB intended allegedly to enhance transport mobility of the public.

These, notwithstanding the moratorium adopted and prescribed by the LTFRB upon recommendation of the City Council, owing to the traffic congestion already being felt building up in the city beginning 1995.

Supposedly, all CPC or franchise applications to operate public utility vehicles (PUVs) during moratorium should secure Route Measured Capacity (RMC) Certification from the DOTC Secretary and the consent or recommendation of the Local Government Unit (LGU) in our case, Baguio City through the City Council.

Unfortunately, these requirements were not observed both by the applicants and LTFRB personnel accepting CPC applications for years now since moratorium was declared in 1996, thereby resulting in the thousands of irregularly issued franchises in Baguio City and CAR.

Similarly now, since we cannot expect the LTFRB-CAR to refuse acceptance of Uber, Grab and Uhop applications, it goes without saying that again we will be flooded with irregularly issued CPCs which will add up to the thousands already issued despite the moratorium.

In fact there are indications that Uber, Grab and Uhop otherwise known as Transport Network Vehicle Services (TNVS) will be more worse than the previous modes of services issued with franchises notwithstanding the moratorium. For, even before these TNVS applications were filed, their units have been seen operating and plying their intended routes within Baguio City to any point in the Island of Luzon except Metro Manila. They in fact were already issued Provisional Authorities to operate upon filing of their applications good for forty five (45) days and expectedly, these Provisional Authorities will be renewed since the LTFRB has committed itself to admit TNVS as additional mode of service purportedly for the benefit of the public who allegedly need to be more mobile.

While some oppositions have been filed from existing other modes of transport service like the buses and the taxis, it is doubtful whether these oppositions will prosper since by all indications a bold lobby has been engaged in by the TNVS companies. This is obvious from the fact that the TNVS units are able to operate without having filed their applications. Never in the history of franchising beginning from the Public Service Commission (PSC), the Board of Transportation (BOT), through the Land Transportation Commission (LTC) and start of the LTFRB has this special treatment given to CPC applicants except now, for the sake of Uber, the Grab and the Uhop TNVS.

What is sweet smelling with the TNVS companies that their members can start operating without a franchise and are able to secure Provisional Authorities to operate even in the absence of initial hearing determinative of the requisite urgent need? Is it the alleged P170,000 paid out by a member to be included in the list of applicants. Maybe. Only the LTFRB and/ or the TNVS company concerned can probably answer the question!

SC MUST CLARIFY MORALES TENURE AS OMBUDSMAN: The third option is to simply wait until her supposed seven-year term is over in 2018, which is actually just a matter of months by now. In the meantime, however, it can happen that in the run-up to 2018, those who know they could be dragged to court after Morales steps down from office in 2018 would already be out of the country by that time.

There could actually be a fourth option, and it is the filing of a petition in the Supreme Court, to contest her continuing in office beyond 2012 (yes, 2012). It is like this: when Morales was appointed in 2011, her appointment was merely as a replacement of then Ombudsman Merceditas Gutierrez, who resigned from her position.

Because of this, Morales was to occupy the position of Ombudsman for only one year, or up to 2012 only, because by 2011, Gutierrez had already served six years of her seven-year term. Since Morales was appointed merely to replace Gutierrez, she, Morales, was only assuming the remaining year of Gutierrez' term, so that she should have stopped being Ombudsman in 2012. The Supreme Court can clarify this for all of us now!

two months of 2017, over 11% came from the EU.

Among the top 12 markets in January and February, European countries with the most substantial growth in visitor volume included France with 15,957 arrivals (+27.64%), Netherlands with 6,890 arrivals (+13.90%), Italy with 6,604 arrivals (+25.60%), and *Spain with 6,244 arrivals (+22.62%).*

Germany registered the highest per capita expenditure for February. On average, a visitor from Germany spent P60,260.45 while in the Philippines.

The number of tourist arrivals from Europe has been improving since 2014, after the EU agreed to remove Philippine carriers from its blacklist. This move followed a 2010 decision of the EU after it found that *the Civil Aviation Authority of the Philippines (CAAP)* failed to implement global safety standards. The EU ban had required travel agents to warn passengers against booking trips with Philippine carriers.

Student participation in observances, however must be regulated; the activities properly planned so as not be within two weeks of academic examinations.

In case of class cancellations due to holidays, natural and man-made calamities, make-up classes may be conducted as agreed upon by the school heads and parent-teacher associations, the order states.
