This is what Senate Majority Leader Alan Peter Cayetano said as he contradicted fellow vice presidential aspirant Senator Francis "Chiz" Escudero's recent statement that a federalism approach to government would not work well in the Philippine setup.

Reacting to Escudero's criticism over Davao City Mayor Rodrigo Duterte's call for a Federal form of government, Cayetano dubbed the latter's account as a "classic Manila-centric" attitude and remained firm that inclusive growth can only be achieved if power and resources are equally distributed among all the regions.

"It is clear that there are some people who just want to get votes and win but lack the passion and the vision to change the country. They offer the same solutions that have failed miserably in the past and will not go to great extents to create real changes that people want and need," Cayetano lamented.

This 'Manila first, other regions later policy' of Senator Escudero and his running mate, Senator Grace Poe, is actually the main cause for underdevelopment and the lack of jobs for our people in other parts of the country. It's apparent that their tandem only wants to limit economic growth and improvement in the National Capital Region," he added.

Cayetano further said Escudero's position on the matter is "understandable" because as the former chairperson of the Senate Committee on Finance, Escudero would naturally defend the national budget,

> The senator also took a jab at Escudero for questioning his motive in backing Duterte's call, stressing that he has been supporting the same agenda even before his tandem with the Davao mayor was formalized.

> "For the past two years, I have been pushing for the decongestion of Metro Manila by decentralizing government and promoting countryside development. This has been my call since the very beginning," Cayetano pointed out.

"The very essence of Federalism is to ensure that growth and prosperity are spread to every part of the Philippines, not just in Manila. It's a pity that Senators Poe and Escudero are against this. Cayetano blasts Poe-Escudero Mayor to POSD personnel: implement Mayor to strengthen anti-drug abuse bodies in barangays

BAGUIO CITY - Mayor Mauricio Domogan on Monday vowed to strengthen the Barangay Anti-Drug Abuse Councils (BADACs) to intensify the anti-drug abuse campaigns at grassroot level.

The mayor said that while the drug problem in the city is not as prevalent as in other areas, the city needs to exert more effort to eradicate the menace considering that it preys on the youth.

'The drug problem is continuing challenge to us because it affects our so we have to see to it that we eliminate this problem totally," the mayor said.

He said the barangays can contribute a lot to the campaign since they know their own constituents and environs and would be able to determine irregular activities including drug-related ones.

The BADACs were first formed in the city as part of the mandate of the City Anti-Drug Abuse Council (CADAC) which spearheads the implementation of anti-drug abuse program in the city.

CADAC was created as per Department of Interior and Local Government (DILG) Memorandum Circular No.

98-227 dated December 1998 mandating the creation of local anti-drug abuse councils from the provincial, city and barangay levels.

CADAC serves as the focal point to which various organizations and individuals work in the planning, implementation and evaluation of programs on drug abuse prevention. The body was also tasked to provide an effective mechanism for the coordination of services and programs for the campaign and to obtain funds, deploy volunteers and make use of facilities and technical expertise.

The CADAC program focuses on "addressing the local drug situation of the city and provide a sustainable institutional support to the implementation of the program consistent with the National Anti-Drug Abuse Program of Action as formulated from the Dangerous Drugs Act and other subsequent issuances of the Dangerous Drugs Board and other authorities.

At present, the CADAC is headed by the city mayor with Councilor Roberto Ortega as action officer./A Refuerzo

DENR regulates entry of tourists to 'La Presa'

A TRINIDAD, Benguet Environment and Natural Resources (DENR) had been installing checkpoints to prevent the hauling of construction materials and regulate the entry of visitors to sitio Pungayan, popularly known as 'La Presa' in Mount Kabuyao, Tuba, Benguet following an order from DENR Central Office.

Provincial Environment and Natural Resources Officer Julio Lopez disclosed in Provincial Peace and Order Council meeting that the establishment of checkpoints manned by a team of forest rangers was upon instructions of the DENR Central Office to protect the forest reservation which had been swarmed by tourists and enterprising businessmen after it has been popularized by a teleserye.

Lopez said this was enforced after the DENR filed a case against 13 individuals who built semi-permanent and permanent illegal structures in La Presa in violation of the Revised Forestry Code

or Presidential Decree 705

The DENR established a main checkpoint upon entering Sto. Tomas to track construction materials that may be transported and might be used for the illegal construction of structures within the La Presa area, according to Lopez.

Another checkpoint was installed upon entering La Presa in Mount Kabuyao to control the entry of visitors. Lopez clarified that they want to protect the forest reservation, and not to overload the carrying capacity of the site especially with the expected influx of tourist this coming holidays.

As defined by the World Tourism Organization, carrying capacity means, "the maximum number of people that may visit a tourist destination at the same time, without causing destruction of the physical, economic, socio-cultural environment and an unacceptable decrease in the quality of visitors' satisfaction".

BAGUIO OVAL GETS RUBBERIZED TRACK IN TIME FOR CARAA

PAGUIO CITY- Barring any unexpected rains in the next few weeks, Baguio City will be welcoming the delegates to the Cordillera Administrative Region Athletic Association (CARAA) with a brand new rubberized track on February.

Baguio Rep. Nicasio M. Aliping Jr. said that the Taiwanese consultants hired to undertake the job has started the work January 6 and that they have until February 5 to complete the task. The CARAA opens on February 6 with Baguio as

This is a project long in the waiting because the Athletic Bowl complex has not received any kind of development work for the last 30 years," Rep. Aliping said.

The three phase project has a total budgetary allocation of P115 million.

The first phase involved the modernization of the main bleachers of at the east end of the compound. The second phase was for the extension of the main bleachers as well as the concreting of the oval track. And the third involved the installation of the rubberized track.

The third phase was delayed for almost a month because of the unexpected rains in November.

"The concrete track needs to be totally dry in order for the adhesive to fully bond with the surface," explained Engr. Louie Gacad, project engineer of contractor RUA construction which is doing the entire project.

"It will probably take the Taiwanese consultants two weeks to finish the entire job and another two weeks for the rubber compound to fully cure and adhere to the surface," Gacad added.

"With the rubberized track." and lawned field together with the already existing Olympic size swimming pool, the city is now ready to host national events like the Palaro Games," Rep. Alipingsaid.

Aliping added that he is working for the allocation of another P50 million to fully complete the Athletic Bowl complex.

The fourth phase will mean the construction of a modern west end bleacher stands as well as for the lighting of the oval track./Carl C. Taawan

There is no set pattern for Dengue fever seen lately, Pangilinan said, unlike before that the change in weather predicts the decrease or increase in cases.

A four-year cycle pattern for Dengue was earlier observed.

The Cordillera region registered a 300% Dengue fever increase as there were 10,593 cases in 2015; from the 2,645 in 2014.

The provincial health offices reported the number of cases, as follows: in 2014 and 2015, respectively; Abra, 594 to 1,012, a 70% increase; Apayao, 282 to 1,080, up 283%; Baguio, 385 to 1,710, up 344%; Benguet, 545 to 2,045, up 275%; Ifugao, 213 to 772; a 262% increase; Kalinga, 352 to 2,434, up 591%; Mountain Province, 92 to 745, a 710% increase; and non-CAR, 182 to 795, up 377%.

There were 4 deaths in 2014; and 12 in 2015; 4 females and 8 males. Abra had one female and two male fatalities; Apayao with a male and female fatalities; Baguio City, a female and 2 male fatalities; Kalinga, 2 male fatalities; and non-CAR.

a year infant, up to 61 years and above, with more males affected. There was clustering of cases in different areas in the Cordillera region, it was reported.

Self-protection from mosquito bites, including wearing of long-sleeved shirts and long pants is recommended, Pangilinan added. Fogging in areas when warranted of outbreak; search and destroy; cleanliness campaigns in the community; proper disposal of garbage, reporting and immediate action on possible mosquito breeding places, is appropriate, she further said.

A suspected case would have symptoms of: at least two days fever with intense headache, body pain, nausea, vomiting, diarrhea, flushed skin and rash, with need to consult a physician. Signs of bleeding are considered an emergency case.

BAGUIO CITY - Regional and city health Victims are from less than authorities, police and fire officers collectively agreed to push for a total ban of use, sale and manufacture of firecrackers through a city ordinance in the wake of injuries caused by legally-bought pyros.

Self-imposed discipline and cooperation is also recommended.

These were discussed during the assessment Kapihan at the DOH regional training center last Thursday morning.

Department of Health (DOH-CAR) Officer-in-Charge (OIC) Dr. Amelita Pangilinan; Pangilinan rued that firecracker injuries occurred despite the scare tactics employed; graphics showing gory details of human body devastation due to minute or gigantic firecrackers.

Earlier campaigns against firecrackers showed how to properly use said pyros, with more injuries treated in the hospitals.

A comparative report yielded a regional count of fireworks and firecracker related injuries of 70 in 2014 and 61 in 2015. Reports in 2011, 2012 and 2013 showed 50 to 58 cases per year.

Provinces that registered a decrease in said incidents were Abra, from 29 in 2014 to 25 to 2015; Kalinga, from 1 case in 2014 to zero in 2015; and Mountain Province; 6 in 2014 and a single case in 2015.

No data is registered in

2014 for Ifugao, and a case in 2015; while Apayao had 14 cases in 2014 and 2015; assured vehicle owners Baguio City's 9 cases in 2014 upped to 11 in 2015. There was an increase from 6 cases in 2014 to 9 in 2015, in Benguet Province. Said cases were reported Dec. 21 2015 up to midnight of Jan. 5, 2016.

City Health Officer Rowena Galpo reported that aside from the 11 cases, there is a case from Itogon, Benguet and another from Urdaneta, Pangasinan. Monitoring was done in seven sentinel hospitals in

A signature campaign for a total firecracker ban is ongoing until January 28; it was known from Fire Officer Jesus Yango.

Baguio City Police Officer (BCPO) Deputy Director Laureano Alexis Marinas reported that there were no incidents of indiscriminate firing among soldiers and policemen including private gun-owners and security guards. This, Marinas said, is attributed to an active campaign; headed by City Mayor Mauricio Domogan. Gun muzzle taping was also

COA: Another institution Aquino damaged

The Commission on Audit had been, even through martial law, one of the most prestigious agencies of our Republic, its reputation untainted by graft or partisanship.

With just a few months remaining for this inglorious Administration, the COA will be left as another institution damaged by President Benigno Aquino 3rd, who has turned it into a political weapon.

Even in this rather late stage of the electoral game, this yellow regime is using the COA for its political ends, as in a report mysteriously leaked the other day alleging unliquidated funds of the Office of the Vice President. The next day, of course, as if on cue, was another accusation against Binay by former Makati vice mayor Renato Bondal – yes, the same accuser whose allegations have been proven false, yet hogged the headlines of the Philippine Daily Inquirer's front pages for 44 nearly consecutive days. latimes.net/inquirer-vs-binay/155669/) It's the familiar flurry of accusations for a vilification campaign.

I had been asked in the comments section of my column why I haven't written much about the allegations against Binay. My simple answer is: Why should I, when the Philippine Daily Inquirer, which claims to have the biggest circulation (Manila Times is just no. 4 among the broadsheets) seemed to have found as its newest cause this year the demonization of the Vice President? Why should I help it in its project, which could have been undertaken for not-so-noble reasons?

I am not only talking about its news sections. Columnist Solita Monsod, its most widely read columnist, must have written over 50 columns against Binay, with many of the occasional contributors trying to show off, unsuccessfully, their polemical skills to vilify the candidate. Fair play, I say, so I have presented the other side to the allegations, most of which, I think, had been indisputably debunked as pure lies. And these lies, the Ombudsman insists, should be investigated in the courts.

For example, both the Securities and Exchange Commission (SEC) and the Department of Environment and National Resources (DENR) records showed that the Batangas estate belonged to a Chinese-Filipino businessman, and not to Binay. The Makati Building II's costs were comparable in terms of price per square feet to Senate President Franklin Drilon's Iloilo Convention Center, or to the Bangko Sentral ng Pilipinas' (BSP) branches in three provinces, which all had the same contractor. Binay's "crime" is his inarticulateness or his campaign staff's inefficiency in debunking and burying the corruption allegations against him.

But back to the COA. It was astonishing that former chair Grace Pulido-Tan claimed, when she stepped down, at the pork-barrel investigations what her legacy was: the pork-barrel exposés. How on earth could she claim that, given the fact the probe had been ordered undertaken by her predecessor who was appointed by President Arroyo, and when most of those investigated under her administration, and charged, were opposition figures like senators Enrile, Estrada, and Revilla?

Pulido-Tan herself said two years ago that a special audit was also being undertaken to investigate the pork-barrel funds released during Aquino's Administration, from 2010-2012. The report had been completed and I myself viewed a TV report in 2013 by broadcast journalist, Anthony Taberna, about that investigation. A camera even panned a copy of

Two years after it was completed, COA hasn't released the report. And she has the gall to claim that she did her part in Aquino's anti-corruption crusade?

the actual report.

Is it because the COA itself received P143.7 million in 2012 from President Aquino's scandalous "Disbursement Acceleration Plan" (DAP), which the Supreme Court has ruled unconstitutional? Or was it because Pulido-Tan has been angling for a position in the Supreme Court when it announced a vacancy in 2012? (Aquino, instead, appointed Marvic Leonen, who is as inexperienced in legal practice as the Chief Justice is. Is Tan still hoping she will be the last Aquino appointee in April 2016, when Justice Martin Villarama retires?)

FRAUD INVALIDATES MARRIAGE: When a marriage is attended by fraud, it could be declared invalid by virtue of a court decision, according to Art. 45 of the Family Code of the Philippines. The question, however, is this: what is the "fraud" that can invalidate an otherwise valid marriage? Art. 46 of the same Code provides the instances where fraud can be said to be present.

Art. 46 says that any of the following circumstances shall constitute fraud referred to under Art. 45: (1) non-disclosure of a previous conviction by a final judgment of a crime involving moral turpitude; (2) concealment by the wife that, at the time of the marriage, she was already pregnant by another man.

Also, the following constitutes fraud: concealment of sexually-transmissible disease, regardless of its nature, existing at the time of the marriage; concealment of drug addiction, habitual alcoholism or homosexuality or lesbianism, existing at the time of the marriage. No misrepresentation or deceit as to character, health, rank, fortune or chastity shall constitute fraud.

"Congratulations and please pass the JOB WELL DONE to all. HAPPY NEW YEAR.", the President's text message to PNP Chief Director General Ricardo Marquez read.

Aquino, who celebrated New Year here in the City of Pines, stressed the effective law enforcement campaign of the PNP that resulted in the "all-time low" casualty record during the New Year.

In his text message to the Chief PNP, President Aquino cited the report of Health Secretary Janette Garin on New Year's Day that showed only 384 medical emergency cases recorded by DOH. Garin added in her report that DOH hospitals performed only nine amputations and noted zero cases of firecracker ingestion.

This was 57 percent lower than the five-year average and 54% lower than the recorded cases last year, according to

The Health Secretary attributed the steep reduction in firecracker-related injuries to effective law enforcement by the PNP against prohibited firecrackers.

The President earlier directed the PNP to strictly enforce the nationwide ban on illegal firecrackers and indiscriminate firing of guns during the holiday season.

In the Cordillera region, the DOH-CAR reported lower firecracker-related injuries with 49 this year compared to 70 cases last year. From Dec. 21 2015 to January 4, 2016, the DOH recorded 18 cases in Abra, 14 in Apayao, 9 in Baguio City, 6 in Benguet, and one each for Ifugao and Mountain

The DOH also reported no recorded death due to indiscriminate firing and no amputation and firecracker ingestion in the region./RMC- PIA CAR

DSWD assures support to families of SAF heroes

 $B^{\mbox{\scriptsize AGUIO}}$ CITY, Jan. 8(PIA) -- Almost a month $\,$ into the first anniversary of the $\,$ Mamasapano encounter in Maguindanao, the bereaved families of the Special Action Force (SAF) heroes from the Cordillera received livelihood assistance from the government.

Department of Social Welfare and Development Sec. Corazon "Dinky" Soliman said that the DSWD has released Php 1,694,536.90 worth of livelihood assistance to the families of the 13 Cordilleran SAF members who were killed in the Mamasapano incident on January 25, 2015.

"Nagbigay napo kami ng livelihood assistance program sa 13 families ng SAF from Cordillera ayon sa kanilang na identify na proyekto," said Soliman who was the guest of honor during the Regional Multi-Stakeholders' Conference on Community Driven Development last December 28 at the Pines View Hotel here.

The financial assistance is from the Sustainable Livelihood Program of the DSWD, she said, adding that DSWD continues to help and support in any way the bereaved families of the Cordillera SAF members.

The family members including some parents of the slain SAF, received the first tranche of the livelihood assistance corresponding to 70% of the proposed project cost. The remaining 30% of the proposed funding assistance will be provided upon the full utilization of the release.

DSWD-Cordilleras OIC- Regional Director Janet Armas added the livelihood assistance is still part of the interventions being given to the families of the SAF heroes to help them recover.

The DSWD has provided earlier last year financial assistance and psychosocial interventions to all the families of the SAF in the Cordillera.

Meanwhile, Police Regional Office - Cordillera Acting Regional Director PCSupt. Ulysses Abellera said that the PNP also has been continuously helping the bereaved families of the Cordillera SAF members.

and Tapaz towns in Capiz.

As in his previous homecomings, Chees, upon arrival at the Manila Airport, called on his aging teacher, Shihan Kunio Sasaki, the missionary master who, in the 1960s established the Japan Karate Association branches in Manila and here in Baguio.

"Without Master Sasaki, I and many other Filipino practitioners of Shotokan karate would not be where they are now," the student noted.

Chees spent three years as assistant to Sasaki in the latter's gym in Manila, an experience that prepared the Igorot student for his exposure in international competitions.

Chees eventually migrated to Germany where he was recruited as a member of the German national karate

team. His stint with the squad proved fruitful as he kept on winning the kata event in international competitions.

This string of victories in the international martial arts scene was capped by his topping the kata event in the 1993 World Shotokan Championships in Germany.

"For that tournament, I would spend winter days in the forest perfecting the basic movements Master Sasaki taught and I was only too glad it paid off with that victory for the German national team which adopted me," he recalled.

"Wherever I am now, I owe it to Master Sasaki and to Master Edgar Kapawen Sr.," he said, referring to his mentor and fellow Bontoc who heads the Northern Luzon headquarters of the IKA./Ramon Dacawi.

He added that the National Headquarters has also opened a trust fund for donations from the police officers and from other individuals who want to help in any way the families of the fallen SAF heroes.

 $B^{\text{AGUIO CITY, Jan. 8(PIA)}}_{\text{of the Philippines (NGCP) appeals to the public to help in safe-}$ guarding transmission facilities following the bombing of several transmission towers in Mindanao recently.

NGCP North Luzon Corporate Communication and Public Affairs Officer Lilibeth Gaydowen called on the public to report any suspicious activities at NGCP transmission lines and to help safeguard and secure transmission facilities to ensure safe and continuous power transmission service.

At least 16 towers of the NGCP - six of them last December-were bombed by lawless elements causing power interruptions in Mindanao.

"Nakakalungkot dahil ang epekto ay nagkakaroon ng deficiency on power generation in Mindanao," said Gaydowen.

The bombing of a tower last Christmas Eve caused two generation facilities, the government's National Power Corporation -owned Agus 1 and 2 to be cut off from the Mindanao grid. As a result, as much as 150 MW of power was isolated from Mindanao consumers. Failure to restore the tower will further aggravate the supply deficiency in the region and longer rotational power interruptions may be expected.

NGCP warns that further bombing incident in any area in the country may prevent customers from enjoying uninterrupted elec-

Although there were no recorded threats or bombing incidents affecting NGCP transmission lines in North Luzon, Gaydowen said that they are still on heightened alert following the bombing of one of the towers of the Lepanto Consolidated Mining Corporation in Mankayan, Benguet in December.

Gaydowen said that they have coordinated with the Philippine National Police and the Armed Forces of the Philippines to help in securing the different transmission facilities of the NGCP particularly in the Cordillera region where several vital installations are located./JDP/ RMC- PIA CAR

It had also been a tradition for the other two members of the commission to be appointed among the COA's veteran auditors, especially for those who spent their entire professional career in the agency.

Contrast that to Aquino's appointees to the COA:

- A nearly retired Heidi Mendoza who had vowed to pin down Binay on corruption charges many years ago, jumping several pay levels – was appointed as one of the three COA commissioners. It was Mendoza who provided Ombudsman Conchita Carpio-Morales, when she testified in Chief Justice Renato Corona's impeachment trial, with grossly false analysis that artificially bloated his bank accounts. For that monumental fabrication that whipped up a mob against the Chief Justice, she, together with Carpio-Morales, should have resigned their posts.
- Jose A. Fabia was appointed a COA member in 2014. Who is he? The Director-General of the Philippine Information Agency since Aquino assumed office, up until 2012, when he reached the government's retirement age. He replaced a former Liberal Party Cadiz City mayor Rowena Guanzon, who served only a year, since she was given what Aquino thinks is a more important task, as Commission on Elections member. DA assures El Nino mitigation fund $B_{8\ (PIA)}^{AGUIO\ CITY,\ Jan.}$

forecast of what the El Niño can bring to farmers and livestock growers, the Department of Agriculture assures that mitigation plan and funds are set in the regions.

DA Cordillera Regional Director Dr. Lorenzo Caranguian, in an interview over DZEQ Radyo ng Bayan, disclosed that with the impact of El Niño expected to be felt this first or second quarter of 2016, the agriculture department already made estimates and forecast of damage as well as mitigation plans.

Caranguian shared that DA's estimate based from the projection of municipal and provincial agriculture offices nationwide, will affect around 23,640 hectares of rice, corn and high value crops planting areas which will result to production loss of around 31,354 metric tons of rice corn and high value crops.

For Cordillera, he shared that the region is far better than the other areas in the country as the tail end of the cold front and past typhoons have brought colder weather and rains in the region which is beneficial to the agriculture sector. The mitigation projects he

UK newspaper: "PHL new breeding ground for ISIS jihadis"

Three weeks ago, I wrote a column entitled, "ISIS' rise and terror should tell us to junk and bury BBL now."

There I pointed out that the two Islamic armed organizations differ in their approach. The Moro Islamic Liberation Front's (MILF) strategy is the Maoist style of raising a conventional guerilla army that would demand from the central government the right for Muslims in the Philippines to form their own independent state.

The Islamic State for Iraq and Syria (ISIS) is also using that strategy, but on a grander and faster scale, using the billions of dollars it receives as financial support from its Saudi Arabian sympathizers and revenues from the oil wells it has seized and taken over.

The MILF's difference from the ISIS, though, is that the Middle East jihadist organization openly espouses, finances and undertakes horrible terrorist attacks that kill mostly civilians, as in their recent carnage in Paris and California, and mass beheadings of people outside of their faith. At least the MILF claims that's not the way it operates.

Both, though, have the same goal – the establishment of an Islamic state. That of ISIS is the medieval grand vision of a global caliphate. That of the MILF, is a Bangsamoro (which translates to Moro Nation) at the heart of Mindanao, disguised at this stage as merely an autonomous entity with an "asymmetric" relationship with the Philippine nation state.

What President Aquino and his bleeding-heart negotiators refuse to see in their obsession for the Nobel Peace Prize is that to set up an Islamic state isn't just a fervent dream for Muslims. It is an injunction for every Muslim to contribute to the establishment of such an Islamic state.

That is the reason why there is no autonomous entity anywhere in the world under Muslim leadership. For an independent state to allow the creation of such a Muslim-dominated area would mean its political dismemberment: the Muslim rulers in such an entity would use their territory to strengthen their army for their eventual secession. We would have been the only suckers in the world to have fallen for such lies by the MILF.

What I did not expect when I wrote that article was that the ISIS was not just in touch with the MILF to recruit potential jihadists. They have also been directly going to the Muslim masses to attract jihadists for training to fight both in Mindanao and in the Middle East.

The London-based Daily Mail the other day had a major feature on ISIS' operations in the Philippines, with several accompanying photos, as well as embedded videos. The article's title: ISIS unveil the Philippines as their new breeding ground for jihadis with their latest propaganda video featuring a secret Filipino jungle training camp.

The text of the article is, however, short as it is mainly a

video-based report:

The Philippines has become the latest ISIS target for expansion after the jihadi group released its first propaganda video of a terror training camp in the Filipino jungle.

"Several jihadi commanders are shown urging Filipinos to travel to Syria to join ISIS before revealing the group have already started their own terror camp in the Philippines.

The footage shows the 'soldiers of the Caliphate in the Philippines' working on their fitness and agility by completing a series of assault course drills.

A small group of recruits, each wearing similar black clothing and masks, are shown climbing up rope ladders, crawling under barbed wire and practicing with weapons.

The Filipino government has long said that support for ISIS in the Philippines was limited to local bandits claiming allegiance to the group.

However, the latest propaganda video suggests that the jihadi group has earmarked the Philippines as a potential site for establishing further new bases.

The new video comes after eight members of a criminal gang that pledged allegiance to ISIS were killed in a firefight with the military in the southern Philippines last month.

The hour-long battle took place in Palimbang, a remote town in the south – home to the predominantly Catholic nation's Muslim minority and the scene of decades of conflict.

The bandits were from Ansar al-Khalifa, a small group that declared its support for ISIS in a video circulated on the Internet last year, regional military spokesman Major Filemon Tan said.

The larger Abu Sayyaf group has also pledged its allegiance to ISIS and is holding at least four foreign nationals hostages.

The group is demanding millions of dollars in ransom for their safe release and have released several videos threatening them with execution.

Tan told AFP that five black flags similar to those used by Islamic State fighters were recovered from the bandits after the clash.

Criminal gangs operate kidnap for ransom and extortion activities alongside Muslim and communist separatist campaigns in the restive south.

While the relatively new Ansar al-Khalifa had extorted from businessmen and stolen cattle from farmers, it had no proven links with Islamic State – also known by the acronym ISIS – national military spokesman Colonel Restituto Padilla caid

'This group is trying to ride on the popularity of the ISIS, but they're not really ISIS,' he told AFP. 'We view them as mere criminal gangs.'

Tan said the military was verifying intelligence reports that one of the eight killed was an Indonesian national."

Sen. Francis "Chiz" Escudero said the position of the Office of the Solicitor General (OSG) recognizing Sen. Grace Poe as a natural-born Filipino citizen only bolsters the Commission of Elections' (COMELEC) wrong and unfair decision against his presidential running mate.

According to Escudero, the OSG's comment submitted to the Supreme Court runs contrary to the decision of the COMELEC to cancel Poe's certificate of candidacy for president on grounds of citizenship and residency.

In a 27-page comment filed with the high court in connection with the petition filed by defeated senatorial candidate Rizalito David challenging the decision of the Senate Electoral Tribunal (SET) which ruled that Poe is qualified to hold public office, the OSG maintained that the senator is a natural-born Filipino.

"The Solicitor General, the statutorily appointed lawyer of the Philippine government, and 10 other solicitors are of the firm belief that Sen. Grace Poe is a natural-born Filipino. This is vindication for the majority of the SET, who were criticized by some sectors for deciding supposedly based on political and emotional considerations," said Escudero, the frontrunner in various pre-election surveys for vice president.

"No less than the OSG recognizes that the Constitution and its framers never wanted to discriminate against foundlings and that foundlings were always meant to be natural-born Filipinos—which is what Sen. Grace has been saying all along," he added.

The OSG, led by Solicitor General Florin Hilbay, has also told the high tribunal that it will not file a comment on behalf of the COMELEC, citing its position in the SET case.

Escudero said he is confident that the magistrates will see the logic and legal arguments of the OSG when they convene to tackle Poe's petition seeking to reverse the rulings of the COMELEC to disqualify her from the presidential race.

"From the beginning, the poll body did not hide its bias against Sen. Grace. The COMELEC acted unfairly on her filings and dismissed the voluminous documentary evidence she submitted that would prove her accusers wrong," the veteran senator said.

He added: "I believe that even our own government lawyers would find it difficult to defend the COMELEC."/Office of Senator Chiz Escudero

Most Cordillera DOST brings early warning shelter plan

m AGUIO}$ CITY, Jan.7 (PIA) - - Majority of the municipalities in the Cordillera Administrative Region (CAR) have completed their Local Shelter Plan (LSP), a roadmap to address local government housing requirement.

The Housing and Urban Development Coordinating Council (HUDCC) extended assistance in the completion of 65 LSPs of the 77 municipalities in CAR for 2016-2024, according to HUDCC Director for Regions 1, 2 and CAR Michellene Inay during a recent meeting of the Regional Development Council -Sectoral Committee on Social Development (RDC-RSDC).

The LSP lays down a comprehensive perspective of housing situation and allows convergence among concerned government institutions and other interested organizations to work together in providing shelter for those

Inay said through workshops and writeshops, target setting of housing requirement is more or less realistic as it identifies those who are really in need, where are they located, what are their sources of income, and those who cannot afford to build one.

LGUs are encouraged to prioritize families located in danger areas such as top of the hill, landslide areas, along river banks, creeks and other critical locations, said Inav.

With the advent of the Climate Change Adaptation and Disaster Risk Reduction Programs, recent issuances called for the mainstreaming of both to ensure that identification of housing sites are hazard free and safe, she added.

The formulation of LSP is anchored on Local Government Code of 1991, Republic Act 7279 otherwise known as Urban Development and Housing Act and the Philippine Development Plan.

The value added of a established shelter plan according to Inay allows the convergence of resources which in a way will aid LGUs to undertake their housing projects with the Department of Social Welfare and Development (DSWD) thru their core shelter program, Department of Public Works and Highways (DPWH) on road access, Department of Health (DOH) on sanitary facilities such as water sources and sanitary toilets among others.

Meanwhile, RDC Private Sector Representative Marietta Paragas who recently attended the National Social Development Committee Consultative Meeting in Iloilo shared updates on government housing project under the National Urban and Development Framework.

Nationally, there is lack of alienable and disposable (A & D) lands for government housing project. Of the 767,108 hectares delineated where some were already used for other purposes, only 275,679 hectares are A&D.

For the Cordillera region, the Department of Environment and Natural Resources-CAR proposed for 119,000 hectares for A & D reclassification but the National Delineation Assessment Committee only approved 24,000 hectares incorporated in the proposed Omnibus Bill filed in Congress, according to Paragas./JDP/SCA-PIA CAR, Benguet

ment of Science and Technology is bringing in the Early Warning System(EWS) Information, Education and Communication(IEC) forums in the different Cordillera provinces.

The project aims to capacitate local government units (LGUs) for them to mainstream science-based tools towards efficient and effective disaster risk reduction and management, in line with the goal of achieving a science-based Weather Information and Climate Change Scenarios for a disaster resilient Philippines.

The IEC forum started in Bontoc, Mountain Province last December 1, in Kiangan, Ifugao last Dec. 3; Bangued, Abra on Dec. 10 and Tabuk City, Kalinga on Dec. 15. To complete the EWS Cordillera road show, the same forum is set in the province of Apayao and Benguet this month.

DOST Science Research Analyst Hansi Dinumla shared that the fora were attended by provincial and municipal disaster risk reduction and management officers who were introduced to the basic concept of early warning systems and the DOST EWS initiatives and projects as well as on the visualization of tools and websites for hydromet sensors and EWS.

Forum participants were also engaged in an open forum and 'Way Forward Planning on the Implementation of Plans for Disaster Prevention and Mitigation' in the provincial and municipal levels especially on the establishment of community-based EWS utilizing available DOST projects.

The forum specifically aims to train DRRM officers of all the municipal LGUs and provincial LGUs of CAR on science-based tools as results of DOST-funded researches and art the same time to recommend activities and initiatives relative to the training to be integrated in their respective local DRRM plans, Dinumla said.

Kalinga farmers to get P13M El Nino mitigation aid

TABUK CITY, Kalinga, Jan. 5 (PIA) - -Farmers in the province are set to receive P13 million funding aid from the national government to recover from losses caused by the long dry.

Provincial Agriculturist Domingo Bakilan disclosed the financial assistance is under the El Nino Mitigation Program of the Department of Agriculture (DA) intended to help the country's agriculture sector cope with the brunt of extreme climatic change.

Bakilan informed the aid will reach the farmers in the next cropping in June following procurement procedures required, since the assistance is given in the form of farm imple-

The P13M shall be downloaded to the provincial government for the procurement of certified rice, corn and vegetable seeds, mechanized water pump sets and livestock.

According to Bakilan, the aid will be distributed to partner farmers associations duly registered with DA through the Office of the Provincial Agriculturist.

TB detection machine now

A TRINIDAD, Benguet, Jan. 8(PIA) - -La TRINIDAD, Deligues, June 2. Xpert machine for the rapid detection and identification of drug resistant tuberculosis

Lodged at the Integrated Provincial Health Office (IPHO) here, the equipment is part of the National Tuberculosis Program (NTP) which aims to eliminate TB cases in the Philippines by 2020.

We have low cases of TB in our province compared to other provinces in the Cordillera region but it doesn't assure us that there are only few people suffering from the disease," said Governor Nestor B. Fongwan during the launching and turn -over of the Benguet NTP Laboratory at the Provincial Health Office

'Through the Gene Xpert machine donated by the Philippine Business for Social Progress (PBSP) through the Department of Health -CAR, we can now give quality test to people suspected of the disease, said Fongwan. Case detection with the use of the Xpert machine can be availed free of charge.

According to the World Health Organization, TB is still one of the world's top health challenges with new TB cases and deaths of nearly 1.5M people each year. In the Philippines, TB is still one of the most fatal treatable diseases.

The recent Philippine Institute for Development Studies shows that 712 Filipinos acquire TB every day but only 632 get their treatments.

In Benguet, there was low detection rate of the disease from 2009 to 2014 but with high success rate or those cured and have completed treatment, according to Provincial TB Nurse Coordinator Purita Maguen.

There were 86 cases diagnosed in 2009, 67 in 2010, 87 in 2011, 66 in 2012, and 42 in 2014. Treatment of cases for the period ranged from a low of 81 percent in 2014 to a high of 96.7 percent in 2012.

TB is not included in the Top 10 causes of death and morbidity in the province but it doesn't mean that Benguet is free of such disease. This can be attributed to the fact that most people don't have their check-ups if they have cough and also for the reason that TB is difficult to detect," Dr. Nora Ruiz, Provincial Health Officer, explained.

But with the Gene Xpert Machine, TB can be easily diagnosed. According to Dr. Allan Fabella, PBSP Medical Specialist, the machine can detect Mycobacterium tuberculosis complex and resistant to Rifampicin in less than two hours in comparison to the standard culture which can take two to six weeks for the result.

The information generated using the equipment also aids in selecting suitable treatment especially those that are resistant to antibiotics. The machine also requires minimal technical training in running the

Six patients positive with TB were already detected utilizing the machine, according to reports of the IPHO./JDP/SCA-PIA-CAR, Benguet with reports from Sandy Calado, Benguet Provincial Government

The assistance is timely to most farmers here who are reeling from a missed cropping due to the long water cut-off because of the major rehabilitation project on the Upper Chico River Irrigation System.
