DOTR, LTFRB told to respect moratorium

BAGUIO CITY – The City Council requested the Office of the President, through the Department of Transportation and Railways (DOTR) and the Land Transportation Franchising Regulatory Board (LTFRB), to stop issuing certificates of public convenience (CPCs) covering routes in the city under the transportation network vehicle service (TNVS) except when issued exemption by the local government through an approved resolution.

The resolution authored by Councilors Benny Bomogao, Faustino Olowan and Michael Lawana noted that there were several CPCs that were issued by the LTFRB covering UHOP and TNVS that resulted to the sudden increase in vehicles using the said type of transport services in the city.

The local legislative body underscored the fact that there is a need for the DOTR and LTFRB to respect the existing moratorium on the **Cont. on page 6**

No extension in BIBAK Mayor formed CHARcT demolition deadline

BAGUIO CITY – Mayor Mauricio G. Domogan said the local government is not inclined to grant another extension on the June 30, 2017 deadline for the voluntary demolition of the illegal structures constructed by informal settlers within the 5,000-square meter Benguet-Ifugao-Bontoc-Apayao-Kalinga (BIBAK) lot along Harrison Road because it was the group that committed to voluntary remove their structures on or before the prescribed deadline.

The local chief executive said city officials do not want to lose their credibility by granting another extension on the self-imposed deadline for the voluntary demolition of the illegal structures within the property so the decision for removal of the illegal structures on the prescribed deadline remains.

He claimed he has no personal knowledge on the alleged endorsement made by former Rep. Nicasio M. Aliping, Jr. addressed to the central office of the Department of Environment and Natural Resources

(DENR) for a local businessman to develop the property, saying that such plan is not within the powers of the lawmaker.

Domogan explained that once the illegal structures are removed from the property, the agreed plan among the local chief executive and officials of the National Commission on Indigenous Peoples (NCIP) and the DENR is to fence the property and subsequently work out a comprehensive master development plan.

Earlier, the informal settlers signed a notarized commitment assuring city officials that they will voluntarily demolish their illegal structures on the lot on or before June 30, 2017, and that the local government will demolish the remaining structures after the committed deadline.

He added officials of the Presidential Commission on the Urban Poor (PCUP) have been in close coordination with city officials and municipal officials of La Trinidad for the conversion of the identified relocation site for the informal settlers from agricultural to residential

to allow for the preparation of the development and subdivision plans.

Further, he received a formal communication from the Housing Land Use Regulatory Board (HLURB) that the La Trinidad municipal government is empowered to approve the development and subdivision plans of the identified relocation site for the qualified informal settlers.

Domogan urged the informal settlers to comply with their signed and notarized commitment that they will voluntarily remove their illegal structures on or before their committed deadline so they relocate to the relocation site in La Trinidad.

The NCIP has been tasked by the Office of the President as the caretaker of the BIBAK property that is planned to house a dormitory for qualified Cordillerans.

Domogan asserted the BIBAK lot should serve the purpose for which it was apportioned by the DENR from Original Certificate of Title No. 1 that covers most portions of the area and its vicinity.

CBAO uses on-line system for speedier delivery of service

BAGUIO CITY – The City Buildings and Architects Office (CBAO) is currently in the trial stage of an “electronic-on-line system” for permit applications that

will allow its clients to track the status of their applications at home or wherever there is an internet connection.

CBAO chief Nazita Banez said the system is

initiated and supported by the Management Information System under the City Budget Office headed by Leticia Clemente and is in consonance with the Anti-Red

Tape Act or ARTA law.

“There will be speedier delivery of service and minimal or no employee-client contact. Transparency will be established since fees to

BAGUIO CITY - Mayor Mauricio Domogan recently created a Human Rights Action Team (CHRAcT) and at the same time establishing a Human Rights Action Center (HRAC) in the city of Baguio through Administrative Order 064.

It is recalled that the Department of Interior and Local Government and the Commission on Human Rights issued DILG-CHR joint memorandum circular no. 1; mainstreaming human rights through rule of law and access to justice at the level of provinces, cities, municipalities and barangays, mandating all LGUs to create their HRACts and establish HRACs.

Domogan stressed that the creation of the CHRAcT ensures that the LGU's offices will operate in a human rights-based local services delivery and

governance.

Moreover, the City Human Rights Action Center will be stationed at the office of the city legal officer, city hall where all human rights matters including human rights promotion and complaints of human rights violations will be acted upon.

The CHRAcT will be chaired by the city administrator and co-chaired by the city legal.

The members include the city social welfare and development officer, city planning and development coordinator, city health officer, city information officer, PNP human rights affair officer, school city superintendent, BHRAO association president and at least one representative from the civil society organizations/non-government organization/people's organizations that advocate human

rights.

The team will develop and implement the human rights plan of the LGU; propose to the sanggunian the integration of human rights programs, projects and activities in the annual budget appropriation; recommend appropriate legislation to the Human Rights Committee of the sanggunian; utilize available resource for human rights promotion activities at their respective LGU levels' spearhead and coordinate the implementation of human rights programs, projects and activities; serve as hubs for access to Justice Network; posting of human rights programs, projects and activities at websites, bulletin boards and newsletters; provide legal and/or paralegal assistance to victim of human rights violations; encourage par-

Underground system for TELECOM and electric power lines on the way

BAGUIO CITY - With the city's plan to convert the existing overhead lines to underground lines in the central business district area, mayor Mauricio Domogan recently formed a technical working group (TWG) to conduct a feasibility study in coming up with an underground system for telecommunication and electric power lines.

Domogan directed the city engineering office to chair the said TWG and sangguniang panlungsod committee on public utilities, transportation and traffic legislation

chair as the co-chairperson.

Members are representatives from the City Buildings and Architecture Office, City Administrator's Office, Department of Public Works and Highways- BCDEO, City Planning and Development Office, Globe Telecom, Smart Communications, Inc., Philippine Long Distance Telephone Company and Baguio Electric Cooperative.

It is recalled that in order to address the top-sy-turvy wiring and cable networks of public utility companies that create eyesores and poses threat

to public safety challenges, councilor Leandro Yangot, Jr. proposed an ordinance requiring all public utility companies utilizing wires and cables to install underground lines and obliging them to convert overhead lines in the CBD into underground lines.

Public utility and cable companies previously are amenable and are in support to the city's plan not only to eliminate eyesores in the city but also to prevent any threat to public safety most especially during the onslaught of natural calamities. */Jho Arranz*

be paid will be reflected on-line, therefore, eliminating corruption,” Banez stressed.

Banez revealed that if CBAO is provided with the needed computer resources, the office intends to fully establish the system by the end of this year.

“At present, simple permit applications like

occupancy, fencing, electrical, excavation and demolition permits can be processed in a maximum of five days while complex permits are processed in a maximum of fifteen days,” Banez said.

Banez explained, however, that these permit applications must be complete in form and complying with the

National Building Code and its referral codes including the City Land Use Plan and Environmental Code.

Her office has also prepared a checklist for easier guide to private architects and engineers preparing building plans and what documents or requirements to submit. */Gaby Keith*

Anti-squatting drive boosted with passage of env't code

BAGUIO CITY – The newly approved Environment Code of Baguio City has given the city government “more teeth” to intensify its anti-squatting campaign.

City building and architecture office (CBAO) head Nazita Banez said the code contains specific

provisions that mandate concerned offices to demolish on-going constructions on road rights-of-way, parks, forest and water reservations and other protected areas.

It also tasked the city environment and parks management office (CEPMO) “to primarily

lead the collective actions of various agencies including the CBAO, Dept. of Environmental and Natural Resources, Dept. of Public Works and Highways, city engineering office, barangays and the city legal office to file cases against the illegal settlers and to impose the

penal provision of fine or imprisonment.”

In her report before city officials and employees led by Mayor Mauricio Domogan and Vice Mayor Edison Bilog last Monday, Banez said that for this semester, the investigation section of the CBAO has received 290 complaints

on squatting activities.

As per CBAO's procedure, the complaints are subjected to investigations with the results forwarded to the anti-illegal squatting committee for deliberation.

“Demolitions are scheduled on a first-in-first-out basis with the

occupants given 30 days to voluntarily demolish and vacate the area or the city demolition team will destroy the structure and even confiscate the materials to be used for government projects,” Banez said.

JHMC urged to submit list of businesses

BAGUIO CITY – Mayor Mauricio G. Domogan lauded incumbent officials of the John Hay Management Corporation (JHMC), the subsidiary of the State-owned Bases Conversion and Development Authority (BCDA), for granting his request to submit the list of companies doing business within the 247-hectare John Hay Special Economic Zone (JHSEZ) for the local government to have a reference in monitoring those that do not comply with existing business rules and regulations in the city.

The local chief executive explained JHMC president and chief executive officer Allan Garcia agreed to his contention that businesses operating inside the JHSEZ that are not registered with the Philippine Economic Zone Authority (PEZA) should secure their business permits from the city which is empowered by law to grant business permits to establishments and companies that are actually involved in business activities.

For PEZA-registered businesses, the companies reportedly enjoy tax holidays and that they are only mandated to pay to the government a total of 5 percent of their annual gross receipts whereby 2 percent will be directly remitted to the host local government.

Personnel from the City Permits and Licensing Division previously attempted to inspect business establishments within the former American rest and recreation center to compel them to secure business permits from the city but JHMC officials refused to allow them to enter the zone.

“We are elated that we have JHMC officials who know how to work with local officials to ensure the smooth conduct of business operations inside the economic zone. We are optimistic that we will be able to harmoniously work together in ensuring improved economic activities inside the zone and the city as well,” Domogan stressed.

He emphasized it would be unfair to the city if businesses operating inside the zone will not secure their permits from the local government because in cases of the problems on peace and order inside the zone, it is the nearest police station that responds.

According to him, the local government is just waiting for this list to be submitted by the JHMC management to allow personnel from the City Permits and Licensing Division to inspect the business operations for their compliance with existing rules and regulations.

Duterte to end martial law when Mindanao 'stable'

MANILA, Philippines (UPDATED) – President Rodrigo Duterte claims he'll be the first to call for an end to martial law once Mindanao is "stable."

"The earlier we attain the equanimity of the community, the stability, I'd be the first to clamor for the lifting of martial law," said Duterte on Thursday, June 1, during the oath-taking of government appointees in Malacañang.

He said the rising death toll of soldiers and police under his administration is pushing him to "hurry up" the war.

"I lose about 3, 4 [security personnel]. It keeps on increasing every day for as long as that war rages on. I am one of those who are really hurrying it up," he said.

Duterte did not specify his definition of a "stable" Mindanao but he reiterated his faith in the military and police to make the proper recommendations based on the situation on the ground.

"Ask the military or police, 'Are we okay, because if we are, let's lift it immediately,'" said the President.

But he warned he may seek the extension of the current 60-day martial law declaration if the military tells him more time is needed to stabilize Mindanao.

"But for as long as the military says, 'Sir, hindi pa talaga kaya' (Sir, we still cannot do it), and it's beyond 60 days, Congress must understand that I may need more time," said the President.

He blasted critics who say he did not consult the military before deciding to declare martial law on May 23. Senators earlier said Defense Secretary Delfin Lorenzana told them that he believed the Marawi crisis could be resolved without martial law.

"You can hardly talk to the fools... You do not declare martial law without asking the soldiers and the policemen," said Duterte on Thursday.

The President previously said he would lift martial law only if the military and police recommend that he do so. He said he would not listen to others.

Critics took this as a warning that the President intends to ignore the Supreme Court and Congress. The 1987 Constitution requires Congress' approval for any extension of martial law.

On Wednesday, May 31, Duterte modified his earlier statement that he might expand martial law coverage to include the Visayas and Luzon. He said he is considering suspending the privilege of the writ of habeas corpus in the Visayas, not put it under martial law.

Duterte made no specific mention of the military air strike which accidentally killed 11 soldiers on Wednesday, but expressed regret for the death of security personnel in general due to the clashes.

"I have many dead, I am very sad. I have many dead soldiers, I have many dead police," he said. /Rappler.com

city through the CEPMO should also focus on establishing a system on the prevention of the squatting activities in critical areas and the filing of charges against those responsible using the provisions of the environment code.

Banez said the code's provisions focusing on critical or high-risk areas and the protection and management of special lands should also be strictly implemented in line with the city's disaster risk management thrust.

"During calamities and rainy or typhoon season, it is the illegal settlers that are affected the most since their structures are built on critical slopes without any compliance to the National Building Code, National Structural Code of the Philippines and these structures are not permitted," Banez said.

The code specifies that the city will not allow constructions on critical slopes without conducting soil tests and introducing appropriate engineering interventions.

Approved last year, the code serves as a blueprint to maintain the city as an eco-cultural tourist destination with emphasis on the protection and management of lands particularly the protected areas covering national parks, natural monuments, parks, protected landscapes, resource reserves, strict nature reserves and wildlife sanctuaries. /Aileen P. Pursuant to Memorandum Circular No. 2015-017, Provisional Authorities or PAs to operate Transport Network Vehicle Service (TNVS) were issued to applicant members of Uhop Company by DOTr-CAR Regional Director Atty. Jose Eduardo Natividad. The said Provisional Authorities authorize the grantee to operate TNVS Service and to carry passengers on the route: Baguio City to any point of Luzon and Vice Versa, pending approval of their filed CPC applications.

Supposedly, these Provisional Authorities have a life of only forty five (45) days after which they should already be operating on the basis of Certificates of Public Convenience issued to them by the LTFRB en banc in Quezon City, since these applications are of inter-regional character of which DOTr-CAR has no jurisdiction to grant.

Question is, why are these Uhop units still operating even when their respective Provisional Authorities have expired after the lapse of 45 days? Since these PAs were no longer renewed by the DOTr-CAR, isn't it the duty of the law enforcing unit of LTO which we call the "Flying Squad" to apprehend and impound these units as required under Joint Administrative Order No. 2014-01 which put a price of P200,000 per unit of van as penalty for operating without a franchise or as colorum.

Because DOTr-CAR is not doing anything to address this violation of the rules, is this is not a confirmation that DOTr-CAR has truly been taken, similarly as when they were taken when it allowed these vans to operate even without having filed any application to operate as TNVS Service or have not been issued Provisional Authorities? We understand that each Uhop member was assessed and required to pay P170,000 each for them to be included in the list of Uhop applicants to be issued immediately with PA upon filing of CPC application.

No matter in what angle one would look at it, there could be no other conclusion that can be made out of this inability of the "Flying Squad" of the LTO under the DOTr-CAR Regional Director to enforce JAO No. 2014-01 but that this failure, just like in the many failures to enforce the laws and the rules in the past, is what is known as blatant inutility of public officials.

Most notorious among them were the failure of the DOTC-CAR now DOTr-CAR to implement the Cease and Desist Order yet issued by the Board en banc in 2007 against the out-of-line operation of the Bua operators in Sitio Trail, Itogon, Benguet, as well as, the continuous operation of colorum taxis and vans for hire in Baguio City and CAR since DOTC-CAR was established way back 2003.

As affected resident-taxpayers of the city, perhaps it will not be too much naman to ask Regional Director Natividad and his now efficient looking Assistant Regional Director Mohammad Abbas what can be done about these lingering blatant inutilities to enforce the laws and the rules by the LTO Flying Squad under them.

In short, what now?

es found to be operating without business permits will be issued the appropriate notices for them to process their permits with the city or face closure for non-compliance within a prescribed period of time.

Among the city government requirements for the issuance of permits to business establishments include barangay business clearance, fire safety certificate, health certificate of employees in case of food establishments, clearances from the Social Security System (SSS), PhilHealth Corporation and Bureau of Internal Revenue. /By Dexter A. City to utilize vacant lot for parking, offices

BAGUIO CITY – Mayor Mauricio G. Domogan directed relevant offices of the local government to study the possibility of utilizing a vacant lot for the construction of a multi-storey building for parking and to accommodate the expansion of other offices of the city government.

The local chief executive admitted the existing city hall building is already overcrowded aside from the fact that there is no available space for expansion that is why the local government must take back the 1,500 square meter vacant lot near the Baguio fire department to build the proposed multi-storey structure.

"There is no more available space within the city hall premises where we could construct structures to accommodate the expansion of existing city hall offices. We have to look for other alternative properties of the local government within the vicinity of city hall where we could build a multi-storey structure primarily for parking and other government needs in the future," Domogan stressed.

He revealed the local government ceded the 1,500-square meter property near the Baguio fire department to the Registry of Deeds for the construction of its building but the project never pushed through for still unknown reasons.

Aside from the construction of a multi-level parking building in the vacant lot, Domogan claimed part of the structure that will be built will be used as extension offices of other local government offices to make sure that services are effectively and efficiently delivered to the residents and visitors alike.

Further, he instructed the City Buildings and Architecture Office (CBAO) to include in the project plans and specifications the construction of a bridge that will connect the multi-storey structure and the main city hall building to allow for the smooth transactions to be done in the different government offices that may be located in separate structures within the city hall compound.

He added once the building will be completed, the city government will have a parking area for government vehicles and the current city hall parking area could be used by people who are transacting business with the different offices.

According to him, since the Registry of Deeds has not utilized the areas for its prescribed purpose the city will take it back as it now as the city needs additional structures that could be **Cont. on page 7**

issuance of CPCs covering routes in the city to prevent the occurrence of tremendous traffic jams that might affect the robust growth of the tourism industry.

It will be recalled that the City Council passed Resolution No. 316, series of 1995 which requested the LTFRB to issue a moratorium on the issuance of franchises for public utility vehicles plying the city because of the tremendous traffic jams.

Because of the said resolution, the LTFRB issued Memorandum Circular No. 96-002 which suspended the acceptance for PUV services in the city.

On November 17, 2003, the LTFRB further issued Memorandum Circular No. 2003-028 directing a nationwide moratorium on the acceptance of new applications and petitions for the issuance of certificates of public convenience, except trucks for hire services.

After 13 years, the LTFRB again issued Memorandum Circular No. 216-008 dated July 21, 2016, suspending all UHOP TNVS applications that took effect on 22 July 2016.

Further, the LTFRB issued Memorandum Circular No. 2016-012 suspending the acceptance of TNVS applications nationwide which immediately took effect after it was published in a newspaper of general circulation.

Some of the councilors expressed surprise that the despite the effectivity of the moratorium, there were some UHOP TNVS applicants who were issued franchises within the existing moratorium which is in violation of the LTFRB's own issuance.

The City Council underscored that in such cases, the LTFRB should refer such applications for the issuance of CPCs to the local government to seek its conformity before acting on the matter to avoid contributing to the worsening traffic congestions around the city because of the unregulated issuance of franchises to vehicle owners.

The resolution urged the LTFRB to cancel all the CPCs it issued for PUVs and TNVS applicants that fall within the moratorium period because the said issuance is considered anomalous and fraudulent that warrants the conduct of the necessary investigation by concerned government agencies and anti-corruption units. /By Dexter A. Residents, bizmen urged to comply with building standards

BAGUIO CITY – City building official Engr. Nazita Banez urged owners of residential and commercial buildings in the city to strictly comply with the building standards to ensure the safety and soundness of their structures.

In her report before city officials and employees led by Mayor Mauricio Domogan and Vice Mayor Edison Bilog last Monday, Banez said that while the city building and architecture office (CBAO) imposes only the minimum requirements and guides through the issuance of building permits, the responsibility of ensuring the structural soundness of their buildings still rests with the owners and the contractors.

"The National Building Code and the Civil Code of the Philippines place the responsibility and the accountability to the owners and their contrac-

tors to build their structures safe for occupancy," Banez said.

The reminder was made in line with the city government's disaster risk management thrust which she said compelled the CBAO to be more strict in imposing the safety requirements under the National Structural Code of the Philippines (NSCP), the Fire Code of the Philippines, the Mechanical Code and the recently approved Environmental Code of Baguio City.

She said the NSCP requires the structural design of buildings to withstand 6.5 magnitude earthquakes but in the case of the city, owners can "command their engineers to design their buildings sturdier to withstand up to 8 magnitude, though, it will cost much."

As per the Environment Code, soil tests and slope stability tests should be conducted to determine

the holding capacity of the lot and any additions or alterations of buildings should not be allowed unless reviewed and certified by an accredited structural engineer, Banez added.

Furthermore, the Fire Code and Mechanical Code require buildings to have fire alarm systems and firefighting paraphernalia. Firewalls should be built with fire-resistant materials and should have no opening.

Banez said that based on their monitoring and inspections, the most common violations found in city buildings were the non-provision of fire protective systems, elevators and the conversion of parking areas to rentable spaces.

To address the said violations, CBAO has initiated filing of cases in court against the erring owners for violation of the National Building Code. /Aileen P. Refuerzo

Lesser Loan Interest with DTI's P3

Baguio City - In support to the directive of President Rodrigo Duterte to assist small businesses that habitually depend on 5-6 lending, the Pondo sa Pagbabago at Pag-asenso (P3) is now ready to assist micro-enterprises such as market vendors, agri-business and workers of cooperatives and industry organizations. The Small Business Corporation will administer the P3 program.

This was bared by DTI-CAR Regional Director Myrna Pablo during the P3 Regional Roll Out Program held in Baguio City recently participated by about 40 micro financing institutions (MFIs) from all the provinces of the region.

The P3 as explained by Pablo is intended to help the underprivileged Filipino entrepreneurs who want to grow and

expand their businesses through an easy access to loans without any hassle like collaterals.

With sufficient funds to provide to borrowers, the DTI and its micro-financing arm Small Business Corporation (SB Corp) will lead the implementation that will assist micro entrepreneurs financially and enable them to grow their businesses.

Venus Albay, the Officer-in-Charge of SB Corp's Northern Luzon Group briefed the participants on the accreditation and implementation guidelines of the P3 program stressing the importance of the client's capacity to pay and good track record as a borrower. Albay however added that P3 Micro-financing Institutions (MFIs), cooperatives and non-bank institutions or association must be accredited by the SC Corp as a conduit to assist in the

distribution of the funds to micro-entrepreneurs.

The P3 program is a P1Billion financing program primarily intended to give micro-entrepreneurs better access to finance and to reduce their cost of borrowing. Said program will likewise make it easier for borrowers since it will only require minimal documentation requirement, easy to access with only one day processing of application, low cost interest at 2.5% per month and easy payment with repayment terms on a weekly or daily basis depending on the business cycles. Borrowers can avail a loan from P5,000 up to P100,000 with no collateral. The P3 Program was initially in the country's 30 poorest province. Now it is being implemented in provinces where 5-6 is prevalent. Art Tibaldo /DTI-CAR

BAGUIO CITY – Baguio nutrition workers and counterparts from Ifugao, Quezon, Laguna and Mandaluyong; numbering to more than 600 were called to renewed enthusiasm for their advocacies in a two-day nutrition summit in the city last week.

USAID program Luzon health representative and speaker Cecille Agpawa emphasized on community nutrition goals achievement with goals on better health condition for everyone. From the 2011-2016 goals, there are now 12 thrusts for 2017-2022, she said, needing to lessen nutritional performance gaps along the way.

On September 1, the presence of "Champions of Baguio" highlight the program and activities; with honorees; performers and achievers in national and international sports, culture and arts, other fields and equally stand outs in the local setting.

Centenarians are also given recognition in the main ceremonies.

The representatives were similarly inspired by Mayor Mauricio Domogan in a courtesy call before a city tour to barangay nutrition sites, accompanied by City Nutritionist Angelita Sabado and nutrition
