Fare Discount Applies on Saturdays

BAGUIOCITY-The city council last Monday approved a resolution asking clarification from the Land Transportation Franchising Regulatory Board (LTFRB) if the jeepney fare discount granted to students applies even on Saturdays when most students still have classes.

Councilor Elmer Datuin who authored the resolution noted that jeepney associations do not give fare discounts to students during Saturdays apparently on belief that Saturday is not considered a school day.

"It has been observed and reported that there are so many jeepneys posted with their own unofficial notices such as 'stu-

dent discount except Saturday and Sunday,' inspite of the fact that the official LTFRB/DOTC fare matrix certification posted inside jeepneys merely states 'school days' only without particular mention of exceptions," he said.

"It is a common knowledge that school days for college students is from Monday to Saturday. It is likewise a fact that on certain Saturdays, elementary and high school students have classes for make-up purposes of lost regular school day/s or for some other academic or school-related purposes," he noted.

He said the essence of the discount policy is to ease the

financial burden of parents and students in transportation expenses in going to and from the school but this is defeated if the policy is interpreted in a different

"The spirit and intention of such discount policy is premised on the term 'school days' regardless of which day such school days may be and not 'week

days," he said.
"To avoid different interpretations on the term 'school days' and to prevent arguments between jeepney drivers and students that may lead to untoward incidents, there is a need for the LTFRB/DOTC-CAR to issue a clarification on the matter," he said. /A Refuerzo

LTFRB Asked to Clarify if Student Jeepney NHA Asked to fund City Housing Project

BAGUIO CITY - The city government will ask the National Housing Authority (NHA) to finance the construction of medium-rise or tenement housing structures at the cityowned property in Irisan barangay here through a joint venture with the city government.

The city council last Monday approved a resolution proposed by Councilor Isabelo Cosalan Jr. for this purpose.

The said measure also grants authority to Mayor Mauricio Domogan to negotiate and enter into an agreement with the NHA to pursue said project.

Cosalan said the city owns two parcels of residential lands at Irisan Barangay, Baguio City covered by Transfer Certificate of Title Nos. T-35737

HSO "Small" Angels for Adoption

Program

BAGUIOCITY—The "adopt a small angel" program of the Health Services Office-Baguio Health Department (HSOBHD), Baguio City Nutrition Council (BCNC) with the Nutritionists-Dietitian Association of the Philippines (NDAP)—Baguio Chapter was a success.

This is according to Angelita Sabado of the BCNC, Thursday last week as sponsors, barangay health workers and childrenrecipients with their parents gathered at the HSO-BHD compound for the giftgiving after a morning mass.

A brainchild of the Barangay Nutrition Scholars Association, Association of Barangay Nutrition Action Officers and the BCNC, more than a hundred paper angels hung on a Christmas tree at the HSO-BHD lobby bearing the photo and names of severely malnourished children in the city. Said pre-school children were identified by their respective barangay nutrition

workers, and "adopted" by sponsors.

"The response was very heartwarming," Sabado said, as even members of their staff headed by HSO-BHD head Dr. Florence Reyes and Sylvia Laudencia, of the Local Civil Registrar's Office and personnel came as participants and sponsors.

Other sponsors, include; several councilors, a former city councilor. Barangay officials, civic-minded citizens, a giant food establishment and business establishments wanting to make a difference in a child's health, and future. A sponsor adopted four children, in an act to help check their health deficiencies.

Some children had two or three sponsors.

Sponsors, surrogate parents and godparents, and their adopted angels met last Dec. 16 where gifts; cash, school supplies, groceries, clothes and food supplements were given. Specially prepared macaroni soup was also served for the children and

those present.

Accordingly, the "love project" recipients are those from the ranks of the "unprivileged and marginalized," as evidenced by the state of their health.

There was also a physical check-up for the children and their parents, and counseling by members of the NDAP as to their dietary needs.

Ms. Sabado envisions a wider scope of the program for the next year, and hopes that there would be more recipients. This was encouraged by the fact that the present sponsors pledged support for the next program. A sponsor pledged support for monthly assistance until next Christmas, another selfless act for the improvement of his ward's health.

Malcolm Raiders' Lawyers: "no contempt... T'was Jueteng not Bingo"

"They should be commended instead of being punished for contempt."

Thus said lawyers of beleaguered employees indicted for contempt of a Regional Trial Court (RTC) Branch 5 diktat which court order likewise saw three of their captives earlier tagged for illegal gambling operations free.

It could be remembered elements of the Public Order and Safety Division (POSD) and the Baguio City Police Office (BCPO) swooped suspected gambling lair at 22 Jacinto St., Barangay Malcolm Square, November 29.

On the same day, POSD chief Fernando Moyaen, PC/Insp. Nestor Carino, and mayor's executive assistant III, Policarpio Cambod, filed joint affidavit-complaint tagging Daniel Mirasol (38), Allan Alvarez (27), and Dexter Santos (20) for violation of Presiden-

tial Decree No. 1602 – the anti illegal gambling law.

In retaliation, a complaint dated December 1 was filed by Domoguen accusing Moyaen, et al. of illegal arrest, grave coercion, robbery, extortion, and usurpation of authority. Private lawyers George Dumawing, Jr. and Rudolfo Lockey represent them.

Domoguen maintains the raided activity legal citing a decision penned by RTC Branch 5 judge Antonio Esteves, November 30, 2006, declaring barangay councils have authority under the Local Government Code to hold bingo sa barangay to raise funds.

More, he cited an April 18, 2006 order of the same court granting the prayer of the Association of Barangay Councils (ABC) for a "[t]wenty day restraining order" from date of the said court diktat preventing police elements from meddling

with the 'fundraiser'.

The case dubbed Special Civil Action (SCA) No. 6220-R is now pending in the appellate court.

In a 9-page 'comment with motion for inhibition' dated December 16, Dumawing and Lockey maintained it was jueteng and not bingo which greeted their clients upon entering 22 Jacinto St.

Among others, they pointed out Domoguen is relying on a TRO which had long lapsed before the Malcolm raid. "Thus," they said, "The TRO cited cannot be basis contempt." More, they claimed he avers a 'status quo order' which in fact does not exist.

The lawyers claimed the bocap misrepresented the court by piecing together parts of its April 18 diktat and came up with new meaning so he would be able to squeeze

Giving's Price Tag

"It's so hard to give," our 7-year old grand-daughter Kristin sniffled, as she cradled a toy doll. Kathie, 4, straddled a mound of dolls.

Misa de Gallo starts Thursday, the wife and I told them. In Advent, their parents have them rummage for toys to share. They periodically hand food packets to slum children during the year. "What are you giving this Christmas?" We ask.

They had sorted dolls into two groups. One, they'd keep; the other, give away. "We love these," Kathie insisted of 28 dolls. The remaining four were to be Christmas gifts. "It's so hard," Kristin repeated.

"Sure. FIES says the same thing," I mumble. "Huh?," Kristin erupted.. Kathie stared blankly. "Nothing. Just look again, please. O K?"

Years later, both may read Family Income and Expenditure Surveys. The

National Statistics Office churns out FIES every three years. Surveys in 2003 and 2006 tracked the slump in family budgets and spread of penury.

"Uninterrupted growth," crowed Gloria Macapagal Arroyo of her graft-sapped nine year term. But hard nosed comparison of FIES, from 2003 to 2009, reveal "six years of unshared growth," concludes the lucid analysis by Social Weather Stations' Mahar Mangahas.

"The new 2009 FIES reports both average family income and family expenditure, in real terms, (stagnated) unchanged from 2003 to 2009. "Mangahas wrote in his Inquirer column. "The key lesson is...the non-stop economic growth 2003 and 2009 was not shared with the poor."

Average families, nationwide, could only scrape up P12,900 for food, clothing and other essentials. This "national median family expenditure" is already below the national average of P14,700 per month" --- already among the poorer of 10 clusters ("Deciles" is the technical term used)

"The aggregate economic growth from 2003 to 2009 was unshared." Mangahas added. "Six years were essentially wasted.

FIES dry-as-dust figures do have a "human face". You glimpse that in those growing numbers of panhandlers. They huddle on castaway cartoon mats on city sidewalks. In the countryside, you bump into small rough-hewn coffins, borne, in scraggly procession by shabbily clothed mourners.

"Prevalence of underweight children under five, "is comparable to Sub-Sahran Africa," the last nutrition survey reports. Only three out of ten drink potable water in the Autonomous Regions of Muslim Mindanao. Empty chairs, in school rooms, signal 16 students, out of every 100 who drop-out. They can't afford the only escape from penury: education. Look at the disparities within this ultimate irony. In Sulu, for example, barely 23 out of every 100 students will graduate from high school, Philippine Human Development Report reveals. It is 20 for Cebu and 81 in Metro Manila.

We grope on how to teach Kristin and Kathie to "look with the heart." Otherwise, those smelly scrawny kids, who croak off-key carols at your gate, won't mean anything.

Christmas tinsel, bustle and rush can make the needy disappear into the holiday woodwork. That won't be the first time. The rich man, who feasted everyday, had a range of vision that never took in Lazarus at his door, hoping to share even scraps from his table.

If we "open our shut-up hearts freely," we'll discover they're "hard as flint, from which no steel had ever struck out generous fire, secret and self-contained, and solitary as an oyster," Jonathan Powers writes in "Scrooge Is Here".

This Christmas season, the wife and I must heed the Inquirer's "Read Along" campaign. We must read to Kristin and Kathie Charles Dicken's 1843 novel: "A Christmas Carol."

This is more than ghosts of Christmas past, present and yet-to-come. It also speaks of 'immortal creatures, condemned without alternative or choice, to tread paths of jagged flints and stones by brutal

If God wanted to, Jesus the son of God and messiah, has the option to be born to a family of means but God chose instead that His son be born to a family of a semi-proletariat. Thus, my belief that the meaning of the phrase, "to proclaim the year of the Lord's favor" is best interpreted within this context.

Clearly, Jesus was meant to communicate God's "bias" for the poor, the subjugated or the unfree, and the oppressed even if God loves all men regardless of their situation. A very interesting thing is that Judaism, Christianity, and even Islam confirm the existence of

Government Assures Stable Supply of Rice, Flour in Baguio-Benguet

BAGUIO CITY—With the Christmas season just around the corner, government agencies assure steady supply of rice and flour until the start of 2011.

According to National Food Authority (NFA) Baguio-Benguet Area Manager Rolando Rufo, supply of rice remains stable and that there is enough supply to last until the start of 2011. He stressed that the goal of the government at this time is self-sufficiency so there is continuous purchasing of palay from rice farm-

Rufo also affirmed that effective last December 7, wholesale price of NFA regular milled rice is now P27 per kilo from its previous price of P25.

Meanwhile, Department of Trade and Industry (DTI-Benguet) Consumer Welfare Division Supervisor Richard Limpin assured that based on their monitoring there is a stable

supply of flour in the Baguio-Benguet area. He added that they do not foresee an increase this December and maybe until January of 2011.

Limpin, however, explained that the price of sugar will now play on the market forces, particularly on the supply and demand as the National Price Coordinating Council (NPCC) lifted the Suggested Retail Price (SRP) for sugar until the end of December.

Based on DTI's latest monitoring, the price of white sugar now stands at P64 per kilo and P56 per kilo for brown sugar. On the effect of steady supply of flour to the price of bread, Limpin stressed that it remains stable and hopefully it will not be affected by increase in sugar prices.

According to Limpin, based on their monitoring in the past two weeks (December 3 and 10) price of loaf bread remains at P30 (for 540grams) and P43 for (765grams).

Meanwhile, Limpin also affirmed that as per NPCC advisory, the price of LPG will have a total increase of P7 per kilogram this December due to the current increase on the price of LPG in the world market.

Based on the special monitoring they conducted from LPG dealers, pick-up price for 11 kilogram cylinder, Shellane and Caltex LPG now costs P810 while Tiongsan (Baguio Gas) and Petron Gasul is being sold at P750.

Limpin also advised consumers to buy their LPG directly from dealers. 'Kung gusto ng publiko na makamura, mas maganda na bumili sila ngdirekta sa mga dealer dahil walang added mark-up price,' he said./Lito Dar/PIA

1,200 Families Get Shelter Aid From Red

Cross

TABUK, Kalinga - About 1,200 families whose houses were damaged by typhoon Juan last October receive shelter aid from the Philippine Red Cross (PRC) Kalinga Chapter.

PRC-Kalinga Chapter Head Glorina Reves said shelter aid materials for the 342 first batch of beneficiaries and 321 for the second batch were already released. Release for the remaining beneficiaries is on-going.

Assistance are given after beneficiaries completed application requirements, Reyes said.

Beneficiaries under the Red Cross shelter aid program get P7,000 worth of construction materials for partial repairs and P35,000 for full repair. There were 200 families given full repair assistance.

Reyes said under the project . labor is the counterpart of beneficiaries.

Typhoon Juan, said to be the strongest cyclone to hit the world this year, blew off roofing and shattered shelters in at least 36 barangays in the province. PRC data showed a a total of 37,009 families were affected by ty-Juan in phoon Kalinga.

Reyes identified the municipalities that benefitted from the project as Tabuk –23 barangays, Rizal 10 barangays and Pinukpuk-3 barangays. Beneficiaries of this aid, according to Reves, are indigent families who could not afford to pay for the repair of their houses. Reimbursements of expenses by those who were able to spend for the repairs of their houses are not accommodated.

The amount of aid distributed for victims of typhoon Juan, according to Reves, is lower than in the last typhoon Pepeng, since donations only came from the Red Cross societies of Asia.

PRC-Kalinga also distributed nonfood relief items consisting of 3,000 sleeping plastic mats, 3,000 blankets, 1,000 bath towels, 1,000 mosquito nets, 1,000 plastic water gallons and 2,000 hygiene kits. Food items distributed totaled to 2,078 food packs. /Larry Lopez/PIA-Kalinga

the Philippine justice system. If Hubert Webb and others are really guilty then the Supreme Court of acquittal means even if justice is found by a Filipino, that justice will only be temporary and ultimately it will be injustice not justice that will triumph.

However, if Hubert Webb and others are really not guilty then 15 years of incarceration of Hubert Webb and companion implies that a miscarriage of justice can happen to a Filipino for about 10 long years. If an "injustice" can be done to a Senator of the Republic, the more can a miscarriage of justice happens to an ordinary invidual like Juan dela Cruz. Thus, the ultimate meaning of the Supreme Court decision on the Vizconde massacre is that "heads", injustice wins, and "tails" justice loses. ignorance" and an avaricious elite, the 31-year-old Dickens told the Manchester Atheneum. By then, Dickens had the novels "Oliver Twist" and "David Copperfield" under his belt.

Yet, "Christmas is the only time I know of, in the long calendaryear, when men and women seem, by one consent, to open their shut-up hearts freely," he wrote. And we must see "people below (us) as if they were really fellow passengers to the grave, and not another race of creatures bound on other journeys. . . ."

Christmas 2010 comes to our nation atrophied by injustice, as it did two millennia ago, for Rome. There was loot for friends of Tiberius Ceasar – like those 1,000 "midnight appointees"? But there were brutal consequences for those who didn't enjoy imperial favor – like Rudolfo "Jun" Lozada who blew the whistle on the ZTE broadband scan.

Abuse and corruption were rife—like Imelda Marcos' shell foundations. As listed by the Supreme Court, these included "Vibur, Xandy-Wintrop, Palmy and Maler' Foundations Sowere summary executions—as in Maguindanao. Court justices were Ceasar's pawns—like what?

And "there was everywhere a contempt for human life", the 1948 Wall Street Journal Christmas editorial recalls. "What was a man for but to serve Ceasar?

The Ceasars, Herods, and Scrooges never left. Only their names have changed. You fill in the blanks. Then, and now, it is still the poor who bear the brunt.

Goddidnotcome into our hard-as-flint world assome superstar whose power, beauty and muscle would dwarfus, Latin American liberation theologian Leonard Boff wrote. "On Christmas, Godentered human history. He made our lot his own" – our fears, hurts, pettiness and betrayals, our cancers and Alzheimers, even our dying."

How do we teach that to Kristin and Kathie? Go figure/J.L.Mercado

himself out of a legal straightjacket.

Thus they said, "It is Domoguen which should be cited for contempt for making untruthful statements in his complaint."

The raiders' counsels meantime bared Domoguen is operating independently from ABC. He cannot thus claim protection under appealed decision SCA 6220-R, which was initiated in the name of the ABC, represented by its then President, Rafael Panagan.

Citing various city legislative and executive issuances, Dumawing and Lockey likewise pointed out the elements of POSD and BCPO were merely executing lawful orders to stamp-out illegal gambling in the city.

They said, "Since the arrest and the confiscation of the jueteng paraphernalia were made while there was actual jueteng operations, respondents did not commit any wrong nor violated any law or lawful order of the court."

They continued, "Settled is the rule that every action must be prosecuted and defended in the name of the real party-in-interest.

"Since the arrest and confiscation proceeded from lawful orders issued by the City Mayor, the need to implead the Mayor and members of the City Council is indispensable; [otherwise, the petition must be dismissed]."

The lawyers in the same pleading likewise asked Esteves to inhibit himself from hearing the contempt charge.

They said, "The decision of the Honorable Court in SCA 6220-R a propos the Bingo sa Barangay esteems the same is legal...."

"What court would sacrifice consistency in its diktat when confounded by seemingly like facts that are in fact disparate from the other?" they added.**

Doguil explained that EEP is being implemented by DOLE for the rehabilitation of the damages brought by typhoon Juan to local communities. 'Work involves opening of barangay roads, rehabilitation of farm-to-market roads (FMRs) and irrigation systems, and erosion control for landslide prone areas,' he explained.

For the DOLE EEP program, P5 Million is allocated for Cordillera and for its implementation. More than 700 local folks are also provided with short term employment.

Kalinga, which suffered the most damages, will benefit 225 with a fund allocation of P1,269,558; Abra with 151 workers -P941,832.40; Benguet, 138 workers – P962,770; Ifugao 100 – P761,713; Apayao 39 – P157,000 and Mountain Province, 104 – P648,679.

'The EEP involves 30 days of work per beneficiary and we expect the work to be finished by January as the workers only work during weekdays. We are now also processing their first 15 days payment for downloading to the beneficiaries,' Doguil stressed.

Meanwhile, DOLE's Livelihood program this year also benefitted some individuals whose small businesses were also affected by Typhoon Juan, Doguil affirmed that they have already made an initial release of P448,763.31 in Ifugao; P248,515 in Kalinga; P471,750 in Apayao; P292,570 in Mountain Province and P983,479 in Baguio-Benguet. The livelihood assistance is in the form of materials and equipment to help the beneficiaries in their small businesses./Lito Dar/PIA

City Mulls Proper Naming of Tombs, Alleys in Cemetery tombs. "Because of the

BAGUIO CITY – Soon, all tombs and alleys at the city cemetery will be properly marked to put order at the burial ground.

The city council last Monday approved a resolution urging the City Environment and Parks Management Office (CEPMO) to devise a scheme for the identification of all tombs and naming of major alleys at the city's graveyard.

Councilor Betty Lourdes Tabanda, who authored the measure, said there is a need to come up with the identification strategy to avoid confusion in locating a niche or tomb because of the lack of proper markings along alleys and aggravated by the sloping terrain and steep ravines that characterize the cemetery

The measure gives the CEPMO the

imprimatur to devise a scheme including the numbering or clustering of tombs, niches, apartments and crypts "in a manner that is easily understood by the general public."

The city cemetery occupies a land area of approximately 94,800 square meters along Naguilian Road which is occupied by individual and apartment niches, private apartments, bone crypts and tenement-type

"Because of the increasing demands for plots to bury the dead, the public cemetery now resembles a crowded mountainous maze without signages directional guides (thus) its present state does not accord a dignified resting place where the living can commune with their dearly departed," Tabanda said.

She said the identification scheme is hoped to cure the problem by putting order and organization at the burial ground./A Refuerzo
