City's drug problem seriou Domoga

 $\mathbf{B}^{\mathrm{AGUIO\ CITY}}$ – Mayor Mauricio G. Domogan revealed the city's drug problem is becoming serious while approaching the 6-month self-imposed timetable imposed by President Rodrigo Duterte to curb the proliferation of illegal drugs in the country.

The local chief executive claimed the 214 drug surenderers recorded by the Baguio City Police Office (BCPO) from the period November 28 to December 4 shows that there are still numerous drug pushers and drug users in the different barangays who still do their illegal activities trying to put an acid test to the government's all-out campaign against illegal drugs.

We call on the remaining drug pushers and users in the city to reform and surrender to the authorities and not wait for something to Cont. on page 7

BAGUIO CITY - Mayor Mauricio G. Domogan vetoed Resolution \No. 252, series of 2016 adopting an experimental scheme for six months to extend the business hours of liquor establishments in the city, saying that the Baguio City Police Office (BCPO) wants reduced operating hours of liquor establishments because of the prevalence of liquor-related incidents.

The local chief executive returned to the City Council the said resolution, noting that there will be no change in the operating hours of the liquor establishments after receiving a verbal report from BCPO seeking to reduce the business hours of the establishments to prevent liquor-related incidents in the city.

Under existing rules and regulations, the City Mayor has the mandate to veto any resolution or ordinance passed by the legislative body when it runs counter to the general welfare clause of the constitution and other related laws but the City Council can override the said veto by a two-thirds vote of its members.

Ordinance No. 25, series of 1987 which codified the city's liquor ordinances governs the products and services, crimes./By Dexter A. See#

tenance and operation of places of amusement within the city, regulating the sale or serving by, and/or drinking of liquor or alcoholic beverages in certain places and on Sundays and legal holidays and providing for penalties for violations.

This ordinance was amended by Ordinance No. 1, series of 1990, and later, by Ordinance No. 88, series of 2009, to include the business hours of the liquor establishments.

Section 9 of the same ordinance provides that for the sake of the general welfare and protection of the people from the effects of all businesses with amusements such as bars, nightclubs, discos, beer gardens, karaoke or videoke bars, billiards, computer centers and internet cafes, their business hours should be limited to 5 pm to 2 am for establishments with dancing; from 3 pm to 12 midnight for establishments without dancing.

Business owners claim the duration of business hours set nearly seven years ago could no longer meet their costs of operation which include electricity, water, rental fees, business taxes and increase in prices of clients that the hours are no longer sensible as compared to other highly urbanized cities and tourist destinations in the country.

The council claimed then a need to extend the hours of operation of the liquor establishments as the present set-up is no longer helpful to their business and tourists or guests that visit the city Mayor Mauricio G. Andrew Pinero, HRAB media officer, said

The first tranche of P7 million was paid to the organizers by the HRAB last November 7, 2016 upon the signing of the contract while the second tranche was again paid last week. The third

Bello reported the remaining locators employed 30 workers that contributed to the increased employment opportunities for qualified local residents.

Under the provisions of existing ordinance crafted by the local government, The top 15 locators companies operating within the jurisdiction of the city must make sure that majority of their work force come from the city's 128 barangays.

Domogan expressed his gratitude to the JHMC management and the locators for employing qualified residents Hay air station, were within the BLISTT area,

saying that the increased economic activities in the city will surely translate to more employment opportunities for the qualified residents.

However, he claimed the potentials of the special economic zone has not yet been fully maximized because the developer of the former American rest and recreation center was only able to develop onefourth of the supposed developable areas, thus, the need to attract more locators to put up their respective businesses in the economic zone for sustained economic growth in the zone.

Political will needed to impose firecracker

 ${f B}$ AGUIO CITY – Health authorities challenged local officials in the region to have the political will to impose a needed total ban on the selling and use of firecrackers and pyrotechnic materials for the celebration of the Yuletide revelry.

Dr. Amelita M. Pangilinan, assistant regional director of the Cordillera office of the Department of Health (DOH-CAR), said many Filipinos were already injured or have lost their lives because of the unregulated use of firecrackers and pyrotechnic materials during the holiday celebrations over the past several decades, thus the need for everyone to start using alternative ways of welcoming the new year to ensure especially the safety of the children.

"We need to already embrace alternative ways of celebrating the coming of a new year. We continue to embark on scare tactics aside from encouraging community participation to the efforts of government to abandon the use of firecrackers and pyrotechnic materials for the Yuletide revelry," Pangilinan stressed.

The DOH-CAR official admitted no local government in the region was able to pass the appropriate local legislation to impose the total ban although there is a pending proposal in the Baguio City Council to impose one.

According to her, the executive order supposed to be issued by President Rodrigo R. Duterte for the prohibition was not released on time because of the need to conduct consultations with the affected stakeholders before the crafting of the final provisions which will be fully implemented probably by next year.

Pangilinan claimed concerned government agencies have already tried all possible strategies to help convince people to shy away from firecrackers and pyrotechnic materials for their New Year celebration to prevent life-threatening injuries or eventual loss of lives.

She expressed gratitude to City Mayor Mauricio G. Domogan and Tuba Mayor Ignacio Rivera for their public pronouncements against allowing firecracker and pyrotechnic vendors to pursue their lucrative trade which is a giant step towards preventing their constituents from suffering injuries and compromising their bright future.

She emphasized the Cont. on page 7

Highest two officials of the land don't respect the rule of law

 $\mathcal{N}^{\mathsf{HAT}}$ kind of country have we become that the two highest officials of the Republic don't respect the law, and even flaunt their disdain for it?

President Duterte the other day made his curses and rape jokes during the election campaign look like convent talk when he said: "I will not allow these police to go in prison. Kahit sabihin ng NBI na murder (Even if the NBI says it's murder),"

The NBI (National Bureau of Investigation) had concluded that about two dozen policemen led by Chief Inspectors Marvin Marcos and Noel Matira and Chief Inspector Leo Laraga were indictable for the killing of Albuera mayor and alleged drug lord Rolando Espinosa and his fellow inmate Raul Yap—in what the victims had probably thought was the safest place on earth, a tightly guarded cell in Baybay City.

I couldn't believe my eyes when I read that Duterte even said that he is willing to go to jail in place of those policemen, whose arrogant impunity (Marcos had nothing to do with Espinosa's case) was matched only by their cowardice (their killing team

I suspect Duterte's workload has become unbearable. How can he claim, as if he was just being rational: "Who would you believe, word of a criminal or of a police?"

But it wasn't a criminal, presumably Espinosa, who claimed from his grave that he was killed by the policemen. Several senators—especially Senator Panfilo Lacson who was once national police chief and Senator Richard Gordon, whose father was assassinated—said that it was "clearly a rub-out" while veteran NBI investigators heroically did their job even if Duterte had announced his backing for the ruthless policemen.

The NBI was so meticulous in its investigation **EDITORIAL** that its investigators even found that the witness, one Paul Olendan, who Marcos claimed had told

them about the guns and illegal drugs in Espinosa's Baybay City jail cell on Oct. 28which became the basis for the search warrant they used to barge into the mayor's cell—had made it all up. He was almost a hundred kilometers away on that day in Tacloban City, where he was assistant principal in one of the schools there.

How can a President forget that his main task, under the Constitution, is to enforce

The rejection of the rule of law is really as worse as Vice President Leni Robredo's labelling the Supreme Court ruling allowing the burial of former President Marcos' remains at the Libingan ng mga Bayani "immoral". She has joined the demonstrations against the ruling, in which protesters hurl invectives at the high court justices.

Doesn't the vice-president, a lawyer, know that our rule of law is based not only on the body of laws Congress has passed, but on the Supreme Court, which is the last body to decide what is legal or not?

Robredo's disdain for the rule of law is also evident in her statements that her rival Ferdinand ("Bongbong") Marcos, Jr. will be "stealing" her post, the vice presidency.

Doesn't the vice president know that the body which will decide if Marcos' claims that he was cheated are vaild or not is the Presidential Electoral Tribunal consisting of all 15 members of the Supreme Court, and also chaired by its Chief Justice?

Rather than denigrating the integrity of the Supreme Court, aka the Presidential Electoral Tribunal, why doesn't she just make sure, with the billions of funds her Liberal Party has, that the alleged evidence of cheating Marcos presents are proven false, rather than declaring again and again that her vice-presidential position will be stolen by her rival?

Pandora's box

As I wrote here several months back, Duterte's call to the police to "slaughter them all," referring to those in the illegal drug trade, is like opening the Pandora's Box. The term refers to the ancient Greek myth that all the evils of the world were contained inside a box, which the first woman on earth opened and released to the world defying the chief god Zeus' warning for her not to do so. Even the all-powerful Zeus was powerless to put back all these seven demons back into the box.

That term has come to mean an action taken in the expectation of some good, but turns out to have several unintended, detrimental and far-reaching negative consequences—which becomes nearly impossible to stop or reverse.

Duterte's war against drugs, which he said would save generations of Filipinos from misery is indeed turning out to be a Pandora's box that he has opened. To call on the police to dispense justice on their own has been to allow them to go on killing sprees of suspects, or just "bad characters," in their areas of responsibility.

They justify such executions on the ground that they have all too often experienced arresting, at the risk of their lives, hardened criminals, only for the latter to get judges to set them loose. They simply post bail or get the charges dropped after witnesses don't appear in court because of fear of reprisal, or out of mere aversion to the

bother of going to hearings.

Such police killings have been going on but kept secret as far as I can remember, and I learned about them from joining other reporters in their police beats. Unlike in American movies, a suspect surviving a police chase, handcuffed, and read his rights is a very, very rare **Cont. on page 6**

Why were 1,300 Chinese allowed to work in RP? BY: ATTY. BATAS MAURICIO



LIFE'S INSPIRATIONS: "... 'And the Good News about the Kingdom will be preached throughout the whole world, so that all nations will hear it; and then the end will come'..." (Jesus Christ, our God and Savior, in Matthew 24:14, the Holy Bible).

WHAT IS THE MISSION OF THE CHURCH OF JESUS IN RP? What is the work---or the mission, if you will---of the Church that Jesus, our God and Savior, established in the Philippines, pursuant to Matthew 16:18 and Isaiah 46:11 of the Bible? THE ISSUE IS THE ILLEGAL CHINESE WORKERS, PERIOD! The issue that we must not lose sight of in the controversy over the alleged bribe try of online gambling operator Jack Lam against Justice Secretary Vitaliano Aguirre II and Chairman Andrea Domingo of the Philippine Amusement and Gaming Corporation (PAGCOR) is the apparent smuggling, as it were, of Chinese citizens into the country to work illegally in Lam's casino.

In the face of the conflicting claims of Lam, through his partners here, and of Aguirre, on whether there was indeed a bribe offer or not, it is clear everybody are in agreement that some 1,300 or so Chinese have been working illegally at the Jack Lam-owned Fontana Leisure Parks and Casino at Clark Freeport Zone in Clark, Pampanga.

How did these Chinese workers get into the Philippines? How come they were allowed to come here? And why did Fontana Leisure Parks and Casino allow them to work illegally, as Aguirre had been saying? Did this not violate the franchise given to Jack Lam to operate a casino and should therefore result in the cancellation of that franchise?

DOJ, IMMIGRATION, MUST DISCLOSE RECORD OF CHINESE WORKERS:

Another question that Jack Lam and Fontana Leisure Parks and Casino must answer is: did not their franchise include a provision that requires the employment of Filipino workers in their casino? As far as I can gather, this employment of Filipino workers by licensed foreign gambling operators is mandatorily provided for in their franchises.

On the other hand, I suggest that Aguirre's department and the Bureau of Immigration should disclose to the public the immigration records of the arrested 1,300 or so Chinese workers at Fontana Leisure Park and Casino. The public has a right to know whether these workers legally entered the Philippines, and what their qualifications are that prompted Jack Lam to allow them to work for him.

What is more, our countrymen should also be informed as to whether anyone of those arrested already came into the country before. Sources are telling me that some of them previously came to the Philippines, worked for a while, but were deported back to China because of their inability to legalize Cont. on page 5

Duterte: I won't let cops in Espinosa slay go to jail

President Rodrigo Duterte gives the assurance to Superintendent Marvin Marcos and his men a day after the National Bureau of Investigation recommended multiple murder charges against them

MANILA, Philippines – President Rodrigo Duterte said he "will not allow" Police Superintendent Marvin Marcos and cops involved in the operation against the late Albuera Mayor Rolando Espinosa Sr to go to jail despite official findings that they are liable for murder.

"I will not allow these guys to go to prison maski na sabihin ng NBI, murder (even if the National Bureau of Investigation says it was murder)," Duterte said at the Urban Poor Solidarity Week in Mandaluyong City on Wednesday, December 7.

"Eh tutal, under ko rin 'yan (Anyway, it is also under me)," he added, referring to the NBI.

Duterte made the statement a day after the NBI released its findings that Espinosa was killed in a rubout. It recommended multiple murder charges against the 24 police officers involved in the operation at the Leyte Sub-Provincial Jail in Baybay City on November 5.

Alleged drug lord Kerwin Espinosa, son of the slain mayor, had accused Marcos of soliciting P3 million from him for campaign funds for his wife, a mayoral candidate in the 2016 elections.

Duterte earlier said he believed in Marcos' version of events - that the mayor had fought back, forcing police to use deadly force during the raid.

Duterte had also admitted that he ordered Marcos' reinstatement despite the decision of Philippine National Police chief Director General Ronald dela Rosa to relieve *Marcos from his post due to his suspected drug links.* 'No obstruction'

Though he did not want Marcos' team in jail - and even after he said that the NBI was under him anyway - Duterte said he would not interfere in the filing of

cases against them. "I do not obstruct. So the finding of NBI is murder.

Good. File a case," he said.

Duterte insisted that as President and thus, head of the police force, it is just normal that he side with

"Kung ano ang sinabi ng pulis, 'yun ang totoo sa akin...Hindi ko pababayaan ang pulis. Kasi sabihin, ako ang may utos eh. 'Kasi sabi mo Sir, hulihin namin tapos 'pag lumaban,'" said Duterte, who didn't complete the sentence.

While he believes in the cops' version, Duterte said in another speech the same day that he may still change his mind if the NBI digs up better evidence.

Duterte, then a presidential candidate, also said that if he got elected, he would direct policemen and the military to not be deterred in killing "all" criminals because it is his "personal order."

instance. Police almost always shoot dead suspected criminals they corner, after a chase.

However, these police killings have been at a low-level intensity, to use that term, as there is, after all, an announced rule of law. These were also significantly reduced after the establishment of the Commission on Human Rights under Section 18, Article XIII of the 1987 Constitution; the conviction of a number of police officers for human rights violations (mainly in cases of political activists);and the establishment of the Internal Affairs Directorate at the PNP.

Duterte simply told the police to forget this human rights thing since more important was his war against drugs, as this was necessary to liberate our nation from this scourge. He opened the Pandora's box and released the extra-judicial executioners.

The irony is that out of the 3,500 killings in the streets (as reported by the police) since July when Duterte assumed power, probably 90 percent were killed in some slum area or dumped near there, and were all wearing slippers or cheap basketball shorts— sure signs that these were poor people, hardly drug lords, the lowest level of pushers, or mere addicts who take shabu to forget their utterly miserable lives.

Even alleged drug lord Espinosa was

killed in shorts and slippers, indicating as in the case of those other mere users, his utter helplessness when he was killed. Many were reportedly killed by the corrupt police who wanted to clean up their involvement in the illegal drug trade.

An alternative narrative for the war vs drugs would be to read every day that the Philippine Drug Enforcement Agency, with a battalion of NBI investigators and police special action force troopers assigned to it, raiding a shabu laboratory or warehouse, and arresting—okay, even killing—drug lords wearing expensive shoes.

Enough is enough, and a recent New York Times photo essay entitled "They are slaughtering us like animals" shows the horror of what Duterte released from his Pandora's box. If you're not convinced, check out that essay (http://nyti.ms/2gCyBBl). Not just because of the horrific photos but the high quality of its journalism, it will become viral not only here but throughout the world, and shaming us as a nation.

happen to them or to the members of their families before they will realize that it is time for them to surrender," Domogan stressed.

From 1,513 drug surrenderers the previous week, the number of drug surrenderers in the city grew to 1,727 surrenderers the following week and still increasing following the government's anti-drug campaign nationwide.

He pointed out the government has given sufficient time to the drug surrenderers to reform by giving themselves up to the authorities to be properly guided back to mainstream society.

According to him, it is unfortunate that there are still drug pushers and users who remain hard headed by refusing to surrender and reform and thse are trying to test the limits of the law.

Domogan reiterated the appeal of local officials for the drug pushers and users to help themselves by surrendering to the police to be provided with the necessary technical assistance to enable them to join mainstream society as a reformed citizen and to prevent their lives from being put to danger.

He explained that what is needed is the vigilance of residents on illegal activities of their neighbors and reporting these for proper police action to the nearest police station.

Domogan is grateful to the government's anti-drug campaign because it proved that all the city's 128 barangays are drug-affected as shown by the presence of drug surrenderers from all the barangays, thus, the problem needs a consolidated effort among the government and the private sector in order to address such menace before it goes out of control and compromise the future of those involved.

Compromise settlement in John Hay row likely

BAGUIO CITY The long standing proposal of Mayor Mauricio G. Domogan for the existing conflict between the State-owned Bases and Conversion and Development Authority (BCDA) and the Sobrepena-owned Camp John Hay Development Corporation (CIHDevCo) to strike a compromise settlement over the development of the 247-hectare John Hay Special Economic Zone (JHSEZ) saw the light at the end of the tunnel after the new BCDA leadership expressed its willingness to peacefully and orderly resolve the dispute without compromising the government's position on the matter.

Domogan met with newly-installed BCDA president and chief executive officer Vivencio Dizon Wednesday and discussed at length the possibility of swiftly resolving the continuous row for the government to maximize its gains from the development of the former American military installation.

"We were elated over the open-mindedness and common sense displayed by the BCDA president

and chief executive Dizon within the next two in assessing and evaluating the present situation in John Hay. We are confident there will be bright prospects of development in the zone once there will be a win-win solution to the problem," Domogan stressed.

He pointed out once a compromise is reached the local government will push that the agreement to be signed will be a tripartite one, wherein to avoid the government's quandary on how to collect its share from operations inside the economic zone, part of the conditions included will be a direct payment to the city of a 25 percent share from lease rentals.

According to him, what is important with the new BCDA leadership is receptive of the government's position for a middle ground to help improve economic activities inside the special economic zone for the additional job generation and improved sources of livelihood for the local residents.

Domogan said he was assured by BCDA that the State corporation will be ready with its position months after the conduction of the ongoing legal audit, so all parties will be aware of what positions to take once the matter will be again brought to their attention without sacrificing the position of the government on the pending case with the Supreme Court (SC).

He disclosed BCDA president Dizon shares his position that the share of the local government will be directly remitted to the local treasury office to avoid the involvement of too much bureaucracy in the disbursement and utilization of the funds.

He expressed optimism President Rodrigo Duterte will be able to complete the appointees in BCDA and its subsidiary, the John Hay Management Corporation (JHMC), so that the government can start addressing issues to maximize the development potentials of the special economic zone, saying the BCDA is on the right track of putting things in the right perspective./By Dexter A.

BAGUIO CITY -Testing for Human Immunodeficiency Virus/ Acquired Immunodefiency Syndrome (HIV/AIDS) is encouraged as said cases in the city and the country as a whole has increased.

This was disclosed in the Kapihan at the Department of Health (DOH) Training Center, Thursday last week, with health authorities including DOH Director III Dr. Amelita Pangilinan.

"HIV/AIDS is a chronic, sexually transmitted disease where the virus weakens the immune system, causing the body's inability to fight diseases."

There is no treatment nor cure for HIV/AIDS, it was stated in an advisory disseminated during the forum. Retroviral medications can only slow down the progression of the disease. Prevention includes having sexual relations within a mutually monogamous relationship with an uninfected partner; using condoms, and for those with medical needs,

firecracker-related incidents this year

BAGUIO CITY - Health authorities in the region are eying substantial decrease in firecracker-related incidents this year compared to the recorded incidents last year with the full cooperation of the public.

Dra. Amelita Pangilinan, assistant regional director of the Cordillera office of the Department of Health (DOH-CAR), said they are keeping their fingers crossed that the people were able to learn their lessons over the past several years relative to the use of firecrackers and pyrotechnic materials during the Yuletide revelry, thus, the firecracker-related incidents this year will likely decrease.

From December 21, 2015 to January 5, 2016 she noted there were 63 fireworks and firecracker-related incidents monitored in health facilities and other health-related facilities regionwide.

She added the recorded incidents were 10 percent lower than the 70 cases monitored for the same period the previous year. The highest decrease was in Mountain Province with only 1 case with an 84 percent reduction followed by Ifugao with

incidents.

However, Baguio City recorded 11 cases for the said period which was a 22 percent increase compared to the 9 cases during the similar reckoning period last year.

Of the 63 recorded firecracker-related injuries, Panglinan revealed there were 61 fireworks-related incidents and 2 cases with still unknown cases.

DOH-CAR The official said most of the injured individuals came from Abra with 25 cases accounting for 40 percent of the total incidents regionwide followed by Apayao with 14 cases, Baguio City with 11 cases, Benguet with 9 cases, Kalinga with 2 cases and Mountain Province and Ifugao with 1 case each.

According to her, all three provinces, except for Baguio and Benguet and Kalinga, had reported decreases in the number of fireworks and firecracker-related injuries monitored as compared to the similar period last

According to her, majority of the injured individuals belong to the age group 3 to 10 years old with 30 cases and the median age was 11 while 1 case and an 80 percent the youngest victim was A. See#

drop in firecracker-related 3 and the oldest was 59.

Based on the report, 54 individuals representing 86 percent of the injuries were described as active users, 6 individuals or 10 percent were under the influence of alcohol. 56 of those injured representing 89 percent were males while 7 persons accounting for 11 percent were females.

She recommended that local governments must continue implementing the Oplan Iwas Paputok campaign in their areas of responsibility, local governments must prohibit the use of pyrotechnic and firecrackers in residential areas with corresponding punitive actions for persons caught exploding and those causing injury to others, everybody must step up efforts to encourage the participation of the public, parents and children to find alternative ways of celebrating the Yuletide season without adding risk to their health, most especially the children, all concerned must refraim from using children in their fireworks-related activities and for the DOH and other agencies to continue lobbying for the total sale and use of firecrackers./By Dexter
