BAGUIO CITY - The National Commission on Indigenous Peoples (NCIP) is set to cancel some of the Certificates of Ancestral Land Title (CALTs) irregularly issued in the city including their derivative titles, Mayor Mauricio Domogan said on Wednesday.

The mayor who attended the meeting of the Task Force for Baguio City and Boracay Redevelopment last Wednesday where the CALT and other land issues of the city were tackled said the NCIP representatives reported finding irregularities in three of the five CALT cases in the city being investigated by the commission. The two other cases are still being probed.

The city has questioned CALTs issued over tracts of land within Forbes Park in South Drive, Wright Park, Botanical Garden, the Casa Vallejo property along Upper Session Road, Loakan Airport and the Dairy Farm at Green Valley. It was not specified which were covered by the three cases said to have been finished by the commission.

"Since some of the cases are pending before the Supreme Court, it was agreed that the city through the office of the city planning and development officer and the city legal officer will complete its research on all the derivative titles so the notices of lis pendens or the order of the Supreme Court against transferring these lots can be annotated to the titles to save possible buyers of said lots," the mayor said.

## US Army Knocks 2-Star Down to 1-Star Rank

WASHINGTON (AP) — A two-star U.S. Army general faulted for failing to properly investigate a sexual assault and other accusation against a colonel on his staff in Japan will be retired at one-star rank, the Army announced Wednesday.

The decision by Army Secretary John M. McHugh comes more than a year after Maj. Gen. Michael T. Harrison was suspended from his duties as commander of U.S. Army forces in Japan.

His case has been cited as evidence of why sex-crime victims say they don't trust the military to protect them, despite efforts by senior Pentagon officials, including Defense Secretary Chuck Hagel, to make commanders accountable.

In March, the Pentagon turned back an effort in Congress to strip commanders of the authority to prosecute cases, especially those related to sexual assault, and hand the job to seasoned military lawyers.

An Army inspector general's investigation report released in April said that in March 2013, when a Japanese woman accused the unidentified colonel on

Harrison's staff of sexually assaulting her, Harrison waited months to report it to criminal investigators. That was a violation of Army rules.

Despite Harrison's suspension, the Army brought him to the Pentagon to make him director of program analysis and evaluation for an Army deputy chief of staff. The Washington Post reported in April that he received an administrative letter of reprimand in December 2013 for mishandling the sexual-assault case and other complaints in Japan, but remained on active duty.

Under federal law, commissioned officers retire at the highest rank in which they are determined to have served satisfactorily.

"The secretary determined that Maj. Gen. Harrison's highest grade of satisfactory service was as a brigadier general," the Army said in a brief statement announcing McHugh's decision.

### Miriam Says She's Ready to Run She added that she only needs to

for President

Nearly two months after announcing that she has lung cancer, Senator Miriam Defensor Santiago seemed to be back in fighting form Wednesday, as she said she is ready to run for President anew.

"I'm not going to be coy. Society leaders have urged me to seek the presidency. I can rise to the occasion, although I was following the other sign posts on the road to recovery," the senator said.

Among the leaders Santiago was referring to was Jesuit priest and constitutional law expert Joaquin Bernas, who in a TV interview advised President Benigno Aquino III against a second term.

Besides citing the constitutional prohibition on reelection for presidents, Bernas, a member of the 1987 Constitutional Convention, said Aquino should "give Miriam [Santiago] *naman* a chance."

"I have licked cancer, and I'm actually thinking of several career options. By 2016, I will be disqualified by law to seek another term as senator," said Santiago, who ran for president in 1992.

The senator said her doctors have found that the tumor in her left lung has regressed after six weeks of medication called tarceva. "[T]he cancer cells are waving a white flag," Santiago said. She added that she only needs to work on her stamina now, adding that she was even able to work on the 2014 editions of some 10 law books which are scheduled for release by the end of the year.

As for the party under whose banner she will run, Santiago, who has always ran under her own People's Reform Party, admitted the likely need to form an alliance with other political parties.

Among them are the Liberal Party of President Benigno Aquino III, now headed by Transport chief Emilio Abaya, and the Nacionalista Party led by former Senator Manny Villar.

Santiago said Villar hinted at willingness to support her during his visit at her home. "But he also said that he is encouraging several hopefuls to raise their survey ratings," Santiago said./By <u>Kim Arveen</u> <u>Patria</u> | Yahoo Southeast Asia Newsroom

Pacquiao said he would visit the academy "once a month, once in three months, to supervise them."

## Pacquiao to help Set up Boxing Academy in China

MANILA, Philippines (AP) — Manny Pacquiao is setting up a boxing institute in China and believes the country of 1.4 billion people can produce professional world champions.

Pacquiao said Wednesday that he has partnered with a Chinese company and the Chinese government to set up an institute in his name, with the aim of imparting the experience that has seen him win eight world titles.

He was speaking from Shanghai where he is promoting his Nov. 22 fight against Chris Algieri for a WBO welterweight title in Macau. He will be defending the welterweight crown he won in a rematch earlier last year with Timothy Bradley, avenging his 2012 loss.

Pacquiao, 35, said the Manny Pacquiao Boxing Education Institute will "start in Beijing, and the plan is for the whole of China." While China has produced accomplished fighters and Olympic champions at amateur level, there is potential to translate that to professional ranks, saying the local boxers "just need some knowledge about boxing and should be taught the basics."

"Of course, with 1.4 billion population for the whole China, they can produce good fighters like other champions," he said.

Pacquiao, who is also a congressman, told ABS-CBN television in Manila he intends his new venture to also foster warmer relationships between the Philippines and China, whose territorial dispute in the South China Sea has intensified in recent months.

"This will even help in strengthening our relationship ... especially since in this project, the Chinese government is involved," he said.

## Cayetano Dares VP Binay: Answer Allegations of Former Makati Vice Mayor

Senate Majority Leader Alan Peter "Companero" Cayetano on Tuesday dared Vice President Jejomar Binay to disprove the allegations of his former ally that he pocketed kickbacks from the construction of the controversial Makati parking building during his term as city mayor.

"We want to give the Vice President all the opportunity to answer. We should give the Vice President an open invitation...Let me assure you, as far as I am concerned, that we will give all the courtesy and all the time to the Vice President," he said.

Appearing before the Senate Blue Ribbon subcommittee hearing, former Makati Vice Mayor Ernesto Mercado admitted that he got kickbacks from the project and that it was "impossible" that Binay did not get a bigger share.

"Sabi mo (Vice Mayor Mercado) magiging ipokrito ka kung sinabi mong hindi ka nakinabang. By nakinabang, meaning kumita dito sa building na ito. Ngayon, kay Vice President o kay dating mayor Binay, kumita din po siya? So, you know it as a fact. Yan ba ay one time lang, sa bidding lang na ito, o sistema na ba yan sa Makati na meron kang kaunti, meron din si VP?" Cayetano asked Mercado.

Mercado said it was part of the system or "kalakaran" for the top city officials to benefit from such projects.

Cayetano argued that the P2.7-billion parking building is clearly overpriced based on the "anti-lokohan book" used in the private sector.

Citing the Davis Langdon & Seah (DLS) handbook used primarily by quantity surveyors, Cayetano said that in the year 2012, the construction of car parks ranged from P17,000 to P20,000 per square meter; standard offices, P31,000 to P39,000, prestige or high-rise offices, P43,000 to P49,000, and general hospitals, P49,000 to P59,000.

In the plunder charges filed against the Vice President and his son, incumbent Makati Mayor Junjun Binay, the complainant claimed that the pricey building had an average cost of P84,000 per square meter.

Cayetano also showed photos of the Makati building's ceiling, parking Cont. on page 11

## **Dominican Retreat House** now Protected Heritage Site BAGUIO CITY - the 100-

year-old Dominican Retreat House which housed the pioneering Dominican priests in the country is the latest addition to the roster of National Historic sites in the country.

The National Historical Commission of the Philippines (NHCP) and the City Government September 1 unveiled the historical marker declaring the Dominican Hill and Retreat House as a protected historical property.

The historical marker was placed at the right side of the door of the structures main entrance showing the name of the structures, the year it was built and a description of its history.

The unveiling of the marker spruced-up the celebration of the 105th Baguio Charter Anniversary and strengthening the cities resolve in the preservation and protection of its historical buildings and structures.

Highlighting the milestone ceremony is the signing of the Memorandum of Agreement (MOA) between the city government spearheaded by Mayor Mauricio Domogan and NHCP Deputy Executive Director Carminda Arevalo for the turn-over and transfer of the historical marker and the responsibily that goes along in attaining the prestige and importance of the structure as a national historical site.

The Dominican Heritage Site passed thorough validation by the NHCP before it was declared as a national historical site following the strict guidelines set by the Commission.

The structure was validated and verified by elements of the NHCP, its historical background and significance going through a lengthy and thorough research.

The Dominican Retreat House was first conceptualized in 1911 after the Dominican Order in the Philippines voted for the construction of a rest and recreation house for Dominican Priests in their 17hectare property in Baguio City which they acquired from the American authorities

It was in 1913 under the leadership and design of Fr. Roque Ruano, OP, a Dominican priest that the construction of the building began.

The retreat house was finished after two years and was inaugurated on May 23, 1915.

To take advantage of tax exemptions, a school was established and opened in 1915 named 'Collegio del Santissimo Rosario.'

Soon thereafter or within a span of just two

## Efficiency Rating in Tax Collection

BAGUIO CITY – The city government attained a high collection efficiency rating of 102,71 percent on local revenues for the first semester of the year earning a very satisfactory rating of 94.35 percent from the Bureau of Local Government Finance (BLGF) regional office.

This was bared by BLGF Cordillera regional director Ricardo Cawed, in a letter to city treasurer Alicia Onoza transmitting the city's Unit Performance Evaluation sheet (UPEs).

"This office would like to congratulate the City Treasurer and the staff for the notable collection efficiency they realized. We look forward that you sustain such performance in you revenue generation and treasury operations," Cawed noted.

As per the report, the city exceeded its first semester collection targets for three local revenues namely real property, business and other taxes and fees and charges.

For real property taxes, the city collected P140.39 million against its target of P136 million for a 103.23 percent collection efficiency rating. For business and other taxes, the city collected P210.72 million against its target of P210 million for a 100.34 percent efficiency and for the fees and charges, the city posted a 118.01 percent rating with its collection of P91.69 million visà-vis its target of P77.7 million.

The city however fell short in its collection from economic enterprises, with 87.94 percent rating (P45.29 million as against the P51.5 million target).

Mayor Mauricio Domogan commended Onoza and the personnel for the feat saying it is a product of everyone's effort in the department.

He however said the accomplishment should not lull the team to complacency but should prod them to continue striving to improve the collection efficiency./A Refuerzo

It served as refuge of Dominican priests and Filipino Families during the Japanese Invasion in 1942.

It was bombed by the Japanese Imperial Forces and incurred heavy damage.

After years of disrepair, reconstruction started in 1947 and was finished in 1948

In 1973, Diplomat Hotels Incorporated acquired ownership of the building remodelling the interior into a 33 bedroom hotel but retaining its unique and distinct personality.

However, the hotel ceased operations in 1987.

The city government acquired ownership of the property in 2005.

The Dominican Hill and Retreat House is one of the oldest structures in the country which boasts of Dominican Architecture and design withstanding the test of time/paul rillorta

**COMELEC** Baguio City election officer John Paul Martin sought the mayor's assistance in disseminating the registration schedule to reach out and encourage more qualified citizens to avail of the registration process.

Martin said the registration is in line with the provisions of Republic Act 10367 which mandate that ... "registered voters with no biometrics (digital photograph, digitally captured signature and fingerprints) will be deactivated.'

"While they have been able to vote in the past, they will no longer be able to participate in the 2016 elections if they do not have their biometrics taken by the end of the current registration period," Martin said.

The offsite registration

was piloted at City Hall last July 7 and has since been conducted per barangay district.

Today August 31, the COMELEC will set up registration at City Camp Proper barangay to cover district 5 and will move to district 10 on Sept. 7 at Upper General Luna barangay hall. On Sept. 14, the registration will be held at East Bayan Park to cover district 9. District 12 will follow on Sept. 21 with the venue still to be determined and District 8 registration will be held on Sept. 28 at the Camdas Multipurpose Hall.

The schedule for October will be: Oct. 5 - district 20 at the M. Roxas barangay covered court; Oct. 12 - district 1, Pacdal covered court; Oct. 19-district 3 at the Hillside barangay hall; Oct. 26-district 11 at Lualhati barangay hall.

November: Nov. 9 district 6 at MRR Queen of Peace barangay hall; Nov. 16 - district 13 at Camp 8 police station; Nov. 23 - dis-

## Contrasts

"Lights are stronger in the contrast." Charles Dickens' line came to mind when TV footage showed Vice President Jejomar "Jojo" Binay clad in starched barong, flinging instructions at aides, trying to look, well, presidential. He did not differ from the suave but lagging-in-the-polls Interior Secretary Manuel "Mar" Roxas II.

See the stark contrast in the seventh president-elect of Indonesia: Joko "Jokowi" Widodo, 53. Binay is 71 and has no assurance he'll enter Malacañang after the 2016 elections. Come October, Widodo will work from the white-colonnaded Merdeka Palace.

"Joko appeals to ordinary Indonesians and international business," Michael Bachelard wrote in the Sydney Morning Herald. The skinny kid, whose family lodged in a bamboo shack and was evicted thrice, is "a breath of fresh air—the best hope Indonesian democracy has yet produced to end corruption and cronyism entrenched by a cozy usually exmilitary elite."

Like Widodo, Binay was a man of modest means—at the start. "Back in the mid-1980s, I covered Binay as a human rights lawyer. He was anything but wealthy," blogged Raissa Robles, Manila correspondent of South China Morning Post of Hongkong and Radio Netherlands.

Not anymore. "When I interviewed Binay shortly before his June 2010 inauguration, I was astounded by his huge, fully airconditioned dining room and by the bountiful breakfast there—like a hotel buffet complete with ham, bacon and cake for dessert. His kitchen is industrial-type.

"I know because I was made to pass through the kitchen door" and saw his huge, long dining table, fully carved chairs, old religious icons on display, etc. "The ceiling centerpiece is a lovely Venetian-type chandelier." So, when Binay displayed his paksiw na isda at

### honor, the obvious PR bid boomeranged.

Widodo's wife Irina shies from the public limelight, unsullied by scandal. They shield their five children from publicity. In contrast, Dr. Elenita Binay is a political figure on her own. So is the family. They battle several raps—from sleaze to abuse.

Doctor Binay's lawyers will sue a special prosecutor of the Ombudsman for reviving cases against alleged overpricing of hospital beds at the Ospital ng Makati when she was mayor. "That was dismissed with finality three years ago," she fumes.

Binay's son has not tamped down the "Makati gate" scandal. Subdivision guards told his convoy the gates were closed for exit at 10 p.m. and to use the alternate exit five minutes down the road. He spent an hour berating, then arresting, the guards.

The election of Widodo demonstrates "for the Philippines and Malaysia a break from dynastic politics," writes Philip Bowring, Asia commentator for the International Herald Tribune and former editor of Far Eastern Economic Review. For Burma (Myanmar) and Cambodia, he says, Indonesia shows genuine elections can produce change without chaos provided power holders concede or institutions are sufficiently responsive to prevent elections from being hijacked.

"In Thailand, the military's solution has been to abolish voting because of the embarrassment of having to nullify the results in the name of a king who appears incapable of speech and a crown prince incapable of being respected."

Bowring continues: President Aquino the son was elected because of his name and the nation's respect for his parents. In previous years, he appeared to have made most of the right decisions. And he led his country to a less corrupt, more dynamic future with social reform as well as economic growth. But his image is tarnished by disrespect for the constitutional process.

Did this come from "an assumption that the Aquino names and his own previous high standing would prevail"? His confrontation with the Supreme Court has had a disastrous impact that will hobble his remaining time in office, Bowring notes.

"So is there a Philippine Jokowi in sight?" Bowring asks. Absolutely not. And yet one is needed at least as badly as Indonesia did.

Bowring answers himself: "As of now the leading contender is Vice President Jejomar Binay. He lacks the reputation for personal integrity that Noynoy enjoyed; he is (also) a classic exponent of dynastic politics." At the local level, he was succeeded by wife and son as mayor of Makati and at the national level by a daughter who became a senator despite minimal experience.

"Then there is the Marcos clan. (They) continue to be reelected ad infinitum despite the fact that the patriarch, Ferdinand, stole billions from the treasury and generated a kleptomaniac class that ruined what had been a vibrant economy." In contrast, "Singapore's Lee Hsien Loong has the good sense to keep his offspring and relatives out of politics."

Bowring then looks to other countries: Next up for a desperately needed break from dynastic politics is Malaysia. Najib Tun Razak is the son of one prime minister and an inlaw of another. Leaders in the ruling party include the son of one prime minister and grandson of Umno's (United Malays National Organization) founder. Mukhriz Mahathir is the son of former prime minister Mahathir Mohamad.

"Numerous offspring of former Umno bigwigs feed at the great Umno trough. The opposition too is prone to dynasties as well. Lim Kit Siang's son runs Penang and the Democratic Action Party and Anwar Ibrahim's wife and daughter are very active in his support."

In Bangladesh, democratic politics has for years been undermined by the dynastic appeal of two feuding women and their families. In Sri Lanka, family rule has replaced both party rule and real democracy with a dangerous and perverted pseudo-democracy.

"The Philippines and Malaysia need outliers in the mould of Joko: men of unquestioned integrity" and who "spread power to newer groups and individuals." Tell that to Binay now on the campaign slog./Juan L. Mercado

*"WHY NOT WIPE OUT THE MILF REBELS?"*

I sat over a few bottles of SanMig lites a few nights ago with a friend who just arrived from abroad. He asked several pointed questions about the still on-going MILF peace talks: why can't the military just wipe them out? Why compromise or give in to the demands of armed rebels when they should instead be made to answer for rebellion, taking up arms and violating the laws? Why are they allowed to establish camps that defy government? Why are they getting concessions more than those given to others who generally remained peaceful and law abiding? Does this mean that others will have to first take up arms before they get equitable attention and benefits? Why engage in peace talks with them, in the first place? Interesting and thought provoking questions indeed.

**ERAP'S WAR POLICY** — I answered him by anecdotal recollections. **President Erap Estrada** during his incumbency declared all out war against the MILF, attacked and overran rebel camps in 2000. In fact, President Erap's popularity rating reportedly went up due to his iron fist Mindanao policy against the rebels. Indeed the main MILF camp, the famous Camp Abubakar fell into AFP control. Many rebels were killed; their commanders were on the run. But when the smoke of war cleared, the MILF was still around. Although badly bruised, it still remained intact. They just moved to other camps and re-grouped their forces. They still retained the support of their Bangsamoro constituencies. Their rebellion continues to this day, although prospects of a negotiated peace and the ceasefire have momentarily quieted the guns of war.

**COST OF WAR** — I told my friend that the question that always begs an answer is this: what is the cost of war? And is it worth it? I explained to him that the "cost" referred to here is not only in terms of the peso cost of the conflict (bullets, bombs, armaments, logistics, etc) but the more unquantifiable, real SOCIAL COST on civilians whose lives are destroyed, disrupted, damaged due to conflict and fighting. The answer to this question surprised my friend. Unknown to him, about one million (*yes, 1,000,000*) Mindanaoans were directly affected by the Estrada war policy. Thousands of families were displaced and their normal lives disrupted, in-cluding the actual loss of lives of both soldiers rebels and civilians caught in the crossfire. This is not to mention the irreparable damage to the island region, now still being perceived as a war-zone and a troubled land to the outside world.

The extent of the damage of the Estrada war policy was so extensive and deep that during my whole nine (9) years in Malacanang in the Arroyo administration that followed, the healing of the wounds of war and the normalization of lives and the return and rehabilitation of those displaced continued to be a high priority task of the Mindanao agency I headed. Again, during the Arroyo administration, the AFP went on an offensive and dislodged MILF guru **Hashim Salamat** and his forces from his hideaway in Buliok, Pikit in the periphery of Liguasan Marsh. The MILF again suffered heavy casualties and dispersed in various directions. The civilian population suffered the most. When I left government in 2010 or about 10 years after the first offensive, it was an unfinished task; the work to help those who suffered the so-called collateral damage of war was not yet fully done. Up to this day, we still ask the questions: did the war Policy quell the rebellion? Despite its obvious superiority, did the government win the war? Was the social cost of war worth the outcome? Is the military solution the answer? Yes, we need the AFP to periodically remind the rebels **Cont. on page 13**

One newspaper in fact said it quite clearly: the wife was battered, got comforted by a businessman, who then ordered the liquidation of the wife's husband.

### World-class building or world-class palusot?

### Cayetano calls on media, Filipino people to do ocular inspection of 'overpriced' Makati parking building

Senate Majority Leader Alan Peter S. Cayetano called on the media and the rest of the Filipino public to do an ocular inspection of the allegedly overpriced Makati parking building to determine for themselves if the structure is indeed worth taxpayers' money.

At the same time, Cayetano said the P2.3-billion Makati parking touted as a "world-class building" will end up as a "world-class palusot" if Vice President Jejomar Binay would refuse to appear in the Tuesday hearing of the Senate Blue Ribbon subcommittee.

Cayetano said Vice President Binay as well as his son, incumbent Makati Mayor Junjun Binay, should also welcome an ocular inspection of the 11-storey Makati parking building, the subject of plunder and graft charges filed against them.

"I think the ocular inspection would be good because we've been dealing with pictures from the outside pero hindi natin nakikita yung building talaga eh. Hindi pwede mag-sinungaling ang litrato at ang TV. Tao na rin ang huhusga kung ito ay world-class building o worldclass palusot," he said in an interview on dzBB radio.

"Asking the hard questions is not being a bully. I can assure the Vice President that he will be treated well."

## Gov Keen on Closing Road to Mount Pulag

BOKOD, Benguet - Benguet Governor Nestor Fongwan is keen on closing a road being used in transporting illegally logged trees and other illegal activities at the Mount Pulag National Park here.

Fongwan said that reports reached his office that a road was opened by still unidentified individuals in Sitio Naubanan in Ekip, Bokod which is part of the forest reservation of the Mt Pulag early this year and this is being used for illegal activities such as the transport of trees which were illegally cut down and the transport of agricultural supplies for farmlands which were illegally acquired.

Fongwan said that upon the recommendation of Bokod Mayor Mauricio Macay and the request of some residents, the more than 4-kilometer road from Ekip, Bokod passing thru Naubanan and leading to Kayapa, Nueva Vizcaya needs to be closed down due to the extent of illegal logging and agricultural conversion being done in the area.

According to Fongwan, the road was constructed without permits from the local government units and the other government agencies particularly the Department of Public Works and Highways and the Department of Environment and Natural Resources who manages the national park. The DENR has not issued an Environmental Compliance Certificate for the road opening in the area.

In May this year, the Joint Provincial and Municipal Anti-Illegal Logging Task Force conducted an inspection of the Naubanan Area passing thru the road and discovered more than 10 hectares of forest land were cleared thru kaingin or the slash and burn farming and converted into agricultural lands.

Although cases have already been filed in court against three individuals who were identified to have been doing the kaingin system in the area, Mt Pulag National Park Superintendent Emerita Albas said that the road closure in Naubanan is necessary to prevent more damages to the national park.

Albas has recommended the road closure in the Regional Peace and Order Council and the Regional Law Enforcement Coordinating Council.

Meanwhile, the Governor believes that illegal activities in Mt. Pulag forest reservation will be deterred with the presence of police at the newly inaugurated Community Police Assistance Center at Badadac, Mt. Pulag. Although it serves as a tourist information and assistance center, the main purpose of the COMPAC station is for the protection of the Mt. Pulag National Park from illegal logging and other illegal activities./JDP/RMC- PIA CAR

## **Centers for Mr – OPV Vaccinations**

BAGUIO CITY - The City Health Services Office (HSO) is calling on parents to bring their children below five years old(0 to 59 months) to the district health centers to avail of the free MR - OPV (Measles Rubella -Oral Polio Vaccine) this September.

**Baguio HSO City Epidemiology and Surveillance Unit** head Dr. Donabel Tubera, in an interview, announced that the free MR-OPV vaccination is part of the nationwide campaign of the Department of Health (DOH) for the whole month of September. Baguio will start the campaign on September 2.

Tubera pointed-out that measles remains a local and national concern and though it is highly infectious and deadly especially among children, it is also preventable through immunization.

For Baguio, Tubera reported that from 46 cases in 2013, there is a very considerable increase with 146 cases already recorded from January to June of this year.

For polio the mass (oral) vaccination, this is in line with the health department's goal of Polio-free Philippines.

"For us to achieve 100 percent coverage, parents should bring their children to the district health centers, whether they already had the vaccine or not. All of the 16 district health centers in the city are set to provide them service, Monday to Friday, 8:00am to

5:00 pm from September 2 to 30", Tubera said. The OPV is for children 0 to 59 months old while the MR vaccines are for 59 nine to months old children./JDP/CCD - PIA CAR

He said that since the protracted move to cancel the CALTs in the city is unprecedented, it will serve as a model for similar cases in other parts of the country. The commission in a resolu-

as null and void 75 CALTs and Certificates of Ancestral Domain Titles (CADTs) which were known as "midnight titles" as they were issued towards the end of the term of office of the first commission.

Seventy four of the titles cover lots in Baguio mostly in Mines View and Loakan while one had no determined location.

In the resolution, the NCIP admitted that there were CADTs and CALTs issued by the first commission "under anomalous or irregular circumstances and conditions such as but not limited to: the paper used was not official or security paper; signatures of Commissioners were incomplete; one or more Commissioners disowned their signatures or claimed that they signed without the benefit of en banc meetings; basic data/information i.e. survey plan and technical description were not available; and there was just no sufficiency of proof on record of the ownership of such domains/lands as required by the IRR applicable at that time."

The resolution however said that the declaration "would not prejudice the right of any legitimate... claimant provided the current applicable and pertinent rules... are properly observed..."

The mayor reported more headway in the city's bid to have the spurious CALTs issued over tracts of government and forest reservations in the city annulled.

He said the NCIP finally agreed to come up with a separate implementing rules and regulations to cover Baguio in line with the provisions of section 78 of Republic Act 8371 or the Indigenous People's Rights Act.

Section 78 of the IPRA law provides a special provision that the city of Baguio "shall remain to be governed by its Charter and all lands proclaimed as part of its townsite reservation shall remain as such until otherwise reclassified by appropriate legislation ..." It also provides an exemption that "prior land rights and titles recognized and/or acquired through any judicial, administrative or other processes before the effectivity of this Act shall remain valid ... " which according to the mayor means that Igorot claims recognized before November 1997, the date of IPRA implementation, are qualified as ancestral claims.

He said they agreed that the new rules should be issued before the end of September this year.

Apart from this, it was also agreed that NCIP and other agencies must comply with due process in the issuance of CALTs which means that stakeholders will have to be consulted before the issuance of said titles.

The mayor during the meeting also asked the Office of the Solicitor General to initiate cancellation proceedings over titles issued to a lot covered by a 211 title located in Busol watershed and to fasttrack the nullification of the so-called expanded titles which as identified during the time of former mayor Braulio Yaranon are: Original Certificate of Title No. -0-128 covering an area of 10,300 square meters which was resurveyed and subdivided and increased in area to 511,556 sq. m. or 51.1556 hectares located in Dontogan; TCT No. T-12826 covering an area of 501 sq. meters which was resurveyed and subdivided and increased in area to 155,795 sq. meters or 15.579 hectares in Pacdal; and TCT No. T-9463 covering an area of 1,000 sq. meters which was increased to 4,483 sq. meters./A Refuerzo

that they cannot continuously operate with impunity. In fact, such military offensives are also "incentives" for the rebels to stay the course in the peace process. It also served as a stern warning that walking away from the negotiating table could bring peril to them and to their cause. But, can this bring lasting peace? We know the answer.

ALL-OUT PEACE —Here's another cogent recollection I shared with my friend. I recall when President Arroyo took over from President Estrada in 2001, she immediately reversed the Erap all-out war policy and enunciated the policy of all- out peace and the primacy of the peace process. Among the first things **PGMA** did upon assumption right after Erap left Malacanang was to issue a Letter of Instruction, which laid down the framework of the pursuit of peace through negotiated settlement. It was to pick up from where President Ramos left off. I was her first chief negotiator to put back on track FVR's peace initiatives with the MILF.

RE-STARTING TALKS --- I cannot forget that day in 2001 when I first entered an MILF controlled territory somewhere in the boundary of Maguindanao and North Cotabato. Immediately after I got the marching orders from PGMA to "re-start" the peace talks, I brought relief assistance to thousands of evacuees, mostly MILF families. It was also to give me "cover" for my secret, exploratory, informal face-to-face meeting with an emissary of then MILF Chairman Hashim Salamat. I remember meeting him who was wearing a bull cap inside a dark, small hut with all windows shut. I can't recognize him if I meet him again. The late Ustadz Salamat's favorite nephew, the late businessman Ebrahim " Toto" Paglas, my close friend, brokered the icebreaker. Former AFP chief of staff, Gen Hermogenes " Jun" Esperon Jr., then a colonel and brigade commander in North Cotabato refused to let me go alone and volunteered to escort me but he had to shed off his military uniform to disguise as my civilian companion in a hostile territory. The risk paid off. In a few weeks, then **OPAPP Sec. Eduardo Ermita** shook hands with MILF's Kagi Murad in Kuala Lumpur signaling revival of peace talks. After 3 months, I signed in June 2001 in Tripoli, Libya as chief negotiator, the landmark Agreement for Peace that served as the framework and roadmap in the subsequent conduct of peace negotiations. By the way, it was in that Tripoli trip when I met face to face with the late strongman Moammar Khadafi in his desert tent in Sirte. (Of course with his pet elephants trucked in by container vans in the background served as fascinating props.)

DEFEATING REBELS --- One poignant event during my work in the Arroyo government also stood out that I also considered instructive as I pondered on those questions posed by my "balikbayan" friend. I related to him what happened during a Malacanang high-level closed door, command conference of the security sector. One Army general was a bit candid about his reservations on a ceasefire mechanism with the MILF, which we discussed. He was describing it as unfairly tying the hands of the soldiers while they fought the rebels. I sensed it was a common sentiment among the uniformed participants. To cut him off, an exasperated high official snapped a question: "Tell me honestly, General. Can you and the AFP decisively and militarily defeat the MILF? If your answer is in the affirmative, there's no more need for this meeting!" The Army General did not answer. No one in the room stirred. After a while of silence, the high official merely said: "I hear none. The answer is clear. Let us now proceed." I pondered for a while on the significance of what took place. Many years passed and up to this day, that episode kept coming back. It was a reality check. It simply taught me that force of arms does not and cannot extinguish the Bangsamoro grievances: that the root causes of rebellion must be addressed; that a negotiated settlement is the way forward.

WHY TALK PEACE? The inevitable question that my friend asked was: why hold peace talks, in the first place? Well, here are a few of my thoughts that I passed on to him:

First, government recognizes that the rebel group has valid grievances that must be addressed and redressed;

Second, government being on a high moral ground must be ready to grant concessions to address those grievances; Third, improving the lives of the affected constituencies, especially those deprived, is key;

Fourth, government cannot decisively defeat the organized rebel group in armed combat without great social cost to the general population;

Fifth, peace engagement with mainstream rebels who are willing to negotiate can isolate the extremists and the radicals;

Sixth, the government due to its superiority can win battles but it cannot win the war unless it wins the hearts and minds of those who had suffered injustices and exclusion;

Seventh, social cohesion or understanding amongst diverse groups in Mindanao and their acceptance of their respective diversities and differences help bring about peace;

Lastly, peace through a negotiated settlement, although difficult than conveniently and easily pulling the triggers of war, is more desirable, durable and sustainable.

**TASK NOT EASY** — The work for a negotiated peace settlement is not the proverbial "walk in the park". Accommodating the aspirations of those who have already forsaken normal processes

of redress and to be done by government that must adhere to those processes (like the Philippine constitution that the rebels disavow and reject) is not an easy task.

**CRUCIAL** — If crafting an agreement is already that difficult, how much more if we talk about IMPLEMENTATION? Indeed, the most crucial is HOW TO IMPLE-MENT what has been signed and to meet the high expectations of all. I've seen it up close with the 1996 peace agreement with Nur Misuari's MNLF that up to this day is still troubled by implementation issues.

In the case of the present agreement with the MILF, we are still not there. As of today, we are still awaiting the release by Malacanang of the final draft of a bill that if passed by Congress can get us going.

## **RITMT Reports 50% Decrease** in Smoke Belching Fines

BAGUIO CITY - the Roadside Inspection Testing and Monitoring Team (RITMT) under the City Environment and Parks Management Office reported this week that the collection of fines for the Anti-smoking ordinance decreased by 50 percent here.

The data showed only P256,050.00 in fines from smoke belching vehicles was recorded for the period July 23 to August 20 which is 50 percent lower than their collection of P626,400.00 for the period March 27 to May 21 this year.

As per report of Wastewater, Water and Ambient Air Management Division (WAMD) Chief Engr. Moises Lozano, the fines were derived from the apprehension of motorists in violation of the Anti-Smoke Belching Ordinance of the city.

Engr. Sofronio Pascua clarified, "the decrease in fines mean motorists are now more compliant and aware of the existing ordinance."/PIO

## City Establishes Busol

BAGUIO CITY - the City Government has taken a big leap in the protection of its remaining forest reserves by securing a portion of the Busol Watershed here.

Barbed wire fences however were installed to protect the area from further encroach-

As per reports from the CEPMO, at least five houses made of light materials are inside the tree nursery area which will be subject to investigation and appropriate action.
