Secretary Belknap left Washington for the West, last night.

All the members of the Cabinet were present at the meeting, yesterday, excepting Mr. Creswell.

The Whipple bleachery in North Providence, R. I., run by Robert Heaton, was burned early yesterday morning.

The "Liberal" Republicans of Cincinnati have indorsed G. W. C. Johnson, the Democratic nominee for Mayor.

Webotuck Hall, at Millerton, N. Y., was damaged yesterday by fire to the amount of \$2,000; insured.

The Republicans elected Wm. D. Garrison Supervisor of Philipstown, Putnam County, N. Y., by a large majority.

Tom Burke, a notorious cabman, in New Orleans, was shot and killed by Robert Despercy yesterday morning.

Hon. Arthur M. Hunter, of Schenectady, N. Y., was nominated by acclamation, for Mayor, by the Democrats, yesterday.

The reported loss of the bark Arethusa, from Bristol, and the drowning of ten men, is declared from Savannah, Ga., to be incorrect.

Two contributions were made to the conscience fund, yesterday—one from New-York of \$50, and the other of \$3, from Washington.

Printing cloths in Providence, R. I., yesterday, were weak and lower; best sixty-four squares 7 to 7½ for contracts and spots.

Allison Hayes and A. J. Martin, both convicted of Kuklux outrages in South Carolina, have been pardoned by the President.

The Third Auditor has stated and reported to the Second Controller over 700 Southern claims which have been awarded. Only about 150 now remain.

At 9 o'clock yesterday morning the Baptist Church in Poughkeepsie was damaged to the amount of \$3,000 by fire; the loss covered by insurance.

Rev. Francis Donnelly, a well-known Methodist clergyman, died suddenly, on Thursday afternoon, at the residence of Caleb Thompson, near Sing Sing.

Rev. Father Mackin, pastor of St. John's Catholic Church, in Trenton, N. J., died there on Thursday night. He was much respected by all denominations.

Thomas Frohock, of Lincolnville, Me., a well-known business man, died suddenly, on Thursday night, of heart disease, at the age of sixty-two.

The General Assembly of Rhode Island adjourned last night after a session of eleven weeks. The Scup bill and new State-house project failed, the latter by one vote.

J. Balender was arrested in St. Louis yesterday for obtaining by false pretenses several thousand dollars' worth of jewelry from the firm of Hirsch & Hoffenheimer, of New-York.

On Thursday, in Loraine, Adams County, Ill., Annie Adair was arrested on a charge of poisoning her husband in January last. The stomach will be examined by chemists.

C. W. Ward was arrested in St. Louis yesterday for committing a murderous assault on his wife, in which he stabbed her with a knife, fractured her skull, and beat her in a shocking manner.

A bill has passed both branches of the Michigan Legislature, after stubborn opposition, providing for the appointment of two professors of homeopathy in the medical department of the State University.

Henry K. Bowman, of Philadelphia, has recovered damages amounting to \$4,000, from the Baltimore and Ohio Railroad Company, for injuries sustained on the Parkersburg branch road, in October, 1870.

The Coroner's jury in Boston find that the death of Charles Mahan, which occurred a few days ago, was caused by his being thrown downstairs by McGloane and Kerrigan in a drunken fracas.

In the case of Cora A. Drisko, who was run over at Park-street crossing, Boston, by an engine on the Providence Railroad, a Coroner's jury found that trains are run at too great speed at that point.

An official statement shows that the total number of persons in the United States who were assessed for income during the years 1871 and 1872, under the act of July 14, 1870, were 74,775 and 74,337, respectively.

Richard Whitney, aged seventy-three years, for many years in the service of the Lake Shore Railroad, was run over and probably fatally injured yesterday by a carelessly driven wagon in Boston.

The application of Samuel Miller and others, of Stanislaus, Cal., to purchase, under the act of July 23, 1866, lands within the rejected Roland grant, has been rejected by the Commissioner of the Land Office.

Morrison, a former porter in the Matteson House, in Chicago, who is accused of stealing a satchel containing \$5,000 worth of jewelry from an agent of Elcox & Co., of Newark, N. J., some weeks since, has been arrested in Montreal.

A man registering the name of George M. Snow, of Concord, N. H., was found dead, yesterday, in his room at the Tremont House, in Lowell, Mass. He was about fifty years of age. It is supposed that he committed suicide with morphine.

Hon. W. P. Sprague, member of Congress from the Fifteenth Ohio District, will either return the sum of money voted as back pay for the Forty-second Congress to the Treasury of the United States, or devote it to the relief of tax-payers in his district.

The balances in the United States Treasury at the close of business, yesterday, were: Currency, \$2,116,052; special deposits of legal tenders for the redemption of certificates of deposits, \$28,445,000; coin, \$70,415,961 49, including \$25,007,500 in coin certificates.

In the Superior Court in Springfield, Mass., yesterday, Henrietta L. Hitchcock, of Belcher-town, obtained a verdict of \$4,000 against Merrick Wood, of Chicopee, for breach of promise of marriage. Their betrothal occurred eight years ago, when the plaintiff was only fifteen years of age.

The Superior Court of the Ninth Judicial District of North Carolina has issued an order restraining and enjoining the commissioners from selling the Wilmington, Charlotte and Rutherford Railway, advertised to be sold April 10, under a decree of the Superior Court of New-Hanover County.
