BAGUIO CITY - The city government is working out the demolition of some 55 illegal

structures at the government property referred to as Benguet-Ifugao-Bontoc-Apayao-Kalinga (BIBAK) lot along Harrison Road here.

Mayor Mauricio Domogan last Wednesday said the city anti-squatting committee is preparing a resolution for the issuance of demolition orders for the dismantling of these structures based on the investigation report of the city building and architecture office (CBAO) and the public order and safety division (POSD).

The mayor said even the Regional Development Council (RDC) has expressed support to the city government's plans to clear the lot of squatters.

The mayor said the occupants are not entitled to relocation privilege as they occupied the lot beyond the March 1992 cut-off period.

Last year, the city council served intention for the city to acquire ownership of the BIBAK lot and to apply for the acquisition of the land for public needs after confirming that the lot which remains a government property cannot be transferred to the Centralized BIBAK Association being a private

Young Mother of Two Seeking Dialysis Treatment Support

Thirty four-year old Evelyn Guiniguin-Bautista, a truck driver's wife and mother to two young girls, has been confined for a month now at the Baguio General Hospital and Medical Center for complications of kidney failure.

"She has difficulty breathing and is on oxygen support," her sister, Joanna Guiniguin-Dang-ay said last week . Joanna was making the rounds of offices, in search of gentle souls who could support her sister's twice-a-week hemodialysis treatment needed to cleanse the blood and prevent poisoning.

Evelyn, the fifth of nine children of "kaingin" (swidden) farmers Pedro and Antonia Guiniguin of Talnag, Ampucao, Itogon, Benguet, was diagnosed for end-stage renal failure last February.

She was experiencing dizziness and her face had bloated," Joanna recalled. "She has been on dialysis since then, scheduled at 3:00 p.m. on Wednesdays and 8:00 p.m. on Saturdays at the BGHMC.'

Problem was she had just used up a P17,600 guarantee support from the Philippine Charity Sweepstakes Office for the dialysis treatments pegged at P2,200 per session.

"She had applied for Philhealth membership but it will take sometime before she will be eligible for coverage," Joanna rued.

In a social case study report, social welfare assistant Sharon Baroa of the municipal social welfare and development office in Itogon said Evelvn's latest dialysis sessions were paid from a P5,000 donation of members of her church – the Assembly of

"The meager income of the client's husband (Ariel) as a driver earning P5,000 a month is being stretched to buy...the basic needs of the family, and if there is excess, it is often used for the education... of the children," Baroa pointed out.

The two kids, Arlene, 12, and Lyka, 11, go to school at the Philex Elementary School.

As Evelyn's cellphone was stolen, people who can help may ring up her sister Joanna's mobile (09109162377) or they may directly pay the cost of one dialysis session at the BGHMC during her scheduled treatment on Wednesday or Saturday./Ramon

Game Fowl Breeders Share P30,000 to Kids of the Blind

Local game fowl raisers last week-end added a humanitarian element to their hobby by providing P30,000 to help pay for the miscellaneous expenses of 43 children of members of the Baguio Federation of Visually Impaired Persons (BFOVIP).

Former city councilor Antonio Tabora Jr., Dr. Edward Dogui-is and Engr. James Oyaman represented members of the United Baguio-Benguet Breeders Association (U3BA) in handing over the support fund to the federation headed by Valentine Manginga during a program last Sept. 14 at the city social welfare and development office.

The fund came from earnings of the U3BA in cock derbies in coordination with the national association of game fowl breeders.

Dogui-is said one child per family was recommended by the BFOVIP to receive cash support ranging from P6,000 for each in the elementary grades and up to P1,000 each for those in high school to augment their regular stipends from their parents.

Tabora added that the U3BA is also set to distribute school bags to children before the end of the year, also as part of its social responsibility thrust.

On his own, U3BA member Gilbert Tanding recently began setting aside a regular fund from gate receipts during Monday hack fights at the Shilan Sports Arena in La Trinidad, Benguet for medical support to indigent patients.

Experimental Spillover Pay Parking System Eyed at **Burnham Park Roadsides**

BAGUIO CITY - The city government is eyeing the operation of a "spill over pay parking" along the roadsides of certain areas within Burnham Park on an experimental basis.

In Administrative Order No. 128, Mayor Mauricio Domogan said the city will explore the possibility of using Jose Abad Santos Drive, the Lake Drive and the side street near the picnic groove including the area adjacent to the Baguio City Police Office (BCPO) Children's and Women's Desk Office as "spillover pay parking areas."

The mayor said that at present these areas are being used as free parking spaces for vehicles but it is high time for the city to start collecting parking fees to be used for maintenance of the park.

At present, the city is using the site of the old auditorium as pay parking space for park goers but the area is not enough to accommodate the volume of vehicles.

In his order, the mayor decreed that the city through the city environment and parks management office- Burnham Park office (CEPMO-BPO) will have "full control, supervision and jurisdiction over the experimental parking operations and maintenance at the three selected roads inside Burnham Park."

Councilor Pushes Common Reference Material on Baguio

In its brief profile of Baguio, a website says the original inhabitants of this so-called Hill Station are "the Igorots, Kankana-eys and Ibalois". Wikipedia, the internet encyclopedia, counts this city's barangays at 129 and places its elevation at 4,760 feet and then at 5,200 feet above sea level.

Such disinformation and conflicting data would be corrected soon, at least by the city's tourist guides who would be duly accredited, should the city council adopt an ordinance providing a common reference material on facts and figures about the country's Summer Capital.

City councilor Elmer Datuin filed such measure last Monday to rectify errors. He pointed out that some information materials on Baguio "are at times inaccurate and may not be the best description for a historical site and thereby resulting to inaccurate information (being shared) to our tourists".

For starters, the truth was and is that the Ibaloys were and are the original inhabitants of Baguio, as correctly depicted in the parade marking the 104th founding anniversary of the city last Sept. 1.

Likewise, the city has 128 barangays, not 129. "Barangay Bagong Lipunan" was dropped from the list as its territorial coverage was the city market. As city policy , no part of the market can be used for residential purpose, hence the so-called "barangay" established out of it was a mis-

When no one blushes

What sets people apart from swine is the capacity to blush. "I will go wash," wrote Shakespeare in Coriolanus. "And when my face is fair, you shall perceive/Whether I blush or no."

Did Imelda Marcos blush when she insisted that Sen. Ferdinand Marcos Jr. would be ideal for president come 2016? He'd "continue the legacy of the former president." The "New Society," she insisted, was "the brightest period in Philippine history." That ignores 3,257 persons "salvaged," 737 desaparecidos, plus thousands detained without trial under the "New Society."

Ferdinand Jr. played coy: "When I was young, I really didn't want to be involved in politics." And now that he's older? "We shall see," Junior said, despite festering accusations of family sleaze. The US Court of Appeals (9th Circuit) slammed Ferdinand Jr. and mother with a \$353.6-million contempt judgment a year ago. Why? They tried to smuggle paintings and other artworks subject to court decision. "Contumacious conduct," the judge said in imposing a daily fine of \$100,000. Did Junior blush? "Innocence is not accustomed to blush," writer Jean Moliere pointed out.

That's peanuts in a 14-year kleptocracy. Ferdinand Sr. and Imelda Marcos used aliases William Saunders and Jane Ryan to open their first Swiss bank account. They plunked down \$950,000 in March 1968, reported Mark Fineman in Los Angeles Times (Oct. 2). Marcos' salary then, as president, was \$5,600. The former first lady also used the alias John Lewis, the Honolulu hearing heard.

"Crying and clutching a rosary, Imelda took the Fifth Amendment more than 200 times." Lawyers questioned her on allegations that she and her husband had stolen billions. "The hearing came just 24 hours after her husband, deposed President Ferdinand E. Marcos, invoked his Fifth Amendment right 197 times during a similar deposition."

EDITORIAL

The Presidential Commission on Good Government stole her jewels, Imelda complained in 2012. These are

three batches of confiscated gems. One is the "Malacañang Collection," found by 1986 People Power demonstrators. The "Honolulu Batch" was surrendered to US government, after racketeering charges were dropped.

The third, now in Bangko Sentral vaults, is the "Roumeliotes Set"—60 gems confiscated from Greek national Demetriou Roumeliotes. A 37-carat diamond, crafted by Bulgari, is the centerpiece. "They were inside a package addressed to Imelda when seized," Arab News reported. Roumeliotes denied ownership, and later said the gems were fakes.

No, snapped reputable auction houses Sotheby's and Christie's. Imelda agreed. "The jewelry was taken out of Malacañang without my knowledge, much less [with my] consent, between Feb. 26 and Feb. 27, 1986," she said in a court petition.

"They are my jewels." The Aquino administration should return them, instead of auctioning them off. Did Imelda blush? "Girls blush, sometimes, because they are alive/Half wishing they were dead to save the shame," Elizabeth Barrett Browning once wrote.

In between, there has been theft on a grand scale. Take the unanimous Supreme Court decision of July 2003. GR No. 152154 directed that Marcos secret Swiss deposits, of US\$658,175,373, be "forfeited" to the government.

The Swiss government earlier returned the loot, mainly through the efforts of the late Haydee Yorac of the PCGG. Until that forfeiture decision, the Philippine National Bank held the boodle in escrow. Imelda, Imee Marcos-Manotoc, Irene Marcos-Araneta and Ferdinand Jr. tried—but failed—to add that to their fortunes.

The International Consortium of Investigative Journalism pinpointed three Filipinos who hold secret offshore trusts in the Virgin Islands: Ilocos Norte Gov. Imee Marcos, then Rep. Joseph Victor "JV" Ejercito and then Sen. Manuel Villar. In the 1986 People Power uproar, Imee left behind a notebook that contained the names of her father's dummies. Does she blush over the Marcos record? "'Tis not on youth's smooth cheek the blush alone, which fades so fast," Lord Byron wrote. "But the tender bloom of heart is gone, ere youth itself be past."

Ferdinand Sr. as president and Imelda as minister of human settlements were of modest means. Or at least that was what their income tax returns claimed, the Supreme Court noted. In December 1965, Ferdinand Sr.'s net worth was P120,000. Between 1965 and 1984, the Marcoses reported a joint income of P16,408,442. Official salaries accounted for 16 percent, farm income 9 percent, and others 15 percent. Legal practice crested at a whopping 68 percent.

"There is nothing on record [of] any known Marcos client as he had no known law office. He was barred by law from practicing his law profession during his entire presidency. Incredibly, he was still receiving payments almost 20 years after. There are no withholding tax certificates... The joint income tax returns of FM and Imelda cannot, therefore, conceal the skeletons of their kleptocracy."

Then came Xandy-Wintrop, followed by Charis-Scolari, Valamo, Spinus Avertina, etc. etc. They hid wealth "under layers of foundations." The Marcos spouses were the main beneficiaries, and Imee, Ferdinand Jr. and Irene equal third beneficiaries.


A day before Ferdinand Jr.'s name emerged in the pork barrel scam, Imelda unveiled presidential hopes for 2016. At the Senate blue ribbon committee hearing, whistle-blower Benhur Luy said lawmakers would receive 50-percent kickback from pork barrel funds.

So, was this a preemptive strike? If so, Oliver Cromwell's 1653 stinging rebuke to England's "Rump Parliament" is apt: "We griev'd, we sigh'd, we wept; we never blushed before."/Juan L. Mercado/E-mail: juan_mercado77@yahoo.com

BITING THE BULLET IN ZAMBO





DAVAO CITY, Sept. 15 --- I am writing this Sunday morning and due to volatile situation in Zamboanga City, events may overtake this when this comes out on print. I am confident though that how the crisis is being handled, may not change necessarily overnight.

It is significant to know that President NOY AQUINO, who was originally scheduled to just take a quick visit in Zamboanga last Friday, decided not to return to Manila. Instead, he pitched tent and took personal charge of the situation. Up to this writing he is still there! Those who know him well however know exactly this is characteristic of him. I will not be surprised if in taking off from Manila, he brought with him his own personal armaments like his favorite shooters gun or his assault weapons, just in case. Being a gun enthusiast, I can only imagine the collection he now has in his arsenal.

In the case of DILG Sec MAR ROXAS, he had been on the ground soon after the incident erupted and had taken full charge himself during the difficult first days of the siege. He stared eyeball to eyeball with the agony, devastation and violence.

BINAY ENTRY ---Suddenly, Vice President JOJO BINAY got into the scene last Friday, announcing to the media in Manila that he had arranged a ceasefire with MNLF boss NUR MISUARI. He was able to personally connect by phone with his former college classmate NUR and took the initiative of trying to help find a peaceful and quick solution to the on-going situation.

No doubt, news about a ceasefire was initially greeted with glee. This was viewed as a first step towards an early and less bloody way of resolving the siege. But the rejoicing was short-lived because the AFP denied there was a ceasefire agreed and hence the military operations continued. Then, DILG Sec. ROXAS who was manning the front line personally came out categorically shooting down the ceasefire talk. He announced: "surrender first, then we talk".

MISUARI CONFIRMATION --- There was an initial confusion. To give credence to the BINAY announcement, the camp of NUR MISUARI confirmed it. Rev. ABSALON CERVEZA, regarded as MISUARI's closest adviser, told the media by phone from his home in BANGA in South Cotabato that indeed, there was an agreement. A violent-tired and badly mauled Zamboanga saw some hope for an early end. Pus

However, at the end of the day of VP BINAY's Zamboanga Saturday visit, he flew back to Manila obviously feeling dejected and could only say: "sayang". He told the public that the mechanisms to implement the ceasefire he brokered could not be agreed upon. A text message from his camp said: "VP Binay is sad that efforts 2 secure hostages didn't prosper. MNLF&PH forces wanted peace but terms 4 peaceful resolution were rejected by Pnoy. VP asks all 2 pray 4 peace in Zamboanga".

ROXAS, BINAY FORMULAS ---From where I sat, I could give my own thoughts why this happened. There was a big difference between the ROXAS and the BINAY formulas. (I do not wish to succumb to the temptation of ascribing a pre-2016 square off between these two honorable presidentiables, as some quarters are now saying.)

Rather, there are some basic, fundamental differences in their formula, although both all point to the same objective: end the standoff. To be continued

Online Gaming Licenses Jurisdictions: Philippines

The state-owned and controlled Philippines Amusement and Gaming Corporation [PAGCOR] is the sole authorized gambling operator in the Philippines. The company operates casinos, bingo, sports betting and betting exchanges online and through brick-and-mortar establishments. In 2000, PAGCOR authorized the Sports and Games Entertainment Corp as the exclusive operator of the Philippines' only online casino. The company launched www.sagecasino.com in August of 2000 while facing opposition from the Philippine government. In 2001, the online gaming industry was nearly shut down by the President of the Philippines, but Internet gaming survived the incident due to the leader's impeachment in the same year.

In 2002, the government opened its Internet gaming industry to competition when it granted Philweb Corporation control of online casinos. Philweb works in cooperation with PAGCOR to regulate and tax online gaming sites based in the Philippines. **Application Procedures**

FCLRC, as sole Master Licensor of Interactive Gaming in CSEZFP, is authorized to receive applications for Interactive Gaming licenses, in accordance with the Interactive Gaming Act (2003). Licenses are available for all forms of interactive gaming including: casinos, sports betting, lottery and lotteries.

An applicant must complete an application form, probity forms and sign the Interactive Gaming Code of Practice when applying for a license. Applicants are encouraged to contact us directly for any information about the jurisdiction. We welcome you to visit the Philippines and see the facilities available first hand.

Specifically, the following are the licensing costs for securing an Interactive Gaming License / Restrictive Gaming License from the CSEZFP:

Full License (E-Casino & Sports Book):

- US\$15,000.00 Non-refundable deposit payable upon submission of application
- US\$25,000.00 Balance to be paid upon issuance of the provisional or official license, refundable if the application is not successful

then informed that the lot was plotted in the name of the Centralized Bibak Association but was not issued a proclamation as the national government cannot name it to the said association being a private organization.

The said lot used to house the dormitory for students from the Cordillera region which was previously managed by the Centralized BIBAK Association.

Two buildings were said to have been constructed on said lot in the early 1960's and were managed by the BIBAK Association as a dormitory for students from the Cordilleras.

The management of the buildings were turned over to the then Ministry of Human Settlements-National Housing Authority.

In 1983, the city engineer issued a demolition order to pave the way for the construction of student housing facilities by the said agencies but the planned demolition was aborted with the abolition of the MHS-NHA.

In 1990, the CEB caused the construction of the BIBAK multi-purpose building on the site of the former dormitory but there was no record of a building permit for said structure.

In November of same year, the CEB turned over the building to the Office of the National Cultural Communities but the Cordillera Regional Assembly continued to occupy the facility.

In 2006, former mayor Braulio Yaranon ordered the demolition of a structure being built on the lot based on the complaint of then BIBAK Students Dormitory Inc. president Constancio Manglan.

On the same year, the municipal council of Tuba town in Benguet passed a resolution inquiring from the DENR Land Management Bureau on the status of said dormitory site with the hope of reviving the project to help Igorot students facing hardship in renting boarding houses./ A Refuerzo

City Sets Rules for Ambulant

Vendors BAGUIO CITY - Mayor Mauricio Domogan imposed rules in the implementation of the "zero vending policy" in all roads, streets and sidewalks in the different parts of the city.

The Baguio City Market Authority (BCMA) adopted a "zero vending policy" through its Resolution No. 009-2013 and 9a-2013. Hence, the city government implemented massive clearing and cleaning operations against all sidewalk vendors even as vending time for certain areas was allowed until such time that a relocation site for the affected vendors be identified.

The designated relocation areas include the parking area of Block IV, between Rillera and Block III and between Block III and Block IV. Vendors were advised to submit applications for screening and evaluation in order to be accommodated for a possible slot. However, BCMA will give priority to vendors who are paying their obligations to the city and to vendors with arrears but are still paying. Delinquent vendors since 2012 will not be included in the priority list.

It is the responsibility of the allocatees of vending slots to pay in advance during the last week of the month to the City Treasury Office the amount of P600 to cover a one month occupancy of the slot, to constantly occupy the vending space for the duration paid for and that he/she will not be allowed to rent out or sub-lease the same, to observe cleanliness within his/her vending space at all times. No allocatee will be allowed to lend his/her vending space to another vendor for a certain period of time in exchange for a certain amount among other favors.

The Public Order and Safety Division (POSD) in coordination with the Baguio City Police Office (BCPO) and the City Treasury Office will strictly monitor the compliance of the allocatees to the prescribed rules and regulations in the identified relocation sites.

Violations of allocatees will automatically forfeit their right of vending spaces. After the forfeiture of the rights of erring allocatees, it will be given to those vendors who were part of the census but were not accommodated in the relocation site because of lack of spaces./Jho Arranz
