

Anti-obstruction task force to be formed

BAGUIO CITY – The city's Traffic and Transporta-tion Management Committee (TTMC) approved the creation of an anti-obstruction task force that will have the primary function of clearing all national and local roads from obstructions to pave the way for convenient travel among the motoring and commuting public.

The agreement was reached by the TTMC members during their recent meeting after the committee was bombarded with complaints of obstructions along national and local roads that contribute to the worsening traffic congestions around the city.

Group (TWG) tasked to conduct an evaluation and assessment on the feasibility of the Benguet Corporation's open pit site in Antamok, Itogon, Benguet as a potential site for an integrated waste disposal facility reported that the site is suitable for the project, Mayor Mauricio G. Domogan reported here Wednesday.

However, he said that some members of the TWG are still looking into an alternate site nearby because there are settlers below the open pit area who will be affected by the solid waste disposal project once put in place.

What is important is the site was found to be feasible and the project is doable that is why we will await the final recommendations of the TWG before we will work on how to go about the put up of the integrated solid waste disposal facility," Domogan stressed.

He revealed the primary obligation of the city in the

Domogan claimed the engineered sanitary landfill will be operational in the meantime that the waste-to-energy facility is being established to process the waste and it will be closed once the plant will be fully operational using generated waste from the Baguio, La Trinidad, Itogon, Sablan, Tuba and Tublay areas.

He disclosed the establishment of the waste-to-energy plant will be subjected to public biding and under the government's Public-Private Partnership (PPP).

The mayor said the host local government will possibly derive income from the tapping fee to be collected from the localities interested to avail of the services of the facility or the sale of the energy to be sold to the grid./By

Mayor bats for strengthening of PNP law

AGUIO CITY - Mayor Mauricio G. Boomogan urged lawmakers to strengthen the provisions of Republic Act (RA) 6975 or the Department of the Interior and Local Government (DILG) Law that also established the Philippine National Police (PNP) instead of removing the power of the local chief executives to appoint the chief of police in his or her area of jurisdiction.

The local chief executive pointed out that if lawmakers remove the authority of governors and mayors to appoint their respective chiefs of police, then the national government should also make sure that it will fully fund the needs of the PNP so that local governments will no longer allocate budgets for the operation of the police in their places.

"It is better for our lawmakers to strengthen the law instead of removing the power of local chief executives to appoint the chief of police in their places. The local government and the police should be partners in sustaining peace and order for the benefit of a peaceful community," Domogan stressed.

The city mayor lamented the practice of PNP officials in unjustly relieving chiefs of police and using their prerogative to assign officers-in-charge just to accommodate their close allies who were not given positions in the PNP hierarchy, saying that such practice should be the one that must be corrected and stopped in order to prevent demoralization among affected police officials.

According to him, people usually blame local officials for poor peace and order situations thus it is still best for the national government to give authority to local chief executives to appoint their own chiefs of police who will be their partner in the implementation of peace and order strategies for their communities.

It was learned that the City Government allocates some P38 million annually from its budget as assistance to the Baguio City Police Office (BCPO) to sustain its operational requirements in the implementation of appropriate peacekeeping and anti-criminality strategies towards making the city a peaceful place.

Under existing rules and regulations, the PNP is mandated to submit a shortlist of qualified senior police officials to the concerned local chief executive from where the latter can choose, within a period of ten days upon receipt of **Cont. on page 8**

SC orals: How justices pursued issues on Marcos burial

Of the issues, the justices gave significant attention to human rights, RA 289, AFP regulations, and Marcos' record as a soldier

August 31, over the burial of the late president Ferdinand Marcos.

Earlier, we listed 6 points raised by petitioners in the cases filed against the interment for Marcos at the Libingan ng Mga Bayani.

Of the issues, the justices gave significant attention to human rights, the law creating the national pantheon (RA 289), the rules governing the Libingan ng mga Bayani and Marcos' record as a soldier.

Human rights

Chief Justice Maria Lourdes Sereno pursued the petitioner's primary argumen that Marcos' burial at the Libingan ng mga Bayani negates the state's obligation to provide full reparation for Martial Law victims through monetary compensation and memorialization of their sacrifices under Republic Act 10368

Her interpellation tried to resolve whether "money is equivalent to the restoration and dignity" of the victims and the status of the government's implementation of RA 10368, which includes the complete distribution of compensation and the establishment of museums for the victims.

She also asked if the law holds Marcos accountable for the criminal acts committed by his state agents. Justice Marvic Leonen asked why the petitioners are linking the crimes to the late president when he was not the one who directly did or ordered the torture methods.

Sereno gave the victims, who were also petitioners of the case, the chance to narrate the human rights violations they experienced under the Marcos regime. She also called for the Commission on Human Rights Chairperson Chito Gascon and Human *Rights Victims Claims Board Chairperson Lina Sarmiento to detail how the victims* have been compensated so far.

RA 289

Justices' questions on RA 289 intended to settle whether or not the "national pantheon" referred to in the law is the Libingan ng mga Bayani.

Justice-in-charge Alfredo Caguioa raised the Solicitor General's argument that the site in RA 289 is distinct from the national shrine in Fort Bonifacio.

He asked counsel Albay First District Representative Edcel Lagman to cite specific laws or issuances that link RA 289 to the Libingan. Lagman said that the hero's shrine is the "factual and logical" realization of the memorial envisioned in the law.

Meanwhile, Justice Presbitero Velasco Jr said the law enacted on June 16, 1948 seems to be a "dead law" after its provisions failed to be implemented 68 years after it became state policy. There have been no public burial grounds built on East Avenue in Quezon City; a Board on National Pantheon has also not been organized, as provided by law.

Justice Diosdado Peralta, for his part, said that if RA 289 refers to the Libingan, "shouldn't Congress have stated such?"

AFP Rules

Justice Teresita de Castro asked the counsels to convince them that, indeed, only heroes are interred at the Libingan. She stressed that all controversies arise from the name that denotes the cemetery is solely intended for heroes.

De Castro pointed out that the shrine has a military nature because it is under the management of the Armed Forces of the Philippines (AFP) under Marcos' Proclamation 208.

She said that the basic purpose of the cemetery is to honor "those who served [the country] in war and in peace time." But later, deceased persons such as national artists, statesmen and widows of presidents, were allowed to be buried there.

Identifying who is a hero and who is not is also challenging for the court, said Peralta, as there is "no system of determination who are heroes and [who] are not."

Leonen, on the other hand, ordered counsel Ibarra Gutierrez III to include in their pleading the validity of the AFP memorandum issued by defense chief Delfin Lorenza that cites "verbal orders" from the President allowing the burial.

Marcos' war records

Justice Estela Bernabe asked Gutierrez a direct question: Has Marcos been dishonorably discharged?

"Not literally, but in essence, the 1986 EDSA Revolution and the numerous decisions of the court to plunder charges are akin to being dishonorably discharged," answered Gutierez.

Doubts cast on **Ombudsman's award**

OUBTS CAST ON OMBUDSMAN'S AWARD: Lawyer Levi Baligod, wittingly or unwittingly, may have cast a shadow of doubt over the award given the other day by the Ramon Magsaysay Awards Foundation to Ombudsman Conchita Carpio Morales, the only Filipino among the foundation's five awardees for this year.

Baligod spoke to media hours after Morales received the award Wednesday, August 31, 2016 at the Cultural Center of the Philippines, virtually challenging her choice as an awardee, with his disclosure that, for P100 million that was given to the Liberal Party, the Aquino government sabotaged the investigation of the P10 billion pork barrel scam which caused the incarceration of three incumbent senators in 2015.

Morales, of course, was appointed chief graft buster shortly after President Benigno Aquino III, a Liberal Party (LP) stalwart, was installed president. She controlled the preliminary investigation of the graft and plunder cases that the Department of Justice, then under Secretary (now senator) Leila De Lima, filed with her office, controlling who should be charged---or not to be charged---in connection with the P10 billion scam.

MORALES MUST SEEK CLARIFICATION: If I were Morales, I will press Baligod to clarify his expose (see http://www.bomboradyo.com/news/top-stories/item/164664-aquino-gov-t-sinabotahe-pork-scam-probe-baligod), where he claimed that P100 million was given to LP as campaign funds by Janet Lim Napoles, the businesswoman who is being accused of having reaped billions of pesos from non-existent projects using pork barrel funds of lawmakers.

Another claim made by the lawyer is that Napoles also gave campaign funds to a candidate for a national position during the 2016 elections. The candidate won, Baligod said in his interview, capping his disclosures with a serious charge: that the Aquino government sabotaged the pork barrel investigation initially pursued by De Lima, and then handled by Morales, the Magsaysay awardee.

This is of course a very serious accusation that casts grave doubts about the prestigious award---said to be Asia's version of Europe's Nobel Peace Prize---that the Ramon Magsaysay Awards Foundation bestowed on Morales on Wednesday. Baligod, or perhaps even Morales, must clarify this issue, to avoid smearing the names of innocent parties.



DOUBLE STANDARD IN PLUNDER RAPS: But, truth to tell, there have been rumblings earlier about the selective prosecution of those involved in the scam. Canada wants to open 5 more visa offices in China to attract more skilled Chinese

workers and students

Following the tightening of restrictions that has led to fewer Chinese people immigrating to Canada, the Canadian government has decided to open up five new visa offices in hopes of attracting Chinese tourists, skilled workers, and international students.

Currently, Canada has four visa offices in China, one in Beijing, Guangzhou, Shanghai, and Chongqing. The government plans to open up new centers in Chengdu, Sichuan province; Jinan, Shandong province; Shenyang, Liaoning province; Nanjing, Jiangsu province; and Wuhan, Hubei province.

John McCallum, Canada's Minister of Immigration, Refugees and Citizenship, met with Chinese officials in Beijing this week to discuss opening the new centers. McCallum also plans to cut down on much of the bureaucratic red tape and streamline the process for valuable workers and students wishing to live in Canada.

We want to make it easier for them to stay in Canada. So we have the system called Express Entry, in which you have a certain number of points to be accepted as an immigrant," McCallum explained, reports ECNS.

Skilled Chinese workers -- particularly those students fluent in English -- are valued assets for an aging Canadian economy. "Canada is an aging country, so we need new young immigrants to support our economy and help make it grow," McCallum said.

McCallum believes that a new demographic of trained Chinese professionals -- experts in technology sectors -- will give the country the necessary push it needs to innovate and prosper.

"Canada needs to take advantage of a great economic opportunity to capture this market and the opening of more visa application centers throughout China would facilitate travelers seeking to come to Canada," an anonymous government official told CBC.

Canadian Prime Minister Justin Trudeau has tasked McCallum with drafting up a three-year immigration plan that will be revealed in further detail this fall.

Hopefully, Chinese officials still aren't sore about Canadian reporters questioning China's human rights record. go through an administrative process that dishonorably discharged him from the service. He said that he was "not separated from the service in the sense that there was a finding that he violated a [rule] that would discharge him."

But Justice Antonio Carpio argued that as president, Marcos also acted as the commander-in-chief – the highest official of the military. He also alluded to the petitioners' claim that the 1986 EDSA People Power Revolution, which ousted Marcos, is "higher than any act of a military tribunal or civilian administrative tribunal.

Justices did not challenge the National Historical Commission of the Philippines' (NHCP) study disputing Marcos' military records. But Caguioa said the report was incomplete since the NHCP failed to mention that the late dictator was awarded a medal of valor – one of the requirements for a state burial based on AFP regulations.

The oral arguments will resume on Wednesday, September 7, where other issues such as the Marcos family's agreement with former president Fidel Ramos will be tackled.

Towards the end of the hearing, Sereno ordered the petitioners, respondents, and resource persons to file the memoranda and documents requested by the justices. These include former interior secretary Rafael Alunan III's copy of the Ramos deal with the Marcoses and research documents from the NHCP./ Patty Pasion / Rappler.com

BAGUIO CITY – Baguio City Mayor Mauricio Domogan in a press conference on September 1, Thursday at the Baguio Convention Center, said there are pending issues that need to be addressed pertaining to the region's claim for autonomy and the shift to a federal form of government.

Domogan, in the presence of Presidential Communication Office (PCO) Assistant Secretaries (ASecs) Mon Cualoping (for Strategic Communication) and Ana Marie Banaag (for Legal Affairs) and Baguio Representative Marquez Go, explained that the inclusion of the Cordillera Region to the proposed Northern Luzon Federal State will result in the inequitable sharing of the resources of the federal state because of the smaller population and land area of the Cordillera Region.

Domogan said autonomy advocates in the region support the Abueva (Dr. Jose Abueva) federal government version because it recognizes the Constitutional Provision mandating the establishment of autonomous regions in the Cordillera and Muslim Mindanao.

'We should not give up the renewed pursuit for regional autonomy because our inclusion in the Northern Luzon Federal State will result in the neglect of the region in terms of development except when there will be laws that will be passed that will equalize the status of small and big regions in terms of their share from the available resources of the federal states," Domogan said.

In the same press conference, Representative Go said that in a recent meeting with the members of the Cordillera Regional Development Council (CRDC), Ifugao Representative Teodoro Baguilat, Jr. agreed to refile the autonomy bill but other lawmakers from the region proposed the conduct of more consultations in order to get more inputs on what should be included in the autonomy bill.

Baguio cops consult with bar owners, workers

BAGUIO CITY – The leadership of the Baguio City Police office (BCPO) recently conducted a dialogue with the owners and employees of bars and other night spots in the city to remind them of the need to police their own ranks as part of combatting illegal drugs in the city.

Senior Superintendent George D. Daskeo, BCPO City Director, informed the bar owners and workers that the BCPO will not hesitate to recommend for the closure of establishments they manage, own or work with, once they are able to find evidence that they are involved in the sale, trade and use of illegal drugs.

"Bars and night spots are among those establishments where there were earlier reports on illegal drugs dealing between the pushers and their buyers that are why we reminded the owners and workers of the need to police their own ranks in order to prevent the proliferation of prohibited drugs among them," Daskeo stressed.

He expressed the BCPO's gratitude to the bar owners and workers for their commitment to help in the government's campaign against illegal drugs by reminding their co-workers not to be involved in the sale and use of prohibited drugs, especially in their establishments, to prevent them from being apprehended that might lead to the closure of their workplaces or their eventual arrest.

According to him, there are already nearly 100 hundred employees of bars and various night spots who already surrendered to the different police sub-stations in the city over the past several weeks which means that there is a serious drug problem among those working in the bars and other night establishments.

The BCPO official revealed bar owners and workers should not wait for arrests among them due to illegal possession and use of illegal drugs to happen before they stop their trade or behavior.

He said bar owners and their workers will be given all the chance to surrender to police operatives before they will apprehend those involved in the prohibited drugs trade.

It was learned that there are some bar workers who use prohibited drugs to allow them to stay awake up to the wee hours of the morning or until the closing time of their respective establishments.

Daskeo revealed some of the bar workers who surrendered to the police identified their sources of illegal drugs which will now be the subject of future operations to effect their arrest for their illegal trade. **B**AGUIO CITY - The Baguio City Police Office (BCPO) and city officials declared support to the war on illegal drugs.

BCPO Director PSSupt. George Daskeo, together with the city officials led by the coucilors and department heads, took the lead in the Covenant Signing and Manifesto of Support for the Campaign Against Illegal Drugs during the flag raising ceremony at the Baguio City Hall lobby last week. Daskeo said the manifesto is a way to show full support to President Rodrigo Duterte's intensified all out-wars against drugs.

Mayor Mauricio Domogan earlier pledged support in all the endeavors to rid drugs in the society.Officials and representatives from the non-government organizations, government line agencies, civil society organizations and the private sector also joined in committing their support to the campaign against illegal drugs. As of August 30, the nationwide all-out war on drugs already killed at least 895 drug pushers while more than 500,000 drug pushers and addicts surrendered in the first two months of the Duterte administration.

In Baguio City, Daskeo said 104 personalities were arrested during in operations from July 1 to August 31. Eighty seven of the arrested personalities were drug peddlers while 17 were users. He admitted that more than half of the arrested have already surrendered but continued with their illegal activities.

Drug surrenderees in the city have also increased from 700 in July to 1,010 in August. Of the 1,010 surrenderees, 108 of are pushers while the remaining are all users.

of the Environmental Management Bureau (EMB-CAR) reported that the air quality within the Baguio-La Trinidad-Itogon-Sablan-Tuba-Tublay (BLISTT) areas is good to fair based on the 2016 second quarter air quality sampling done in ten sampling stations within the said localities.

Reynaldo S. Digamo, EMB-CAR regional director, said that the ambient air monitoring and technical services section of the agency's environmental monitoring and enforcement division conducted 24-hour air quality sampling and monitoring at the established air sampling stations within the BLISTT areas. He added there were six sampling stations which recorded air quality within the good air quality index, to wit: Tublay, Sablan, Tuba, Itogon, all in Benguet; the Mile Hi Center and the Ayala

Digamo said the sampling stations were collected for Particulate Matter (PM 10) using the BGI PQ100 high volume samplers.

However, th e EMB-CAR official disclosed the data collection within the Burnham Lake from the continuous air ambient quality monitoring station was temporarily discontinued due to the malfunctioning of the machine during the current monitoring and preventive maintenance schedule but the machine was later repaired.

The ÊMB-CAR reported there were construction activities within the compound and dry weather conditions contributed to the air quality during the sampling period also helped in particulate matter suspension, thus, the construction firm must strictly implement the effective measures to reduce the particulate matter volume. Digamo recommended that there should be continuous sampling within the established sampling areas to establish the trend of air quality within the designated areas and be able to provide accurate results to guide concerned groups.

Further, he recommended continuous reconditioning of the ambient air quality monitoring stations installed along Lower Session road and particulate matter station installed at Burnham Lake to ensure accurate results related to air quality in the said areas during the prescribed sampling periods.

It was noted there was an increase in the suspended particulate matter in the air in the sampling stations compared to the data gathered last year but the latest ambient air quality in the said areas remain to be good to fair.

The EMB-CAR report was furnished the different local governments comprising the BLISTT area and the management of the John Hay Management Corporation (JHMC) for their information and action. /By

BAGUIO CITY – The City Government necessary fencing of the property to prevent further encroachments that city-owned property in Gibraltar barangay in order to prevent the prime lot from being encroached on by informal settlers.

Officials of the City General Services Office and City Buildings and Architecture Office (CBAO) will do the required relocation survey to ascertain the metes and bounds of the city property so that monuments can be installed prior to the actual fencing.

Earlier, City Legal Officer Melchor Carlos Rabanes raised the observation that the cityowned property in Gibraltar barangay is allegedly being invaded by alleged informal settlers, thus, the need for the local government to fast-track the implementation of the

prevent further encroachments that will significantly affect the state of the property in the future.

Initially, Assistant City General Services Officer Eugene Buyucan reported that there are already some squatters along the road that encroached into the city property and that there was an earlier survey conducted that identified the metes and bounds of the property although there were no appropriate monuments that were put in place except for the so-called tie line.

City Building Official Nazita F. Bañez recommended that a joint relocation survey is first done to identify the exact location of appropriate monuments simultaneous with the preparation of the plans and specifications of the fencing project.

At the same time, City Accountant Antonio Tabin suggested that the concerned offices write a formal request for the funds from the local finance committee for the fencing project.
