



Says "The issues hurled at Senator Grace Poe are deja vu. It has already been seen in 2004, when the same issues were thrown at her father, the late Fernando Poe Jr. or FPJ when he ran for president. The senator, who was the campaign spokesman of FPJ in 2004, came to the defense of Senator Grace Poe who is bombarded with residency and citizenship issues for the 2016 Elections. Poe has yet to confirm her candidacy but is considered one of the stronger contenders for president for the 2016 polls.

Escudero also pointed that it was only last month when the camp of Vice President Jejomar Binay expressed preference for Poe as his runningmate in the 2016 Elections. BAGUIO CITY - the city govern-Award ment here is a recipient to the 2014 Seal of Good Financial Housekeeping Award (SGFH) handed over by the DILG.

Mayor Mauricio Domogan personally received the Award Monday given by the DILG Cordillera Administrative Regional Office under Regional Director John Castaneda and handed over by DILG City Director Evelyn Trinidad.

Also present are Vice Mayor Edison Bilog and Councilors Betty Lourdes Tabanda, Elaine Sembrano, Elmer Datuin and Fred Bagbagen.

The award cites the city government of Baguio incessantly advanced the principles of accountability and transparency in local governance by complying with two major areas during the 2014 Seal of Good Local Governance assessment.

The two areas are Full Disclosure Policy of Local Budget and Finances, Bids and Public Offerings and Accounting and Auditing Standards, Rules and Regulations.

About Deja Vu, Lawmaker Voluntary Demolition at Cockers Prop up Baguio-BAGUIO gal structures to protect

Busol CITY

Owners of the illegal structures at the area designated for a tree nursery at the Busol watershed fulfilled their commitment to voluntarily demolish the shanties after the ten-day grace period granted to them by the City Government.

Engr. Israel Galvez of the city buildings and architecture office said the occupants said the occupants were the in the process of taking down the shanties as of last Thurs-

The City Government agreed to defer the implementation of the demolition for ten days after the occupants appealed for more time to consider voluntarily demolishing the structures

The ten-day reprieve expired last Sunday.

The area has been designated as a tree nursery and field office of the Dept. of Environment and Natural Resources, the Baguio Regreening Movement and the city environment and parks management office.

Mayor Mauricio Domogan said that with the resolution of the legal issues involving the squatters at the watershed, the City will pursue the demolition of all ille-

ture projects funded under DILG's Bottom-up-Budgeting Program.

Together, they have pooled a fund of P147,400 and \$300, of which P56,647.76 and \$100 have so far been distributed to 22 patients and a student here and in Benguet.

Members of the Baguio post of the Veterans of Foreign Wars, most of whom served in the United States Navy, made the initial thrust, raising P25,400 under the direction of outgoing and incoming post commanders Larry Senato Willy and Totanes during their induction of officers last April.

Of the amount, P4,340 went to the purchase of medicines for Helen Vicente, a 61-year old widow with nine children who has been suffering from diabetes for 19 years now. The patient lost her husband to kidney disease a few years back.

From the same fund, P1.400 was used for the laboratory tests, catheter and medicines of Gay Mordayne Naslangan, a five-year old girl from Sinto, Bauko, Mt. Province who is fighting lymphocytic leukemia.

Three thousand pesos paid for the initial tuition fee of Cherry Ann Realinza, a 16-year old computer student whose father, Andres, a security guard, died when he was hit by a pine tree which fell while he was assigned at the Busol Watershed at the height of a storm several vears ago.

Other beneficiaries were dialysis patient Josalyn Balisbis (P2,200), a 35-year old man suffering from schizophrenia (P1,162.50); a widower who lost his daughter to kidney disease last year

City Strengthens 100 Meter IEC, Awareness **Tobacco Ban in Schools**

BAGUIO CITY - Mayor Mauricio Domogan has ordered the strict implementation of the 'no sale of tobacco products' in the 100 meter radius of schools in this mountain resort.

The order came just in time for the opening of classes for public schools this June.

Domogan said, "the strict implementation of this law will prevent children from being exposed to cigarettes and its harmful effects."

As per Republic Act 9211, Section 10, the sale and distribution of tobacco products is prohibited within one hundred meters from any point of the perimeter of a school, public playground or other facility frequented by minors.

Any person, business entity or establishment selling to, distributing or purchasing a cigarette or any tobacco product will be fined the amount of P5,000.00 or imprisonment of not more than thirty days, business licenses or permits shall be cancelled or revoked.

If the violation is by an establishment or business entity, the owner, manager, or the most senior officer shall be liable for the offense.

The city government also strengthened its Anti-Smoking Policy thru the continuous enforcement of Administrative order No. 28 series of 2012 which created the Implementation Committee for the 100% Smoke Free Environment Policy of the Civil Service Commission and enforcement of City ordinance No. 8 series of 2008 or the Comprehensive anti-Smoking Ordi-

Domogan said," warning the public on the ill-effects of smoking and enforcing the no smoking policy is the best way of protecting the people from the dangers of smoking.

The Philippines is a signatory to the World Health Organization (WHO) Framework Convention on Tobacco Control.

The city council is also slated to amend the Comprehensive Anti-Smoking Ordinance of the city to make it more effective.

The new comprehensive anti-smoking ordinance enumerates in detail the places where it is prohibited to smoke and further strengthens the tobacco Regulation Act./Paul Rillorta

Safety of Boarding Houses Reviewed BAGUIO CITY - The present

houses in the city may trigger a revision of the minimum safety and sanitation standards for such establishments to make them realistic and in tune with the times.

This developed as reports from the members of the boarding house inspection composite team on the conditions of these establishments showed the need for the updating of the old ordinance regulating the operation of these businesses and for the revision of the standards based on the present day scenarios

Councilor Betty Lourdes Tabanda said that if the provisions of the old ordinance or even the present National Building and Fire Safety Codes will be imposed particularly on the three-squaremeter-per-person "air space" requirement alone, a considerable number of lodging houses will have to be closed for violations. And if the City will insist that owners comply with the requirements on the provision of enough air space, study hall, reception area and bathroom for every ten persons, among other requirements, students will have to contend with exorbitant rent.

Tabanda said both options cannot just be done considering the plight of the students.

Best Weapon Against HIV-AIDS

BAGUIO CITY - The fight against Human Immunodeficiency Virus/ Acquired Immune Deficiency Syndrome (HIV-AIDS) goes on through education and right information campaign, even after the international AIDS candlelighting ceremonies at SM Center, May

This was advocated in messages of Mayor Mauricio Domogan, Committee chair on Health and environment protection Councilor Fred Bagbagen, Health Services Office (HSO) head Dr. Rowena Galpo, Department of Health OIC Amelita Pangilinan, other medical personnel and health advocates.

The message was echoed by Marlene de Castro of the Baguio Center for Young Adults (BCYA), as she emphasized that each should employ intelligent decisions, and use discipline with responsibility when confronted with AIDSrelated situations. Government agencies, nongovernment organizations are within reach for persons needing help, she said.

Audience during the forum are members of the Baguio Association of Bars and Entertainers (BABES), aside from government personnel and concerned private individuals.

As to information, the national AIDS prevention control programs was launched in the Philippines in 1988; and later, surveillance, organization of persons with AIDS, establishment of the Bahay Lingap in 1995, an AIDS international congress in the Asia and the Pacific in 1996, an AIDS congress with the Department of Interior and Local Government (DILG) in 1997. The Philippine Information Agency (PIA), Non-Government Organizations (NGOs) and the mass media ioined the information campaign.

There is no known technology nor medical cure for AIDS, thus everyone should keep safe and healthy, Councilor Bagbagen cautioned. It was for this purpose that exercises including the popular Zumba dancefitness program is endorsed

AIDS, though preventable, is transmitted through unprotected sex, blood transfusion, needle and syringe use specially among drug users. breastfeeding. Statistics now show a steep increase in AIDS cases due to rapid transmission, and now termed as "epidemic," causing alarm among health and medical personnel. The cases show the vulnerability of every individual, thus the need for precaution.

For those infected, researches on pain treatment caused by AIDS infections are being done, Dr. Galpo said in her message.

A voluntary, confidential and free diagnostic HIV testing is provided, including pre and post counseling, in coordination with the Baguio General Hospital and Medical Center (BGHMC) and DOH-CAR, Dr. Pangilinan said in her message. Early diagnosis, treatment, care and support, including a non-stigma approach and non-discriminatory environment is favorable for infected persons, it was known.

The ABCDE for the prevention of AIDS are: Abstinence; Be Faithful; Careful Sex; Don't Share Needles; Education and information

Other offices represented in the forum include the Baguio AIDS watch council. City Social Welfare and Development Office (CSWDO), Department of Education (Dep-Ed), Family Planning Organization of the Philippines (FPOP), the Philippine National Red Cross (PNRC), among other national and local agencies./Julie G. Fianza

House to Ratify Proposed Open High School System Bill

Baguio Representative munity partnership as Nicasio M. Aliping, Jr. announced yesterday that the House of Representatives is expected to ratify a bicameral conference committee report establishing an open high school system in the country.

House Bill 4085, to be known as the "Open High School System Act," establishes an Open High School System (OHSS) as part of the Department Education's (DepEd) alternative secondary education program to provide secondary education through the open learning modality.

Rep. Aliping, vice chairman of the Committee on Higher and Technical Education and coauthor of the bill said that, "The measure will provide equal opportunity for adults and children of high school age who are out of school to avail of free open high school education through the distance learning modality."

The measure authorizes public secondary educational institutions certified to practice open learning through self-instructional materials, multi-channel learning and school-family-comqualified implementers.

Under the measure. the OHSS shall be open to all youth and adults who have finished elementary education, as well as high school qualifiers of the Philippine **Educational Placement** Test (PEPT) and the Alternative learning System (ALS) Accreditation and Equivalency (A&E) Test.

The OHSS will adopt the K to 12 Enhanced Basic Education Curriculum using the standards and learning competencies of different subject areas of the program.

The DepEd is tasked to administer the OHSS and create an OHSS Unit to assist the Department in performing its func-

It will be responsible for the training of the open high school teachers, teacher advisers, and community advisers, which will be done in coordination with the LGUs and the non-government organizations concerned.

Replay Buttons

Late in May, the Catholic Church beatified the martyred Bishop Oscar Romero of El Salvador. Will similar recognition come someday to Mindanao?

That's where missionaries Tulio Favali and Fausto Tentorio were likewise murdered. The two were members of the Pontifical Institute for Foreign Missions (Pime). "Why do you wish to be a priest, even though priests are being killed?" someone once asked Favali. His reply: "So that they will have more priests to kill."

Established in 1850 in Italy, the Pime is now in 17 countries, including the Philippines. Its roster includes 18 martyrs and one canonized saint.

As in El Salvador, paramilitary operatives of counterinsurgency groups in Mindanao have tarred popular movements for change as "subversive." Their agents smeared Pime missionaries—whispering about the Communist Party of the Philippines' praise for Father Tentorio, for example.

EDITORIAL asked Giuseppe Pinto, then

Pope Benedict XVI met these smears head on. He the Vatican's apostolic nun-

cio in Manila, to convey his message to Filipinos. Tentorio was "a good priest, a fervent believer," the Pope wrote. "For many years, he served the people of the Philippines in a courageous and indefatigable way.'

Benedict's statement was published in the Vatican's official daily, L'Osservatore Romano.

Who slammed the replay button?

For years, opponents within the Vatican blocked the cause of Blessed Oscar Romero. "But with the presence of Pope Francis, a sensible Latino who knows Latin America, the process was revived," then finally pushed through, writes Bernardo Barranco, the president of the Center of Religious Studies, an institute in Mexico City. "It acknowledged a figure of the Church who has been denied for decades."

Romero was shot while saying Mass by a junta gunman. A "truth commission" later concluded that former army major Roberto d'Aubuisson ordered the killing. He was never tried. Impunity enabled him to establish the conservative Arena party, which governed El Salvador until 2009. He is now in the opposition.

"For a whole generation of Christians in Latin America, Romero's murder demonstrated the barbarity of military dictatorships," writes Barranco. Romero morphed from a timid bishop to an outspoken prelate after El Salvador goons gunned down a Jesuit priest who defended the poor.

In the Philippines, it has been four years now since the murder of Tentorio (or "Father Pops").

Last October, a caravan disembarked in Arakan, North Cotabato. The caravan members heard Mass concelebrated by 15 priests. The theme of the liturgy was Pope Francis' call: "Go. Do not be afraid. Serve the people.'

They recalled that after arriving in Kidapawan, Father Pops stayed in the village of Kabacan to learn the local languages.


He trekked to far-flung villages to reach the neglected tribals and farmers. And he taught them how "to unite into organizations where they developed a new kind of education that empowered them to struggle for their rights."

Lawyer Gregorio Andolana documented "some investors racing to exploit the natural resources of Arakan." He pinpointed the corrupt politicians who feared that the organized farmers and tribals would no longer sell their votes.

These politicians considered priests like Tentorio and Favali as subversive. For some, this was sufficient motive for an extrajudicial killing.

After many appeals to the President, a new spe-

ANIMUS REVERTENDI AND GRACE POE: Is Sen. Grace Poe really disqualified from running for the presidency in 2016 in view of her declaration in her certificate of candidacy when she run for senator in 2013 that she had been a resident of the Philippines for less than 10 years, as Malabon Rep. Toby Tiangco of the United Nationalist Alliance (UNA) is saying?

The answer is no, Poe is not disqualified on ground of residency. She can run for the presidency or for any other elective position, for that matter, even if she has not resided in the country for 10 years or more immediately prior to an election, according to Supreme Court decisions dealing precisely with candidates who have not continuously resided in the places where they intend to run, and thus have not completed the residency requirement under existing election laws.

The decisions of the tribunal make use of the so-called doctrine of "animus revertendi", which says that even if a candidate is not an actual resident of a town or city but intends to return to it every now and then, that candidate can be allowed to run for any political position in that place. This doctrine, I believe, can apply to Grace.

IS GRACE POE A NATURAL BORN FILIPINO? Be that as it may, UNA may want to look into whether or not Grace is a natural born citizen under the Philippine Constitution, so as to entitle her to run as president or vice president in 2016.

This should be a more substantial argument, if UNA now sufficiently feels that the candidacy of Vice President Jejomar Binay is threatened by the seemingly surging and apparently unstoppable popularity of Grace. Again, as we all know, only those who are natural born citizens can run for the presidency or vice presidency of the country.

Now, what is a natural born citizen, and how does this affect Grace? According to the Constitution, a natural born Filipino citizen is a Filipino citizen who did not have to do anything to perfect his or he Filipino citizenship. In the case of Grace, while it can be argued that she was originally a natural born citizen, he having acquired US citizenship meant renouncing her Filipino citizenship.

WHAT US CITIZENSHIP DID TO GRACE POE: When Grace returned to the Philippines and made a vow to become a Filipino citizen again, that meant she was becoming a Filipino citizen once again as a consequence of that vow. For all legal intents and purposes, therefore, Grace had to perform an act so she could become a Filipino citizen once more. Anyway one looks at this situation, it is clear that

Anti-discrimination Laws Mandated: Human Rights' Vigilance

"It is often easier to become outraged by injustice half a world away than by oppression and discrimination half a block from home." Carl T. Rowan

Discrimination happens because of age, disability, race, language, culture, beliefs/religious affiliations, ethnicity, sexual preferences, gender as well as the educational institutions where graduates earned their degrees. According to Dictionary.com, it is a treatment or consideration of, or making a distinction in favor of or against, a person or thing based on the group, class, or category to which that person or thing belongs rather than on individual merit. Without statistical analysis for the emergence of figures to prove their occurrences, we hear multiple accounts encountered by countless individuals which elucidate bias incidents.

The discrimination-related experiences of fellow citizens reverberate for everyone's awareness not to mention multiple accounts of individuals who kept them in long-endured silence. But whether these forms of discrimination are told or not, the bottom line is they are all victims of unjustified prejudice who deserve restitution of citizen's legal rights. Despite the drawbacks of the governments' efforts in finding solutions for these impartiality, some of these discrimination-related problems are being addressed by country's law-making bodies.

In the government service, the case on job search discrimination isn't much a piercing controversial issue. A republic act governs how applicants are absorbed into the Philippine Civil Service (PSC). According to Republic Act No. 7041, it is an act requiring regular publications of existing vacant positions in government offices. In here, Section 1 stipulates "that it shall be the policy of the government to promote efficiency in the allocation of personnel in the civil service, as well as transparency and equal opportunities in the recruitment and hiring of new personnel." It further specifically points out in its Section 2 that "The duty of all Chief Personnel or Administrative Officers of all branches, subdivisions, instrumentality and agencies of the government, including governmentowned or controlled corporations with original charters, and local government units, to post in three (3) conspicuous places of their offices for a period of ten (10) days a complete list of all existing vacant positions in their respective offices which are authorized to be filled, and to transmit a copy of such list and the corresponding qualification standards to the Civil Service Commission not later than the tenth day of every month." It further explains that "Vacant positions shall not be filled until after publication: provided, however, that vacant unfilled positions that are: primarily confidential; policydetermining; highly technical; coterminous with that of the appointing authority, or limited to the duration of a particular project shall be excluded from the list required under this Law." Furthermore, its Section 3 focuses on publication of vacancies which defines that 'The Chairman and members of the Civil Service Commission shall publish once every quarter a complete list of all the existing va-

cant positions in the Government throughout the country, including the qualification standards required for each position and, thereafter, certify under oath to the completion of publication." It further reiterates that "The said publication shall be posted by the Chief Personnel or Administrative Officer of all local government units in at least three (3) public and conspicuous places in their respective municipalities and provinces: provided, further, that any vacant position published therein shall be open to any qualified person who does not necessarily belong to the same office with the vacancy or who occupies a position next-in rank to the vacancy." It finally affirms that "The Civil Service Commission shall not act on any appointment to fill up a vacant position unless the same has been reported to and published by the Commis-

Republic Act No. 6725 which is an act strengthening the prohibition on discrimination against women with respect to terms and conditions of employment, amending Article 135. In its Section 1 on Discrimination Prohibited, it articulates that "It is unlawful for any employer to discriminate against any woman employee with respect to terms and conditions of employment solely on account of her sex." It has been specified that "The following are acts of discrimination: (a) Payment of a lesser compensation, including wage, salary or other form of remuneration and fringe benefits, to a female employee as against a male employee, for work of equal value; and "(b) Favoring a male employee over a female employee with respect to promotion, training opportunities, study and scholarship grants solely on account of their sexes. This is interlinked with the Philippine Commission on Women (PCW) advocating the National Machinery for Gender Equality and Women's Empowerment (NMGEWE) that continuously focuses on the presence of Republic Act 9710 called Magna Carta of Women (MCW)." The MCW is a comprehensive women's human rights law that seeks to eliminate discrimination through the recognition, protection, fulfillment and promotion of the rights of Filipino women, especially those belonging in the marginalized sectors of the society. It conveys a framework of rights for women based directly on international law.

Base from the information obtained from the National Council on Disability Affairs (NCDA), Republic Act 7277 which was mandated on March 24, 1992 by the late President of the Philippines, Corazon C. Aquino, is an act providing for the rehabilitation, self-development and self-reliance of disabled person and their integration into the mainstream of society and for other purposes. "Title two focuses on the rights and privileges of disabled persons chapter One (1) specifically tackles on the legal rights for employment under Section 5 on equal opportunity for employment which affirms that "No disabled persons shall be denied access to opportunities for suitable employment. A qualified disabled employee shall be subject to the same terms and conditions of employment and the same compensation, privileges, benefits, fringe benefits, incentives or allowances as a qualified able-bodied person. Five percent (5%) of all casual, emergency and contractual positions in the Department of Social Welfare and Development; Health; Education, Culture and Sports; and other government agencies, offices or corporations engaged in social development shall be reserved for disabled persons."

PDEA, PRO-Cor Nab Drug Personalities in Separate

Operations

LA TRINIDAD, Benguet - The Philippine Drug Enforcement Agency-Cordillera and the Police Regional Office - Cordillera scored big with the dismantling of a drug den in Baguio City and the arrest of various drug personalities in separate operations in the region.

Armed with a search warrant issued by Judge Reynaldo Alhambra of Regional Trial Court Branch 53, Manila, PDEA-CAR swooped on a drug den at Lower Quirino Hill night of May 30 resulting to the arrest of drug den maintainers and three drug users. Also confiscated were 1,016.2317 grams of marijuana dried leaves, six sachets of methamphetamine hydrochloride weighing 3.1072 grams and 18 tablets of diazepam and other drug parapherna-

PDEA-CAR Assistant Regional Director Gil Castro identified the arrested drug personalities as Annabell Del Rosario Atienza, 41, micro financing officer and her common-law husband, Robert Manalili David, 26.

Castro said Atienza and David were members of a notorious drug group operating in Baguio City and La Trinidad, Benguet.

The suspects are now detained at the Baguio City Jail and are facing cases for violation of Republic Act No. 9165 otherwise known as the Comprehensive Dangerous Drugs Act of 2002.

Meanwhile, the Police Regional Office Cordillera arrested four persons involved with illegal drugs in Benguet and Abra.

Significant Number of Meat **Products Condemned**

BAGUIO CITY - The city government here is firm in protecting the people from acquiring illnesses related to eating double dead meat.

During the Monday flag raising ceremony at city hall, city veterinarian, Dr. Brigit Piok disclosed that 48,513 hogs, 2,464 cattle, 107 carabao, 711 goats and 147,505 poultries for a total 199,300 livestock and poultries were inspected and passed for the period of January to May 2015.

A total volume of 6,119,897 kilograms of meat and meat products and 4,007,578 kilograms of fish and fishery products were inspected by passed for the same period.

In the slaughterhouse, the city has confiscated a total volume of 8,019.70 kilograms of meat and meat products because of liverfluke infestation, hemorrhagic/pneumonic, foul odor, gangrenous, brittle and enlarge, cirrhotic, hemorrhagic condition, and "double dead"

While in the city and satellite markets, the city has confiscated at total volume of 2,386.05 kilograms of meat and meat products, and 20 kilograms of green mussel (tahong) because of mishandling, no accompanying meat inspection certificated ("hot meat"), no accompanying auxiliary invoice (source was positive of red tide), adulteration, decomposition with greenish discoloration.

Because of numerous unscrupulous meat vendors in the city mixing the bocha with fresh meat which the sell to customers, mayor Mauricio Domogan recently formed a task force to monitor the sale, proper and hygienic handling of meat and meat products in the in the city market through Administrative Order No. 030, series of 2015.

Baguio City High School Welcomes More than 7,000

BAGUIO CITY — The largest high Studes school in Baguio City and the Cordillera region welcomed more than 7,000 students

during the first day of school on June 1 Monday.

Baguio City National High School (BCNHS) Principal Dr. Elma Donaal said that the main campus recorded 6,404 enrolees with 5,145 in the regular classes and the rest in the Special Programs in the Arts and Sciences, Science Technology and Engineering Programs and the Open High School Program.

The Fort Del Pilar Annex inside the Philippine Military Academy has 801 enrolees while the Hillside Annex has 154 students.

The BCNHS has only two remaining annexes as the other annexes were already converted to national high school status.

According to Donaal, among those they welcomed are the Grade 10 students who will be the first to graduate in the Senior High School under the K-12 program of the Department of

tional disaster risk reduction and management (DRRM) programs amounting to P35 million for this year to be financed under the DRRM fund.

City Disaster Risk Reduction Management Council action officer city administrator Carlos Canilao said most of the projects deal with calamity preparedness including the acquisition of disaster supplies and equipment, preparation of information materials and conduct of trainings with a total amount of P24,213,300.

A total of P7.2 million will be used for prevention and mitigation particularly the conduct of assessment and surveys of the hazardous areas and preparation of local sewerage and septage plan and drainage master plan.

Other projects address the rehabilitation and recovery mostly repair and rehabilitation of infrastructures in the barangays to cost P3,377,000 and response particularly the provision of transportation, medical and burial services, assistance and operation fund amounting to Cont. on page 9

BAGUIO CITY - Rabies is a deadly viral disease most commonly transmitted through dog bites.

Thus, it is the goal of the city government here spearheaded by the city veterinary office to have zero animal rabies case.

City veterinarian, Dr. Brigit Piok reported that out of the 18,000 dog population in the city, their office has vaccinated 14,217

Also, their office has impounded 689 dogs in public places and neutered 26 dogs and cats

'Our office takes care of dogs that bite people while the bite victim is taken cared of by the health services office," stressed Piok.

Pet owners are reminded of ordinance numbered 025, series of 2000 prohibiting dog owners to allow their dogs loose in the streets and outside their homes, and ordinance numbers 09, series of 2008 stating that dog owners must

spective barangay offices and to subject their dogs to anti-rabies vaccination every

Piok said, "the purpose of having a dog is for a guard, for a pet and for the blind as a guide and for the sick for therapy. The guard dog must always be at its post at home and so with the pet dog, the guide dog and the therapy dog must always be home and well taken cared of."

Mayor Mauricio Domogan urged pet owners to be responsible by following laws and ordinances in keeping his dog.

"A responsible pet owner keeps his dog at home and will not allow it to go outside his home to cause nuisance to other people and the community as well. Hindi madaling makagat ng aso dahil mahal ang anti-rabies vaccines," added Domogan.
