Burnham Park should be self-liquidating - Domogan

m AGUIO}$ CITY – Mayor Mauricio G. Domogan underscored it is high time the administration, maintenance and operation of the 34-hectare Burnham Park should be self-liquidating to lessen the burden from the local government that is heavily subsidizing its operation to date.

The local chief executive said to operate and administer the park, the local government needs at least P36 to P40 million annually to do so without the introduction of significant development within portions of the park.

However, he said that the city is only generating between P12 to 15 million annually from the park concessionaires among other income-generating activities within the said park.



Establishments given 30 days to comply with anti-smoking law

BAGUIO CITY Mayor Mauricio Domogan directed all establishments in the city to comply with the provisions of Ordinance No. 34 series of 2017 or the "Smoke-Free Baguio Ordinance" within 30 days.

The measure which was approved last April prohibits the use, sale, distribution and advertisement of cigarettes and other tobacco products in public utility vehicles, government-owned vehicles (mobile and stationary), accommodation and entertainment establishments, public buildings, public places, enclosed public places or

or private place of work except in duly designated smoking areas.

Dr. Donnabel Tubera, tobacco control coordinator of the City Health Services Office under Dr. Rowena Galpo said the measure essentially bans smoking and vaping inside establishments and requires the establishments to identify one designated smoking areas

She said the DSA should be duly approved by the city health officer and must comply with the following requirements: must be located in open space outside schools, youth hostels and

any enclosed areas outside the building with no one's private residence permanent or temporary roof or walls; not located in or within ten meters from entrances, exits of place where people pass or congregate; must not be larger than 10 square meters where food or drinks are not served and minors are not allowed and where signed like "Smoking Area," "Minors not Allowed" and graphic health warnings on the effects of tobacco use are posted.

Tubera stressed that the DSA should not be located in places where absolute smoking bans are in effect particularly centers of youth activity,

> recreational facilities, elevators and stairwells, locations where fire hazards are present like gas stations, public and private hospitals, medical,

∡Cordillera Regional Peace and Order Council (RPOC) requested the regional office of the Philippine Drug Enforcement Agency (PDEA-CAR) to correct the report of its central office that pinpointed Baguio city as a marijuana producer.

The resolution requesting the PDEA-CAR to immediately rectify the said report was unanimously approved by the RPOC-CAR during the joint meeting of the region's peace and order council and the Regional Development Council (RDC-CAR) hosted by the provincial government of Apayao here Thursday.

PDEA-CAR assistant regional director Allan Lloyd Lleaño belied regional office that provided the information to its central office that Baguio city is a producer of marijuana and that he will refer the RPOC's request to higher authorities for them to correct the said report being provided to key local officials from different parts of the to prevent creating a bad country.

Mayor Mauricio G. Domogan, who chairs both the RPOC and RDC in the Cordillera, said that he was surprised to learn about the PDEA central office report that Baguio City has been tagged as

Retail or wholesale stores should secure a permit from the business permits and licensing office and post the sign: 'Sale/Distribution of Tobacco Products and E-Cigarettes to Minors is dental and disallow children below 18 Unlawful;" and "Walang

Sindi;" should secure approval from the CHSO for storages or containments of tobacco products and ensure that these are only opened by store personnel at the counter during actual purchase or when being replenished, cleaned or inspected.

All establishments should establish internal procedure and measures to implement the ordinance in their premises and ensure that all employees are aware of the ordinance. /Aileen P. Refuerzo

Council summons applicant for digterrestrial television station

AGUIO CITY - The City Council will Baguio Ciri - inc ch, communication of the Makati-based Baycomms broadcasting Corporation to explain its planned operation of a digital terrestrial television broadcast station in the city pursuant to its pending application filed before the National Telecommunications Commission (NTC) central office which is now undergoing preliminary hearings.

Members of the local legislative body want the Baycomms Broadcasting Corporation officials to appear before their regular session on September 25, 2017 to shed light on the company's application for digital terrestrial television broadcast station.

Engr. Dante Vengua, newly assigned NTC-CAR regional director, said the Commission is still in the process of requiring the company to submit detailed technical and financial requirements before public hearings can be conducted for the issuance of their provisional authority to operate the said station.

The NTC-CAR official said the local government set conditionalities to the Commission for its consideration before it issues the provisional authority to the company to operate.

However, Vengua admitted the processing of the company's provisional permit could take one year depending on the company's compliance with the requirements for the issuance of the certifi- Cont. on page 5

Cardinal Tagle: 'We cannot govern the nation by killing'

'We cannot allow the destruction of lives to become normal,' Cardinal Tagle says in his strongest written statement against drug war killings

The Philippines' most influential cardinal appealed to the country's leaders **L** on Friday, September 8, to stop the rampant killings in President Rodrigo Duterte's war on drugs, as "we cannot govern the nation by killing."

"With pain and horror, we continue to get daily news of killings around the country," Manila Archbishop Luis Antonio Cardinal Tagle said in a letter issued past 8 am on Friday.

"We cannot allow the destruction of lives to become normal. We cannot **EDITORIAL** govern the nation by killing. We cannot foster a humane and decent Filipino culture by killing," Tagle said.

He continued: "As we denounce as inhuman and un-Christian an act willfully intended and planned to inflict harm or death on a human person, we call on those who harm or kill others to listen to their conscience, the voice of God that summons us to do good and avoid evil."

"Heartless violence can be conquered only by a change of heart and by discovering in the depths of our being the inclination to do good and to love our neighbor," Tagle added.

Issued on the Catholic feast of the birth of the Blessed Virgin Mary, this is the cardinal's strongest written statement against the drug-related killings.

'Stop wasting human lives'

This comes as the deaths of 3 teenagers – 17-year-old Kian Loyd delos Santos, 19-year-old Carl Angelo Arnaiz, and 14-year-old Reynaldo de Guzman fueled public outrage against Duterte's war on drugs.

Tagle issued an earlier letter against the killings in Duterte's anti-drug campaign.

"We knock on the consciences of those who kill even the helpless, especially those who cover their faces with bonnets, to stop wasting human lives," Tagle said on August 19.

More than 14,100 people have been killed in both police operations and vigilante-style killings since Duterte began his drug war in July 2016. Of this number, at least 3,811 have been tagged as drug personalities killed in anti-drug operations as of August 29.

Meanwhile, 2,098 have died in drug-related homicide cases, and 8,200 others in homicide cases under investigation as of June 16.

The Catholic Church is one of the staunchest critics of the widespread killings under Duterte. Other religious groups, such as the United Methodist Church, have also slammed the drug-related deaths in the Philippines. - Rappler.com

HURRICANE IRMA PACKS 555 KPH WINDS: Every American in the US mainland is once again shaking in fear on account of Hurricane Irma, a super typhoon which packs winds of up to 185 miles per hour, or 555 kilometers per hour. The whole of the American continent is still reeling from the impact of Hurrricane Harvey which visited with much death and destruction last week, yet another calamity has come.

According to reports, there is now a severe shortage of gasoline and other petroleum products, including basic necessities such as water and food, as Americans are scrambling one over the other to stock up on these items, for their use while Hurricane Irma is roaring through their cities, or even after it blows over. Many are also leaving their houses and evacuating to areas that would not be hit by the Category 5 typhoon.

What Kind of Change Works?

It started hundred years ago, Filipinos yearned for change. They dreamed about it. They worked for it. And after three foreign countries, they finally achieved their dream of change. The Philippines has became one if not the first to adapt the western style of democracy. A government led by the people for the people.

function or any other authorized affair which may last beyond h curfew time; provided that the police was notified of such affair at least 24 hours before it is held.

*College and/or high school students under the age of 16 shall be exempted from the coverage of the Ordinance; provided that they can show valid certification from their respective Deans and Principals that their class schedules do not permit them to go home before the curfew period established.

*Church members below 16 years of age who are involved in church or other religious activities shall be exempted from the coverage; provided that they can show valid certification from the head or leader of the religious organizations or denominations stating that the said scheduled activities do not permit them to go home before the curfew period established.

*Activities sanctioned by school administration that are scheduled within the curfew period involving among others , children below 16 years of age shall need prior exemption from the Office of the City Mayor through a letter signed by the person in-charge of said activity and noted by the Deans or Principals of the concerned educational institution.

Parents and guardians are also encouraged to monitor and keep an eye to their children and at the same time impose them to be home before the curfew hour, stressed BCPO director Ramil Saculles. /Jho Arranz

areas of the park because the executive orders that were issued turning over the management, administration and operation of the park to the city allows us to generate funds for its upkeep," Domogan stressed.

Executive Order No. 224, series of 1995 issued by then President Fidel V. Ramos as amended by Executive Order No. 695 issued by Gloria Macapagal-Arroyo provides that funds generated from the activities within Burnham Park shall be deposited in a trust fund to be used for the maintenance and operation of the park.

During the initial stages of the management of the park by the city, he revealed that the national government, through the Philippine Tourism Authority (PTA), was providing an annual subsidy of P18 million before it was reduced to P10 million annually until the subsidy stopped for still undisclosed reasons, thus, the local government had to heavily subsidize the maintenance, administration and operation of the park.

According to him, the public should understand that the local government has to sacrifice some of the funds earmarked for its priority projects to sustain its responsibility of decently maintaining, administering and operating the park, one of the preferred tourist spots in the city being located at the heart of the city.

Burnham Park was named after American urban planner Architect Daniel Burnham who master planned Baguio City to be good for at least 25,000 inhabitants.

Among the proposed income-generating projects within the park will be the construction of the multi-level parking facility at the Ganza parking area, a similar multi-level [parking building with recreational business components at the site of the old city auditorium up to the tennis court area, the transfer of the night market to the perimeter of the Melvin Jones grandstand and the possible increase in the rentals of various concessionaries in certain portions of the park.

He said the scenic beauty of the park will be maintained even with the limited business activities because residents and visitors love to frequent the park with their families and to enjoy its various amenities offered to the public. /By Dexter A. See

The local legislative body wants to know from the company the final site of its tower, its coverage and its technical and financial capacities to make available the digital terrestrial television in the country's undisputed Summer Capital that will provide subscribers with alternative channels aside from the existing regular television and cable channels.

Vengua explained the digital terrestrial television operational system is wireless and the applicant is provided with a specific frequency which it could split into six channels, two channels of which could be used for pay-per-view, one channel for emergency while the three channels could be used for the station's regular broadcast activities.

Local legislators also want concerned NTC central office officials to appear during the session to explain the process involved in the issuance of the company's provisional authority and the required certificate of public convenience to operate a digital terrestrial television broadcast station, one of the latest trends in the digital media industry.

Vengua explained to the local legislators that he cannot provide them with detailed answers to their queries as the NTC central office did not furnish him the requested technical and financial documents of the company. /By Dexter A. See

BAGUIO CITY - As a result of the legislative monitoring and evaluation conducted by the sangguniang panlungsod, city ordinance no. 7, series of 2009 requiring carwash establishments to have a drainage system is not being fully implemented considering that most of the carwash establishments have no drainage systems of their own.

It has been reported that the water used for washing vehicles goes directly to the canals, rivers, street gutters or storm drains.

Meanwhile, some provisions of city ordinance no. 18, series of 2016 also known as the environment code of the city of Baguio states; "auto repair and carwash establishments must conduct their business anywhere near and at least ten meters

creeks, rivers, gulleys and streams to prevent the discharge of motor oils, petroleum products and untreated waste water into the waterways. Owners or repair shops shall install appropriate catchment and receptacles for used gas and oils that must be properly placed in sealed containers and disposed of through authorized means. Carwash owners must construct/install a treatment facility like septic tank with grease separator before water is disposed to the drainage

The City Environment and Parks Management Office and the Permits and Licensing Division of the city mayor's office are tasked to monitor the activities of all auto repair shops and carwash estabaway from roadsides, lishments and accordingly /Jho Arranz

pavements, drainage lines, close any business establishments found to be violating the provisions of the city's environment

> No business permit shall be issued for non-compliance.

City council recently passed resolution numbered 302 tasking the CEPMO and the PLD to closely coordinate with all the 128 barangays in Baguio to strictly monitor the compliance to the existing ordinances of all carwash establishments and auto repair shops operating in the city of Baguio.
