o Prosecution Service Named

BAGUIO CITY - the more than a year wait for the Chief of the Prosecution Service in this mountain resort is now over with Malacanang picking its man.

President Benigno Aquino III officially signed the appointment of Prosecutor Sagsago last January 22.

Deputy City Prosecutor Elmer Manuel Sagsago took his Oath of Office as the new City Prosecutor of Baguio Thurday before Regional Prosecutor Nonnatus Caesar Rojas at the Hall of Justice here.

Sagsago was born on August 21, 1955 in Baguio but traces his roots from the hinterlands of the Cordilleras particularly Natonin, Mountain Province.

He replaced former City Prosecutor Gloria Agunos who retired September 28, 2013 with the post unfilled for 1 year and six months.

Sagsago was sworn into office wearing a traditional Baliwon Tribe costume in the presence of his mother Kathrina Manuel, now 80, family members, friends and employees of the Justice Hall.

His stint in government service started in 1984 as a legal researcher of the City Fiscal and slowly climbed the ladder until his appointment as the Deputy City Prosecutor in June of 2011.

Prior to his entry into the Prosecution Service, Sagsago was a civilian instructor of the Philippine Military Academy (PMA).

He is also an active professor in the College of Law of the University of Baguio (UB) and Saint Louis University (SLU)./Pul Rillorta



Mayor Still Optimistic on Road Train Project

BAGUIO CITY - Mayor Mauricio Domogan is still optimistic of the planned Mono-rail Transport System which the Department of Science and Technology (DOST) hopes to run in this mountain resort.

Domogan said, "if everything goes as planned for the Mono-rail project, the city will soon have an alternative mode of transportation which is environment friendly and cost efficient.'

It can be recalled that the DOST is coming up with a Feasibility Study on the Automated Guideway Transit (AGT) or road train for the Central Business District (CBD) as another mode of transport for city residents.

Domogan said, "there is no word yet with regards to the Feasibility Study but hopes it will be finished soon.'

"We requested that the study will be expanded to cover the adjoining municipalities of La Trinidad, Itogon, Sablan, Tuba and Tublay (BLISST) last year that it why it is taking a little longer," he said.

The idea of a mass transport system for the summer capital was hatched in 2013 after a Memorandum of Understanding (MOU) was signed between the DOST and the City government of Baguio to formally start a joint endeavour of conceptualizing an alternative mode of transportation system as a possible solution to pollution and traffic woes.

The project is being spearheaded by the DOST through the Metals Industry Research and Development Center (MIRDC-DOST) in consultation with the University of the Philippines-Diliman.

The AGT or road train technology is designed by Filipino engineers and scientists at UP and DOST –MIRDC.

The train is designed to be fully automated coaches that can hold passengers on the transport needs of BLISST which will run on rubber tires instead of metal wheels.

The results of the study will be presented to the BLISST municipalities and other concerned agencies and stakeholders when finished./Paul Rillorta

Council Okays 21 Departmental Budgets; 12 More Up for Deliberation

BAGUIO CITY - The city council has approved 21 department budgets in the past three sessions and 12 more are scheduled for discussion when the budget deliberations resume tomorrow (Monday) at 2 p.m.

The body gave the green light to the budgets of the following: city assessor's office, city human resource management office, accounting office, Municipal Trial Court in Cities, office of the city auditor, civil registry office, Regional Trial Court, city library, PhilHealth subsidy, Baguio General Hospital and Medical Center (BGHMC), city engineering office, city legal office, city treasurer's office, city buildings and architecture office, Bureau of Fire Protection, city environment and parking management office, health services office, Public Attorney's Office, Parole and Probation Office, city prosecutor's office and the city council.

Up for deliberation are the proposed budgets of the city planning and development office, city administrator's office, general services office, budget office, non-office component, city veterinary office, Bureau of jail Management and Penology male and female dormitories, Baguio City Police Office, city mayor's office, office of the city social welfare and development and the city schools division.

Also up for review is the proposed Annual Investment Plan (AIP) which lists the projects of the city government for this year.

Mayor Mauricio Domogan said the 2015 AIP "allocates P180,656,000, which is 12.03 percent of the city's total budget, for various programs, projects and activities (PPAs) to be funded under the 2015 development fund after a thorough process of project identification and prioritization."

"Basically focused on enhancing people's welfare,

this plan contains PPAs to address the concerns of the city specifically on solid waste management, improvement of Baguio Convention Center, road concreting, sewerline projets, traffic and transportation master plan, develop-

"You are not at war with each other, so shut up and stop fighting in public.' This was the message of Senator Chiz Escudero to the Armed Forces of the Philippines (AFP) and the Philippine National Police (PNP) in the face of the debacle over the deaths of 44 members of the elite police force who were on a mission to get an international terrorist in Mamasapano, Maguindanao last week.

Instead of bickering in public, the leadership of the AFP and the PNP should take their cases to the Board of Inquiry (BOI) and other probe panels that will investigate the Mamasapano carnage, Escudero said.

"If they have so much to say, they can do so within the walls of the Board of Inquiry and before the probing panels. If they want to fight, go lock themselves in a room and do not drag the public into it," Escudero reminded the AFP and the PNP.

The senator said the ongoing word war between the police and the military over responsibility and liability in the PNP Special Action Force operation "is not only unhealthy but unprofessional, as well. It goes to the path of using the incident to turn against each other when they are brothers in uniform."

He added: "If they want respect, they better start by deserving it."

According to Escudero, President Aquino should intervene as commander-in-chief to order both the AFP and the PNP to refrain from further issuing statements that would only stoke the fire.

"Our military and police forces should rally as one in support of law enforcement, justice and peace, and not be at war with each other," Escudero said.

Philhealth — CAR Enlists 86% of Population; Pushes for Universal Health Care Coverage

BAGUIO CITY - To achieve universal health insurance coverage to ensure financial risk protection of every Filipino family remains to be the overarching goal of the Philippine Health Insurance Corporation or popularly known as Philhealth.

Alma Laarni Manzano of PhilHealth Cordillera Regional office, in an interview over PIA Hour at DZWT 540 Radyo Totoo, reported that they have already enlisted 757,920 members comprising 86 percent of the region's population.

Towards achieving universal health care coverage, the Philhealth – CAR through the initiative of Regional Vice President Gerry Ibay, launched project "GUAPO" or Grassroots UHC (niversal Health Care) Project Officers that provides grassroots information, education communication (IEC) campaign around the region.

In terms of member's benefit, Manzano reported that in 2014, Philhealth paid 155,139 claims totalling to around P1.5 billion.

Aside from its health care benefits under the case rates system, Philhealth has also the 'TSeKAP or Tamang Serbisyong Kalusugang

Pampamilya' program which aims to provide preventive care services to their sponsored program members, and overseas workers, as well as Department of Education employees for their employed members.

PhilHealth's TSEKAP provides preventive services such as blood pressure measurement and consultation; diagnostics such as Complete Blood Count and urinalysis, and provision of selected drug/medicines like those for

Expect chilly temperature this Feb., PAGASA-Baguio

BAGUIO CITY - - Activities for Panagbenga 2015 are starting to heat up since it opened last Sunday, but the cold temperature in the city felt especially in the early morning and late afternoon to evening is getting even lower.

Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA - Baguio) weather observer Ian Jasper Pelayo, in an interview, said expect cold temperature for the whole month of February due to the northeast monsoon affecting Luzon and the Visavas.

Based on PAGASA forecast, the northeast monsoon can bring cloudy skies with light rains and moderate to strong wind, and temperature that ranges from 10 to 22 degrees Celsius, he said.

Pelayo said the lowest temperature recorded in Baguio for the year is 9.8 degrees Celsius last February 2.

The coldest temperature so far in Baguio city was 6.3 degrees Celsius, recorded in January 1961.

The multitude of visitors who are expected to troop to the city for the Panagbenga are advised to pack jackets or warmers to protect themselves from the cold weather./JDP/CCD/Christine Faye Kim – UC Intern

Pope Francis Beyond Manila

What events are shaping beyond Pope Francis' successful visit to the Philippines? The Associated Press' Nicole Winfield asked en route to Rome from Manila on the papal flight last Jan. 19.

Which cities in America will you visit? While there, will you go to California for the canonization of Junipero Serra?

Do you intend to preside over the beatification ceremony of El Salvador's Archbishop Oscar Romero? Where? And are you heading to some African and Latin American nations?

"There'll be a war between Cardinal Amato and Monsignor Paglia over which of the two will do the Romero beatification," Francis said, chuckling. Beatifications are normally done by the cardinal of the dicastery.

A shy conservative prelate, Archbishop Romero turned into a blunt, fearless critic of El Salvador's military junta for its abuses. A sniper killed him while he was raising the consecrated host at Mass.

The three US cities are Philadelphia (for the meeting of families), New York and Washington, plus perhaps a stopover at the United Nations, Francis

What if President Barack Obama or the US Congress invites you? Francis waved that aside—for now.

"I'd like to go to California for Junipero Serra's canonization, but there is the problem of time," the Pope added. It requires two more days. So I will do

that canonization at the National Shrine of the Immaculate

Conception in Washington.

Born in Majorca, Spain, in 1713, Father Serra joined the Franciscan order in 1730. He became an eminent theological professor before relinquishing his comfortable life to evangelize in the Americas. From 1769 to 1835, 90,000 Indians were baptized along the US West Coast, from San Diego to San Francisco.

The decision to canonize will not be unanimous. Some prominent critics dub Serra as less than saintly, the New York Times reports.

Deborah Miranda, professor at Washington and Lee University, flay mission mythology as masking the forced stay of about 310,000 Indians in what is now California. Only one-sixth remained 100 years later,

Mission Dolores, in San Francisco's Mission District, was founded by Serra in 1776. Made of adobe and wood, the simple white church abuts a garden and cemetery of slanting tombstones of people with Spanish and Irish

More than 5,700 Indians, many of whom died prematurely, are buried at the mission. In one unmarked trench are the remains of 363 Indians who contracted measles from Europeans. All are buried under what is now church offices, a school, and a parking lot. The only indicator at the mission of their deaths is one thin, wooden gravestone.

The Pope plans to go to the Central African Republic and Uganda this year. "I think this will be toward the end of the year, because of the weather," he said. "They have to calculate when there won't be rains, when there won't be bad weather. This trip is a bit overdue, because there was the Ebola problem. It is a big responsibility to hold big gatherings—contagion, no?

The Latin American countries foreseen to be visited this year—everything is still in draft form—are Ecuador, Bolivia and Paraguay. These three.

"Next year, God willing—but everything is still in draft—I would like to go to Chile, Argentina and Uruguay. Peru is missing there, but we don't know where to put it.

The afterglow from Francis' Manila visit continues. On the papal flight, Filipino reporter Kara David of GMA7 asked: Is there something the Holy Father learned from the Filipinos?

It was challenging, and, as we say in Spanish, "pasada per agua" (it rained on the parade). It is beautiful. The gestures! The gestures moved me, Francis said. They are not protocol gestures, but felt gestures, gestures of the heart. Some almost make one weep. There's everything there: faith, love, the family, the future.

A second gesture is an enthusiasm that is not feigned, a joy, a happiness (alegria), a capacity to celebrate.

Even under the rain, one of the masters of ceremonies told me that he was edified because who were serving never lost the smile on their face. No, no! It was a smile that just came, and behind that smile there is a normal life, there are pains, problems.

There's a word that's difficult for us to understand because it has been vulgarized too much, used too much, but it's a word that has substance: resignation. A people who knows how to suffer, and is capable of Cont. on page 8

MAMASAPANO, WHAT NEXT?

MAMAMAYAN !!!

For those many of us who are watching from the sidelines and from a distance the events unfolding, it's been an emotionally draining week due to the Mamasapano incident. It's a mixture of shock, disbelief, anger, grief! Many a tear has been shed. The agony that struck the sensitivities of all Pinoys still lingers and will continue to

So, where do we go from here?

MAMAMAYAN!!!

That reminds me of that favorite line of the Romans of yore that became the title of that old movie "QUO VADIS", meaning "where to", "where are we going" "what next". On this, I have a few thoughts of my own I wish to share.

FAMILIES - For the families and loved ones of those who died, it is still about grappling with the reality, accepting the painful loss. It is still denial to some. It is about recalling those last moments like the last phone call or the last "goodbye" or those last intimate moments. It is also about how to grapple with life without them. At this time, it is still grief and pain. The human dimension of it all is replete with anecdotal vignettes that if recalled, told and re-told help numb the pain and give temporary solace to those grieving, shunting aside for some fleeting moment about grim death and its concommitant pains. But then, for now, it's more about getting satisfactory answers for their question: "why this?"

MALACANANG — For the palace, it is about telling the angry and suspicious public what actually happened. It is about accountability for what has been perceived as a blunder, a big mistake, a "faux pas", a seeming cover-up. It's about bringing justice to all by punishing those responsible.

Many believe there's a cover-up story to evade accountability even in the highest level: the presidency. It is about stemming the tide of anger and discontent that may lead to public disorder that can seriously undermine the stability of the government. To some it is about President Aquino showing sincere compassion and owning up to his role and responsibility. It's about Citizen No. 1 having the integrity and moral courage to say "I'm sorry", if necessary. It's about the public expectation that President Aquino stops his glib, insincere and evasive posturings and instead takes full responsibility for what happened. Then and only then can he lead in the first step of healing a badly divided nation. Anything short of this will not be acceptable. Anything less will not mollify an already angry and grieving nation.

CONGRESS — As for Congress, it must learn from the lessons of the incident in crafting the law that will entrench the peace agreement by providing the necessary safeguards in the so-called BBL. It must give the mandate to an independent high level body which must look into what actually happened, sparing no one. Never mind the never-ending congressional investigation. Political alignments will screw things up. It will only bring more unnecessary agony and disbelief to all.

Moreover, there is more urgent need now NOT to rush the BBL entrenchment but allow a longer transition period to heal the wounds of distrust worsened and inflicted by this Mamasapano incident. The congressional hearings may have to await the report of that independent investigative body. Also, we need to give sufficient and reasonable time for the MILF to regain lost ground and show its capability to clear its area of the bad guys and do good governance. As of now, there is preponderance of anger against them and distrust. Moreover, it has to mature into a political party to be able to fairly compete with others who

WHITEWASHING PNOY'S LIABILITY IN THE KILLING OF SAF 44: As expected, there is now a frenzied effort on the part of key officials of the Aquino government to absolve President Aquino of any liability in the Maguindanao killing of 44 SAF officers and men on January 25, 2015, with the AFP and the PNP leading the evident whitewash, even at the expense of its officials publicly berating each other.

First, AFP Chief of Staff Gen. Recollections of Mandated Laws for Educational Institutions' Tours and Field Trips (PART 2)

Section 23, under Article IX on sanctions makes it clear that," in order to ensure compliance with the guidelines and regulations stated in this CMO, Commission en Banc may, upon the recommendation of the Regional Offices and CHED legal services, impose the following sanctions depending on the nature and seriousness of the violation or non-compliance of Higher Education Institutions. Any HEI found guilty of violating any of the provisions contained in these guidelines may be subjected to the following sanctions: 1st offense, a written warning;2nd offence is a suspension from conducting educational tours and field trips for a period of time as determined by the Commission en Banc, and the third offense results to the disapproval of the application for other school fees and introduction of fees of HEI; administrative and criminal charges against it/and /or its responsible officers under existing laws and the imposition of penalties such as revocation of permits, downgrading of status, phase-out and such other penalties may be validly imposed by the Commission to concerned HEIs.

To simplify based from CHED'sCMO No.17 of its policies and guidelines on educational tours and field trips of college and graduate students, the CHED has carefully considered specific rudiments under three essential stages : before, during and after the educational tour or field trips.

Before the field educational tour/visit or field trip, the following standards has to be embedded: that the purpose of the educational activity should be linked with the college's curriculum, that the educational activity should have been earlier included in College Handbook which were reiterated earlier to freshmen's General Orientation, that it has to specify the faculty in charge's designation and roles before, during and after the activity; that it has been appropriately coordinated in advanced with local government units and concerned private offices, that a consultation has been conducted to participating students, faculty and sponsors with documented minutes of meetings and attendees'signatures, that the destination chosen be specified including the cost and benefit requirements, safety and its importance to the subiect matter: that the funds and other resources are properly secured and accounted for; that a briefing must be conducted to concerned faculty and students for the purpose of providing the needed information materials; that if applicable, there should be a written plans by the accredited travel agency with the attached Gan Chart duly -approved by the Higher Education Institution; a copy of the itinerary and travel agency's or tour operator's accreditation certificate issued by the Department of Transportation (DOT), that individual or group insurance for the students, faculty and other concerned participants must be provided standard format of learning journals must be given to students for documenting their educational activities, that the educational tour or field trip should be reminded to parents one (1) month to two (2) months before the slated date, that a risk assessment plans and preventive mea-Cont. on page 8

Mini-hydro Power Plant in Ifugao Town Nears Completion

ASIPULO, Ifugao- - The mini-hydro power plant project at Barangay Haliap this municipality is nearing completion.

The project which started in January 2014 is targeted to be completed in June 2015, and expected to be operational after a month.

The project is funded through a grant from the Japan International Cooperation Agency (JICA). It is intended to generate electricity for the community, earn income and provide employment to the people of Ifugao.

The power plant if operational can generate 820 kilowatt hour (KWH) of electric power supply or a total of 5,585.5 megawatt hour (MGH) annually which will be sold to the Ifugao Electric Cooperative (IFELCO) to act as the distributor to the consumers since the host community are not yet technically capable of operating and managing the power plant.

Part of the revenue generated by the project will also be used for the restoration, preservation and development of the Ifugao Rice Terraces and

The power plant called Likud Mini-Hydro Power Plant Project (LMPPP), can help stabilize energy supply with minimal electric cost to consumers in the province. At the same time, it will contribute towards the realization of the Renewable Energy program of the government and the Ifugao Mini-hydro Electric Power Plant Development Program.

Part of the revenue generated by the project will also be used for the restoration, preservation and development of the Ifugao Rice Terraces and its watersheds.

The feasibility study of the LMPPP was conducted in 2011 and after several consultation meetings with the stakeholders consisting of the Ifugao Provincial Government, JICA representatives and the residents and local officials of the affected communities of Barangays Haliap and Panubtuban of Asipulo and Barangay Duit of Kiangan, the project proceeded.

The LMPPP is implemented with the help of the technical expertise of the Tokyo Electric Power Corporation and contracted by the IWATA Construction Corporation also of Japan but the actual work is subcontracted by local contractors./JDP/DBC-PIA CAR, Ifugao

Ifugao Farmers go on Study Tour in Organic Farms

LAMUT, Ifugao -- Organic farming practitioners from the municipality of Hingyon and technicians from the Provincial Government went on an expository and study tour to learn more about organic gardening and greenhouse projects.

The group first visited the Integrated Organic Farm of Villafuerte Camat Jr. here, who is the regional awardee on organic farming. Camat explained to them how he prepares fermented organic feeds for his swine farm using the plant Azola which is found in his fish pond which he also manages using organic farming methods.

Azola is the main plant ingredient in his organic feeds. This is mixed with rice bran and other concoctions such as sugar.

The group also went to Rancho Domingo in Barangay Namillangan, Alfonso Lista owned by Jesus Domingo, a regional organic farming awardee in the cattle farming category.

Rancho Domingo is an integrated farm where organic vegetables, swine, chicken and catfish are produced using organic farming methods. It makes use of readily available farm materials which are fermented and used as feeds for the animals and are also fed to worms called "African Night Crawlers" that produce vermicast, an organic fertilizer.

The farm also features the container gardening strategy that uses sacks and trellises which is observed to be more effective and less expensive than the conventional garden plots

Rancho Domingo is currently serving as the hands-on training facility for on- the-job agriculture students from the Ifugao State University and other nearby schools.

The group also visited the Green House managed by Faustino Gamutan also in Alfonso Lista that produces organic pechay and other green vegetables. Gamutan said he is trying to grow carrots to see if it is possible to produce them inside the green house.

They also went to the green house farm of Ferdinand Buscas located nearby that features banana mushroom production.

According to the farmers and technicians, they were inspired and determined to also try to venture into these kinds of organic farming activities./JDP/DBC-PIA CAR, Ifugao

SUMMONS BY PUBLICATION

WHEREAS, plaintiff through counsel filed this verified complaint in this Court on July 25, 2014 quoted as follows:

COMPLAINT

With all due respect to the Honorable Court, plaintiff by counsel respectfully avers that:

1. Plaintiff is of legal age, married, Filipino and a resident of FA050 Cabanao, BSU Compound, La Trinidad, Benguet, where she has been residing for more than six (6) month prior to the filing of this complaint; while defendant is likewise of legal age, married, Filipino and a resident of 585 Gibraltar Road, Baguio City, where he may be served with summons and other court processes:

2. Plaintiff and defendant met sometime in 1997 in Sagada, Mountain Province, where both parties were attending the wedding of their relatives. The parties became lov-

ers a year later and what ensued for the next ten years was a complicated relationship but somehow, the parties made the wrong decision of getting married;

3.Plaintiff and defendant were married January 3, 2008 before Judge Delilah N. Gonzales-Munoz of MTC La Trinidad, Benguet, copy of the Marriage Contract attached as annex "A";

4. Thereafter, the parties live as husband and wife and stayed in Norway where both parties were then working:

5.During their marriage both parties exhibited immaturity and psychological incapacity which is permanent, incurable and grave personality disorder;

6.On the part of the defendant, he exhibited a permanent, incurable, and grave personality disorder, which condition prevented him from fully appreciating and complying with his essential marital obligations, as manifested by, but not limited to the following:

a) Defendant is extremely attached to his family so much so that he is preoccupied on how he can help hisfamily rather than attending to his obligations to his wife and soon to be children;

b) While defendant is employed and earning modest income, the plaintiff was solely responsible for herself, and defendant's earnings are being kept and spent by him as he pleases;

c)Defendant has the strange attitude of not making effort to help or alleviate the stress, or other form of sufferings of the plaintiff as his wife, but is willing to spend all his time, effort and resources to help other people in need;

d)Defendant exhibits manifest attraction to any beautiful woman he comes close to and even in the presence of his wife, he can't help himself but show his interest in other women;

e)Defendant often indulge in too much alcohol even inside their apartment which he does every day after coming home from work, thereby resulting in frequent quarrels;

f)Defendant became extremely arrogant towards the plaintiff, he always quarreled with the plaintiff without apparent reason;

g)Defendant often times speaks to the plaintiff in unnecessarily high tone of voice, instead of intimate tone appropriate for husband and wife;

h) Whenever plaintiff is not with him, he always suspects that plaintiff is having an affair with another man;

i)Defendant exhibited violent and raging temper towards the plaintiff even to the extent of physically attacking the plaintiff by throwing whatever objects he gets hold of, so much so that he had totally disregarded his wife's needs and sensibilities and failed to give the love and affection that would have cemented their relationship:

i)Defendant, for unknown reason, wrongfully accused the herein plaintiff of taking large amount of money supposedly deposited in a joint account, but the truth is there was no joint account of the parties because as mentioned above, each of the parties kept their own money, and settle their respective liabilities:

7. On the part of the plaintiff, she also exhibited permanent, incurable, and grave personality disorder, as manifested by, but not limited to the following:

a)While plaintiff may have initially married defendant out of love yet she failed to sustained her relationship with the defendant by continuous shower of kind understanding and support rather than confronting the defendant with antagonism and vindictiveness whenever they have misunderstanding;

b)Whenever they have serious quarrel, plaintiff often simply absorbed everything to the point of falling into extreme depression, rather than confronting the problem directly;

c) Plaintiff failed to share her predicament with the people close to her or even to the defendant, and chose to solely bear the burden she was experiencing, which made the situation extremely serious;

d)In the end plaintiff was defeated by stress, pressure, and hatred and broke her will, thereby putting the relationship in an irreversible condition.

8.Plaintiff was forced to spend some time alone and became desperate which eventually led to a more violent quarrel between the parties.

9.It is clearly shown that the psychological incapacities of the parties existed before the marriage, which psychological incapacity is grave, permanent, incurable, and has prevented them from complying with their marital obligations and that they will never be able to comply with their marital obligations towards each other;

10.The misunderstanding became extremely bitter that the parties were forced to live separately. The plaintiff went home to her parents in Sagada, Mountain Province while defendant was left in Norway;

11.Defendant is apparently having an affair with another woman, but plaintiff is so frustrated and depressed that she don't feel the need to

confront him;

12. For more than six(6) years of marriage, the herein parties were unable to bear a child, which further aggravated the feeling of inadequacies between the parties;

13. There is absolutely no hope for reconciliation as both parties fail or refuse to recognize their inadequacies;

14.The parties have acquired no conjugal real properties and other properties of value;

15. The plaintiff now seeks the said of the Honorable Court so that after due notice and hearing, the marriage contracted by the parties be declared null and void pursuant to Article 36 of the Family Code of the Philippines;

sures be provided to students and stakeholders, that waivers / medical clearances of students authentically signed by parents or physician and medical aid kits for the participants are prepared prior to the activity, that the parent/guardian consent are duly notarized to be submitted prior to the educational tour or trip.

The rule for this is found in Section 2, Rule 112 of the Revised Rules on Criminal Procedure. But even while MTCs are legally part of the judicial branch of government, they are considered officers of the Department of Justice when they carry out preliminary investigations, so that their resolutions are appealable to the Department, not to superior courts.

fects of carbon dioxide (CO) in high altitude places like Baguio. Citing researches and studies, Del Rosario said the influx of tourists to high altitude areas like Baguio "may dramatically increase pollution levels in general and CO levels in particular" since "the local CO level or concentration is affected by regional characteristics: seasons; altitude and lateral variations, urbanization degree, populace and amount of vehicular traffic.

He said that the city may consider studies showing that vehicles tuned up for lowland driving condition emit more (CO) when used for mountain driving.

Vehicles tuned for mountain driving emit 1.8 times more CO at 2,424 meters (8,000 feet) than at 1,600 m (5,200 ft.). Whereas, vehicles tuned at sea level driving condition emit almost four times more CO at an altitude. CO emission is increased at altitude by driving at reduced speed along steep grades under poor driving conditions and by the cold weather conditions prevailing at altitude," he quoted.

"CO emission increases dramatically during cold weather because more fuel is needed to start at cold temperature and some emission devices such as oxygen sensors and catalytic converter (if equipped) operate less efficiently when they are cold.

He also warned of the danger of death while riding at the back of motor vehicles.

'Children in this case are the most vulnerable as they are the usual back riders. Accidental poisoning from exposure to exhaust in pick-up trucks, riding under a rigid and closed canopy on the rear of the trucks and other tragedies might also happen inside fully enclosed transit vans, school buses and camper trucks," he warned.

"Possible delay in diagnosis in these situations is fatal since initial symptoms were consistent with motion sickness and many parents or guardians would normally believe that their children were just asleep while in fact they were already unconscious. Moving vehicles with vertical tailgates or door and opening the rear window can result to the drawing of exhaust into rearmost compartment. Holes in the car body, floorboards or leaks around windows or doors may also allow fumes to enter passenger compartment. Worn out improperly replaced mufflers may cause dizziness and possible death."/A Refuerzo

Air Quality in Baguio for

BAGUIO CITY - The ambient air quality readings in the city for 2014 had been fair to good in various parts of the city except for one area, Mayor Mauricio Domogan said on Wednes-

The mayor said this was based on the 2014 roadside ambient air quality monitoring report submitted by the wastewater, water and ambient air management division (WMD) of the city environment and parks management office bearing (CEPMO).

The report showed the year-round readings of the monitoring devices put up in various sampling locations in the city utilizing the pollution index of particulate matter (PM10).

The readings were generally good at Upper Session Road, City Hall grounds, Diplomat Heritage Park Dominican Hill, Camp John Hay, Scout Barrio, Pacdal Circle and Mines View where the air quality index value ranged from 0-54 micrograms per cubic meter (ug/m3) from March to December.

Fair readings were obtained at Malcolm Square, Happy Homes Old Lucban Burnham Park, City Social Welfare Development Office grounds, Igorot Garden, UP Baguio campus, Bell Church, Veterans Park, Kabayanihan and Naguilian Road which had a range of 55-154 ug/m3.

The lone area which registered a failing mark was at the Baguio City Police Office particularly at the intersection of Abanao and Kayang St. near the overpass going to City hall where the index value reached 190 ug/m3, which is unhealthy for sensitive groups.

The mayor urged vehicle owners in the city to ensure that their vehicles are always in good condition so as not to contribute to air pollu-

He also submitted to the CEPMO for consideration the inputs submitted by Mario Alvarez Del Rosario, inventor of the water reactor Mario D'Hybrid technology on the ef-
