Baguio City- The heart of Worthy Acosta's ballot theft story as stated in a sworn affidavit submitted to the Comelec investigation panel revolved around the alleged participation of former Congressman Bernardo Vergara and Ferdie Balanag in the alleged electoral offense.

In paragraph 18 of his Affidavit, Acosta said, "sometime before June 30, 2013, I was instructed to go to Baguio". Acosta then says, "about a day or two after" he travelled to Baguio where he allegedly met respondent Vergara and that "the following day" he went to the warehouse where the ballots were kept and that he then opened the ballot boxes and stole the ballots with Balanag. All in all, Acosta said that he stayed in Baguio for "three or four days". Thus, even assuming that he got the instruction to go to Baguio on June 30, 2013 and he did travel a day or two later on July 2, 2013 and that he stayed in Baguio for four days or until July 6, 2013 - it would have been impossible for respondent Balanag to have accompanied Acosta in stealing the ballots since Balanag was out of the country from June 17, 2013 to July 7, 2013.

Seeks Council characterization study Tomas Site

BAGUIO CITY - the city council here is asking for a master development plan for the Santo Tomas area covering approximately 139 hectares in this mountain resort.

This came as plans for the area as a multi-use site emerged during deliberations to approve the Terms of Reference (TOR) for the planned Engineered Sanitary Landfill (ESL).

The council however will return the TOR for the development of the city's ESL to the Solid Waste Management Board (SWMB) unacted.

This was decided Monday after Councilor Betty Lourdes Tabanda inquired from City General Services Officer Romeo Concio the complete paper works for the Integrated Solid Waste Management System (ISWMS).

Tabanda said, "what was forwarded to the council is the endorsement for the approval of the TOR on the future development of the ESL."

City General Services Officer Romeo Concio said, "they did not yet submit documents for the ISWMS and the revised 10-year Solid Waste Management Program pending completion of the Waste Analysis and Characterization Study (WACS) preparatory to the development of the city's waste sys-

Concio added, "the conduct of the waste

was bidded-out twice unfortunately, but there were no takers.

"We are in the process of a negotiated procurement for the WACS, the amendments to the 10-year solid waste management program is dependent on the completion of the WACS that is the reason why we are not yet submitting it, " he said.

Concio however requested the august body to give them more time until they have completed the negotiated procurement on the WACS being the guiding principle for any development on the waste system.

Concio was invited to present to the council the waste system operation and its components and documents prior to approval of the TOR for the planned sanitary land-

It can be recalled that five potential sites were investigated and the Santo Tomas Site was recommended by the monitoring committee and eventually approved in city council Resolution number 78-

Concio updated the council on the present status of the Santo Tomas area and the components of the system consisting of a central Materials Recovery Facility (MRF), Environmental Recycling System (ERS), Engineered Sanitary Land-

Development Plan for Santo Rebid Deal, Dont't Appeal Postpone "No Plate, No Travel" SC Decision on Smartmatic Policy Implementation

Senator Chiz Escudero said that a no-election scenario in 2016 was impossible after serious concerns emerged following the Supreme Court's decision to nullify a deal between the Commission on Elections (Comelec) and Smartmatic for the repair and maintenance of 82,000 voting machines for next year's national polls.

The high court nixed the Comelec-Smartmatic deal amidst allegations of indiscretion and abuse surrounding the awarding of the repair contract, but Escudero said the SC ruling will not impede the conduct of the 2016 elections since there were other options available to the poll body.

"Postponing the elections is not possible. Under the Constitution and even under our laws, elections cannot and should not be postponed, Escudero said. "Comelec has no power to do that. Their only mandate is to supervise elections in our country every three years. And precisely because elections happen only every three years, there is no reason for the Comelec not to do it effectively."

Escudero, who heads the Senate Committee on Finance, said the best option for the Comelec was to bid out the contract anew as there is still enough time left to do so.

"Para sa akin, mag-bidding na sila at huwag nang umapela sa sa korte upang sa gayon ay mas magkaroon sila ng sapat na panahon para dumiskarte at gumalaw pa ng naaayon sa SC decision. Lalo na at unanimous ang desisyon ng korte, malamang hindi na 'yan babaligtarin," the senator explained.

According to Escudero, if Comelec would stick with the bidding process and procedures, there is still time to address the technical needs for operating the machines and even Congress has time to help the poll body if needed.

'May sapat pang panahon. Ngayon kung magkukulang sila ng pera, alam ko may savings pa ang Comelec na humigit kumulang dalawang bilyong piso; pwede nilang kunin dun. Kung may kailangan pa silang dagdag na gastusin, ipagbigay alam nila sa amin para sa lalong madaling panahon maaksyunan ng Kongreso at maibigay ang kinakailangang pondo para sa automated elections sa 2016," Escudero said, as he dismissed the possihility of going back to manual elections next year in Treiaed Treng in Last Scenson OFFICIAL

fill (ESL), Waste-to-Energy (WTE), Anaerobic Digester (AD) and Health Care Waste Treatment Plant (HCWTP).

Concio said, "the survey of the area has been completed and the Solid Waste Management Board is awaiting the Geophysical study being done by

the Bureau of Mines on the soil structure in the area.'

"The road leading to the site, an alternate route is being prepared by the Office of the City Engineer," he said.

Concio requested the council to hold in abeyance the discussions for the ISWMS until the WACS is accomplished.

Concio said, "they have already requested Cont. on page 8

Cong. Aliping Helps Indigents Together with DSWD

BAGUIO Rep. Nicasio M. Aliping Jr. has assisted over a thousand indigent constituents with a roll out of more than P13 million from the Department of Social Welfare and Development (DSWD)'s Assistance to Individuals in Crisis Situations (AICS) program.

The AICS is a little known program of the DSWD to help defray the cost of emergency situations which indigents can avail. A maximum of P5,000 per individual can be availed of by the recipient. Beneficiaries have been given financial assistance to pay for a myriad of crises including burial assistance, hospitalization aid, educational support, and transportation help.

'Although there is maximum amount which can be disbursed, we make sure to carefully assess the crisis of the beneficiary so we can recommend a higher amount to be released by the DSWD," Rep. Aliping said.

He added, "We make sure that we not only help pass quality laws for the entire country, but we also help our indigent residents of Baguio access financial assistance from government to directly assist them in their crisis."

Last year, 1,774 locals took advantage of the AICS through the referral and assistance of Rep. Aliping and the congressional staff at the Baguio City Hall office.

A total of P13,024,029 have been disbursed to the beneficiaries referred by Rep. Aliping in 2014 alone.

"We hope to help more of our constituents through this program so that they can feel directly how government is taking care of them," he added.

Majority of the financial assistance sought under the AICS allotment of Rep. Aliping come in the form of medical assistance, burial assistance

Nominees Last Straw

STEPPING DOWN. Ex-Customs Commissioner John P Sevilla resigns, after refusing political appointments.

MANILA, Philippines - When newly-resigned Customs commissioner John "Sunny" P. Sevilla first took the post in December 2013, it didn't take long before text messages and phone calls started coming in.

They came from government officials – people asking for favors, political appointments – but Sevilla, who vowed to run the bureau without politics, ignored the requests. Appointments especially, he said, should be the call of the deputy commissioner who would oversee those positions.

"Early on, actually days within I started, there were already lots of pressures for me to move certain people to certain sensitive positions," Sevilla told Rappler in an exclusive interview on Thursday, April 23, his first since he publicly announced his resignation.

"When it all started it was texts and phone calls. From people I knew within government. None of these were, 'Do this.' It was all, 'Hey you know so and so is counting on this. So and so wants so and so to be placed there.' But I thought if you give in to one, its a slippery slope.'

His refusal to play along worked. For about a year and 4 months.

"I did not think that anyone outside of Customs or outside of government should have any say in appointments in Customs so I just asked the relevant deputy commissioners," he said.

But on Wednesday, April 22, Sevilla submitted

his resignation to the Office of the President after receiving word that an appointment he opposed is set to go through.

Intellectual Property Rights Division acting chief Teddy Sandy Raval has been pushed "very hard" for an appointed position in the Bureau - for the post of Director of Enforcement and Security Service (ESS), more commonly known as head of the Customs police. The position would oversee the 400 or so armed police force of Customs.

Sevilla had no information on Raval's qualifications for the post, but the only reason always being given, he said, was that Iglesia ni Cristo (INC) or Church of Christ - a group that has grown to 2.25 million followers - wanted Raval there.

'I said, 'What is this? Why are we appointing people at the behest supposedly of Iglesia ni Cristo? That just goes against my own principles. Every assurance I made to our own team here at Customs that politics and influence-peddling would have zero role in appointments and promotions in Customs," he said.

"So I tried to resist that appointment for as long as I could. I learned fairly recently that the appointment is going to come through. I said, 'Look there is something that is not right about this and I think it is something that's important enough to the future of Customs and to me personally to take a stand against."

On Thursday, with little fanfare and seeming abruptness, Sevilla announced his resignation. There have been rumors since January that he was on his way out. There had been some personal attacks here and there and talk of powers-that-be easing him out, but when Rappler last spoke to Sevilla 3 months ago, he denied he was stepping

Did anyone ask him to leave his post this time around?

"I'd rather not answer that," he said.

Customs' Sevilla: Political Travel Clearance Needed for Minors Traveling Abroad Alone, DSWD

BAGUIO CITY - Children who are travelling abroad alone or with companion other than their parents should secure a travel clearance from the Department of Social Welfare and Development (DSWD) here before applying for the children's passport in the Department of Foreign Affairs

In the issuance of clearance for minors travelling abroad, the children's parents or legal guardians submit documents to the DSWD to ensure that the travel to be undertaken is favorable to the minor's safety and well-being. Assigned social worker assesses the documents and recommends the approval or disapproval of the request for a travel clearance.

'Aside from the travel clearance being a DFA requirement, securing a travel clearance shall protect the children from the threat of human trafficking," DSWD-Cordillera Regional Director Janet P. Armas said.

Human trafficking or trafficking in persons is an act of recruitment, transportation, transfer, or receipt of persons by means of threat or coercion, abduction, fraud, deception, abuse of power, or compensation, with or without the consent of the person for the purpose of exploitation.

Minors Travelling Abroad Section (MTA) Focal Person Julie Balagot advised applicants to secure all necessary documents when filing for a travel clearance to facilitate the process. "The processing and release of Cont. on page 8

Solon Goes After Baguio's **Share of CIH Rent**

BAGUIO CITY - Baguio Rep. NIcasio M. Aliping Jr emphasized that he together with other city officials will make strong representations with the Bases Conversion and Development Authority (BCDA) to collect the city's 25% past dueshare of the rentals from Camp John Hay.

This developed as the Office of the Ex-officio Sheriff of the Regional Trail Court Branch 6 served the Notice to Vacate to Camp John Hay Development Corporation (CJHDevCo) representatives Monday afternoon.

The order was addressed to CJHDevCo "and all persons claiming rights under them [CJHDevCo].'

When Rep. Alipinglearned of the Notice to Vacate, said Wednesday, April 22, that he will make representation with BCDA president and CEO Arnel Paciano Casanova on how to collect the city's share from the PhP 1.4 billion the Philippine Dispute Resolution Center, Inc. (PDRCI) ordered the government-run corporation to return to CJHDevCo.

The amount represents the rental CJHDevCo paid to BCDA for the first years of its operations of the former American rest and recreation facility located in Baguio.

Previous to the issuance of the notice, Casanova opined that the city can collect its share from the amount BCDA is set to return to CJHDevCo.

He also gave the similar advice to other third parties of interest to the case particularly the locators, sub-lessees, unit owners, and golf club

It was learned that Regional Trial Court Branch 6 Judge Cecilia Corazon Dulay-Archog ordered BCDA to set up a trust fund, the amount would be deposited and which the court will disburse to CJHDevCo depending on the Cont. on page 8 Cont. on page 8

City Working Out Requirement to Rev up *Waste Program*

BAGUIO CITY - Waste program implementors here are working on the main requirement to jumpstart the Integrated Solid Waste Management System (ISWMS), a multi-strategy program for the long-term solution of the city's garbage woes.

City general services officer Romeo Concio of the City Solid Waste Management Board said the city is in the process of bidding out through negotiated procurement the waste analysis and characterization system (WACS), which will serve as the basis of all solid waste projects in the city and even the ten-year solid waste management plan.

He said the WACS contains primary data needed to determine the viability of solid waste projects and thus is essential to the implementation of the ISWMS.

Concio also said that regular biddings for the WACS failed so the city will undertake the negotiated mode.

Concio also said the CSWMB has withdrawn the proposed terms of reference for the engineered sanitary landfill (ESL) earlier submitted to the city council for approval deciding to pursue the project alongside the other component strategies of the ISWMS.

The board earlier thought of advancing the implementation of the ESL as an immediate solution for the city to stop hauling its waste to outside facilities but the city council balked at the piecemeal pursuit of the ISWMS and questioned some of the terms including the cost and the life span of the proposed facility.

Concio explained that the ESL is intended only as a support facility or as a stop-gap waste strategy while the city is still constructing the waste-to-energy technology which is the main strategy of the ISWMS thus they did not plan for a larger facility with a longer life span.

"In fact, if we can help it we really do not want to construct an ESL because of its effect on the environment. Climate change program advocates are now wary of the effect of the methane gas being emitted by the ESL facilities that there is now a pending proposal at the United Nations to ban these facilities, Concio said.

Mayor Mauricio Domogan when told of the council's question on the short life span of the proposed ESL said, "To me, the shorter the lifespan is, the better for the city because even the World Health Organization is now discouraging ESL because of their seepage underground. Until now, there is no concrete finding on their long-term effect to the environment," he said.

The city's ISWMS consists of several waste management strategies intended for long-term management of the city's wastes among which a waste-toenergy technology, a central

AFP Chief: We're on Our Own Against China

MANILA - Armed Forces Chief of Staff Gregorio Catapang has admitted Filipino soldiers will have to go it alone if armed conflict erupts in the West Philippine Sea between the Philippines and China.

Catapang said the United States would not come to the defense of Manila, its long-time ally.

"We understand the treaty, it does not include the West Philippine Sea, and so we want to develop our own capabilities. When the time comes that we will be on our own, given the training with the Americans, we can do it on our own," Catapang said in an interview with ABS-CBN News. "It's a contested area. Until now it's in the international tribunal, so we have to be realistic."

Catapang was referring to the 1951 Mutual Defense Treaty (MDT) between the Philippines and United States, which compels both nations to come to each other's defense if an external armed attack occurs in metropolitan areas, island territories in the Pacific

Ocean, or armed forces, vessels, and aircraft in the Pacific. The MDT makes no

mention of the South China Sea, also known as the West Philippine

Catapang's position is different from that of the Department of Foreign Affairs.

The DFA said the US considers the West Philippine Sea to be part of the Pacific Area, based on a letter of former US Ambassador Thomas Hubbard to former Foreign Secretary Domingo Siazon.

NO SOLUTION

When the Enhanced Defense Cooperation Agreement (EDCA) was signed a year ago in April 2014, its proponents said it would help the country solve problems in the West Philippine Sea.

"To me, the value of EDCA is in the assistance during times of calamity and it will serve as a deterrent to would-be aggressors, then AFP Chief of Staff Emmanuel Bautista told ABS-CBN News in

By June, the agreement's constitutionality had been challenged thrice before the Supreme Court. No temporary restraining order was issued.

In December, Defense Secretary Voltaire Gazmin told a Senate committee hearing the EDCA had successfully kept China's aggression at bay.

"Kita nyo, hindi tayo ina-atake sa pag-resupply ng mga tropa sa Ayungin Shoal," he said.

But while EDCA was being discussed at the Senate, the court, and in the streets, and as questions about the sincerity of the United States continued to linger, China quietly but swiftly reclaimed land and constructed runways and buildings in seven different reefs within disputed waters.

At least five incidents involving Chinese vessels in the West Philippine Sea were also reported last year.

"EDCA will not solve our problem," Catapang said.

P450B modernization plan

But building a credible defense and security posture could help. Unfortunately, it will take at least P450 billion and decades before the Philippines achieves this goal.

In the meantime, Catapang said the US can aid the Philippines through training, equipment, and information.

Facilities that may be built or refurbished under the EDCA could also be useful. But any aid would come before, not during, an armed conflict./by Gigi Grande, ABS-CBN News

Students after completing their K to 12 may start to work for some time and can again enroll in the undergraduate courses without reverting back to the basic subjects of the course they plan to achieve.

And to address this crucial need, the Commission on Higher Education (CHED), Technical Education Skills and Development Training Authority (TESDA) and the Department of Education (DepEd) as three educational governing bodies in consultation with the Philippine Regulation Commission (PRC) cooperatively devised a means of promoting quality education in the country and this is through the Ladderized Education Program (LEP) as mandated by Republic Act No. 10647.

Other government agencies have expressed their support: the PRC, Department of Labor and Employment (DOLE), Department of Agriculture (DA), Department of Science and Technology, (DOST) Department of Trade and Industry (DTI), National Economic Development Authority (NEDA) and the Department of Budget and Management (DBM), among other concern agencies as this pedagogical process goes.

The LEP under "Ladderized Education Act of 2014." approved on November 21,2014 by President Benigno S. Aquino III is a result of the consolidated Senate Bill No.2272 and House Bill No. 3575 passed by the Senate and the House of Representatives on September 24,2014

According to this Act, "It Promotes an equal opportunity rights of all citizens to quality and accessible education at all levels and to establish and maintain and support a complete, adequate and integrative system of education relevant to the needs of the people and contributory to national development. "Therefore this elucidates a policy for the state to institutionalize and ladderize the gaps between Technical-Vocational Education and Training (TVET) and Higher Education of which the TVET graduates and even workers have easy access in Cont. on page 7

Mar Roxas: 'I was Betrayed by President Aquino'

MANILA, Philippines (The Adobo Chronicles) – Initially one of the leading contenders in the 2010 Philippine presidential elections, now Secretary of Interior and Local Governments Mar Roxas slid down to become a vice-presidential candidate in order to make way for then Senator NoyNoy Aquino. Roxas was was defeated by Makati City Mayor Jejomar Binay by the narrowest margin in the history of the Fifth Republic.

In the last 5 years, Roxas has been one of Aquino's staunchest supporters and apologists, often sacrificing his own reputation and integrity just to make Aquino look good in the eyes of the Filipino people.

Now, Aquino is reportedly mulling on courting Senators Grace Poe and Francis Escudero to run as a tandem under the Liberal Party in the 2016 presidential elections, as the ratings of presumptive standard bearer Roxas fail to improve.

Binay is the opposition party's standard bearer.

Upon hearing of Aquino's plan for the party, Roxas screamed an expletive, the same one that he was heard saying at a campaign rally in 2010. (The Adobo Chronicles is a family-oriented news site, so we can't print the expletive.)

"I have been betrayed," Roxas said. "After all that I've done for Aquino, this is what I get," he added. A very religious man, Roxas likened himself to Jesus being betrayed by Judas

In his frustration, Roxas told reporters that if he is not annointed as the party's standard bearer, he will immediately resign as Local Governments secretary and work for Binay's political campaign. "Let's see who will have the last laugh," Roxas said.

Customs' Sevilla...

released a press statement on Friday's turnover ceremony for the new commissioner – Alberto D. Lina, a known supporter of the ruling Liberal Party and a close friend of Finance Secretary Cesar Purisima. Lina was also Customs chief under former president Gloria Macapagal Arroyo.

Sevilla's resignation comes just a day after he announced his refusal to have the Bureau used as a fundraiser for the coming elections.

Sevilla, a former finance undersecretary, boasts an Ivy-league education, having graduated from Cornell and Princeton. Prior to joining the Department of Finance, Sevilla was an investment banker. He worked as executive director at investment bank Goldman Sachs, and was associate director and sovereign rater for credit rating agency Standard and Poor's.

Sevilla has a subdued air about him, and is not one to speak much to media. He works long hours, and does it all again the next day, and is the first to admit that the job is tough – but he sincerely believed, and still does – that reforms in the agency are still possible.

Just not with him at the helm.

Sevilla speaks of a changing atmosphere in the Bureau – one that has become tangibly more political as the country approaches the 2016 presidential elections in May. And because he knows he is not a politically savvy person, he decided to step down.

Even now, he admits he still does not know who is behind all the pressure for the appointments.

"To be honest, I don't exactly know because the name that was being dropped all the time was Iglesia ni Cristo. Nobody from Iglesia ni Cristo ever spoke to me so I have no direct knowledge of whether this is really Iglesia ni Cristo. I also find it hard to believe that the INC would do this. Maybe it's just a name being dropped. But obviously powerful from page 3

people (are behind this)," he said.

The INC is known for its strict rules. Aside from bans against marrying non-INC members, gambling, and excessive drinking, it requires members to vote only the politicians whom their leaders endorse. This is where it gets its political influence – in its powerful bloc voting.

During elections, it has been a tradition for candidates, from the local to the national levels, to make a pilgrimage to INC leaders to secure their support. The INC has also been known to lobby for government posts for members of its church.

Sevilla may have no evidence, aside from what he has been told, that it is the INC indeed pushing for Raval. But in his press conference, Sevilla talked about how, in June 2014, Deputy Commissioner of the Enforcement Group Ariel Nepomuceno, challenged Sevilla's new process of promotion and appointments – which opened up positions to both insiders and outsid-

"He (Nepomuceno) said, 'Officers of ESS are requesting only insiders be considered for senior positions in ESS because it might demoralize people, and there's a certian chain of command and experience that should be preserved,'" Sevilla said.

"I told him and some senior members of ESS, 'I don't agree that we should only promote insiders. We need new blood, we need to be open. Once we start making exceptions, our credibility will be undermined. My promise is a level playing field when it comes to promotions."

If Raval does get the appointment, he will report to Nepomuceno who is also reportedly supported by the INC.

Full support of Palace?

Sevilla refuses to name names of who sent him text messages and who called, only saying "people in government." Asked whether he thinks the pressure comes all the way from the top, he shrugs his shoulders.

CORRUPTION. Widespread corruption is a problem associated with the Bureau of Customs.

The point is, Raval may soon be appointed by the President – despite Sevilla's irreverent objection. And while Sevilla concedes this is well under the jurisdiction of President Benigno Aquino III, he simply feels wrong about it, knowing there have been people pushing for Raval to get that post.

"Put it this way. I have my own theories but I won't talk about what they are. I think the mere principle of a political appointment is wrong in and of itself. And I think it imperils the consistency of merit-based hiring and promotions within Customs that we have been trying so hard to achieve," he said.

"The fact that elections are just a wee bit more than a year away makes me 10 times more sensitive to these types of considerations."

Meanwhile, while Malacañang, Rappler spoke to Sevilla on outside pressures weighing in on Customs, Communications Secretary Herminio Coloma Jr was simultaneously and perhaps ironically telling reporters that "whoever is appointed to the position can expect the full support of the Palace and the Department of Finance.

'It felt wrong'

During Sevilla's tenure, he was able to grow the Bureau's collections by 21% year on year. He made moves toward transparency and efficiency, and filed 30 administrative cases against erring individuals. His entry into the Bureau was trumpeted as the start of reforms in one of the government's most corrupt agencies.

On social media, netizens expressed surprise and sadness at Sevilla's departure, but Sevilla is hopeful "they find someone better than me to go forward."

He admits he could have possibly dealt with political appointments, but simply said it was something he felt the need to take a stand against, adding, "when your conscience bugs you about something you've got to listen to it."

"It didn't sit well with me. It felt wrong. It felt like something I shouldn't just let go by," he added.

"Could I have dealt with it? Yes I could've dealt with it. There are ways to deal with it, yes. But I can already sense the environment is changing. I think it's better for someone who has the skills to navigate in a much more political environment to take over at this point."

Sevilla said he had already submitted suggested names to the Palace, but did not want to share his list to give the President full discretion.

He did say, however, that the next person would need to have integrity – "given the extent of temptation in a place like this" – an ability to think strategically, and someone who can "navigate a much more political environment without compromising principles and efficiency."

He said he has also neatly outlined key points for continuity, for his successor.

"One – do we achieve 4-hour processing time by the end of this year? Two – do we achieve paperless processing by next year? I've outlined in more detail than anybody wants, for whoever comes after me, what we are trying to do, what we've gotten to do – what's the situation today – and what would have been my next steps," he said.

"Now obviously whoever comes in may have ideas of their own. But the next person, I'd like that person to at least have the benefit of the stuff I've thought about. Whether she or he wants to continue in that direction, or tweak it, or has better ideas, that's obviously up to them."

Reforms possible

Despite the evident challenges of the post – one of the "most challenging ones out there," as he describes it – Sevilla is grateful for hav-

ing had the opportunity to work as Commissioner.

"I regret absolutely nothing. I regret the fact that I started a lot of stuff and didn't get to finish it but I have no regrets whatsoever. Serving the people of this country has been the greatest honor of my life and that's something I will carry with me for the rest of my life," he said.

And while "it takes a lot out of whoever is sitting here," he also believes the job is doable, and reforms possible.

"I think there's no reason to give up on Customs. There's no reason to give up on the prospects of reform," he said.

For most of the interview, Sevilla spoke with a sense of excitement in his voice, perhaps relieved and almost ecstatic about the decision he finally made, considering that the idea of resignation had been on his mind for quite some time.

He joked about drinking "more beers than I've ever drank in my life put together," now that he has resigned, and how his mother is the happiest person on earth. But his voice dropped when asked what he wants people to know about Customs, following his departure.

"I think what's important to know is that this effort has been a huge team effort. I've been the face of it just because we're a culture that's very personal but behind me have been hundreds, maybe thousands, of brave, risk-taking men and women who, despite the fact that they know they work for the most hated government agency out there, take risks and make sacrifices every day. And those people are still there," he said.

"So there's no reason to despair. But it's going to be tough. It's a tough situation but the elements of success are all there. I could pull out my phone right now and show you texts that would make you cry. I'm not talking about reactions to my departure. I'm talking about texts that have come through in the last 14 months by people telling me, 'You know. We seized this. And my wife got visited by armed people she doesn't know at her house."

He paused, "That's the kind of sacrifice I'm talking about. Made by people who are still there." / Natashya Gutierrez /Rappler.com

for a few days after", why then did Balanag ask for Acosta's phone number only on August 2, 2013? It negates any suspicion that Balanag was a coconspirator. Verily, it exonerates Balanag.

The private confidential Facebook messages between Acosta and respondent Balanag all talk about an educational forum on August 16, 2013. Nothing about any supposed plot to steal ballots. And certainly, there is nothing in the confidential text messages that would show any crime being committed by respondent Balanag. As would be detailed in the counter statement of facts below. respondent Balanag was only informed by respondent Congressman Vergara on August 2, 2013 about the request of Worthy Acosta for assistance in putting up an educational forum on Election Irregularities. On that same day. respondent Balanag contacted Acosta for the first time. Other than the perjured narration of Acosta, there is nothing – no evidence to show that respondent Balanag participated in stealing ballots with Acosta "sometime June 30" 2013 and for a few days after".

travel clearance usually takes 3-5 days, but due to incomplete documents, some applications take longer. So, we encourage our clients to complete the necessary documents before filing", Balagot said.

Among the requirements in securing a travel clearance include duly accomplished application form, photo copy of the birth certificate or passport of minor, written consent of both parents, solo parent or legal guardian permitting the child to travel alone or with someone else, two colored passport size photos of the minor taken within the last 6 months, and a photocopy of which is applicable, marriage certificate of minor's parents, certificate of legal guardianship, solo parent identification card issued by the local social welfare and development office or death certificate of deceased parent of mi-

Application for travel clearance can be filed at the DSWD-Field Office Cordillera Administrative Region or in the Provincial Social Welfare and Development Offices (PSWDOs) in their areas.

The 42-year old business and civic leader cited the unfortunate experience of the BCDA with CJHDevco adding that if only government had the right business partners to deal with, "John Hay would have been a much better place (for investments) than it is right now."

Pantaleon said the business club will respect the decision of the court as she urged "wellmeaning CJHDevco officials to just respect the court order."

The court's notice of eviction is expected to be a prelude to finally close the long-running legal tussle between CJHDevCo and the BCDA.

"It is important that we are united and we want a smooth transition," Pantaleon said and cited that some sublessees who entered into original contracts with the departing CJHDevco might be facing legal problems.

"I am sure JHMC (John Hay Management Corporation) will take care of them," Pantaleon said.

JHMC is a subsidiary of the BCDA and is tasked to oversee the development of the former US military camp in Baguio City.

A number of sublessees and sublocators were reportedly duped by CJHDevco to enter into lease contracts for 50 years in spite of the latter's lease agreement with the BCDA for only 25 years.

The BCDA claimed that CJHDevco failed to disclose these transactions in spite of the government's

Earlier, the BCDA through its president and CEO ArnelPaciano Casanova said that the sublessees are part of the Notice to Vacate and, therefore, CJHDevCo should be held liable to these sublessees for damages.

"Sublessees should lay claim to the P1.4 billion that BCDA will be returning to CJHDevCo as part of the Writ of Execution," Casanova said.

Pantaleon, on the other hand, said unlike commercial establishments with yearly contracts, most of those affected by contracts tainted with irregularities are hotel residents or homeowners or buyers of log homes.

"Tens of millions of hard earned money by some of these buyers were invested for their vacation place or retirement home," Pantaleon said and expressed concern that some of these buyers who originally dealt with CJHDevco will be affected by the eviction notice.

JHMC "The Help Desk is also a good thing," she said referring to the government's support center inside Camp John Hay for sublocators and sublessees which will eventually demand compensation from CJHDevco for the unfinished portion of their contracts.

"The MILF and our own peace panel always say that these are just regional offices. Kung regional office 'yan, ilagay natin sa provision na regional office yan. counter affidavit a faithful copy of his passport and travel documents attesting to the fact that Balanag was out of the country during the time of the commission of the alleged crime. The Bureau of Immigration stamp on Balanag's passport shows that he left the country on June 17, 2013 and that he came back on July 7, 2013. Balanag travelled to the United States of America with his 80 year old father and returned to Manila on July 7, 2013. He rested in Manila for a day and retuned to Baguio on July 8, 2014. Obviously, it was impossible for Balanag to have accompanied Worthy Acosta in allegedly stealing election ballots in Baguio.

The flight and booking records of Balanag attached to his counter affidavit shows the fact that he indeed left the country for San Diego on June 17, 2013 aboard Japan Airlines and that he left San Diego California for Manila on July 6, 2013 using the same Airline. It was therefore ridiculous for respondent Balanag to have participated in the ballot stealing story of Acosta.

The truth of the matter is that no arrangements were ever made by Tingting Cojuangco and former Biliran Cong. Glenn Chong with Vergara for any ballot retrieval or ballot-stealing plan. Vergara recalls receiving a phone call on August 2, 2013 from Cojuangeo on a proposal to hold an Educational Forum in Baguio on Election Irregularities and for herein respondent to assist a certain Worthy Acosta. Putting up an Educational forum is a millennium away and vastly different from stealing ballots. Vergara thereafter called up respondent Balanag and instructed him to contact this Worthy Acosta and assist him in organizing the said forum.

Balanag's affidavit states that he only got to know of Acosta on August 2, 2013. attached to his affidavit are faithful copies of the private confidential facebook messages that were exchanged between Acosta and respondent Balanag. It can be gleaned from these Facebook messages that the earliest confidential conversation between Acosta and Balanag transpired on August 2, 2013 at around 6.42pm to be precise. The conversation is damning for Acosta's story. It is quoted below as follows,

"Conversation started August 2, 2013. Ferdie Balanag: Magandang gabi sa iyo Worthy. Paki send naman

Lawmaker : BBL Should Withstand Legal Challenges

Chiz Senator Escudero has asked the Senate Committee on Local Government for a thorough review the proposed Bangsamoro Basic Law (BBL) to ensure that the legislation could withstand any legal challenge once the bill is passed.

"Iyan po ang hiniling ko na kay Senator Marcos, as chairman of the Committee on Local Government, na sana provision by provision ay ma-discuss natin para mapagharapharap lahat ng stakeholders. Ang problema puro press release ang laban ng OPAPP (Office of the Presidential Adviser on the Peace Process at GRP (Government of the Republic of the Philippines), Escudero said.

"I look forward to engaging the advocates of the BBL, including OPPAP, the MILF (Moro Islamic Liberation Front), the Advisory Committee on the issues of constitutionality and unconstitutionality of some of the provisions. I don't think we should just sit on it

and let it drag on," he added.

According Escudero, the contentious issues in the BBL must be settled because getting the law passed at its present form is very unlikely.

As chairman of the Senate Committee on Finance, Escudero previously said he wanted a line-item budgeting for Bangsamoro government since it will receive P70 billion for its first fiscal year.

Escudero is pushing to amend separate provisions in the proposed BBL for the creation of constitutional offices like the Civil Service Commission (CSC), the Commission on Elections (Comelec), the Commission on Audit (CoA), the Office of the Ombudsman and the Commission on Human Rights (CHR). These can be consolidated, he said, in a single provision.

Escudero takes the position that the Constitution does not allow the creation of the equivalent of the said agencies.
