## A Solemn, Heartbreak rival Honors for Saf's Fallen Men

Even the toughest men couldn't hold their tears.

This was the scenario at Villamor Air base as the government gives arrival honors to the 42 fallen members of the Special Action Force.

At least 44 policemen perished in what authorities said were a "misencounter" with alleged members of the Moro Islamic Liberation Front and breakaway group Bangsamoro Islamic Freedom fighters at Mamasapano, Maguindanao while chasing high-ranking terrorists Zulkifli Abdhir and Basit Usman.

The 42 caskets, all draped with a Philippine flag, were slowly carried by marching pallbearers, from the C-130 plane to the Villamor Air base grounds. Two of those who died have already been buried in Zamboanga.

Some policemen and soldiers were seen on television desperately tying to hold back tears, as they give honors to their fallen comrades.

## Baguio City's Crime Volume Down by 13.5%

BAGUIO CITY - During the meeting of the City Justice, Peace and Order Council (CJPOC) last Tuesday, the Baguio City Police Office (BCPO) through P/Supt. Leon Talleo, chief of the BCPO Operations Unit disclosed that the crime volume in the city went down by as much as 13.5 percent or from 10,755 to 9,299 incidents last year compared to the same period last 2013.

The index crime rate also decreased by 14.3 percent while the non-index crime rate fell by 12.7 percent.

Despite its low percentage, crimes against property or theft remains highest with 2,612; robbery with 566; and carnapping with 23.

On crimes against persons – 1,639 cases of physical injuries; rape cases of "The significant decrease of crime volume last year is a good indication that the public is aware of their duties and responsibilities as residents of Baguio to report crime incidents and that the city of pines still remains to be one of the safest community and place to live in," said Talleo

Furthermore, the authorities were able to arrest 469 wanted persons, arrested 1,873 persons thru warrantless arrest.

Also they has successful operations against illegal drugs (20 buy-busts, 1 marijuana eradication, 42 arrested pushers/users, 26 cases filed); arrested three under PDEA Watch list; and arrested 7 members of Bahala na Gang involved in drugs.

On illegal gambling, the authorities had 27 successful operations.

## Lawmaker Put to Justice Those Responsible But Don't Give up on Peace

Senator Chiz Escudero said that the quest for peace in Mindanao must not be abandoned following the deadly clashes in Mamasapano town that left 44 members of the elite police force dead and 11 others injured, but wanted those responsible for last Sunday's carnage brought to the bar of justice.

"The government

cannot simply brush aside the fact that a lot of our policemen died performing their duty. Someone must be held to account, even MILF members if they will be found to be at fault. The lives our policemen gave must not be for naught," Escudero said.

## Mayor Urges Muslim Community to Support Illegal Vending Drives

BAGUIO CITY – Mayor Mauricio Domogan called on the city's Muslim Community to support the campaign against illegal vending in this mountain resort.

This came as another incident of clashes between Public Order and Safety Division (POSD) personnel and Muslim vendors happened again in the Central Business District (CBD) this month.

Domogan said, "the Muslims residing and having business deals in the city is part of the city's community and are not exempt from the laws and ordinances."

"I urge them to cooperate with our law enforcement to prevent untoward incidents, we are not discriminating them, we are treating everyone fairly," he stressed.

The mayor also renewed his call for vendors not to sell in areas not designated as vending areas to avoid confiscation of goods especially in alleyways, streets and pedestrian walkways.

Domogan said, "vendors who violate the no vending policy and those who do not adhere to rules and regulations being implemented will be dealt with and cases will be filed against them."

As per reports of POSD personnel, they were implementing saturation drive on vendors who have illegal extensions in pathways when the incident transpired.

The vendors were verbally warned not to extend on the sidewalk and a verbal agreement was reached however, some vendors refused to remove their illegal extensions prompting POSD personnel to confiscate the cellphone stand including its contents which sparked the conflict.

The mayor warned he won't bow down to them if they don't follow the city's ordinances.

"The city will defend its POSD personnel if what they are doing is right but we will not tolerate them if what they are doing is wrong," he said.

Meantime, cases between the POSD personnel and the vendors have been filed before the city's courts for action./Paul Rillorta

## OCD – CAR Reports a More Disaster- Resilient Cordillera

BAGUIO CITY - The Office of Civil Defense Cordillera regional office (OCD – CAR) reports a more disaster resilient Cordillera in 2014.

Through the leadership of regional director Andrew Alex Uy and guidance of Civil Defense Administrator Alexander Pama, a more empowered regional and local disaster risk reduction management (DRRM) councils resulted in a lesser number of casualties and damages during the occurrences of typhoons and emergencies in the region.

Last year, the report showed no death was officially recorded in the Cordillera, and two missing and five cases of injury only. In 2013, strong typhoons plus the Southwest monsoon resulted to three deaths, 35 injured and one missing.

"Pro-active programs, services and advocacies resulted to zero-casualties during the occurrences of major weather disturbance in Cordillera last year", Uy said.

He added that all regional civil defense personnel are properly trained and capable to respond to emergencies anytime. The OCD had spearheaded 22 capacity building activities for local DRRM and also facilitated several local DRRM and contingency planning as re-

quested by various local government units, region wide.

For this year, Uy said they are looking forward to still a more resilient Cordillera through the delivery of more capacity building programs and advocacies, as well as on strengthening partnerships and bringing in more partners to DRRM and climate change advocacy efforts.

Uy disclosed that OCD is already focusing on the establishment of early warning and communication systems; preparation of regional plan DRRM roadmap; and the strengthening of public and private partnerships, as well as expanding the DRRM network in as many local community as possible.

To ensure that local DRRM Councils are in sync with the regional DRRM council, OCD is also set to monitor the updating of their respective comprehensive or enhanced DRRM plans and the establishments of their local DRRM Office, and creation/appointment of their respective DRRM officer and personnel.

Uy also called on the public to also ensure that year-round preparedness and DRRM efforts are instilled in their own homes, families and communities towards zero-casualty in any disaster, calamity or emergency./

## **Baguilat Calls for Justice for** Slain Soldiers, But keeps Support for BBL

BAGUIO CITY - Ifugao Representative Teddy Brawner Baguilat has called for swift justice for the soldiers killed during the "misencounter" in Mindanao last Sunday, but said legislators should take "the high road" and retain support for lasting peace in Mindanao through the passage of the Bangsamoro Basic Law.

Baguilat said the mood among legislators had dramatically turned toward pessimism following the massacre, but he said the peace process should continue despite the considerable odds, and that means making those who made the mistake of mis coordination and inefficient intelligence gathering accountable.

"This should not only be on the government side, but also with the MILF. If the MILF truly wants to have the BBL to pass in Congress, then it should show its sincerity by policing its ranks and more importantly by helping hunt down the extremists," he said. Baguilat said it was

emotionally difficult for him to stay true to the call for peace considering that Cordillerans were among those who were mercilessly killed during the fierce battle.

"Cordillerans thousands of miles away died for the country. They are among the fiercest warriors of the country and were recruited as special forces and usually assigned in strife-torn areas because of their skills in warfare. jungle Cordillerans are really paying ultimate sacrifice to maintain peace and order in the country," Baguilat said.

He said among those from the Cordil-

## City Grieves Death of Cops

BAGUIO CITY - The city government joined the nation in mourning the death of the 44 elite policemen, 13 of whom hailed from the Cordillera region, in an Mamasapano, encounter in Maguindanao last Jan. 25.

'It was very sad and very unfortunate that it happened in Mindanao and while the peace agreement is being worked out. Words are not enough to express our sympathies. We condole with the families of our fallen policemen," the mayor said.

Domogan and other city officials and employees were expected to join the vigil and necrological service rendered by the Police Regional Office Cordillera (PRO-CAR) for the 13 Cordilleran cops. They are Sr. Insp. Cyrus Anniban of Balbalan, Kalinga; Sr. Insp. Gednat Garambas of Tabdi of La Trinidad, Benguet; PO3 Robert Domollog Allaga of Banaue, Ifugao; PO3 Noel Onangey Golocan of Mankayan, Benguet; PO2 Peterson Indongsan Garap of Kabayan, Benguet; PO2 Nicky De Castro Nacino Jr. of Baguio City; PO1 Russel Bawaan Bilog of Baguio City; PO1 Gringo Charag Cayang-o of Sadanga, Mt. Province and PO1 Angel Chocowen Kodiamat of Mankayan, Benguet.

Their remains arrived Friday night at Camp Bado Dangwa where night's vigil was held. Saturday morning, a necrological service was conducted before their remains were brought to their respective hometowns by their families.

The city officials also sent a message of condolence to the families of the local policemen.

"We express our deepest sympathies and heartfelt condolences to the bereaved families of the late (policemen) who was treacherously murdered by members of the Moro Islamic Liberation From (MILF) and Bangsamoro Islamic Freedom Fighters (BIFF) on 25 January 2015 as per series of print and broadcast reports in various media outfits over the past days while in the performance of their sworn duties and responsibilities to effect the arrest of wanted foreign terrorists but were among the 44 fatalities of the celebrated 'Mamasapano massacre' in Maguindanao;

"The fallen law enforcers who were members of the (PNP)-Special Action Force (PNP-SAF) were considered (heroes) as (they) died while in the performance of their sworn duties in the midst of the territory of high profile criminals in the rebel-infested Maguindanao area. His gallantry and bravery is worthy of emulation;

"The untimely demise of a huge number of members of the country's police elite force put the nation in mourning as the country lost a good number of its dedicated, responsible and true public servants who died in line of duty."/A Refuerzo

## City Signs Agreement with Kaltimex on Asin Hydro Operation

BAGUIO CITY - Mayor Mauricio Domogan on Friday signed a memorandum of agreement with Kaltimex Energy Philippines for the privatization, development and operation of the cityowned Asin mini-hydroelectric plants in Tadiangan and Nangalisan, Tuba, Benguet.

The signing came after Kaltimex fully complied with the requirements set in the terms of reference (TOR) for the project. The firm was awarded the project last July 17 after winning the fifth bidding that employed the negotiated procurement method.

Kaltimex chairman Krishan Kumar Ralhan signed the agreement for his company.

By virtue of the MOA, the city government will turn over the mini-hydropower plants to Kaltimex "unencumbered and without any accounts payable to any authorities whatsoever" for rehabilitation, upgrading, expansion, operation and management for a period of 20 years.

Kaltimex, for its part, will undertake the full rehabilitation, upgrading, expansion of the three power plants within four years commencing upon

the issuance of the notice to proceed, with a minimum capitalization amounting to P500,000,000 spread over four vears as based on the typical plans showing the initial Project Implementation Rehabilitation Schedule it submitted.

The notice to proceed will be issued within ten days from the confirmation of the contract by the city council.

Kaltimex will also submit not later than six months from the issuance of the notice to proceed the detailed working plans with work schedules and the environmental compliance and disposal plan of the project based on a detailed engineering Feasibility Study of the Asin Mini Hydro Power Plants as basis for the construction, rehabilitation, operation, and also for the evaluation and monitoring of the project.

Failure to submit said documents shall be a ground for the rescission of the agreement.

The firm will pay the city monthly rental fees which for the first two years will amount to P18 million or the peso equivalent of 32 percent of gross power plant production valued at the prevailing selling price, Cont. on page 9

### The life of Nazareth

The knee-jerk reaction of journalists who retire after spending a lifetime chasing the next headline is to cast about for the next one.

Take it from us who have spent over half a century in this quest, and forget it.

The best thing is to take instead a good hard look—and consider copying—the silence that Jesus spent in an unnoticed life in the hick town of Nazareth.

Anonymity and a dull routine constituted most of His 33 years of life. His public life spanned only three years. And most of that was compressed to His teaching years and the week leading to His crucifixion as a common criminal.

Many scholars, like Charles de Foucauld, have been captivated by those almost 18 years of silence. He was captivated, like many others, by Christ growing up and working as an obscure carpenter.

The silent preaching that Jesus did in His ordinary, day-to-day activities became something that De Foucauld wanted to emulate. It grew to be the context of his discipleship.

How many of us feel the similar tug to live a life of simplicity, being little and joyful, doing ordinary things, out of love for God?

Jesus came to Nazareth, the place of the hidden life, of ordinary life, of family life, of prayer, work, obscurity, of silent virtues. Nazareth is the place where most people like us lead our lives.

It's not just the next headline, or officials dodging Senate committee sanc-

tions, that really matter in the long run.

The life of Nazareth can be followed anywhere, in places where it is most helpful to your neighbors. Nazareth is anywhere we work in humility, poverty and silence.

After the Christmas Nativity and the flight into Egypt, Christ and His family withdrew to Nazareth. There, He spent the years of childhood and youth, till he was 30 years of age and appeared in the Jordan.

Again, what was the meaning of that part of His life? It meant continuous instruction, not in words, but by silence and example, De Foucauld suggests.

He was teaching all of us that it is possible to do good to men—great good—without using words, without preaching, without fuss, but by silence, goodness toward those about one, and domestic duties fulfilled without griping. The example of poverty, lowliness, and recollection: The obscurity of a life hidden in God, a life of prayer, penance and withdrawal, completely lost in God, buried deep in Him.

"I was teaching you to live by the labor of your own hands, so as to be a burden on no one and to have something to give to the poor. And I was giving this way of life an incomparable beauty—the beauty of being a copy of mine," De Foucauld writes.

"And He went down with them," the evangelist Luke writes, "and came to Nazareth and was subject to them."

"He went down." His whole life was spent in "going down." He went down in the Incarnation, going down to be a small child, going down in obedience, in becoming poor, abandoned, exiled, persecuted, tortured, in always putting Himself in the lowest place.

"When thou art invited, go, sit down in the lowest place." It is what He did Himself from the time of His coming into the feast of life till the time of His death. He came to Nazareth, the place of the hidden life, of ordinary family life: a life of prayer, work and obscurity, the silent virtues, practiced with God, His close relations, and His neighbors as the only witnesses. It was a humble, holy, obscure life of well-doing—the life of most human beings. For 30 years, He was our example of it.

"He was subject to them." He, God, was subject to them, human beings, so becoming our example of obedience, humility and, in the real sense of the word, renunciation as infinite as His divinity.

The Feast of the Visitation, which commemorates the time Mary went to visit her cousin Elizabeth (Luke 1:39-56), was very meaningful to Charles de Foucauld.

"Even before I was born, I was working on this mission, the sanctification of man ... and I urged my mother to work at it with Me.

"Here and now I am saying to others: I tell them to sanctify souls by silently carrying Me among them.

"To souls in silence, leading the work at it as my mother does; silently, without words."

Being a "universal brother" to everyone was essential to De Foucauld's understanding of the life of Nazareth.

From his writings:

There is always work to be done by example, goodness and prayer. We can enter into closer relationships with souls that are lukewarm or estranged so as to lead them gradually, by the power of our patience, gentleness, and goodness, by the influence of virtue rather than advice, back to a more Christian life or to the faith itself.

#### **DIMENSIONAL ROAD**

Recollections of Mandated Laws for Educational Institutions' Tours and Field Trips (PART 1)

Educational tours and field trips define extensions of classroomlearning amongstudents. These additional methods of instructions thatbenefitthemmore than the educators responsible for planning and initiating the said activities not to mention the complexities in making educational -related transactions. Before the conduct ofthese instructional processes, it is perceived that students andeducators should besafeguarded from any untoward incidents and liabilities, respectively. The previous tragic events that have been streaming as breaking newsin the public are reflections among educators who initiate outdoor activities to fully understand the laws that govern educational tours and field trips. Furthermore, both students and teachers shouldcomprehend the distinctions between educational tours and field trips based from the mandates implemented by educational authorities. The Department of Education (DepEd) has (3) threegoverning laws that apply to elementary and secondary students' extended activities particularly on educational tours or field trips: Department order No. 52 series of 2003, Department Order No. 51 series of 2002 and Department Order No. 56 series of 2001.

According to Department order No. 52 series of 2003, schools should secure the written consent of students' parents and guardians; no punitive measures should be imposed upon those who opt not to join the field trip; the field trip should be well planned ahead of time and that safety measures should have been well deliberated; the tour should be set in natural and historical sites where educational insights shall take place like science exhibits and museums; trips to malls and noontime TV shows are discouraged; trips if possible should be sponsored to augment financial burdens from parents. This department ordertoo emphasizesthat the existing provisions from Department Order No. 51 series of 2002 and Department Order No. 56 series of 2001 are still effective.

One particular point to cite is the consent of students' parents and guardians. Parents and guardians should be aware that there is no any responsibility of the school upon their approval that's why there is a need to weigh and consider how safe the children or wards are in their areas of destinations; both parents and guardians' discretion should be cautiously exercised for the welfare of the students.

The Commission on Higher Education (CHED) memorandum order No. 17, series of 2012 emerged after series of disasters related with College field trips and educational tour incidentsperceives the well-being of students involved and covers the policies and guidelines on Educational tours and field trips of college and graduate students.

Section 4 of this CHED memorandum Order (CMO) defines clearly the distinction between a field trip and an educational tour. "Educational tour is an extended educational activity involving the travel of students and supervising faculty outside the school campus which is relatively of longer duration usually lasting for more than one day and relatively more places of destination than a field trip." The Field trip on the other hand, "is an educational activity involving the travel of students and supervising faculty outside the school campus but is of relatively shorter duration usually lasting for only one day and with fewer places of destination."

Section 5 specifies the objectives of this CMO

## Cayetano: MILF wants Dictatorship over BBL-Covered areas

Uproar over massacre a 'wake up' call to gov't

Sen. Alan Peter S. Cayetano castigated the Moro Islamic Liberation Front (MILF) for playing down the murder of 44 PNP-SAF men as a mere



misencounter that it said should not affect the peace process and the enactment of the Bangsamoro Basic Law (BBL).

Cayetano said if the MILF maintains this position and does not show any effort to show genuine sincerity, then it may be a preview of what's to come if the BBL is passed into law: a violent dictatorship over the areas covered by the measure.

"It is time to open our eyes to the impunity by how the MILF disregarded, not only the rule of law, but the value of human life in Sunday's gruesome killing of our policemen. We should wake up. We are focused on peace but the government is surrendering to the MILF. What is clear is that this is an indication of how they would act in case the BBL is passed into law, which is to run their areas like a dictatorship," said Cayetano, who earlier withdrew his support and co-authorship signature for the BBL.

"Ngayon pa lang na hindi pa binibigay ang areas nila ay ganyan na ang ginagawa, pano pa kung me kapangyarihan na sila? Bawal ang pulis, bawal ang law enforcement at bawal ang walang coordination."

The senator said that the MILF by coddling terrorists and their supporters is a cause for grave concern.

"This early, it is clear that the MILF's plan is to set up a totalitarian kingdom, which will also be safe haven for terrorist and violence. If the BBL is killed where it stands, it is because of the MILF's lack of sincerity," he said.

Earlier, Cayetano said the MILF wanted power more than peace in Mindanao. He submitted a letter to the Senate to signify his position.

"Already the country is losing in the war against drugs. Imagine if terrorists and drug lords find a haven in one region and become untouchable just because there is no coordination?" Cayetano said.

"If this massacre happened anywhere else in the country, the government will be up in arms and perpetrators will be brought to justice. Why is the MILF, who obviously still has ties with BIFF and terrorists, so special?"

What is worst, he added, is the MILF warning to the government against entering Maguindanao and not to pursue perpetuators of the massacre.

"There will only be true peace if govern-

## City Joins Civil Registration Month this BAGUIO CITY – the National Statistics Of-

**February**BAGUIO CITY – the National Statistics Office (NSO) and the Civil Registry Office (CRO) here will be extending free services come February as part of the celebration of the Civil Registration Month here.

The scheduled free issuances of certified copies of civil registry documents such as birth certificates, marriage certificates and death certificates are however scheduled on February 27.

The Civil Registration Month is observed every February of each year as mandated by Presidential Proclamation No. 682.

The celebration is simultaneous with the nationwide celebration with the theme, 'Sama Ka sa CRVS GROUPIE'.

NSO serves as the frontline government agency attending to various concerns of Filipinos regarding records and documents on birth, marriage and death while the CRO is in charge of these concerns within the city.

As per latest report from the CRO for the year 2014, there are at least 10,957 births, 1,667 marriages and 2,333 deaths recorded in the city's registry books.

At least 135 petitions for Change of First name have been acted upon.

Petitions for change of first name and correction of entries mostly stem from wrong entries on birth records such as dates, status, misspelled family, middle or first names, unmarried parents and the child's family name does not reflect the father's surname.

There are also 1,181 for correction of clerical error and 154 migrant petitions.

Correction of Typographical Errors in the Day and Month in the Date of Birth or Sex of a Person Appearing in the Civil Register without the need of Judicial Order can also be done as per Republic Act 10172;

Discrepancies in the original name as indicated in the birth registry and the current name presently being used for official transactions are also common including the use of baby boy and baby girl in the birth certificate among others.

This discrepancies or errors may be remedied through Republic Act 9048 or the Clerical Error Act and for births that does not reflect the father's surname can be remedied through an Affidavit to Use the Surname of the Father under Republic Act 9255;

The city also recorded 5,026 children born out of wedlock. Legitimation of children born to parents under the marrying age can be undertaken under Republic Act 9858./Paul Rillorta

WHEREAS, plaintiff through counsel filed this verified complaint in this Court on July 25, 2014 quoted as follows:

#### COMPLAINT

With all due respect to the Honorable Court, plaintiff by counsel respectfully avers that:

1. Plaintiff is of legal age, married, Filipino and a resi-FA050 dent of Cabanao, BSU Compound, La Trinidad, Benguet, where she has been residing for more than six (6) month prior to the filing of this complaint; while defendant is likewise of legal age, married, Filipino and a resident of 585 Gibraltar Road, Baguio City, where he may be served with summons and other court processes:

2.Plaintiff and defendant met sometime in 1997 in Sagada, Mountain Province, where both parties were attending the wedding of their relatives. The parties became lovers a year later and

what ensued for the next ten years was a complicated relationship but somehow, the parties made the wrong decision of getting married;

3.Plaintiff and defendant were married January 3, 2008 before Judge Delilah N. Gonzales-Munoz of MTC La Trinidad, Benguet, copy of the Marriage Contract attached as annex "A";

4. Thereafter, the parties live as husband and wife and stayed in Norway where both parties were then working;

5.During their marriage both parties exhibited immaturity and psychological incapacity which is permanent, incurable and grave personality disorder;

6.On the part of the defendant, he exhibited a permanent, incurable, and grave personality disorder, which condition prevented him from fully appreciating and complying with his essential marital obligations, as manifested by, but not limited to the following:

a) Defendant is extremely attached to his family so much so that he is preoccupied on how he can help hisfamily rather than attending to his obligations to his wife and soon to be oblidators.

b) While defendant is employed and earning modest income, the plaintiff was solely responsible for herself, and defendant's earnings are being kept and spent by him as he pleases;

c)Defendant has the strange attitude of not making effort to help or alleviate the stress, or other form of sufferings of the plaintiff as his wife, but is willing to spend all his time, effort and resources to help other people in need;

d)Defendant exhibits manifest attraction to any beautiful woman he comes close to and

even in the presence of his wife, he can't help himself but show his interest in other women;

e)Defendant often indulge in too much alcohol even inside their apartment which he does every day after coming home from work, thereby resulting in frequent quarrels;

f)Defendant became extremely arrogant towards the plaintiff, he always quarreled with the plaintiff without apparent reason:

lera who died were loval soldiers from his province of Ifugao. He knows their names and their families and his first reaction upon hearing the news was to doubt the process and call for a strong military response.

"But then I remembered my brother, Capt. Winston Baguilat, who died in 1998 in the fields of Basilan, killed probably by a Muslim insurgent's bullet. I felt grief. But I told myself if I could make a difference someday, I would rather take the tougher road to lasting peace than a knee jerk call for total war," Baguilat

He said this belief in peace was why he strongly supports the passage of the Bangsamoro Basic Law, believing it is the way to help Muslim brothers and sisters in Mindanao achieve their development goals under an autonomous region.

"I believe the braver thing to do now is to pray and persevere and believe, still, in the vision of peace," said Baguilat./PIA/Office of Cong. Baguilat

tribal, ethnic, race and other groupings, the mayor said.

instructing that "these set of policies and guidelines aims to rationalize the Conduct of Educational Tours and /or Field Trips among Higher Education Institutions(HEIs) in order to as provided by Section 5.1." which explains to "provide access to efficient and interactive learning of students through meaningful educational tours and/or field trips as required in their program requirement embodied in the approved curriculum;" and further continued by provision 5.2 of this section which orders "to ensure that all Higher Education institutions provide quality educational tours and/or field trips relevant to the acquisition of the necessary knowledge ,skills, and values for student welfare and development.'

Under Article V on students, sec-

tion 8, itclarifies that "students who cannot join the educational tours and/ or field trips shall be given parallel school activity which provides similar acquisition ofknowledge of the required practical competencies and achieves other learning objectives. Learners withspecial needs such as Persons with Disabilities (PWDs) shall begiven due consideration." This article is further exemplified by Section 9 which commands that "students undergoing internship, practicum or on-the-iob training program, the same shall be governed by CHED Memorandum Order No.23 series of 2009 on "Guidelines for Student Internship Program in the Philippines(SIPP) for all programs with practicum subject. Educationaltours and field trips shall not be made as substitute of a major examination for the purpose of compelling students to participate in educational activities not otherwise compulsory."

Section 12 of Article VI on destination emphasizes that "whenever necessary for the safety and convenience of the touring party, advance and proper coordination with the local government units with appropriate clearance from the concerned government and non-government offices shall be secured before the scheduled dates of the educational tours and/or field trips."

Article VII on roles of the Higher Educationspecifies security as a main responsibility. Section 18 reveals the "security of the students should be the foremost responsibility of the higher education institutions concerned HEI authorities shall inform parents or guardians on the HEI guidelines on the conduct of educational tours and/or field trips." It further warns through its section 18 that "it shall be unlawful of an HEI employee to personally profit from educational tours and /or field trips. An employee who violates this section may be terminated for Grave Misconduct.' to be contiuned

If someone asks me why I am gentle and good, I must reply, "Because I serve One who is so much better than I am. If only you knew how good my Master, Jesus, is." whichever is higher. The amount shall be paid on twelve monthly equal installments every third week of each month without any extension.

The firm will also be given a maximum of six months from the confirmation of the agreement by the city council to secure all the neces-

sary permits to operate but it will be required to pay the full rental fee for the first year from the time it commences payment.

On the third year, the rental will increase to P40 million; to P50 million on the fourth year and to P60 million on the fifth and succeeding years until the end of the contract.

Any underpayment of the accruing month based on actual meter reading shall be reflected in the succeeding billing month. Payment of the fees will be made whether or not the plant is operating for the duration of the agreement.

On top of the rental fees, the firm will remit one percent to the province of Benguet, municipality of Tuba and barangays Tadiangan and Nangalisan the gross receipts based on the distribution scheme provided for in RA 7160 in Sec. 291 and Sec. 292 of the Local Government Code and three percent of the net surplus (net profit after tax and 1 perent share of the province of Benguet) to the affected surface owners whose properties are affected by the pipelines and plant facilities.

The company will also absorb existing personnel who meet its staffing and qualification and skills requirements but will have the right to hire, retain and terminate its personnel in the entire duration of this agreement.

Among the terms of the MOA are that the city and Kaltimex together with a representative from the host municipality, jointly conduct monthly meter reading to determine actual gross power plant production as basis for computation of shares of parties/other beneficiaries.

All existing machineries and equipment in that area are owned by the City Government of Baguio.

"In case of breach of any of the provisions of this agreement for the delivery of the share of the City Government of Baguio, Kaltimex Energy Philippines shall be liable for liquidated damages which shall be equal to one-tenth of one percent (0.1%) of the cost of the undelivered share for every day of delay but shall not exceed ten percent (10%) of the amount of the contract. The City Government of Baguio may rescind this agreement, without prejudice to other courses of action and remedies open to it;"

"In the event Kaltimex Energy Philippines fails to deliver the guaranteed shares due to the city despite power production and sale thereof at the date specified in this agreement, it shall pay the City Government of Baguio the additional penalty of two percent per month. Undue delay for two months shall be a ground for rescission."/A Refuerzo

## CRO Reports Increase in Mortality by 6.38%

BAGUIO CITY – a slight increase in the number of deaths was recorded in a 2014 statistics in this mountain resort.

The Civil Registry Office (CRO) Monday reported a 6.38 percent increase or a total of 2,333

deaths has been registered last year slightly higher than the figures in 2013 where there were 2,193 recorded deaths.

The slight increase in mortality shows an increase in deaths of less than 1 year old age group by 8.38% last year.

According to records, there were at least 97 infant deaths registered as compared to the 89 recorded in 2013.

39 deaths were also recorded for 1 year to 4 year age group, 27 for 5 to 9 age group and 24 for the 10 to 14 age group.

A significant increase was however recorded in the 15 to 19 age group where 45 deaths were recorded as compared to only 30 deaths recorded in 2013.

For ages 20 to 24, 59 deaths were recorded while a 20.59% decrease was noted in the 25 to 29 age bracket with only 54 deaths recorded as compared to 68 in 2013.

There are also 91 deaths registered for the 30 to 34 age group, 73 deaths for the 35 to 39 age group, 104 for the 40 to 44 age group, 131 for the 45 to 49 age group, 183 for the 50 to 54 age group, 221 for the 55 to 59 age group and a whopping 1,179 for the 60 years old and over.
