The Department of Foreign Affairs and the Department of Justice should immediately and without delay get in touch with their counterparts and demand the attendance of the four witnesses.

As worded in Article V, "US military authorities shall. upon formal notification by the Philippine authorities and without delay, make such personnel available to those authorities in time for any investigative or judicial proceedings.

The VFA clearly states that the Philippines has criminal jurisdiction over US soldiers involved in a crime in the country, and it is a matter of invoking it with speed and conviction. Mayor Assures no **Open Waste in ESL** Site

BAGUIO CITY - the fifty hectare area within the one hundred thirty nine hectare city property in Santo Tomas eyed to house the city's first Integrated Solid Waste Management System (ISWMS) has been identified.

This was revealed by Mayor Mauricio Domogan during the Weekly Ugnayan Presser Wednesday where the city is now undertaking to take the planning stage.

Domogan said, "the 50-hectare area is free from congestion and a single house is within its vicinitv.

The city is planning to develop the ISWMS incorporating modern technology to address waste concerns.

The ISWMS will be patterned with the Materials Recovery Facility (MRF) of Hesperia City, California which city officials visited this year.

The technology incorporates waste recovery thru segregation, recycling and conversion to electricity.

It can be recalled that the Santo Tomas area has been approved as the site for a sanitary landfill for the city way back in 2009 by City Resolution Number 78.

The area was part of five possible sites for an engineered sanitary landfill evaluated and recommended by a monitoring committee.

Domogan however stressed, "there would be no open dumping of waste at the site as it in contrary to Republic Act 9003 or the Solid Waste management Act."

"We have to change our perception of waste disposal, there are more advanced, environmentally friendly and cleaner ways to address our garbage, he said.

Domogan said, "the waste facility will have the capability of separating biodegradable from nonbiodegradable waste, recyclables, wet and dry and other forms of wastes."

A separate technology will also be added to address hospital wastes.

The city government and local barangay officials in the community has agreed to open the lines of communication and conduct series of consultations especially in areas which may be affected by the project.

Modern technologies being eyed as component of the solid waste facility are a central materials recovery facility (MRF); environmental recycling system (ERS) facility; engineered sanitary landfill

Consultation on Tax Increase

BAGUIO CITY - A mass consultation on the proposed tax increase will be held in the city soon to explain to and get the sentiment of the various sectors on the proposed adjustments in the business and real property taxes.

The city council on Monday decided to do away with the pocket public hearings currently being conducted by the city council committee on ways and means cluster B headed by Vice Mayor Edison Bilog and instead conduct a single but all-encompassing public hearing to save time and resources.

Bilog said the hearings were mostly on personal invitation to him but some councilors and city treasurer Alicia Onoza and city assessor Nilda Navarro were able to join him as resource persons. He said they have so far covered 20 barangays and a number of associations and plan to continue with the consultation by sector until the first part of 2015.

But the aldermen led by Councilors Richard Carino, Elaine Sembrano and Betty Lourdes Tabanda and including cluster B committee members Councilors Peter Fianza and Faustino Olowan opted for a common hearing to also ensure that complete facts will be presented to avoid confusion and misconceptions especially since the updated schedule of fair market values of real properties cannot be presented yet as it is still being reviewed by the Bureau of Local Government Finance (BLGF).

They tasked Bilog's committee to set the date for the mass hearing.

Mayor Mauricio Domogan expressed hopes for a speedy consultation to according to him "strike an agreement on what is reasonable to both the city and the taxpayers."

The city, he said, is now obliged to implement the increase after years of stalling to make the antiquated rates attuned with the times and with the requirements of the law.

The city is eyeing a 10 percent increase in business taxes under Tax Ordinance No. 2000-01 including city market rental and fees and garbage charges which were last adjusted in 2001 or 13 years ago.

The mayor said the rates are now outdated and must be revised to keep up with the prevailing charges now being levied by nearby cities like Urdaneta and Dagupan in Pangasinan and San Fernando City in La Union which impose business taxes higher by as much as 500 percent than the city

For instance the city charges P15 for certifications and clearances while other areas collect as much as P100. For stall rentals at the fish section, the city charges P20 a month but other cities collect P78 a day.

The city also needs to update its schedule of fair market values of real properties which remained unchanged since 1996 making the city non-compliant with the New Local Government Code or the Republic Act No. 7160 provision mandating local government units to undertake a general revision of real property tax valuation every three years.

It was assured that a minimal assessment level will be recommended to temper the expected huge increase in the market value as a result of the city's passing up on several revision terms since 1996.

At present, the city's assessment levels are pegged at 12 percent for residential and 35 percent for commercial properties./By: A Refuerzo

Anti-Smoking Campaign Crackdown on Intensified sion Road and General E-Casino Loin

BAGUIO CITY – The city government intensified the anti-smoking campaign with the conduct of surprise inspection of business establishments to ensure that they are complying with the provisions of Republic Act 9211 or the "Tobacco Regulation Act of 2003" and City Ordinance No. 8 series of 2008.

Combined elements from the Alay sa Kalinisan Inc. (ASKI) last week rounded up more than 20 establishments along Session Road and General Luna Road which were found violating the antismoking laws by allowing smokers and even minors to smoke within their premises.

The team was headed by city health office under officer-in-charge Dr. Rowena Galpo and city epidemiology and surveillance unit head Dr. Donnabel Tubera and the city mayor's office public order and safety division under Policarpio Cambod.

Mayor Forms Task Force to Prepare Skating Rink Master Plan

BAGUIO CITY – Mayor Mauricio Domogan last week created the technical working group to prepare the master development plan for the Burnham Park skating rink.

Urban planner and former city architect Joseph Alabanza of the Baguio Heritage Committee and city building and architecture officer-incharge Johnny Degay will co-chair the group with the city environment and parks management officer, representative of the United Architects of the Philippines Baguio chapters and the deans of the colleges of engineering and architecture of the University of Cordilleras, University of Baguio and St. Louis University as members

The master plan will serve as basis in the drafting of the terms of reference in the bidding of the operation of the skating rink after the expiration of the city's contract with the present concessionaire Quirante's Fun Rides/ Skates Rentals and Recreation Center set on November 2.

The drafting of the plan was agreed on between the mayor and the petitioners advocating to open the Burnham Park skating rink for free use by the public in a meeting recently.

During the meeting, both parties also agreed

that the lease contract with Quirante firm will not be renewed by the city and the operation of the facility will instead be bid out based on terms that are beneficial to both the city government and the public.

After hearing the mayor's justifications, the petitioners led by Alabanza, Bishop Carlito Cenzon of the Burnham Park Fencing Committee and former punong barangay Ferdy Bayasen acknowledged that the city cannot allow the absolute free use of the skating rink being one of the few income generators where the city source out funds for the maintenance of the park

At present, the city earns only P15 million from the various park concessionaires which is way below the fund requirement of P37 million to pay for manpower, water, fertilizer and other maintenance needs of the park, according to the mayor.

As to the petitioners' call for the removal of other business enterprises not in line with the area's intended use, the mayor said this is consistent with the city's stand that these operations which include bump cars and arcade games must not be allowed inside the facility meant only for a skating rink and including a refreshment canteen and coffee shop.

E-Casino Joints BAGUIO CITY – Mayor Mauricio Domogan ordered the city police headed by Sr. Supt. Rolando Miranda to round up electronic casino (e-casino) joints operating in the city following confirmation by the Philippine Amusement and Gaming Corporation (PAGCOR) chairman and chief executive officer Cristino Naguiat Jr. that there was no permit issued for any electronic game like e-casino and e-bingo in the city.

"I asked our city police to check on these e-game establishments, find out what authority they have to operate and to close them if they have no permit," the mayor said on Wednesday.

Baguio Apostolic Vicar Bishop Carlito Cenzon earlier called the mayor's attention on the existence of e-casino operation in one shopping mall in the city.

The mayor who said he has not signed any permit to allow said operation authorized the bishop to conduct a study and submit a report to serve as basis for the chief executive's action.

Naguiat reportedly assured that PAGCOR will not approve any application for e-games in the city unless the city allows it.

The city has standing resolutions opposing the establishment of casino or any form of gambling.

Domogan during his term as congressman of the city was among those who proposed the amendment of the PAGCOR charter to give local government units a say on allowing PAGCOR games to operate in their locality.

At present, PAGCOR requires applicants for license to operate games to secure a Letter of No Objection from the local government units.

Naguiat also reportedly said that the city's refusal to allow casino and other PAGCOR games would not mean forfeiture of its privilege to secure assistance from the PAGCOR.

PAGCOR recently agreed to fund the construction of a 32-classroom structure on the lot allotted for the Baguio City National High School in Irisan barangay and a 20-classroom building at the Pines City National High School in preparation for the senior high school program to start in 2016./By: A Refuerzo

Bayasen said the petition entitled, "A People's Initiative and Manifesto: "Return the Skating Rink at Burnham Park to the Public'" which gathered a total of 17,065 street and 1,119 on-line signatures aimed to get the pulse of the residents on how they want the skating rink managed.

He said that the common sentiment was that the facility be restored to its olden day status as an open facility.

Alabanza who broached the drafting of the proposed master plan said they will consider the suggestion in the drafting of the plan. He committed to complete the master plan within two weeks./By: A Refuerzo

From Waste to Energy for Free and with Profit, Why Not! so that we have to haul our garbage

I'm not stupid enough to commit the same mistake.

This as Mayor Tabanda clarified a proposal of a waste to energy facility of a company form Australia.

The G20 of Austaralia with an office in Singapore and is operating internationally has proposed a waste to energy facility to be installed in Alno, La Trinidad. It has with it a dryer and a conveyor for segregating garbage that are being collected within the municipality.

"This is not like the Black Hole as some constituents in the council presumed. The engineered sanitary landfill in Alno, under the law, should not had been utilized with a mixed garbage instead it should had been utilized with residual waste under R.A 9001 or the recycle, reduce, reuse law to minimize the waste collected but the landfill was not used to what it should had been," said Mayor Tabanda.

The Asian Development Bank has piloted La Trinidad, Benguet in solid waste management from training, management, and facility. 'Earlier, the Black Hole in Alno, La Trinidad was not sustained. Garbage that were put in the Black Hole were not segregated that it has caused the machine to collapsed and bugged down. They even borrowed money to buy the machine that did not passed the testing of the Department of Science and Technology. Now, the Benguet Bank has sued the municipal office for the non-payment of the money borrowed and a case is now in court. The Black Hole is just standing there as a scrap metal," said Mayor Tabanda.

Mayor Tabanda said that seven conditions were set by the Asian Development Bank that the municipality has to comply with. "There are cracks at the dumpsite so that we have to haul our garbage out of the site so as not for Sablan and Tublay would eventually experience a trash slide and then them suing as to court, "she added.

The Asian Development Bank with the investors of the waste to energy, the G20, introduced and presented schemes on the waste to energy proposal in the municipality.

"The financial is the company's. There will be no cashing out from the municipality's funds. Profits will be shared between the company and the municipality while it sells the energy produced by the facility to BENECO and to the grid corporation," explained Mayor Tabanda.

The G20's prototype machine is now in Santa Cruz, Bulacan that is being tested by the Department of Energy, Department of Environment and Natural Resources, and the Department of Science and Technology. "We went to Bulacan for three times already together with the technical committee, the Benguet State University, barangay officials, and some media," said Mayor Tabanda.

The project is a public private partnership the company shoulders the finances. The municipal council is just waiting for the final report to be handed over by Mr. David Coupland of the company.

"It's okey. It is just that some media and members of the council did not understand much of the proposal prior and before. But councilors Botiwey and Quintos who are in charge of environmental matters were able to digest it when we talked of it over. Still, some media organizations were misquoting the council as against and are denial of the proposal but were just actually not. Instead, they just wanted clarifications of the company's Security and Exchange Commission's documents and reg-

Beyond the stutters

Listen beyond Vice President Jejomar Binay's flustered stutters whenever a sensitive question is lobbed.

The queries range from the P15.6-million Redwood-type, three-bedroom unit of The Woodlands at Tagaytay Highlands to overpriced beds at the Ospital ng Makati to the whereabouts of top aides, like Gerry Limlingan, who have dodged below the radar screen.

That takes some doing. Front pages, end-to-end Senate hearing coverage plus evening broadcasts or talk shows are plastered with his denials. "Vice President Binay categorically denies the malicious and baseless accusation that he owns a three-bedroom log cabin," says Joey Salgado, Binay's spokesperson. Thus, the Vice President's statement of assets, liabilities and net worth didn't jot the cabin down. Naturally.

Eight out of 10 Filipinos, however, want the Vice President to face the Senate blue ribbon subcommittee probe, reports pollster Social Weather Stations (SWS).

In a nationwide survey, conducted from Sept. 26 to 29, 79 percent of the 1,200 respondents said Binay should personally refute graft charges. Only 11 percent wavered. And 10 percent thumbed the idea down flat.

SWS notes that the clamor for Binay to attend the Senate probe spreads **EDITORIAL** across all social classes. Four

out of five who were satisfied with Binay's performance still wanted him to appear in the Senate.

That has fallen on deaf ears. His spokespersons reiterate that the Vice President won't amble into what he sees is a booby-trapped proceeding. The absent, however, are always wrong.

Witness former vice mayor Ernesto Mercado has filled the vacuum and told a Senate blue ribbon subcommittee hearing: The wife of the Vice President, Dr. Elenita Binay, and his daughter, Sen. Nancy Binay, signed billing statements and receipts for the Tagaytay Highlands mansion. These included membership in the International Golf Club in Tagaytay Highlands.

More documents have surfaced since. One is an official receipt dated Sept. 2, 1997, showing Limlingan bought a P546,000 manager's check. It bore the address 8514 Caong St., San Antonio Village, Makati City a known address of the Vice President.

The Inquirer, however published a document, dated Jan. 31, 1997, addressed to Binay, then mayor of Makati City stating, "You have been allocated a Redwood-type, three-bedroom unit of The Woodlands at Tagaytay Highlands," it asserted. "The purchase price... is P15.6 million."

Another document dated May 9, 1997, said that a 10-percent discount, amounting to P1.56 million, slashed the net price to P14.04 million. The terms of payment were extended to 20 months. "TO: M1 [code for Binay] Your copy on the price and schedule of payments. Gerry."

Asked about the property, a spokesperson from the SM group said in a text message: "We have no records" [of the alleged transaction]. The Sys of the SM group became majority owners of Belle Corp. in 2010.

Look beyond the interlocking scams into the equally pressing national concerns.

Four out of every 10 Filipinos today are homeless, notes John F. Lagman in the study titled "Anatomy of the National Housing Problem." It is a problem that has been compounding, over the years, from a stew of population growth, poverty, armed conflict in some places to policy gaps.

In the early part of the postwar period in 1950, just a little more than five million or about one-fourth (27 percent) of Filipinos clustered in urban areas, mostly Metro Manila. Four decades later, the country's urban population surged to well over 29 million. That was or almost onehalf (48 percent to be precise) of the country's total population then.

By 2005, the urban population totaled more than 53 million or over 60 percent of the country's population. Add to that the 300,000 displaced by conflict, as in Mindanao.

And come 2050, some 117 million or 84 percent of Filipinos will be urban dwellers. Few could afford a Redwood-type, three-bedroom unit of The Woodlands at Tagaytay Highlands.

It was not planned. But I unexpectedly walked into a consultation forum on the proposed **Bangsamoro Basic Law (BBL)** in a downtown hotel in **Iligan City** a few days ago. I had really wished earlier to attend any one of the on-going BBL consultations to get a feel of how the stakeholders themselves view (*orfear*?) the **MILF** Peace Agreement. Or how the peace panels deal with those concerns. Was I glad I unexpectedly walked into one!

Coming from **Davao City**, it took only 45 minutes via **Cebu Pacific** to new **Laguindingan Airport**, about 35 kilometers at the outskirts of **Cagayan de Oro**. (I gathered the lacking navigational lights will be operational soon. In the meantime, far-away Lumbia airport tower assists. No wonder there are no night flights in such a modern hub.) It took only about one hour of drive from the new airport to Iligan City. I would have really preferred the Davao- CDO land trip that would have given me the joy and luxury of stopping over along the way at our **Seagull Mountain Resort** high up in the clouds at 4,000 feet closer to the sky. But a long 7-hour land trip could be at another time.

POWER PLANT — I was to meet up in Iligan City with international investment "whizman" **ALOYSIUS "Nonoy" COLAYCO** and his partner **VICENTE "Vic"CENIZA** (*both Jardin Davis veterans*) to look into plans of **POWER SOURCE, PHIL. INC.** (*where I now serve as senior advisor*) to set up a power plant there for the **LAFARGE** cement factory. It was during our call on both Iligan City Mayor **CELSO REGENCIA** and **VICE MAYOR RUDERIC MARZO** where I learned that a forum that morning was underway on the BBL at Caledon Pension House downtown. Mayor CELS, a former police director, had to rush to go. I dropped everything and proceeded to the venue.

JAMPACKED —Proceedings were already on-going when I discreetly walked into a jam-packed function room and got seated at the back hoping I would come unnoticed. But no sooner had I settled down when CONG. VICENTE "Varf" BELMONTE, Jr. spotted me and came to my seat to welcome me. He offered a place up front but I politely declined. (Many just don't know how good it is to be just in the audience — a liberating feeling after years of being "up front".) Cong. "Varf" ably skippered the forum all throughout making known to all that inputs gathered during the day he would submit to Congress which is now working on the proposed law. I had earlier planned on sneaking out also unnoticed to catch up with my LAFARGE meeting but with the announcement about my presence and requesting that I also give some remarks later in the day, my early exit plan was no longer possible. But that was propitious. And yes, I was glad I sat through.

INFORMATIVE — I found the forum informative and refreshing. All those who had something to ask or say got their chance on the microphone. The crowd was multi-sectoral. Judges, lawyers, businessmen, IPs, barangay reps, plain residents — even kibitzers were all there. I though the whole town was there through their reps. The resource panel , headed by no less than GPH Panel Chair MIRIAM "Iye" CORONEL -FERRER fielded the questions, clarified and quieted some apprehensions. They were simply engaging, adept and down-to-earth. The forum somehow exorcised some lurking phantoms that many ILIGANONS were fearful about. Nonetheless, you can't blame them for their angst. Is there "SOP" for poll automation contract?

-000-HOW MUCH DOES RP NEED TO AUTOMATE ELECTIONS IN 2016? Gus Lagman, the former commissioner of the Commission on Elections, is echoing a question coming from the TransparentElections.org.ph, which Chairman Sixto Brillantes Jr. and its other present commissioners must answer.

The question: why is the Commission desirous of paying some P18 billion for an automated election system that is dependent on the already-discredited precinct count optical scan (PCOS) machines to be used for 2016 when there is a similar system, or which maybe even much better, for the price of only P5 billion?

And while we are on the issue of asking questions about the use of PCOS for the 2016 presidential elections, I might as well repeat here another query from Lagman: why is the Comelec hurrying to approve the P18 billion PCOS 2016 contract before Brillantes and Commissioners Lucenito Tagle and Elias Yusoph will retire on February 02 2015?

IS THERE "SOP" IN POLL AUTOMATION CON-TRACT? We can guess as much as we want on the probable correct answers to these questions, and maybe Brillantes and his gang would not even care to explain, since they are entitled not to explain. But then, people are now starting to make irrepressible deductions or predictions about profits which unrighteous men and women could possibly make with a contract which fetches the price of about P18 billion.

Surely, Filipinos are aware, and have been talking about it, that for any government contract to be awarded to private businessmen in times past, there had always been what was known as the "SOP" which had to be given to the heads and other officers of agencies which will award the contract. In olden times, "SOP" meant "standard operating procedure", but in our country, it simply meant grease money

Formerly, the amount given as "SOP" was pegged at 10% of the contract price. But, as the Philippines moved on in its history as a nation, there have been reports that government contracts now carry as much as 40% "SOP". I am not saying that there is an "SOP" for the Comelec P18 billion contract now, but certainly, if there is, the amount could range between P1.8 billion to P7.2 billion, which is big enough even for a presidential campaign.

Priming Filipino Specializations for **Global Competitiveness** BY : MARVIN WACNAG LIDAWAN

THE

The English language when comprehensively absorbed is a sturdy tool that cultivates the intellectual capacity of Filipino graduate professionals to penetrate and take part towards successful international interactive endeavors even how complex a corporate world is.

As early as the last decade of the 20th century, world labor gave opportunities for Filipino professionals with English language specialization to endeavor overseas as educators to other nationalities. English teachers of the English language go global that implies Filipino graduates are at parity with graduates abroad. But as the 20th century moves to the 21st century, qualifications become standardized due to the influence of Western educators who come from varied universities and colleges around the world. These teachers' popular destinations are in Asia influencing countries' education authorities and administrators to revamp their hiring criteria as well as aligned their curriculum to the concepts of Western education introduced by native speakers as catalysts for pedagogical evolutions outwitting Asian English language lecturers known to possess impressive academic performance abroad and in their countries of origin.

Let's examine common requirements which were raised due to the influx of foreign language educators. Graduates in the Bachelor's degree with English should have a teaching experience for a minimum of two years after graduation. The candidate should be a licensed teacher with a TEFL (Teaching English as a Foreign Language) or TESOL (Teaching English to Speakers of other Languages) certificate from any internationally recognized institution and should be able to display his fluency in written and oral English. For graduates of the Master's degree in English or other allied courses, it follows the requirements of the Bachelors' degree applicants and must have (2) two to (3) three years teaching experience after obtaining his masters. TEFL or TESOL certificate is an edge although some public education institutions strictly require the said certificate regardless of a candidate's master's degree. For a doctorate in English, it follows the requirements in the master's degree and the candidate should have a minimum of (2) two to -(3) three years teaching experience after obtaining a doctorate degree where TEFL or TESOL is an edge from other applicants. However, some universities necessarily require the said additional English language credential. The candidates' field of specializations from bachelors to doctorate should be aligned.

Why is there a need for these extra certificates in English? It is due to the fact that TESOL or TEFL programs signify a highly practical method to English language teaching. The curriculum of this certificate reflects careful study of current theory and its practical application in teaching methodology. It has been designed to provide teachers with the firm background in teaching students who speak differ-

Last October 10, the anonymous Samaritan handed the six envelopes to the conductor of a GL bus with body number 919 in Bontoc, Mt. Province, saying the recipients, or their representatives, would claim these at the company station here in Baguio.

He or she then texted the recipients or their relatives for the pick-up, using the cellphone numbers indicated in the news items as the contact numbers for those who would like to respond to the pleas.

"I saw the names scribbled on the other envelopes and was quite sure they were written by only one person," swore Maribel Cruz, a 55-year old mother from Pacdal here who claimed an envelope for her son, 35-year old dialysis patient Roel.

"The support was pure relief. Immediately after receipt, I texted the sender my son's gratitude, hoping to receive a response that would somehow give us a clue on who she or he is," Maribel said.

But not one of the five other recipients or their relatives also had any inkling on the identity of the Samaritan who just texted them back his or her hope for their mustering courage to endure the challenge of sustaining the patients' life=time dialysis treatment.

Mayor Mauricio Domogan who heads the ASKI said the campaign will be a continuing program to ensure that establishments will observe the antismoking regulations.

The city police under Sr. Supt. Rolando Miranda regularly report the number of apprehension of violators of the smoking ordinance to the ASKI.

Tubera pushed for the conduct of inspections of the establishment to boost the campaign.

The city government intends to strengthen its anti-smoking law by amending Ordinance No. 8 series of 2008 or the Comprehensive Anti-Smoking Ordinance of Baguio City and its Implementing Rules and Regulations to clarify the definition of public places where smoking is supposed to be banned. Trees Survival, Tree Cutting

BAGUIO CITY - Busol watershed, Botanical gardens, residential, commercial and institutional areas have been planted with 22, 331 assorted tree seedlings, as to reports from the City Environment Parks Management Office during the Alay Sa Kalinisan (ASK) meeting last week.

For the botanical garden along Leonard Wood road, there are 9,721 Benguet Pine seedlings planted; followed by coffee at 220 seedlings; citrus, 20; cypress, 156; guava, agoho and bamboo, 1 each.

At the Busol watershed, 9,050 Benguet pine tree seedlings were planted.

In both parks, the trees were planted by religious groups, the local government of Baguio, the barangays, national line agencies, non-Government Organizations, private groups and companies and private individuals.

A portion of Forbes Park along South Drive, has also been planted with 1,400 Benguet Pine tree seedlings with Benguet Electric Cooperative (BENECO) directors Ferdy Bayasen and Virgilio Orca as sponsors

As to city ordinance mandating the planting of trees, fruit tress and ornamentals in vacant areas within the barangays, rooftops, and commercial areas, as of end of September 2014, there have been 886 ornamentals, 177 various tree species and 698 fruit trees planted in 1194 residential areas, 364 commercial places, and 203 institutions; for a total of 1,761 planted.

According to CEPMO forester Walter Aguirre, the survival rate is determined six months after the planting season; thus the need for planters to care for, water and clean the surroundings of the seedlings. As to earlier reports, tree survival has been pegged at 87%.

As to tree cutting permits issued, from August permits approved by the city authorities, with 30 trees cut; 8 live trees, 20 dead, and 2 trees for trimming. Permits are issued if the trees are deemed a threat to persons and property.

This was culled from the report of Beatriz Gajete, head of the Forestry Division of the CEPMO. Eight (8) of the trees are in Road-Right of Ways or government lots, while 22 are in private occupied lots.

Meanwhile, there are 1,693 dead trees; 1,378 in

Oplan Kaluluwa Guidelines out

BAGUIO CITY - The Baguio City Police Office (BCPO) through Oplan Kaluluwa for Nov. 1 and 2, All Souls and All Saints' day commemoration, has given out crime prevention and safety tips for motorists and the general public alike.

For public safety at the Baguio Public Cemetery; firearms, deadly weapons or any pointed objects, gambling paraphernalia and noise makers are not al lowed. Intoxicating drinks and the selling of merchandise inside the cemetery are strictly prohibited, it was known.

Cemetery-goers are cautioned to bring just enough food, water and materials and be watchful of their belongings, and of their kin, specially children. To prevent fires, lighted candles on tombs should be supervised, or put out before leaving. Trash should be taken care of by visitors, or disposed at proper receptacles to be made available at the site.

Cemetery-goers should also know where the Police assistance booth or first aid station are, for any emergency or medical need.

Before leaving their residences, house owners should make sure that door and windows are properly locked, and activate burglar alarms, if any. Electrical appliances are to be unplugged, or stoves and water should be checked; clothes on the clothesline should also be kept.

Motorists should make sure that their vehicles are properly mechanic-checked before travel. Those using public vehicles are also cautioned to travel light and bring only essentials; arrive at the bus station or airport early, to avoid undue rush. All suspicious packages are to be treated with care, or reported to the police. Alertness is a must, as there could be bag or baggage snatchers within the area, the police warned.

For those going to cemeteries to honor their dead, 150 flower and candle stalls are open at the Ganza parking area, Burnham, Park from Oct. 26 to Nov. 1. There are also flower stalls along the side of Harrison road.

For motorists, same as in the past years, trucks and buses are NOT allowed along Quirino highway (Munoz st up to Buhagan road) going to Baguio City from 4AM to 12 Midnight of Nov. 1. Alternate routes are Marcos highway or Sta. Lucia circumferential or Lamtang-Longlong road to the central business district (CBD) or La Trinidad, Benguet.

peripheries of the proposed Bangsamoro territory (*adjoining Marawi and Lanao del Sur*) and they had previous bad experiences with the MILF. Former **SECRETARY SENEN BACANI**, a panel member who had served former Philippine presidents and doing ground work principally in agriculture Mindanao, was a moderating, experienced voice with his clarity and distinctive competent demeanor. Add to this were the curt and succinct repartees and explanations of lady chair "IYE" FERRER whose voice came through as re-assuring (*and alluring!*)

WHY DIVIDE? — I was particularly struck by an eloquent ATTY ZARAGOSA who bewailed the "divisiveness" that the setting up of a Bangsamoro would inflict on a nation that ought to be united. He drew from the contemporary dividing lessons of the Berlin Wall of the East-West Germany; the North-South Vietnam, North-South Korea divides; the Gaza Wall, etc. He was asking "why should the Bangsamoro be specially allowed to have their own separate world distinct from other Filipinos when all of us Boholanos, Cebuanos, non-Muslims, Ilocanos and specially those in Mindanao suffered the same experience of exclusion and poverty that Muslims complain about". He claimed that we were all common victims of history when foreign colonizers divided us all as a people. Interesting points indeed.

SOVEREIGN CHOICE - What provinces or areas will ultimately comprise the Bangsamoro territory was thoroughly explained with emphasis on the sovereign prerogative of inhabitants to either "opt in or opt out" of the Bangsamoro territory during the plebiscite. The bottom line is: at the minimum, at least two (2) provinces must vote "yes" otherwise the Bangsamoro may end up like the Cordillera's "autonomous region that never was" because only one province opted "in". Although Iligan City is definitely "out" and not "in" as part of the proposed Bangsamoro, the common expressed concern was about the 6 Muslimdominated barangays with a total area of about 20,000 hectares that may be "detached" from the city if (yes, if) the residents will " opt in" during the plebiscite. Some distinguished legal minds, notably some judges, raised legal points to question such eventuality.

RESOURCES — The sensitive issue on inland waters and the use of natural resources by the Bangsamoro was expectedly raised. They worried on how non-Bangsamoro consumers could avail of those resources since the Bangsamoro would take over these natural jewels. Suggestions on how implementing gaps could be bridged were also submitted. Even the rumors about some "fast operators" cashing in on the proposed Bangsamoro setup "selling" positions in the proposed bureaucracy, including police slots were quashed. Why "Bangsamoro" is now the new buzzword to replace "Muslim Mindanao" was explained. Indeed, if non-Muslims like Lumads or IPs or even Christians can be

inhabitants within the new autonomous territory, to refer to it as "Muslim Mindanao" will not fit.

LUMADS — The Indigenous Peoples (IPs) also aired their own angsts, apprehensions and yes, hopes too. With around 35 tribal groups in Mindanao whose ancestral domain areas also overlap or are within the Bangsamoro, the tribes were evidently in clear search for clarifications and assurances of mutual respect and recognition of their own exercise of the right to self-determination. Re-assuring words from the Moro and IP members of the **Bangsamoro Transition Commission** (BTC) present were helpful in clearing some misapprehensions. MILF Panel Member DATU ANTONIO KINOC, BTC members SAID SHEIK, TIMUAY MELANO ULAMA and TALIB ABDULHAMID BENITO took turns in dealing ably with raised issues. Even one questioner who at the outset declared an emphatic "NO to Bangsamoro" appeared assuaged and enlightened after a response from the panel. Former MAYOR FRANKLIN QUIJANO whom I have not seen for ages, came forward and gave his own pitch urging everyone to help contribute to bring clarity to the discourse.

"WHAT IF?" - One significant information volunteered by one of the BTC members was about MILF's resolve and steadfastness in not abandoning the peace track whatever is the outcome from the Congress (on the final BBL) or from the Supreme Court (if constitutional issues will be raised). One panel/BTC panelist announced: "To the credit of the MILF, it significantly downscaled its claim for their right to self-determination to the barest minimum by abandoning cessationist intentions and resolving to submit to the final decision of the Philippine sovereign authority." This declaration alone is re-assuring enough given the "what if questions" lurking in many minds apprehensive on what the MILF will do if some provisions of the comprehensive agreement will be substantially altered in Congress or in the Supreme Court. Then we were informed about the first stage of the decommissioning (or disarming) of the MILF with the "warehousing and padlocking" of their crew-served weapons for starters. Examples of crew-served weapons are the shoulder-fired rocket propelled grenades (RPGs) and armaments that are considered offensive weaponry that usually require more than one person (or a crew) to handle or operate. Then there was mention of the on-going feverish pace in organizing MILF's political arm called the Bangsamoro Justice Party that will compete with other mainstream political parties in the plebiscite and the elections. This, hopefully, will be the start MILF's political coming of age - transforming and transitioning from an armed revolutionary group into a political party that seeks reforms through democratic ways by participating in mainstream politics.

"STAY THE COURSE"--

When, towards the end, I was called to say a few words, I took the microphone and indeed stuck only to a few words knowing that this forum was to be for Iliganons and I was only an observer. Describing the whole exercise as "inspiring and enlightening", I expressed what everyone in the hall, I surmised, was sharing silently in common: that we should give peace a chance, that whatever the challenges are up ahead or how bumpy the road ahead may be, especially when the more difficult stage of implementation starts, that we all must "stay the course". Otherwise we will squander this rare opportunity of coming close to what every Mindanaoan has long dreamt of. try and its population has its own responsibilities and that the two are given of with equal opportunities. The resources are usually difficult to reach the marginalized and underprivileged people because the poor families have usually the most number of children. And health centers are scarce and family planning is poorly relayed to term. Even if the country is populous but if poverty is rampant then quality of life for all Filipinos are not sustained and the effects to the environment is heavy."We want to make every Filipino a steward of the environment. With the population ballooning, carrying capacity of a place and saturation point is heavy and is above the rehired population. Consequences are that traffics. squatters, garbage, floods and housing problems among others mushroom," said Ms Fortaleza.

As of 2014 the accomplishments of the Commission on Population-CAR under the component programs of the Philippine Population management Program on Adolescent Health and Youth Development Program are as follows:

Launching and roll out of the 101XSX: 101 Ways to become an Empowered youth is an interactive social movement campaign aimed at bringing in commitments and messages of the youth for themselves in the fight against risky sexual and non-sexual behaviors. With an active online presence with its own website 101xsx.com and on social media platforms like facebook and youtube. The campaign has also developed digital advocacy materials like its teenage pregnancy animated infomercial and Sureteen Teenage fertility tracking mobile application. Both materials are to be officially launched by the coming year.

The national U4U teen Trail initiative also put under the 101XSX campaign has reached 1081 youth, one of the highest outputs in the country. Teen trails have been conducted in Baguio City, Ifugao, Mountain Province and Benguet with target activities to be done in Abra and Kalinga before the end of the year.

Together with provincial launches of the 101XSX campaign the teen trail has also trained more than a hundred teen facilitators who were equipped with proper knowledge on addressing concerns for adolescent reproductive health, sexuality and youth development.

Improved partnerships with both private and public institutions like UNFPA, Center for Health Services Innovation, LuzonHealth and LGUs is mobilizing joint resources for bringing Adolescent Health services to grassroots areas.

1.Responsible Parenthood and Family Planning Program (RP-FP)

Complete staff work in field monitoring and data collection on unmet need for Family Planning covering all provinces and cities in the region.

In-house Development of offline database systems for reporting and profiling of couples in the Pantawid Pamilyang Pilipino Program and the Responsible Parenthood Movement.

Training of more than 200 Barangay Population Volunteers for Ifugao Province to assist in profiling of families and conduct of RP-FP classes.

Development of a localized campaign called Men Tako to increase Male involvement on Responsible Parenthood and Family Planning. Considering Indigenous cultures in the region concerned with family values and issues of Cordilleran men.

Around 7000 couples reached and profiled in terms of unmet needs for family planning and participated in FDS and RP-FP Classes. All profiles are encoded on the National RP-FP Database of PopCom and accessible for partners and LGUs.

2. Population and Development

Training of teachers from both private and public schools in the provinces of Apayao and Benguet of the new PopDevEd modules. In partnership with Philippine Center for Population and Development, LuzonHealth, DepEd and local government units of Kabugao, Conner, Luna, Pudtol, Sta Marcela, Flora all in Apayao and Mankayan in Benguet. Trained 170 elementary and secondary teachers on Population and Development modules to be integrated into the new k-12 curriculum.

PPMP and POPDEV Orientations.The RPO, in partnership with the City Population Offices of Baguio City and La Trinidad conducted a one-day orientation on the PPMP and POPDEV Integration with more than 300 barangay officials attended. This was funded by the LGU and the RPO provided technical assistance.

•Continued provision of technical assistance (as trainers, facilitators, resource persons) to LGU-initiated activities in the areas of data and information management, gender and development, peer education, POPDEV integration, responsible parenthood and family planning, etc.

The Regional Director has been assigned as the National Director for Gender and Development, in charge at overseeing all aspects of GAD implementation across all component programs of PopCom.

The Commission on Population caters to every Filipino regardless of religion, culture, beliefs including those of the Muslims, indigenous peoples, age specific population, teenagesr, and adults. It has programs on gender and development and gender issues involving women and men on their working environment. It addresses trainings, gender analysis and gender responsiveness.

ent languages other than English to be able to exhibit their skill to apply what hey have learned to real teaching conexts as conceptualized primarily from western education system as adapted by overseas curriculum designers.

To prepare for these qualifications overseas, it is recommended that CHED (Commission on Higher Education) recognized institutions should revolutionize the curriculum of graduates to ensure global competitiveness in directing them in search of livelihood when eaching job opportunities in the Philippines deteriorates. It is essential that universities and colleges in the Philippines should establish an affiliation from other recognized colleges, universities and other legitimate educational institutions that offer TEFL or TESOL like Canada, USA, Ireland, UK, South Africa and Australia whose people are recognize as native speakers of the English language to offer these certificates in consortium which shall pave the way of establishing Filipino graduates' credential credibility to teach. Other than establishing the said affiliations abroad, the British Council based in our counry could provide support towards the achievements of teaching credentials since they are agents of empowering the English language as an international medium of communication especially to aspiring English teachers around the world through the English certificate awards like TKT (Teaching Knowledge Test) which is an examination that documents your English teaching ability through the awarded certificate if you passed. For the English courses that they offer, hese are the CELTA (Certificate in English Language Teaching for Adults) and the DELTA (Diploma in English Language Teaching for Adults) especially to non-English specialization graduates. The world-wide recognized English cerificate awards and the courses are designed and bestowed by the University of Cambridge, United Kingdom to deserving individuals. The British Council is a non-profit but charitable organization that disseminates the role of the English language towards international opportunities. Their main function is merely on educational extensions and supports for the public and private organizations as well as private individuals who are interested in their services. In our country, the British council's office is in Ortigas, Manila. With this kind of career paths preparation, it would ensure qualified graduates to land a teaching job and to intensify the credible image of Filipinos towards worldwide professional interfaces in language teaching.

It is also significant that Philippine colleges and universities impose admission policies of teachers majoring in the English language in the graduate schools to follow the same alignment of specializations when taking masters and loctorate degrees. Repetitious engagement of expertise gives effective outputs because the field is reinforced and further conditioned. One drawback that finds Filipino's failures during inter-

view is the fact that their baccalaureate courses have more of literature subjects than language studies thereby grammatical structures are neglected that should have been fundamental to language teaching. This has been wearyingly manifested among other applicants' interviews from overseas public educational institutions that employ native speakers as interviewers when they come to the Philippines. Native speakers as interviewers meticulously deal with the candidates on the level of how they speak their native language by asking questions which are very theoretical that might haven't been elaborated in the Philippines' college English language programs causing prospectively active applicants to fail during the manpower selection process. Expository writing, phonological and morphological structures of the English language, English for specific purposes, technical writing, and communication research rudiments are some of the course contents being profusely asked to applicants overshadowing the latter's other linguistic competencies.

Meanwhile, the Philippine curriculum developers in public schools have responsibilities in scrutinizing the English curriculum of the elementary and secondary education despite its transformation to K-12. It is crucial that grammar studies should have the greatest bulk of coverage over literary studies. Nor should the literary studies outwit the numbers of grammar courses, then literature should serve as springboards of language learning and teaching. If we are to figure out deeply into the contents of the English program offered in the public schools, there are evident changes of the learning contents which were signs of educators attempts to replace traditional learning to contemporary instructions but as they do academic adjustments, some components of the grammar are neglected which include: perfect tenses, subject- verb agreement , continuous tenses, intensive studies of the parts of the sentences, clause and phrase construction rules among others which should be incorporated in the learning systems. If they are stipulated in the curricular blue prints, departmental heads and supervisors should have close monitoring for these components' execution by classroom teachers and if these components are missing in the language program, they must be incorporated for these are the foundations which students may carry-out and manipulate to absorb higher education.

Failures to academically condition majority of these students in their foundation levels don't rest the flaws against higher education educators but rebound to the secondary and elementary authorities who should have been responsible enough in the inculcation of students' language basic education that are expected to be refined or applied while they acquire knowledge in the tertiary levels which will soon elevate their language proficiency when enhanced to be at par with candidates in the international labor markets.

the person somehow or the person is close to me... For instance, I went to the wake of the mother of Governor (Alfonso) Umali recently. The mother of Governor Umali had entertained me in her house in the years previous and Governor Umali is very close friend. In Leyte, I went to the unanticipated demise of the wife of Congressman Boying Cari, and I had a chance to talk also to his children-the eldest is 23 and the youngest is Grade Six. As a general rule, I attend wakes wherein there are some connections, so that 'yung I don't want to be a burden but rather I want to help them at their time of grief.'

No one can accuse Aquino of not being transparent. He does not bother masking his arrogance.

Really, why would Aquino go to Jennifer Laude's wake? Who is she? She is not a relative. She is not in his class. She is not a member of the Liberal party like Oriental Mindoro Governor Alfonso Umali, treasurer of the LP and Rep. Jose Carlos Cari of Leyte's 5th district.

I asked Fr. Eliseo Mercado for his reaction. He pointed out three things:

First, "PNoy is the President and he is known to almost all Filipinos."

Second, "All the while he keeps mouthing the Filipino people are his bosses. Jennifer belonged to the people – his bosses. Or this is purely for sound bytes?"

Third, "Jennifer was murdered brutally, that is, beating and drowning in a toilet bowl by US Marine – part of VFA (Visiting Forces Agreement). Since he likes the VFA, at least he should sympathize with victim of VFA."

Anne de Bretagne commented in Facebook: "To be perfectly honest, I don't think the president should be expected to attend the wake of Jennifer – the deceased was not a member of his political family nor was a serving member of the military but if interviewed or challenged to attend the wake, he should mouth a less callous answer and show a bit of empathy, something expected of the president of the republic no less!"

I commented that being tactless seems to be an Aquino trait. The President's sister is dubbed as "taklesa."

This is not the first time that Aquino has made insensitive comments. Last year, in a post-Yolanda community meeting in Tacloban, a businessman complained about the breakdown of law and order in the typhoon-devastates city. Aquino snapped at him: "But you did not die, right?"

Movie Director Joey Reyes in a Facebook comment underscored two points: "First, some people mistake tactlessness with brutal honesty, insensitivity for frankness or even wit. Second, empathy is a quality that defines integrity in leadership and sincerity in the responsibilities that come with the position. Enough said.".

Being honest is being truthful.

Being tactless is being rude and inconsiderate.

It is a mark of a person's maturity to

be honest and truthful and still be considerate and mindful of somebody's feelings.

Going around social media are pictures of the funeral marches of President Aquino's parents: Benigno Aquino, Jr in 1983 and Cory Aquino in 2009.

The thousands of people who paid their last respects to his parents didn't know them personally. But they lined up and marched. It said a lot of the Filipino people.

In the same way, Aquino's statement why he is not going to Jennifer Laude's wake says a lot about his person and his quality as a leader. *By Ellen Tordesillas* | *VERA Files – Fri, Oct 24, 2014*

Mayor Clarifies Selection Process in the City

Wednesday, Mayor Mauricio Domogan clarified the recruitment and selection process of the city government of Baguio.

All vacant positions in the city are open to all qualified applicants who meet the minimum qualification standards. Covering the qualification standard includes education, eligibility, experience and training, stressed the mayor.

Domogan emphasized that all documents attached to the application letters submitted will be evaluated by the personnel of the City Human Resource Management Office. During the selection process, the Personnel Section Board will convene to review the merits of each applicant based on the comparative evaluation form.

"However, there are instances where the points/merits of every applicant for a certain vacant position being applied for is more or less equal, seniority is being given consideration," said the mayor.

While it is true that the appointing authority has the widest latitude in selecting/appointing an individual for a certain position, I am basing my selection on the applicant's merits in order to fair to all applicants, he added.

Mayor Domogan expressed his predicament in filing up vacant positions pointing out that for just one vacant position, there are numerous applicants.
