Busol Squatters Ask

BAGUIO CITY - Mayor Mauricio Domogan appealed to the illegal occupants of the Busol watershed to cooperate and voluntarily give up the premises to allow the City to undertake its programs for the preservation and protection of the city's biggest watershed that supplies a third of the city's water needs.

"We are calling on those obstructing the watershed to stop blocking our efforts because if we do not protect our watershed, what will happen to our city?" the mayor said.

The mayor said that as much as possible, the City does not want to resort to filing criminal cases against the lot claimants.

"I hope they will just cooperate so that we will not go to the point of filing criminal cases against them."

The city is working out the demolition of the illegal structures

cluding the shanties built within the area designated for the Busol Tree Nursery

and field office.

Last May 7, anti-squatting operatives were set to undertake the dismantling operation of the five structures but were fended off by occupants who barricaded the area.

The mayor said the City will pursue the demolition anytime in collaboration with the concerned law enforcement agencies.

The mayor said they will also issue demolition notices to the owners of the small and large structures in the other parts of the watershed.

He also directed the investigation of alleged new structures and the filing of new cases against those who will continue to defy the law.

The Supreme Court in a decision issued last year sustained the City Government's bid to demolish illegal structures numbering 33 located in three sections of Cont. on page 9

Despite Traffic Problem

City continues to get its fair share of tourist arrivals despite the inconvenience caused by the various road repair projects being undertaken in the central business district and other roads leading to the city's tourist spots.

Councilor Elmer Datuin on Monday said hotels and other accommodations in the City have been reporting full bookings for the past weeks indicating that the City remains as a favorite tourist destination despite the traffic snarls caused by the road and drainage rehabilitation works.

Mayor Mauricio Domogan said contractors of the road projects have been advised to fast-track or be methodical in undertaking the road works to minimize the traffic discomfort borne by motorists.

Only last week, the mayor complained to Baguio City District Engineer Alexander Castañeda on the discontinued project along Rimando Road which was abandoned due to unresolved contractual issues

The mayor said the work has resumed and is now being fast-tracked. "I am glad that contractors are heeding our advice. I hope they will work 24 hours to speed up the projects so these will be completed in time for the opening of public classes schools," the mayor said.

He directed the city police to continue manning the chokepoints to ensure that vehicle flow

BAGUIO CITY - The will continue despite the obstructions.

The mayor also concerned offices to continue to address concerns on peace and order to continue to contain traffic and crime problems, utilities to ensure enough water supply, smooth garbage collection and the tourist-oriented establishments to ensure hasslefree stay for the vacationers.

City budget officer Leticia Clemente said the City continues to host big conventions so the venues must be maintained properly.

As per report from the city tourism office, the city had close to 730,000 guests for the first quarter of the year. The number only came from accredited hotels and inns and did not include those unaccredited that include the numerous inns and transient houses all around the

The number also did not include the establishments that were accredited but did not submit reports to the tourism office. According to the tourism office, only 83 of the 142 accredited accommodation establishments were submitting reports on guest arrivals.

Last year, the city had a total of 932,292 guests billeted in these accredited hotels, according to the Department of Tourism Cordillera (DOT-CAR)./ A Refuerzo

Tourists Still Choosing Baguio Planning Chief Clarifies Melvin Jones Issue

BAGUIO CITY - the Chief of the City Planning and Development Office (CPDO) has come forward to put to rest issues of a multi-level parking facility at the premier park here.

Architect Evelyn Cayat in a letter to the public bellied allegations of a planned multi-level parking to rise within the Melvin Jones Football field circulating in the social networking site facebook.

Cayat stressed, "there is no planned construction of a multi-level parking in the site."

Cayat said, "there is indeed a conceptual plan prepared by Architect Ignacio Estipona, the former City Architect and Parks Superintendent of the city government which incorporated a parking facility within the Melvin Jones Football Field area intended to address the parking demand within the Central Business District (CBD) at that time.'

It was however shelved due to lack of funds. Recently though, the city government received a proposal from an Australian firm to conduct a feasibility study for a parking facility within Burnham Park at the proponents own expense.

The results of the feasibility study showed two options as viable, the first is the construction of a multi-level parking at the Ganza Cont. on page 9

DOST Road Train on Track

BAGUIO CITY - the Feasibility Study (FS) to assess the potential of operating an Automated Guideway Transit (AGT) or road train as an alternative mode of transportation in this mountain resort is now in its final stage.

This was reported by the Metals Industry Research and Development Center (MIRDC-DOST) in coordination with the University of the Philippines-National Center for Transportation Studies (UP-NCTS) who is currently undertaking the study to know if the AGT project is a viable mode of transportation for Baguio and La Trinidad.

A proposed expansion of the project would also cover the adjoining municipalities of Itogon, Tuba Sablan, and Tublay.

The update on the AGT Feasibility Study was presented to the different stakeholders last week with the full feasibility study completion before July, this year.

Initial reports for the AGT project showed transportation problems being faced from Baguio City to La Trinidad such as congestion and rapid vehicle population increase, too many existing franchises on Public Utility Vehicles (PUV), duplicated lines of service routes, lack of off-street loading and unloading stations.

The team also observed problems in traffic management rules, smoke pollution, pedestrian-motorists conflicts, undisciplined drivers and pedestrians on the streets, lack of traffic enforcers to direct traffic especially along the Central Business District (CBD) during peak hours in the morning and afternoon.

Location of schools, hospitals and other commercial establishments along the CBD also contributes to traffic congestion and the lack of parking management strategy to effectively reduce the private vehicles, space for loading and unloading zones for private vehicles and the lack of implementing body and Cont. on page 9

Binay 'Dummies' Closing Accounts Since Senate Probe

The Court of Appeals says it is urgent to freeze 242 bank accounts and investments of Vice President Jejomar Binay, his family, and his alleged dummies

MANILA - The Court of Appeals (CA) issued a freeze order on 242 bank accounts and investments of Vice President Jejomar Binay, his family, and his alleged dummies, saying it found probable cause these were related to "unlawful activities."

The CA resolution, copies of which were shared with the media by Binay critic Ernesto Mercado, cited the findings of the Anti-Money Laundering Council (AMLC) investigation that Binay, his wife Elenita, their son Makati Mayor Jejomar Erwin "Junjun" Binay Jr, and alleged dummies had "large and frequent" bank transactions from 2008 to 2014.

This was the period when the Makati City Hall parking building and Makati Science High School building were constructed. These two projects are the subject of investigations of the Office of the Ombudsman and the Senate for allegedly being overpriced due to kickbacks.

The freeze order is effective immediately and covers a period of 6 months.

The CA, citing the AMLC report, stressed the urgency of freezing the accounts of Binay and his alleged dummies, saying some were already closed after the Senate started looking into the corruption claims in August 2014.

Both Limlingan and Baloloy started selling securities, conducted inter-account transfers within the same bank, pre-terminated their time deposits and investment placements, encashed checks, and withdrew bank deposits after the commencement of the Senate hearings," the order said.

The CA and the AMLC said there is probable cause that the Binays and their dummies violated the anti-graft law, and the anti-money laundering

"Unless frozen, the funds in the subject accounts will certainly be withdrawn thereby placing these beyond reach/recovery," the CA said.

This is the first time in recent history that the CA issued a freeze order on the bank accounts of the country's second highest official. The opposition leader, Binay is also the front runner in the 2016 presidential polls.

The AMLC observed increases in the net worth of said government officials which were not commensurate to their declared incomes, assets, liabilities, and business interests," stated the CA in a 33page freeze order dated Monday, May 11.


The court granted the ex-parte petition of the AMLC for a freeze order after the Ombudsman asked the agency to probe possible violations of the Anti-Money Laundering Act (AMLA). The CA First Division issued the order.

The AMLC investigation looked into the Statement of Assets, Liabilities and Net Worth (SALN) of the officials, Securities and Exchange Commission (SEC) records on the alleged dummy companies, Commission on Audit (COA) findings, and testimonies during the Senate probe.

The order also covers the bank accounts, investments, and insurance policies of Binay's alleged dummies, including the following:

- Gerardo Limlingan Jr, Binay's financial officer and alleged bagman
 - · Eduviges Baloloy, Binay's longtime secretary · Antonio Tiu, Binay's close friend
- Former Makati Vice Mayor Ernesto Mercado, Binay's ally-turned-foe and whistleblower

Solon Respects CA Decision on structure

BAGUIO Representative Nicasio M. Aliping Jr. of this city respects the decision handed down by the Court of Appeals (CA) on the petition for a Writ of Kalikasan filed by two Catholic bishops last year.

The decision of fifth division written by Associate Justice Ramon Cruz granted the petition of Catholic Bishops Conference of the Philippines (CBCP) president and Lingayen-Dagupan Bishop Socrates Villegas and Baguio-Benguet Bishop Carlito Cenzon to permanently stop any development in Mt. Sto. Tomas straddling Baguio City and the municipality of Tuba, Benguet.

The 54-page decision also made permanent the Temporary Environmental Protection Order issued last year on the forest reserve by the Supreme Court.

Aliping said that he respects the decision of the CA but that he may appeal the ruling.

'We respect the decision but we will avail of our legal remedies available to us as part of the procedural process," Aliping stressed.

Aliping has tax declarations covering 2.688 hectares at Mt. Sto. Tomas which he plans to develop into a resort.

But the CA put a stop to this plan when it ordered a halt to any land development including flattening and undertaking of earth moving activities, constructing any

opening of roads. "We have not yet re-

ceived a copy of the decision," lawyer Ron Perez, Aliping's counsel in the case, said as he added that until he receives the ruling he will not be able to comment or even talk about their next moves.

The decision also Tuba Mayor Florencio Bentres from issuing any kind of permit for any activity involving the Mt. Sto. Tomas forest reserve.

Aside from Aliping's claim, there is a community at the area including farm lots for vegetable production which is part of Barangay Poblacion of Tuba; a number of relay towers of major television and radio stations; a military base; and adits of small scale mining activities

The decision stops the Tuba mayor from granting business, occupancy or building permits at the forest reserve.

It also directed concerned agencies to find a solution to the soil erosion experienced at the Amliang Creek which supplies water to a portion of the south western side of Baguio City.

The CA also said that the DENR should criminally charge those who violated the environmental laws, including those involved in illegal mining, illegal logging and illegal squatting in the Mount Sto. Tomas Forest Reserve./ Carl C. Taawan

The city government here is currently dealing with two issues involving the historical sites being declared by the National Historical Commission of the Philippines (NHCP).

Recently, Burnham Park was declared as a national heritage site aside for the on-going improvement of the city hall grounds.

Domogan stressed and reiterated that the city government does not oppose the declaration of heritage sites, however decries that the city hall was kept in dark and needs to be enlightened.

He disclosed during his weekly forum that in a letter dated May 6 of the NHCP, they said that the city hall and areas surrounding the building such as the parking and flagpole areas are included in the building landscape and therefore form part of the city hall. Also, city hall bears an NHCP marker thus signifying the same that it is a heritage and historical building.

Dr. Maria Serena Diokno of the NHCP stressed that the fencing and improvement of the city hall grounds would be acceptable provided that they do not obstruct the view and prominence of the structure and enhance the overall architectural integrity of the

TWG Formed to Evaluate the Possibility of Melvin Jones

Parking Plan BAGUIO CITY - The city government here through the office of mayor Mauricio Domogan received the result of the feasibility study of the CW Development Inc. and Parkwise Philippines, Inc. with regards the possibility of having a parking facility at Melvin Jones football grounds.

The proposal of the CW Development Inc. and Parkwise Philippines, Inc. is to develop and operate an undercover, off-street parking facility at Melvin Jones football ground and still taking into consideration that said football ground will be integrated in the overall development.

Accordingly, the development will craft over 3,000 parking slots which will be of great help in addressing the urgent need for off-street parking especially in the Central Business district (CBD).

Said project is to be run as a Built Operate Transfer (BOT) scheme under a Public, Private Partnership (PPP) arrangement.

Parkwise Philipines, Inc. submitted the feasibility study for the possible establishment of a one floor parking area at Melvin Jones together with a three to four storey parking opposite Ganza and Solibao Restaurants

The proponents assured that "this type of development has been undertaken successfully throughout the world, and has the potential to provide significant economic and social activation to the city of Baguio.

The composition of the Technical Working Group (TWG) Domogan formed through Administrative Order No. 045, series of 2015 tasked to evaluate the feasibility study submitted by the Parkwise Philippines, Inc. will be headed by city engineer Leo Bernardez, Jr., with members sangguniang panlungsod committee on Tourism and special events and SP committee on public utilities chair councilors Elmer Datuin and Joel Alangsab, city budget officer Leticia Clemente, city treasurer Alicia Onoza, city accountant Antonio Tabin, city planning and development officer Evelyn Cayat, city administrator Carlos Canilao, city assessor Nilda Navarro, city general services officer Romeo Concio and city environment and parks management officer Cordelia Lacsamana.

Domogan has given the TWG 30 days to evaluate said feasibility study and to submit recommendation for a possible off-street parking in the city of Baguio.

An off-street parking at Melvin Jones will ease up traffic congestion and address the lack of parking spaces in the city while maintaining the surface of the football grounds, stressed the mayor./Jho Arranz

PHL Slams China for Questioning its Actions in the West Philippine Sea

The Philippines on Wednesday shot back at China for questioning its action to bring journalists to Manila-claimed Pag-asa Island off the South China Sea, insisting it has "full sovereignty" over the feature.

"We have all the right to do such actions and no one can question it because we own it," Foreign Affairs spokesman Charles Jose said in the latest trade of diplomatic barbs with China.

Led by Armed Forces of the Philippines chief Gen. Gregorio Pio Catapang, local journalists visited Pag-asa Island on Monday, sparking criticisms from Beijing, which claims nearly 90 percent of the resource-rich waters, including areas that fall within the country's sovereignty.

Beijing called the Philippines a "rule-violator" and "trouble-

maker" for arranging the known by its international

name, Thitu.

China's Foreign Ministry said the Philippines was endangering international law, a Reuters report said.

"China has made clear on many occasions that it opposes the Philippines' futile and illegal occupation," said ministry spokeswoman Hua Chunying. "The reality of the situation has again proven the Philippines to be a rule-violator and a troublemaker."

Jose maintained that no violation was committed by the Philippines.

"It is not a violation because Pag-asa is within our sovereign territory," he said.

For his part, Armed Forces Western Command chief Vice Adm. Alexander Lopez said that China could do the same and invite media to the islands where they started reclamation work.

"We tried to be as transparent as we can to further emphasize 'yung policy ng administration na we are compliant doon sa declaration of code of conduct. So the foreign media was there, the Chinese media was there. They have seen for themselves na wala tayong ginagawa. We were compliant. Kumbaga, we respected the provision, unlike China," he said.

Lopez reiterated that there is nothing wrong with sending media to Pag-asa since the trip was part of Catapang's schedule.

"In the first place, automatic 'yan basta kung saan pumunta si chief of staff eh may bitbit na media 'yun, 'yun lang naman 'yun," he added.

Manila and Beijing have been locked in years-long conflict over South China Sea territories, where undersea gas and oil deposits have been discovered in several areas.

It also pointed out that it was China who violated international law for undertaking massive and rapid reclamation of seven features in the waters, including those that are within Philippine

China's reclamation in the South China Sea, Manila said, is not only illegal, but is intended to advance its so-called nine-dash line claim which covers almost the entire waters.

Why I have American Blood in my Veins

A few days ago, I got reminded, during a recent clan reunion in my late father Martin's hometown JANIUAY in Iloilo, that I have American blood in my veins. I was one year old and born in another Iloilo town GUIMBAL when our family migrated down south to Davao where I grew up and have taken permanent residence since then up to now. I am a Dabawenyo but an Ilongo forever. Going back to the family "memory lane" and meeting seldom-seen relatives are always a source of unending joy. It's reconnecting with the past that we never lived but only heard about, that's valuable.

FAMILY STORY - Last Saturday, on our way to the venue of the Dureza clan reunion, we were passing through an old bridge being re-constructed, in entering the town when someone told us that the old, concrete turret or structure with openings for gun implacements at the foot of the bridge was where our late father, Martin, Sr. almost died during the war years when he was still a teenager.

Hearing that, we all immediately jumped out of the vehicle! Ah so this is what our father always told us about when we would sit by his side and he would regale us with his exploits as a young boy.

Here's his story. He was a teenager when Japanese occupation soldiers barged into their nipa hut, roused them up in the dead of the night and rounded up all males in the neighborhood. His father (our grandfather) was among those taken. Luckily our father Martin jumped out of the window and escaped. The following day, at daybreak, word got around that the men taken the previous night were all beheaded by the Japs. At nightfall, his family recovered his father's headless body using a carabao-drawn sled. The young Martin, with revenge in his heart did not return home and volunteered to join the local guerillas and in no time, he earned the local reputation of being a Japanese hunter-killer. He volunteered to be in the front lines during raids. One important mission for him one fateful day was to clear the bridge of the armed sentry guard to allow a guerilla dawn entry into town by silently killing without firing a shot the Jap soldier manning the gun turret. He volunteered, climbed the wall and engaged the Jap sentry. It was mission accomplished. But before the Jap gave his last gasp, he was able to thrust his bayonet at Martin who fell to the ground below mortally wounded. He however survived after months of treatment at an American hospital where it was said that he was saved because of the transfusion of American blood. Were it not for the massive transfusion, he would have died. (All 8 of us Dureza siblings would not have been around today.) Truth to tell, up to this day, I never stopped believing I have American blood in our veins — but still wondering why we don't have the American GI looks! (Lol)

Global and National Competitiveness through Filipino Youth's Prudent Career Decisions: Republic Act 7722

Entering colleges and universities for most students in the country will soon commence after three months or so and for this reason, the fast-approaching higher education opening provides ample and appropriate time for parents and students to resolve educational matters to determine the right career path the latter will undergo as a lifetime basis of livelihood and to be contributory in the country's vision to provide efficient graduates reliable around national and global industries at par with the ASEAN community not to mention graduate's pertinent qualifications to other regions of the world. At this juncture, the urgent need to decide wisely must be performed the soonest possible time. Course decision for future careers should have two outstanding factors to remarkably note despite other underlying barriers that may confront the learner in the acquisition processes. Contrary to recent news which has raised speculations on the legitimacy of the Kagandahan ng Kapaligiran Foundation, Inc., is not a bogus non-government organization recommended by former Congressman Bernardo Vergara to implement a series of livelihood and training seminars conducted in Baguio City for 595 beneficiaries of the program.

The Kagandahan ng Kapaligiran Foundation Inc., went through the stringent process of registration with the Securities and Exchange Commission and underwent a screening prior to the approval of the National Commission of Muslim Filipinos to implement Congressman Vergara's recommended livelihood project.

Former Congressman Vergara's participation in the livelihood project is limited to recommending it to the NCMF and monitoring the implementation and conduct of the livelihood trainings and seminars.

The Livelihood Seminars and Training conducted by the KKFI took place at the Baguio Benguet Community Credit Cooperative sometime in December 2012. Step-by-step, hands on training in meat, fish, and fruit processing, as well as dimsum and paper flower making were conducted by the Kagandahan ng Kapaligiran Foundation, Inc. and NCMF. Field tested livelihood technology kits were distributed after each training session consisting of a set of 5 books which introduces various livelihood activities that may provide alternative means of additional income.

The KKFI is not in any manner associated with Janet Napoles.

The funds were sourced from the president's DAP coursed through the NCMF and not from the Congressman's PDAF.

"The AMLC observed large and frequent transactions made between the period 2008 to 2014 involving the aforementioned accounts of VP Binay, maintained individually or jointly with either Limlingan or Lily Hernandez Crystal. The AMLC likewise observed that these transactions were not commensurate to the income declared by VP Binay in his SALNs for said years," the order stated.

AMLC The found that money was transferred to banks outside of the Philippines.

"Considerable amounts of US dollars were transferred from Philippine to Canadian banks in the years 2008 to 2014, the period when the subject buildings were constructed. The US dollar transferred originated from accounts held either individually by Limlingan, or jointly by Limlingan and VP Binay at Rizal Banking Commercial Corporation, Metropolitan Bank & Trust Company, or Unibank, Inc."

The AMLC, the CA said, also found huge transactions involving the bank accounts of Mayor Binay for the same period.

"At least 78 large transactions and five notable transactions involving Mayor Junjun Binay's aforementioned accounts were observed to have been made from 8 April 2003 to 8 January 2015," the order said.

How did dummies get millions?

Despite the absence of their testimonies, the AMLC found that their bank accounts contained amounts way beyond their income.

Based on the client information recorded by Landbank. Limlingan received an income of P30,000 in 2011 and 2013. Baloloy's source of income is her employment with the Makati city government.

The AMLC's investigation would however disclose that in 2007 to 2014, cash deposits, transactions. majority of which were in millions of pesos, were applied to the individual and joint accounts maintained by Limlingan and Baloloy in BDO, Metrobank and Security Bank," the CA said.

The court added, "Other large transactions conducted by Limlingan and Baloloy involved funds that apparent have been placed in investment management fund accounts."

Mercado previously told the Senate that he delivered bags of cash to Mayor Binay, Limlingan, and Baloloy. These funds allegedly represented the 13% share of the Vice President in every project in Makati.

The AMLC investigation also revealed large transactions with other alleged Binay dummies, including Tiu, the billionaire businessman supposedly fronting as the owner of the 145-hectare property in Rosario, Batangas, known as "Hacienda Binay."

"The investigation into the bank accounts of Greenergy, Earthright, Sunchamp revealed multiple transactions involving receipt of award remittances, in-

ter-branch fund transfers cash withdrawals and cash deposits among the accounts of these entities, of the SPCMB Law Office and of Tiu from 30 June 2014 to 2 July 2014 alone," the order

"The investigation further revealed that despite Tiu's supposed business losses in 2013 and comparatively small net profit of P22.45 million in 2013, the accounts under this name showed multiple large transactions '

Liberal Party conspiracy?

On Tuesday, May 12, the Binays denied having knowledge of the freeze order, and lamented the disclosure of the court document. It criticized the AMLC for being part of the "conspiracy" to malign Binay.

Binay spokesperson Joey Salgado blamed the ruling Liberal Party (LP) and its president-on-leave Interior Secretary Manuel Roxas II for the release of the court order, and the AMLC report.

the watershed during the time of former mayor Reinaldo Bautista Jr. in July, 2009 which did not materialize after the National Commission on Indigenous Peoples (NCIP) issued a temporary restraining orders and later a preliminary injunction.

The High Court upheld its decision in February 4, 2009 quashing the jurisdiction of the NCIP to issue similar orders in 2006 to stop the implementation of the three demolition orders issued by then Mayor Braulio Yaranon for the dismantling of the illegal structures owned by three lot claimants.

In the said case, the structure occupants filed a petition for iniunction and restraining orders before the NCIP Cordillera claiming that the lots within the watershed are their ancestral lands and that their ownership of said lots "have been expressly recognized in Proclamation No. 15 dated April 27, 1922" which declared the areas as a forest reservation.

In the order, the higher court maintained that the lot occupants' ancestral land claim was not expressly recog-

nized by Proclamation No. 15 which should have justified the issuances made by the NCIP.

The court said Proclamation No. 15 "does not appear to be a definitive recognition of private respondents' ancestral land claim."

"The proclamation merely identifies the Molintas and Gumangan families, the predecessors-in-interest of private respondents, as claimants of a portion of the Busol Forest Reservation but does not acknowledge vested rights over the same. In fact, Proclamation No. 15 explicitly withdraws the Busol Forest Reservation from sale or settlement," the decision

"The fact remains, too, that the Busol Forest Reservation was declared by the Court as inalienable in Heirs of Gumanagan v. Court of Appeals. The declaration of the (reservation) as such precludes its conversion into private property. Relatedly, the courts are not endowed with the jurisdictional competence to adjudicate forest lands," the court added/A Refuerzo

BCPO Reports Drop in Crime Volume for 1st Quarter

BAGUIO CITY - To address recent concerns about crime in this mountain resort, the Baguio City Police Office (BCPO) OIC-Police Director Rolando Miranda provided city officials here a patch report for the first quarter of 2014 and 2015.

The report, compiled by the BCPO, compared crime rates from January to March 2014 vs. January to March 2015 which included the comparative crime volume, index crimes and non-index crimes.

According to the crime situational report, Baguio City is seeing a decline in crime rates this year.

Miranda said, "the crime volume for the 1st quarter last year is 3,427 while the same period this year is 2,631 with a significant drop of 796 or 23.22 percent."

Last year, Index crimes totalled 1,620 for the first quarter and this year, it is 1,219 which is 24.7 percent lower,' he said.

Non-index crimes also showed 1,807 last year while 1,412 this year for the first quarter with a 21.85 percent drop.

The prevalent crimes in the city are theft, physical injuries and robbery.

Theft remains highest in index crimes for 2015 which has reached 633 cases for January to March, 2015.

For the same period last year, there were 927 theft cases or a 31.71 percent drop.

Physical Injuries is second highest with 423 this year comparing to the same rating period last year of 518 or a 18.33 percent drop.

Robbery cases last year is 163 while this year, there are 118 cases for the same rating period.

Other crimes reported for the period January to March are; Murder 1(2014), 3 (2015); Homicide 5 (2014), 8 (2015); Rape 4 (2014), 18 (2015); Carnapping 2 (2014), 16 (2015).
