

Pakistan's launch of work on its largest nuclear power plant last week is the latest example of big-money Chinese infrastructure projects in the troubled nation.

Cash-strapped Pakistan, plagued by a bloody homegrown Taliban insurgency, is battling to get its shaky economy back on track and solve a chronic energy crisis that cripples industry.

Politicians in Beijing and Islamabad are fond of extolling the profundity of their friendship in flowery rhetoric and on the ground this has translated into around 10,000 Chinese engineers and workers flocking to Pakistan.

Chinese companies are working on more than 100 major projects in energy, roads and technology, according to Pakistani officials, with an estimated \$18 billion expected to be invested in the coming years.

"Some projects are being done by the government, then most of the projects are being done by the Chinese companies, by the provinces and also with the state enterprises and authorities," Ahsan Iqbal, Pakistan's federal minister for planning and development, told AFP.

"In the energy sector, Chinese engineers are building up to 15 power projects that include hydel (hydroelectric), thermal and nuclear plants."

mini-hydroelectric plants rehabilitation and operation in the fourth bidding of the project but only one qualified. The offer is now being evaluated by the members of

the Asin Hydro Power Plant technical working group (TWG) who will submit their observations to the Special Bids and Awards Committee (SBAC) chaired by city budget officer Leticia Clemente next week.

Engr. Ransam Avance, hydro plant supervisor and member of the TWG said they are scheduled to submit the observations this Wednesday.

Mayor Mauricio Domogan last week expressed hopes that the latest bidding exercise for the hydro project privatization will succeed so the project can take off and the mini-hydro plants can be harnessed after years of dormancy.

He said the city will consider directly contracting out the project if the bidding fails anew. He said direct or negotiated contract is tenable as long as the city ensures that all the requirements are met by the investor.

The city the fourth time bid out the project last October after the first three exercises conducted in January and June, 2012 and in June 2013 failed due to the disqualification of the companies that tendered offers.

The project entitled "Privatization of the Operation and Management of Asin Mini-Hydro Power Plants" has an approved contract budget of P500,000,000.

Based on the terms of reference, the bid components will be for the rehabilitation and rental under the conditions that the operator shall invest a considerable amount of money for the rehabilitation, upgrading and expansion of the plants to produce 41,406,178 kilowatthours, install independent substation and power line to the national grid.

The terms also provided the schedule of remuneration to the city government and other concerned parties including the provincial government of Benguet, municipality of Tuba and barangays Tadiangan and Nangalisan where the plants are located and including the surface owners whose properties are affected by the pipelines and plant facilities./A Refuerzo

Mayor Downs Request for Sidewalk Christmas Vending

BAGUIO CITY - Mayor Mauricio Domogan during the Weekly Ugnayan Presser continues to deny requests for vendors wanting to sell during the yuletide season in parks and sidewalks here.

Domogan said, "numerous requests have already been turned-down for the reason that sidewalk vending is no longer tolerated."

"We have to deny their requests if it is outside the allowable relocation site for vending so it would be fair to everyone, " he said.

According to Mayor Domogan, vending is only allowed in pinpointed locations such as areas in and around block 3 and 4 of the city market.

Domogan said, "the city government is doing all it could to contain illegal vending around the city and the cooperation of everyone is needed."

"We also have to be vigilant against those who will be taking advantage of the Christmas season in order to sell outside the allowed vending sites, we have not approved any requests," he said.

The mayor said vendors should take advantage of the improvements done in the city's public market and register with the Baguio City Market Authority (BCMA) so they can work unhampered and legally.

Domogan also ordered the Public Order and Safety Division (POSD) to monitor all streets and alleyways especially in the Central Business District (CBD) for anti-vending operations.

Domogan said the city market which underwent rehabilitation is more than "capable of accommodating vendors who seek to legally display their wares."

Meantime, Domogan directed Burnham Park Personnel to ensure that regulations inside the park is implemented

"I hope that enterprising individuals will not take advantage of the Yuletide Season to sell in our parks, let us follow rules and regulations, "he stressed.

Accordingly, the city has accommodated vending along certain streets, particularly throughout the Christmas Season for the past years and is now asking cooperation to not only reduce but stop vending in unauthorized areas./paul rillorta

City Eyes JICA Help Anew to Upgrade Sewer Treatment BAGUIO CITY - The city government

Plant is seeking the assistance of the Japan International Cooperation Agency (JICA) anew to upgrade the aging Baguio Sewer Treatment Plant (BSTP) in North Sanitary Camp here.

JICA in 1984 made the design study for the city's existing STP which led to the grant of a monetary assistance from the Japanese government and enabled the city to construct the said facility with the help of the Local Water Utilities Administration (LWUA) in 1986.

Mayor Mauricio Domogan in a letter to JICA Philippine Office chief representative Takahiro Sasaki Dec. 9 sought JICA's "technical assistance for the conduct of a feasibility study on the upgrading of the BSTP to accommodate current excess inflow including future inflow projections."

"Results from the (study) shall greatly help us toward attaining a cost-effective and efficient implementation of our proposed BSTP upgrade," Domogan told Sasaki.

"The Government of Japan would be happy to know that the BSTP continues to operate and serve the residents of Baguio 24 hours a day, seven days a week. The BSTP in the course of 27 years thus far still helps immendsely in averting pollution of the Balili River from domestic wastewater," the mayor noted.

"(However,) data show the steady increase in raw domestic sewage inflow and inflow Biological Oxygen Demand (BOD). In fact, inflow received at the BSTP has been surpassing the planned daily mean flow of 8,600 cubic meter per day since 2004," the mayor informed

Sasaki, in his reply, advised the mayor to course the request through official diplomatic channels subject to certain requirements and procedures.

He said the request will be subject to the endorsement of the Department of Foreign Affairs and the approval of the Japanese government and advised further the city to consult with the LWUA and the National Economic Development Authority (NEDA) regarding the procedures.

He said the city may also avail of the concessional loan fund provided by JICA to the Development Bank of the Philippines (DBP) through the two-step loan called the Environmental Development Project (EDP) but the city has to go through the procedures of the bank based on technical and financial and other project information./A Refuerzo

Firecrackers out – Mayor BAGUIO CITY - Mayor Mauricio Domogan is bent on

having a firecracker ban in the city, despite its being an unpopular decision. This was his pronouncement during the regular media Ugnayan last week.

Earlier, members of the Paputok, Lucis atbp., led by Agnes Montoya lobbied for another chance at disposing their wares; having been told that only the city-sponsored air shows on Dec. 24 and 31 go on, as part of the month-long Golden Christmas in Baguio celebration.

The mayor countered that the vendors could have alternative means of livelihood through selling Christmas toys and the like.

The mayor also cited injuries due to firecrackers, and ambient air condition in the city that could be threatened by toxic fumes of exploding pyrotechnics. The entry of banned products, and also those bought in neighboring towns should be prevented, the mayor emphasized.

In a letter to the members of Paputok, Lucis atbp., the mayor conveyed his understanding for the sources of their livelihood but said that the greater benefit, and health, of the majority of Baguio citizens is at stake, thus the ban.

It was two years ago, 2011; when an ultimatum was given for the firecracker sellers, but they pleaded for an extended last chance in 2012, which was granted.

NEWS Public Hearing on 211 Titles **Conducted**

BAGUIO CITY-The public hearing on the city's 211 titles spearheaded by Council committee on Urban Planning, Lands and Housing chaired by Councilor Leandro Yangot, Jr., conducted last Thursday at the city session hall turned out to be a sounding board for constituents' various land problems.

Yangot, Jr., reminded the attendees of the objectives of the forum: to solicit inputs for the approval of a proposed council resolution, that the solicitor general's office will conduct "proper judicial proceedings" for Baguio's 211 titles.

The proposal is for the solgen's office to either revert the 211 original titles to public land status, thus make them "alienable and disposable,"or to grant said lots to legitimate ancestral land claimants. This would be for validated 211 titles, while unvalidated 211 titles still pose a problem, it was known.

Long-time occupants who had "peaceful, undisturbed possession," of the lots would benefit from the move, Yangot, Jr. said, as it would legitimize them as land owners, and real property taxpayers. Their application for building permits, light and water connection would also be legitimized, Yangot, Jr. added.

As to titled lots with seemingly no claimants, Yangot reiterated a trace-back or a trace for legitimate claimant-heirs. The councilor thus asked those with queries to present all documents as to

cases or claims within their barangays, either or not they are 211 claims. Position papers would be appropriate, if the lot in question is for barangay use. Yangot, Jr. said.

Queries on longtime occupied titled and untitled lots; or those claims straddling valid and unvalid 211 titles, mineral land claims: forest reservations; occupied lots within a local government property and covered by a Memorandum of Agreement; application procedures; occupied lots under the jurisdiction of the Philippine Commission on Good Government, were among those dealt with during the forum

A query was then raised as to unvalidated 211 claims which were recently applied for at the local Land Registration Authority office, validated and sold to unsuspecting buyers, Yangot said proper legal moves are being done. The 211 titles' record should be cleared, as some unscrupulous persons take advantage through false claims and speculation, Yangot said.

In an earlier privilege speech delivered at the city council, Yangot said government offices SolGen and the Department of Justice (DoJ) "settle the issue at their level by issuing an opinion that will clear the cobwebs, and craft the policies to serve as guidelines for the Register of Deeds (RoD), Land Registration Authority (LRA), Department of Environment and Natural Resources (DENR) and the city

City Seeks Geological Test on Land Eyed for Waste Management System

BAGUIO CITY - The city government requested the Mines and Geo-Sciences Bureau of the Dept. of Environment and Natural Resources Cordillera (MGB-DENR-CAR) to conduct a geological assessment of the site being eyed for the proposed Integrated Solid Waste Management (ISWMS) of the city.

Mayor Mauricio Domogan said the 22-hectare lot is located in one of the city's neighboring towns in Benguet. He did not name the specific location pending results of negotiations.

City general services officer Romeo Concio last Dec. 11 wrote MGB-CAR officer-in-charge regional director Faye Apil requesting MGB for technical personnel to undertake geological study on the lot to ensure its safety.

He said the city needs the assessment before it finally comes up with a "plan to consider the place for the city's ISWMS.

Domogan said several assessments and studies have to be undertaken to qualify the site for the city's ISWMS including tests by the DENR and the National Solid Waste Management Council (NSWMC) to determine its suitability for the purpose.

The lot was the latest in a bunch of sites which the city considered over the years in its quest for a suitable location to build its own engineered sanitary landfill (ESL).

The mayor said the city hopes to develop the site as its ISWMS station to house its two Environmental Recycling System (ERS) machines which process the city's biodegradable wastes and its ESL to take charge of the nonbiodegradable refuse.

This is while the city is also hatching its plans to set up a waste-toenergy facility under a private-public partnership scheme which is being considered as a long-term solution to the city's waste problem.

The three projects comprise the city's ISWMS which it is pursuing to address is waste concerns.

The waste-to-energy technology is still undergoing assessment by the NSWMC prior to the grant of a permit to prosecute the project. The National Economic Development Authority (NEDA) has required documents from the proponent of the waste-to-energy technology to process its application.

The final proposal will be forwarded to the DENR for the Environmental Compliance Certificate (ECC) and other environmental requirements and to the Dept of Energy for the energy production and sale permits.

The waste-to-energy proposal which was submitted by a private company based in Singapore involves the processing of wastes for conversion into energy through a process called Cont. on page 8

Heels and heroes

Reports on officials "sick, sick, sick" from gorging at the pork barrel straddle headlines and newscasts. These smudged the reports on the passing, last week, of a soldier who wrote on how guerrillas seized the "Koga Papers," which radically altered World War II's liberation battle for the Philippines.

Colonel Manuel Segura was 94 when he died last week. He documented how fishermen recovered the Japanese "Z Plan" in a four-engine plane that crashed off San Fernando town in Cebu in April 1944.

Drafted by Admiral Mineichi Koga, the Z Plan was adopted in March as the "Combined Fleet Secret Operations Order No. 73." It anticipated that Allied forces would leapfrog into Mindanao first. Koga was right on the button.

In July, US President Franklin Roosevelt OK'd General Douglas MacArthur's plan to thrust first into Mindanao, recall military historians James Carroll and Spencer Tucker. The options included a December landing at Sarangani Bay, plus airborne drops in Northern Mindanao.

But an April 1 typhoon altered all that. The storm slammed into two Japanese planes flying from Palau to Davao. Even flotsam from Koga's plane was never found. The second plane, carrying Rear Adm. Shigeru Fukudome, ditched off Barangay Balud Fishermen Ricardo Bolo and Cornelio Manguas pulled out 11 crash survivors, recalled Segura in his book. Guerrillas hustled them to Col. James Cushing's headquarters in an upland forest in Cebu. Two days later, fishermen Pedro Gantuangko and Rufo Wamar recovered "a box blackened by oil" off Barangay Perilos. It contained documents, condoms, plus a handful of gold pieces.

Within 24 hours, soldiers, planes and boats were crisscrossing the area. "Return unconditionally all documents or face severe measures," Cebu commander Takeshi Watanabe threatened. Executions were coupled with incentives like rice and cash. They "left, in their wake, burning houses and executed civilians," Segura wrote.

To end the massacre, Cushing ordered Lieutenant Pedro Villareal

to yield the prisoners. Thus, "the only Prisoner of War exchange on Cebu took place," Segura wrote. "Through field glasses, we observed the low bowing of Japanese troops as the chair-borne admiral passed a ridge, silhouetted against the skyline."

The Japanese offered P50,000 for the portfolio. Soldiers floated boxes where the plane crashed and tracked them as they drifted southward. Guerrilla radio operator Sgt. Victoriano Maribao said Cushing reported to Allied headquarters in Australia: The briefcase included "two operations maps showing air bases, emergency airstrips in Palau, Philippines, Hainan, Southern China…"

Australia replied: "Documents described in your number six may be of extreme value. Ensure safe arrival at southern Negros for dispatch here." Thus, the documents, "in two tight rolls," were packed into an empty mortal shell for waterproofing.

Lieutenants Irving Joseph and Dominador Canastra, with Sergeant Tudtud, sneaked it to Tolong in Negros Oriental. Midnight of June 5, a submarine surfaced and took the papers. It survived depth charging twice before arriving on May 19 in Australia, where the documents were analyzed. The Koga Papers revealed that the Japanese had only 17,000 troops in Leyte.

Sappers secretly installed navigation buoys in Dinagat and Homonhon islands on the night of Oct. 17. They guided, three days later, the 701 US ships that ferried the 132,000 men of the 6th Army who stormed ashore. Filipino guerrillas coordinated their attacks. Col. Ruperto Kangleon's troops, for example, overran the Japanese redoubt in large caves on Camp Buga-Buga, Southern Leyte.

Despite relentless air interdiction missions by US aircraft, the Japanese managed to ferry more than 34,000 troops from Mindanao to Leyte. They shipped over 10,000 tons of materiel, through Ormoc on the west coast.

The Japanese Navy's high command then committed its entire remaining surface fleet—four light carriers, 35 destroyers and 300 planes under Adm. Takeo Kuroda to battle. From Oct. 23 to 26, the 3rd Fleet under Adm. William Halsey, composed of 16 carriers, 141 destroyers and 1,500 planes, engaged the Japanese fleet.

The Leyte Gulf Battle erupted from Sibuyan Sea, Surigao Strait and Cape Engano to the waters off Samar. It also unleashed the first desperate kamikaze attacks. A Japanese decoy aircraft carrier succeeded in diverting Task Force 34 away from the vulnerable Leyte beachhead. Two prongs of the Japanese fleet then tried to ram their way through the opening to hit the fragile beachhead.

From Pearl Harbor, Adm. Chester Nimitz sent Task Force 34 a terse message: "Where Is RPT, Where Is Task Force 34 RR. The World Wonders." Military historians today say the last three words, intended as "padding," were mistakenly retained.

By coincidence, Oct. 25 was the anniversary of the Battle of Balaclava, which Tennyson wrote of in "The Charge of the Light Brigade." It was not intended as a commentary on the crisis off Leyte.

Admiral William Halsey "threw his cap to the deck and broke into sobs of rage." Rear Adm. Robert Carney, his chief of staff, confronted him and snapped: "Stop it! What the hell's the matter with you? Pull yourself together!"

In the end, Kuroda's force lost all its carriers, 11 cruisers and 11 destroyers. "The majority of its surviving heavy ships, deprived of fuel, remained in their bases for the rest of the Pacific War."

Today, no marker recalls how ordinary fishermen rewrote history despite risks to their lives. Memory is too frail a thread to peg history on. Can a people blind to their past grope their way to the future—if the present pivots around officials "sick, sick, sick" on the pork barrel?/E-mail: juan_mercado77@yahoo.com/Juan L. Mercado

DO YOU KNOW 'MADER' RICKY REYES?

QUEZON CITY —I was Davao congressman in the late 1980's when I first met Ricky Reyes who was already widely known as a trend setter in beauty and hair fashion in the Big City.

One day, with a group of hairstylists all the way from Manila, he landed in Davao and personally launched his "ISANG GUNTING ISANG SUKLAY" project which was a skills training program for the jobless and unskilled youth and some mothers in our barangays within my first congressional district. They were trained for free and at the end of the course, all the "graduates" also received starter kits consisting of scissors, combs, brushes etc to start a livelihood that could earn them somehow some modest income for the family. That was 25 years or so ago. Fast forward today.

A few days ago, my wife Beth and I were brought by Ricky to a place called 'CHILD HAUS" in Quezon City. It was a big bungalow type 7-bedroom residential house that he converted into a half-way house for young, out-of-town and indigent cancer patients undergoing chemo or treatment in Manila hospitals. There were about 23 children there at the time of our visit, mostly wearing isolation masks. They live there, free board and lodging and medical care including a "bantay" each for as long as their treatment needs them to be in Metro Manila. They have learning and play sessions in between treatments. Ricky is able to generate support from generous benefactors to sustain the expense of a full time staff of six, including doctors and volunteers attending to them. He brought with him 2 sacks of rice when we visited. I was touched when he whispered: "I told them you brought the rice."

Ricky said during the period of 10 years , there were about 11,000 kids who passed those doors. Some of them passed away although quite at a remarkably low percentage. Others returned back to their homes cured. There were also a number who kept returning after their cancer recurred. They all came from outside Manila, kids whose treatments needed them to be in Manila and they had nowhere to go. I met some kids from Bicol, Pangasinan, even from the Visayas. A pretty young face on a wheel chair was a bit bloated partly covered by a hygienic mask — signs of steroid treatment. Another young boy, about 5 years old had a shiny head, ravaged by chemo and all. Ricky told me he could assist just in case I have similarly situated young kids from Mindanao.

One could see the passion of selfless service and the love that Ricky showered on the unfortunate young patients as he talked to them, touched them, hugged them. He was "mader" to all of them.

His face however turned sullen when he recalled how the CHILD HAUS and the children beneficiaries were ejcted by the PCSO from a government facility that housed them when the Aquino administration took over from the Arroyo government in 2010. Ricky however declined to give me details. He merely said that the eviction resulted to more blessings from generous donors that made possible their transfer to its present site. He related how, during those trying times,(he shed pails of tears on public television, I was told) the family of tycoon Henry Sy Sr of SM through his son, Businessman Hans Sy, told him that he could use a 7-bedroom bungalow that was available somewhere in the vicinity of Quezon City hall.

The residential house was promptly transformed into a dormitory. All vacant spaces were filled with double-deck beds. It has a spacious garage that now is a

common function area, a medical clinic room, kitchen, etc. Cont. on page 8

Norms of Fixing (1) (A Reprint)

Fixing activities in the LTFRB-CAR to the extent that it is practiced by its personnel basically partake of the following norms:

1) Fixing of walk-in CPC applicants by the personnel themselves;

2) Fixing by outsiders in cahoots with some personnel; and in some small measure,

3) Fixing by lawyers, also in alliance with franchising personnel.

Fixing by personnel in the franchising Board is the most attractive, inviting, hence the best patronized by CPC applicants. For, aside from the fact that it appeals to the psyche and culture of the padrino minded pinoys, it offers the most effective "sales talk" there is in the game — that the application will be approved without any hitch or snag; that the franchise or CPCs shall be released in record time even in the absence of essential documentary requirements submitted; that the Decision shall be signed by the Regional Director even without the applicant appearing in the scheduled hearing; and, all that the applicant will do is to sit idly by and wait for "just 2 weeks" or the beacon call or text by the fixer for the release of the decision.

In time, as this sales pitch goes around advertised by word of mouth and spread like wild fire throughout Baguio City and CAR, CPC applicants ultimately learn to avoid the lawyers. They would now march to Pacdal to deal directly with personnel fixing in the franchising office. This, to the damage and detriment of lawyers practicing their profession in the LTFRB.

To these fixers, it probably matters not whether they violate the laws, the rules and the LTFRB Code of Conduct or take unduly the cream of business from the legitimate practitioners. What matter importantly to them, it appears, is that other than what they receive as compensation for fixing enough for the basic sustenance of the family, they also are able to earn extra monies to allot as well for their own luxury and pleasure in life. As the cliché in the bureaucracy goes: "Ang lagay, sila lang!"

In the beginning, fixing of this kind was tolerably acceptable since these personnel knew their limits or that they would easily be contented with what the public seem to give as tokens of gratitude for extra good service rendered. But not anymore.

Fixing by personnel has now a price more often costlier than what lawyers charge their clients. This is understandable though since lawyers, no matter how skilled they are in lawyering, cannot compare with fixing personnel when the object of application is beyond what is circumscribed by the rules whereof the skills of the lawyers do not count. In such a situation, they definitely have the edge over the lawyers because they are either situated within the realm and circle of those who have the exclusive power to grant franchises or they themselves are the ones vested by law with that power to exercise that discretion to grant or not to grant authority to operate public transport utili-

When such power of discretion is abusively exercised, however, such as when the one exercising it goes to the extent of causing the issuance of fraudulent or spurious franchises, fixing by personnel not only becomes an administrative offense but also criminal under the Anti Graft and Corrupt Practices Act and other laws.

Being the more prevalent norm of fixing, the abundance of PUVs in the city may perhaps be attributed therefrom. Not a few observers from the resident public annoyed by the traffic congestion and pollution in the city are therefore baffled why fixing activities remain untouched in the DOTC-CAR despite its manifest

Mayor Domogan is optimistic that with the participation and proper coordination of barangay officials to the police, the number of crime rates will lower.

"Being elected by the people, we have a big responsibility to the city and we have to accept the challenge. We should help each other because we have a lot of homework and partnerships to do," said the mayor./Jho Arranz

Pakistan faces an electricity shortfall of around 4,000 megawatts in the sweltering summer, leading to lengthy blackouts that make ordinary people's lives a misery and have strangled economic growth.

To combat the crisis, Pakistan has sought Chinese help in building power generation projects across the country, including nuclear.

Aside from the 2,200 MW project near Karachi launched by Prime Minister Nawaz Sharif last week, Chinese companies built two of Pakistan's three operational reactors.

Chinese engineers are also busy in the construction of a 969 MW hydropower project in Kashmir. They have also committed to generate 6,000 MW of electricity from coal and wind in southern Sindh province.

Economic corridor

But cooperation goes beyond energy.

Visiting in May during his first overseas trip after taking office, Chinese Premier Li Keqiang linked growth in his country's restive west with that in Pakistan, saying the two sides wanted to create an "economic corridor" to boost development.

The concept involves improving road and rail networks to link China through Pakistan to the Arabian Sea and planning minister Iqbal said its benefits would extend to other neighbouring countries.

"The biggest flagship project is going to be the economic corridor. I hope with its completion, we will be able to create opportunities not just for China and Pakistan but for the entire region," he said.

'If the economic corridor is constructed, trade between China and India can also take place from this corridor. Similarly, trade between China and Central Asia and also between India and Central Asia can take place," Iqbal said.

In January the Pakistani cabinet approved the transfer of Gwadar port, strategically located in the country's far southwest, to a Chinese state-owned company.

Once the road network is improved, Gwadar will slash thousands of kilometres off the distance oil and gas imports from Africa and the Middle East have to be transported to reach China.

'Special feelings'

The bloody six-year Taliban insurgency and threat of expat workers being kidnapped and beheaded by militants has made many foreign firms wary of investing in Pakistan.

Chinese engineers on construction sites are guarded at all times by armed policemen, and some AFP spoke to seemed happy with their time in Pakistan

"Pakistani people are very friendly with Chinese. That is why I am here since last three years and I will spend some more years over here," said Wang Yanjun, supervising a road-building project in Muzaffarabad, the main town in Pakistani Kashmir.

"They provide respect and support to Chinese, so cooperation between China and Pakistan is increasing. I think we will

do much more development projects in Advocacy Mindanow ... future than now."

Wang Yanjun's company China Xinjiang Beixin, has already worked on projects in Pakistan ranging from roads to airports.

Another engineer, Wang Songqiang of China International Water and Electric Corporation, is looking after the construction of a shopping centre in Muzaffarabad.

"Our company is working in 38 countries, but we have special feelings while working here in Pakistan," he told AFP.

Pakistan and China presently have annual bilateral trade of around \$12 billion and are trying to take it to \$15 billion in the next three years, though Iqbal said Sharif is dreaming of doubling even this volume.

For China, investing in Pakistan's crumbling infrastructure is a chance to boost trade but also about using its southwestern neighbour's workforce as it seeks to keep prices down while satisfying growing domestic demand.

"Some industries are becoming very costly in China and their government feels they can get cheaper labour in Pakistan for those factories, which includes electronics and autos," Ahmed Rashid Malik, senior research fellow at the Institute of Strategic Studies, Islamabad, told AFP.

"For that they need energy in Pakistan and investing in Pakistan's energy sector can prove beneficial for China in future."

But there are dissenting voices, raising worries about possible corruption in the somewhat opaque deals struck between Pakistani government departments and provincial administrations and Chinese firms

"The capacity of Pakistani bureaucracy and the issue of transparency in this whole development plan is a source of concern for me," Senator Mushahid Hussain, chairman of Pakistan China Institute and a strong advocate of Pakistan-China friendship, told AFP

"There have been allegations of corruption against them in the past, so it's a challenge for us to utilise this opportunity which came to us through Chinese cooperation," he said./ By Khurram Shahzad | AFP News

While we were leaving, we met at the sidewalk a young couple bringing down from their van food and items into the house. Someone was celebrating a birthday in the couple's family and what better celebration they could have than by bringing their "handa" and goodies and bringing cheers instead to the sick children.

I looked at the children's eyes as they sang christmas songs to us. I knew some of them would die soon. Others would have to go through painful treatment and healing procedures. Some were so young they could not even comprehend what was happening to them. Some mothers left their families in the provinces just to be with them - for sure agonizing with them. But then my thoughts consoled me thinking and believing that they are God's chosen few who suffer so that others like us may be given the opportunity to share and be blessed.

Yangot anchored his view on the presence of the native Ibaloi titles, where they were subjected to "historical injustice," being forced out of their rightful claims through American "colonial government.'

After his speech, however, Councilors Faustino Olowan, Peter Fianza, Richard Carino and Betty Lourdes Tabanda asked for a more thorough study of the proposal. Queries have also been raised as to the authority to revert the 211 titles to public land status, or to affirm the veracity of ancestral land claimants.

The next public hearing is scheduled on January 16, 2014 at the multi-purpose hall./juliegfianza

pyrolysis and will not involve incineration. As proposed, the project will be at no cost to the city. The investor will take charge of locating its own lot, constructing its building and other infrastructure and machineries. It will oversee the entire operations and will also take over the collection of the wastes from the barangays.

The investor will recoup the investment cost through the sale of electricity it will generate which is pegged at 10-12 megawatts of power daily. After ten years, the city stands to receive a share from the earnings. The deal will be for 25 years./A Refuerzo

being duped into assisting in traffic and safety control for foot races advertised as 'for-a-cause' that turn out to be profiteering events at the expense of our community," Fangasan said.

She also appealed to media not to announce or advertise fund drives unless these are covered by a mayor's permit and for them to help her office follow up and monitor the distribution of the proceeds to the beneficiaries.

"For the sake of transparency and in recognition of the contributions of donor," the administrative order stressed that developments in the drive should be submitted to the media for airing and publication, to eventually include the names of the donors and the names and personal circumstances of beneficiaries.

The mayor's crackdown on sham fund-raisers was well-received by pioneer folksingers here who began sharing their talents for free in concerts-for-a-cause they launched as early as the '70s, at the height of student activism.

"We stopped mounting concerts-for-a-cause when we realized that there were copycats who held their own events that were not transparent, with no disclosure of how much was raised and to whom it went to," noted Conrad Marzan, former lead singer of the Foggy Mountain Band.

Now based in Northern California, Marzan came home last summer for "Baguio Reunion", a concert-for-a-cause he performed with teammates Mhia, in BubutOlarte, March Fianza, Alfred Dizon, Alma Angiwan, Liza Noble and the police regional combo.

That May 20 concert was sponsored by the Association of Government Information Officers-Cordillera and supported by the Philippine Information Agency., the Cordillera Association of Regional Executives, the Regjonal Police Command, and the Baguo General Hospital and Medical Center.

That concert raised P111,600, divided into P27,200 each for 10year old kidney patient Chelsea Benito; kidney patient June Willy of PTV4 and cancer patient Linda Fines of the Department of Tourism; P5,000 each for jail officer Jonathan Bulwayan who was suffering from kidney failure, jeepney dispatcher and cancer patient Randy Almoite of Crystal Cave and cancer patient Eufemia Santos of the Housing and Land Use Regulatory Board.; P6,000 for police officer and kidney patient Rolando Dulay; P6,000 for the hospital bills of senior citizen Alfredo Quidilig; and P3,000 for folksinger DolpoPedronio./Ramon Dacawi.

a-cause here over the years. The Christmas treat is sponsored by the Association of Government Information Officers-Cordillera (ASGIOCO), the same group that mounted "Baguio Reunion", Mhia's coming home concert with fellow expatriate Conrad Marzan last May 20 that raised P111,600 for six other patients.

"Baguio Reunion II", as the upcoming concert is dubbed, will be for former newscaster and country music spinner Cesar Marzan of DZWT-DZWR who is suffering from protesta and colon cancer, Baguio folk and country musician Art Mina who has been sidelined for heart ailment, and Graciel Solano, a 23-year old single parent of two kids from Loakan Proper, Baguio, who needs surgery for tuberculosis arthritis.

It is dedicated to four kidney patients who are undergoing thrice- or twice-a-week hemodialysis treatment at the BGHMC: QuakelyLisayen, a23-year old former volunteer of the City Disaster Risk Reduction and Management Council who was diagnosed for end-stage kidney failure last September:

Agustin Gayao, a 54-year old unemployed father of two from Apugan, Irisan, Baguio; Lennon Cambod, 46-year old father of four from Pinget, Baguio; and 23-year old Mary Grace Binay-an, former SangguniangKabataan chair of Irisan barangay who is into three times a week hemodialysis.

It is also in memory of kidney patient James Belinan, a 57-year old father of six from Kapangan, Benguet, who passed on as the concert preparations were being finalized.

In keeping with tradition established by pioneer folk and country musicians here, bulk of the ticket sales and proceeds will go to the identified beneficiaries and will be subject of full disclosure through the media after the concert.
